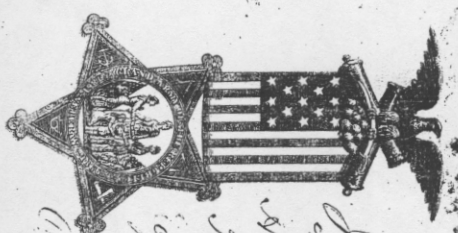

I do hereby in conformity with the Rules and Regulations of the Grand Army of the Republic and by virtue of the power and authority in me vested, constitute them and their associates and successors a Part of the Grand Army of the Republic to be known as Division
Department of Missouri
and I do hereby authorize and empower them to perform all acts necessary to conduct said organization in accordance with the Rules and Regulations of the Grand Army of the Republic.

Dated at the Grand Quarters of the Department of Missouri of the Grand Army of the Republic at St. Louis, Missouri, on the 10th day of December, 1861, in the year of our Lord One thousand Eight hundred and Eighty Five and of our Independence the One hundred and Ninety.
