As of September, Vicksburg indicated that the detailed surveys of the Missouri regimental markers was not yet complete and could not provide a time table for their completion. As such, the committee has a recommendation:

Given the discussion at the Central Region Conference relative to the need to establish new Department wide initiatives, it is recommended that the scope of this committee be expanded to identify, propose and execute new programs to generate Department wide interest and public appreciation for the work of this organization. Given this, it is also recommended that the name of the committee be changed to Department Programs Committee or something along those lines. The collaboration with Vicksburg will remain as a task of this committee with action taken at the appropriate time. However, it is recognized that there is an ever present need to introduce new opportunities for Department wide collaboration. Passes

For Department Encampment Site Committee, Walt Busch reported on issues with Department Encampments in the past and submitted four recommendations.

1. Department Encampments be run entirely by the department. Although camps can request one being held in their area.

Recommendation to continue pursuit of the Regimental Markers program pending release of the NPS survey.

He then spoke about doing program at Shiloh National Military Park or the National Cemetery where Missouri Veterans are buried. Recommendation to continue plans to hold a Shiloh event in the future. A third program he mentioned was brought forward at Spring meeting by Lillie Camp #6, has to do with the Centralia Massacre and the Union troops killed in that are buries at the Jefferson City National Cemetery. The committee recommends it be sent back to the Camp to initiate and conduct as an annual event to support the Camp's recognition in the community. The Recommendations were approved. Martin Aubuchon moved for the committee to make May 23, 2020 a target date for the program at Shiloh. Seconded and Passed.

JROTC Award Committee: It was reported there was one recommendation for the award.

Essay Award Committee: There were four finalists for the award. The Committee recommended to continue for another year. Walt Busch added an amended motion to change criteria time frame to Missouri in the Civil War and/or the Grand Army of the Republic to the end of the GAR in 1949. It was seconded and passed. 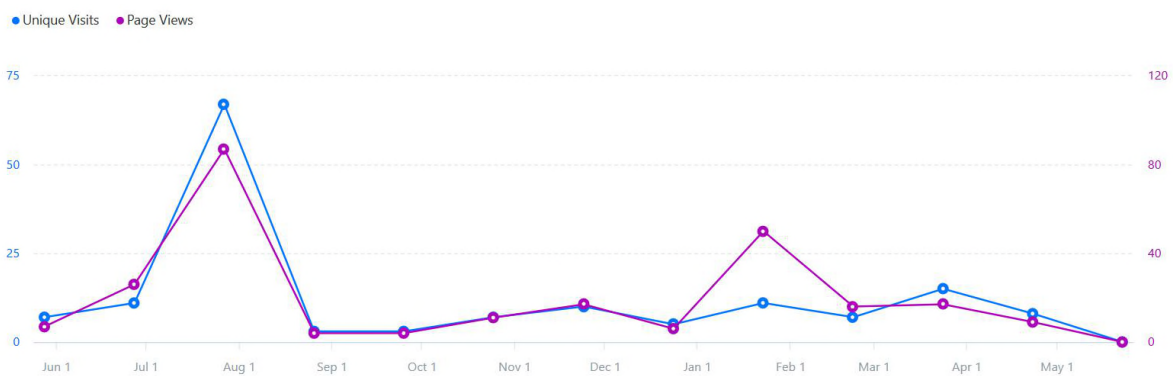

Encampment Committee Chairman Report

Walter E Busch, PDC, Chair

The following is my report with recommendations. Despite my recommendation that the department run all encampments, the following are set to take place:

2020 Kansas City Area

2021 St Louis Area

2022 Columbia Area

2023 Jefferson City Area.

At this point, I will cobble together the 2021 for St Louis since it was my suggestion to hold it at the Civil War museum prior to the national encampment in St Louis so all our members had a chance to see it AND Lillie Camp was gracious enough to move their participation from 2021 to 2023. However, I wish to be removed from being the chairman of the committee and even on the committee. I would consider it again if the department runs all aspects of the encampment.

Some issues that have occurred and continue to occur include:

1. Camps not meeting deadlines established by the department and the chair having to work around them.
2. Camps wanting participation and then dropping the ball and me being forced to go through with their suggestions.
3. Camps making grandiose claims of what will happen at encampments and then those also falling through. Also camps thinking this can be a money maker for them.
4. No communication between camps and the chair even when repeatedly asked for information.
5. Dumping follow-through on the chair after promising to do everything.
6. Officers taking action without at least informing the chair the action has taken place.

I kept the list general as all camp led encampments over the past few years have had one or all these things occurring and do not want to get into specifics about any particular camp or member. If national encampments were run like we run our department encampment, Ohio would be calling up right now to the Commander-in-Chief and telling him they don't have enough interest in running this year's encampment and to find someone else (while planning on keeping the money given them by national).

These will continue to be a problem as long as we operate in the current manner, therefore it is the Chair's recommendation that

1. Department Encampments be run entirely by the department. Although camps can request one being held in their area.
2. If holding an encampment in a camp's area, the camp can assign a liaison to work with the committee.
3. The chair appoints the committee members.
4. Actions done to further an encampment by anyone other than the chair must have an e-mail accompanying the action and the chair copied on the e-mail.

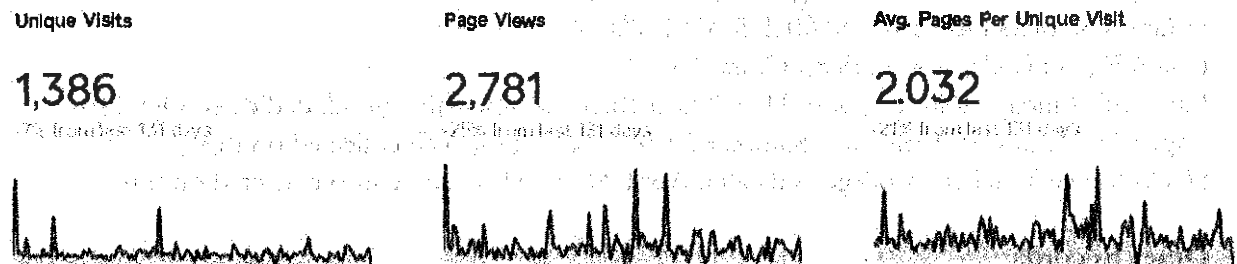
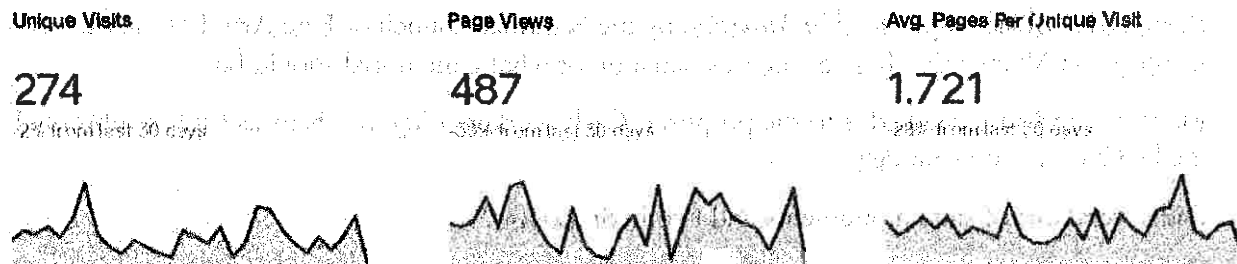

Checked with two people who e-mailed the site in the last month to make sure they have received assistance. Have not heard back from either yet.

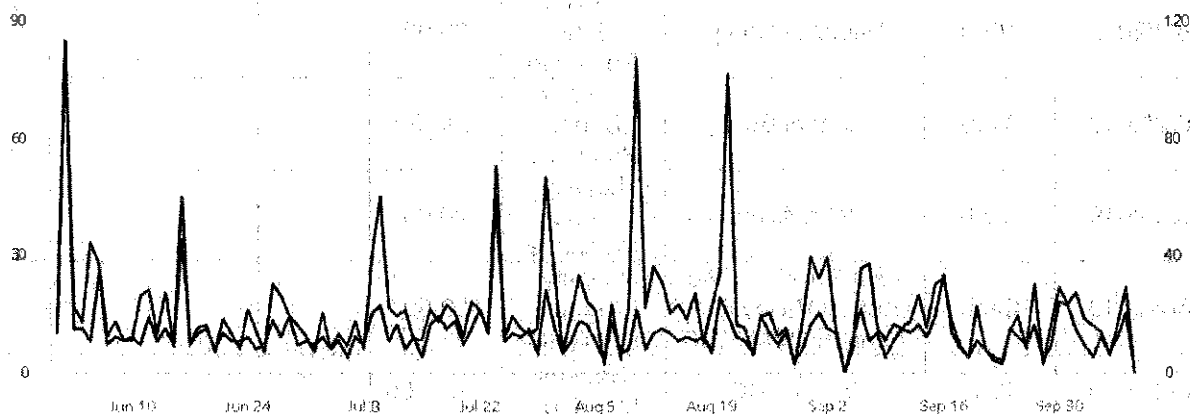
