Opening Prayer – Mark Coplin - Department Chaplain

Oct and March meeting minutes approved – Dale Crandell 1st and Randal Burd 2nd – Approved

*Walt Busch made a motion that if a member did not have a written report, then he would only have 5 minutes of discussion. Craig Mathews 1^{st} and Randal Burd 2^{nd} – Approved

Commander Report — Bob Amsler Jr — Started out by mentioning the Sherman Flag program — General Petraeus was given a flag last year at the Grant Event in New York. Gave a flag to the Grant Tomb director Frank Scaturro — The tomb was in disrepair — He was able to get the government to correct the problems. He also mentioned the apology of Brother Petrovic to the department for his actions against Dale Crandell. Walt Busch — Question — will we see the report? Per the DC the report is in the committee's hands. Don Palmer — The hearing council has to review and make a decision — then send their finding to the DC. Then the findings can be released to the entire department. McNeil Camp has officially folded. See Report for more details

Senior Vice Commander Report - Bob Aubuchon See Report

Junior Vice Commander – Randal Burd– Multiple new members – A gentleman from Maryland had ancestor who fought for Missouri. He suggested that the new member join a camp I Maryland so he could participate. Dead Line for the Unionist is June 30th - Essay Committee – not appropriate essays submitted. Recommendations 1) Quartermaster e501 – rewrite (see report) 2) Adjust the State map to better reflect the areas each camp cover since the lost of McNeil from Northern Missouri. (see report) 3) Department Commander to review all past orders in the Department – (see report)

Point of order – Walt Busch and Don Palmer - Need an Encampment Committee to review all the recommendations, by law and order presented at the Encampment. Bob Amsler Jr. appointed Don Palmer Jr, Joe Rainey and John Palmer to review the items mentioned above. Since only recommendations were made Don asked Sumner to assist in the review.

Essay – Randal Burd – Need to review if want to continue the essay contest. Need also contact the schools so they know what the scope of the essay should be.

Bob Amsler Jr – May want to contact Greg Wolk to see if his organization would be willing to assist with the essay reviews. Need to review and see how best to move forward.

John Palmer – Focus on 7th to 12th grade. They start American History in 7th and review in High School.

Unionist -Randal Burd - Dead line for information is June 30th

Mark Coplin – Mentioned the passing of a member of the Talkington Camp in Arkansas – David Nelson Alexander - 69 of Van Buren, Arkansas – Information to be sent into Randal and to the National Chaplain.

Secretary Report - See Report

Walt Busch suggested that we need to decide if we can have a cut off day earlier in March. To give the Secretary more time to prepare the Per Capita Tax forms. It also gives him more time to chance down problems and make corrections. Maybe a March 15th date? Ed Krieser CinC mentioned that National Sets the deadlines. He did not think a department could change those deadlines. Walt – Withdrew his Suggestion and reported we need to think about it and address at a later date.

Treasurer Report - See Report -

Recommendations - 1) Approve the Budget today. 2) Past Department Commander's fund — What is the fund for? 3) *Charitable Fund* (defer this until the October meeting) 4) Would suggest the Department have 2 years of operating funds on hand. Contact Department members to make sure they are aware of the Department's 501C3 status.

Don Palmer Jr – Has anyone requested funds? Dale – No one has requested any funds. He has gotten a request for a project for Grant Camp.

Bob Amsler Jr – We need to have a written definition of what a charity is.

Randal Burd - Is there already a definition out there already? Ed Krieser No – Your use the funds for what you think is for charity and the IRS will see if it <u>meets their requirements</u>.

Walt Busch – Honoring the Civil War or something dealing with Patriotism, Confederate Essay was awarded funds in the past

Bob Amsler Jr - We should not be rewarding someone for a Confederate Essey.

Don Palmer Jr – Just to give a historic perspective the Past Department Commander fund was started 20 years ago

Ed Krieser - Charitable means there is a need. Restricted fund – articles in the bylaws – articles of incorporation

Walt Busch – Can Dale and I meet and put together a form to pass out to the camps on what is e expectable as charity? This will be presented in the October meeting.

Don Palmer Jr and Bob Amsler Jr. – Now that we are a 501C3 we need to be very careful.

Dale Crandell - May need to reword the definition of what the Department can do.

Walt Busch – Currently has \$10,000 in a CD with a 4% interest rate for 8 months

Bob Amsler Jr. - Can invest in conservative investments – 501C3 Vanguard - Fidelity or Edward Jones. Stock market is doing better than the rate of inflation. Low risk – Will look at this and present at the October meeting – in the meantime will help look into the type of products we would be interested in investing in. Vanguard takes 1% on the money you make.

Walt Busch – Money Market? Bob Amsler Jr – Looking at what product to place the funds of the department.

Glen Alsop – Mercy where he works uses Vanguard for their 401K and is happy with the product. Don Palmer Jr – Boeing uses Fidelity – Sumner Hunnewell – Wise to look into investments to grow the funds of the Department

Kirk Singleton – Is there a minimal amount to invest? Bob Amsler Jr - \$5000,00 and you can pull money out without a penalty.

Budget - See Report – Walt Busch 1^{st} and Randal Burd 2^{nd} – Approved the budget section with the cash section put on hold.

- <u>Patriotic Instructor</u> Dale Crandell Recommendation The Department send a donation to the Springfield National Cemetery Patriotic US National Cemetery to Flag Day. Submitted to National
- <u>Eagle Scout</u> Sumner Hunnewell This past year we had 7 Courts of Honors We have a patch, challenge coin and certificates. Kevin Miller West had 2, Travis Cummings in Arkansas also had 2, Chris Warren has talked with his Scouting Troop to make sure they knew of our free program for their Eagle Scout Events.
- ROTC JROTC Dale Crandell No report Arkansas awarded the most, Westport came in 2nd JROTC 1 nominee for outstanding cadet Joe Rainey Major Clay contacted all the ROTC and JROTC units. Will be presenting him with an award for all his work. He is a member of Spradling Camp Was suggested by the encampment that he be an assistant to help with covering the state of Arkansas. Joe will ask him.

Walt Busch – Are the members in Arkansas still trying to establish enough camps to form their own Department? – Suggestion – to have an assistant Patriotic Instructor, Eagle Scout and ROTC/JROTC in Arkansas. That way when you are ready to form your own Department you will already have the frame work set for the leadership in those areas.

Graves Registration Officer – Gary Scheel is stepping down as grave registration officer. Randal Burd – Recommended Glen Alsop to take over the position of Grave Registration Officer. Glen agreed to taking over the position. Bob Amsler Jr. – Recommended that Glen contact Gary if he had any questions or needed help with the position. Gary was one of the hardest working grave registration officers. Glen mentioned that grave registration was one of the reasons he joined the Sons.

Medal of Honor - Randal Burd - No report

<u>Historical Records Officer</u> – Walt Busch (See Report) In July 21 and 22nd - The director of Fort

Donnelson to give a talk at The Soldier's Memorial and also at Grant Remembrance Day at U. S.

Grant Historical site. October 20th at Jefferson Barracks – US Grant Camp will be holding their annual 56th Colored Infantry Remembrance – two JROTC units will be providing a color guard.

Will have a bag piper. Bob Aubuchon is setting up the uniformed units and color guard. Retired General Bagby will be the speaker at the ceremony.

- Physical book of all the encampments – Retiring from the post. Time to give it up. Walt Busch is to take over the position. He has a large garage.

<u>Camp Reports</u> - Arkansas submitted the only camp report. (See Report) Items not mentioned in the report include – McPherson Camp members volunteer at the Pea Ridge Battlefield and Prairie Grove sites. They run Children's Programs, Artillery Crews. Murphy Camp – Mark Price working on putting up a Colored Infantry Monument – 5 artists so far have submitted their ideas. There will be a review. Shawne Lynn CC – is on the committee in Little Rock – Is requesting funds from the Department and National for the monument.

Dale Crandell – There are funds in the budget for monuments.

Joe Rainey – We have started to receive fund but still don't know the final cost of the project. Mark Coplin- Have the members in Arkansas asked for funds from any state or local agencies? Joe Rainey – Central Library is making a donation for the project.

Ed Krieser – With the computer age more Department and Camp Newsletters are being reviewed by the C in C.

Randal Burd – Are Department members using it? How do you we move forward? Issue with the program – There are free version or similar programs that do the same thing?

Glen Alsop – Motion – That we use the Group IO program for one year starting in March.

Dale Crandell - Camps will have a subgroup - top down

Ed Krieser and Don Palmer – They know that most of the camps will not be able to set this up. If all the camp can put up the information on Groups IO – put there calendar up on the Group IO – It will need to be set up initially.

Bob Amsler Jr - Would benefit from the camps to put in basic and information to the members. Not to replace the Unionist and could up load all the older Unionist editions.

Walt Busch - You can't require at camp to use this program.

Dale Crandell – Have a hard enough time getting the camps to get their EIN – Or send in the forms. About $1/3^{rd}$ of them will try it for the year.

Motion to continue the trial period for Groups IO - Glen Alsop 1st - 2nd by Joe Rainey

Majority of those present voted yea and 2 objected. - Approved

Award Committee - Plaque - Cost increase

Don Palmer – Awards were plaques – other awards for other certificates. He is in favor of returning to using plaques for the top awards – Blair Award, Meritorious Service and Show Me Spirit Awards – We need to stop the cheapness in the Department. We are sitting on funds and can use them to help thank those that have helped the Department.

Walt Busch – Prefers certificates – Made a motion to purchase plaques at \$50.00 or less per plaque. This would include the Blair Award, Meritorious Service Award and the Show Me Spirit Awards. Craig Mathews 2nd

Randal Burd – Why are we asking for an increase in dues?

Mark Coplin – The Blair Award is received in 2005 still hangs on my bedroom wall. I look at it and realize I need to continue to strive to do my best for the Department. The plaque means more to me then a piece of paper in a cheap frame.

Motion to return to plaques as noted above - Unanimous vote -Approved

<u>Treasurer</u> – Dale Crandell - Will move the funds from different accounts and amend the budget. Would prefer to move for the budget to be considered.

Quarter Master - Post to be filled by Walt Busch.

GAR monument in Mountain Grove

<u>Transgender Policy</u> – Randal Burd – Wrote a revised version of the police and read it aloud to those at the Encampment. The Department of Missouri does not concur with the policy as it is currently written. Sumner Hunnelwell – Can this be sent on to National as an amendment to the policy.

Randal Burd – Yes that is the plan. yes, Walt Busch made a motion to approve what Brother Burd has written.

Dale Crandell – Likes the wording from National.

Sumner Hunnelwell – Prefers this new version as it provides intent. (Talking to Randal Burd) Can this be drawn up into a resolution. Randal Burd – Agreed to finalize the resolution and send it to the Department Commander. This will then be sent onto National in time for the National Encampment.

Dale Crandell – Wants to make it clear in the resolution that the Department of Missouri is against the current version as written.

Motion 2^{nd} by Craig Mathews – 1 Dissenting vote – Approved to be made into a resolution and sent onto National.

<u>New Business</u> – Walt Busch -Do we want to present gifts to the Commander in Chief and if so, what? Memorabilia form Shiloh? Vicksburg medal, books? Set of coins?

Sumner Hunnewell – He reported he has a 16 x 20 Red Sox signed photo – will donate as a gift.

President of the Auxiliary – She is RN at Fort Leonard Wood. She may be heading to Germany. A gift certificate in Euros would be nice. Should be able to confirm if she is going in the next two months. 25.00 Euros?

Walt Busch – Need to put an ad in the National Encampment book. Motion to put and ad in the Encampment book. 2^{nd} by Randal Burd Ad –Motion approved. Bob Amsler Jr – Make a General Order to allow for the ad to be placed.

Don Palmer DP –Point of Order – General Orders only are issued by the Commander in Chief.

State Senators and State Representatives to see if he can get a bill passed and signed by Governor Parsons

Walt Busch - Resolution – To include the items of breaking up the KKK and he up held the 14 and $15^{\rm th}$ Amendments

Ohio - Has already pasted this. Go in as a bill in January. Ed Krieser – Consensus

Don Palmer – Item for committee reports- program committee – coordination with MOLLUS – Sumner Hunnelwell – member of MOLUS to hold and event at Wilson Creek.

Don Palmer – On the event map for October – Longer term events like Vicksburg in 2017 and Shiloh –

His feeling to continue these events are becoming less. 2024 Chattanooga - Atlanta campaign

Do we want to continue with these events? Some members have shown that they don't want to continue. NPS at Vicksburg had great support – at the Shiloh did not have any support from NPS at Shiloh. No media coverage.

They were to be commemorative events and help promote the organization.

Dale Crandell – Vicksburg was a great success – Shiloh was also a wonderful event. Bigger scope – should have events in the future.

Don Palmer – Department level events – very rarely collaborate on events.

Bob Amsler Jr – What do you mean by support from the Department –

Don Palmer – State Parks Sites within the State of Missouri – Going outside the state helps further the education of the public – But educating those in our own State is important as well.

Walt Busch – We can also focus mostly in Missouri and Arkansas to help add membership to the Department – By going to Tennessee or other states it does not help with our numbers. Some events outside our state tie into those monuments within – The 56th Colored Inf attacked within Arkansas.

Doug Roussin – A lot more local smaller battles as compared to other states that had larger and bigger battlefields. Examples coming up include the anniversary of Price's Raid that is coming up next year.

Bob Amsler Jr - We had a lot of battles and small engagements – Missouri ranks either number 2 or 3 in number of battles.

Don Palmer – Wilsons Creek this year – Chattanooga – Pea Ridge

Doug Roussin – Pilot Knob – State function next year – should the Department hold an event next year at Pilot Knob?

Sumner Hunnewell - Lone Jack - nice location - Lexington has an event center.

Mark Coplin mentioned that John Rutherford was asking the department to help cover the cost of the van he rented for the tour yesterday. Dale Crandell made a motion to donate - DC- motion to donate to be paid 60.00 CW - approved

Treasurer's Report 3 June 2023

Financial Statement. The Department ended the year with a minor \$218.46 spending deficit and \$152.00 accounts receivable from Camps.

Bank Accounts. The Department has two checking accounts with US Bank; Treasurer Dale Crandell, Assistant Treasurer Walter Busch, and Past Treasurer Edward Krieser have access. The Department retired its CD with Montgomery Bank. The Department invested \$10,000 with First Community State Bank in an eight-month CD at a 4.05% rate and 2 January 2024 mature date; Assistant Treasurer Walter Busch and PDC Sumner Hunnewell have access.

2023-2024 Budget. The proposed Department budget is based on revenue being low and expenses high with a \$203 deficit.

Recommendation 1: Approve the proposed 2023-2024 annual budget [see budget spreadsheet].

Financial Policy. The Department has accumulated \$15,524.81 in cash assets and would benefit by setting financial policies for the Department Treasurer.

Recommendation 2: Approve the following three Department Policies and authorize the Bylaws Committee to add them to the Department Policy and Procedures Manual (P&PM):

¶ 900 Past Department Commanders Fund. The Past Department Commanders (PDC) fund is an endowment to support the Department's charitable work. The Department, Camps, members, Allied Orders, and non-members may donate to the fund. All donations to the PDC fund shall be invested in long-term instruments to produce annual income. All annual income from the PDC fund shall be used for the Department's charitable work. The Department Treasurer shall invest the PDC funds and provide regular financial reports. The Department Council shall provide guidance and regular audit reports in accordance with the SUVCW Constitution and Regulations (C&R).

¶ 901 Charitable Fund. One dollar (\$1.00) from each member's annual Department per capita shall be restricted to the Department's charitable work. The Department Treasurer shall maintain a separate Department charitable fund and provide regular financial reports.

¶ 902 Reserve Fund. The Department Treasurer shall reserve two-years operating expenses to manage annual cash flow, provide special project seed money, and ensure long-term financial stability. Reserve funds may be invested in short-term instruments. A



Louisa Volker Monument

The General Thomas C. Fletcher, Camp 47, DeSoto, Missouri and the Louisa Volker Aux. 215 have formed a committee to put up a monument dedicated to Louisa Volker, a female telegraph operator, during the Civil War. Her station was located at Mineral Point, Missouri. During Price's Raid in September 1864, she remained at her post until it was occupied by Confederate troops. She then hid the telegraph key to keep it from being destroyed by the Confederates.

Ø Authorize the Bylaws Committee to edit Department Policy 301 as follows:

¶ 301 IRS 990 Filing. Camps are required to maintain their IRS 501(c) tax exemption status with annual submission of an IRS 990 Return of Organization Exempt from Income Tax. Camps must forward a PDF copy of their most recent IRS 990 filing to the Department Commander and Department Secretary Treasurer or Secretary-Treasurer by March 1st.

Ø Authorize Assistant Treasurer Walter Busch to pay penalties, fees, and lost interest to close the Department's certificate of deposit with Montgomery Bank.

Ø Authorize adding Treasurer Dale Crandell, keeping Assistant Treasurer Walter Busch, and cancelling all others as account signers for the Department's certificate of deposit with Montgomery Bank.

Ø Authorize Treasurer Dale Crandell to destroy unused check books, deposit books, and miscellaneous banking items not listed on inventory.

Unable to locate the original letter for the Department's CD from Montogomery Bank.

Mark Coplin – The CD was initiated March 1, 2007 \$1,183.10

Walt Busch – When we obtain the funds from the Montgomery Account, we can open another account. When the Secretary gets a Notarized copy of the minutes we can go to the bank to have the funds of the CD released.

Bob Amsler – Use the funds to open a Vanguard S&P 500 – minimal investment is \$6,000. Any return is around 10% - can loss money but during

the past few years the return has been between 15-18% - the fee is 1% for computer transfers. No manager. We can move funds as we would like.

Dale Crandell - Placement of funds in the PDC fund.

Don Palmer - National is now a 501c3

Bob Amsler - No issues with the IRS

Ed Krieser – File 990 forms – the way it is set up you can see the results in a few hours. Some numbers are used multiple times.

Dale Crandell – The EIN numbers for Arkansas – Two camps have revoked EIN numbers.

Walt Busch - Appropriate to ask Joe Rainey for the original letter of the EIN#

Dale Crandell - We have that - there is no more letter - it is on computer.

Bob Amsler – Tax report #

Dale Crandell – We are under group exemption – National can't add those camps. They operate under un-organized. If the camps apply for an EIN number they would have to pay a large fee. Jim Pahl stated they can stay un-organized.

Ed Krieser – Bank can check on the EIN #

Don Palmer – Original into the Department – Does this throw a wrench into the organization of a Department (Arkansas) – It is not an IRS rule it is a National issue. How many camps are currently in Arkansas (4) – are they solvent?

Bob Amsler – Not as strong as it could be. There are quite a few members that below to multiple camps.

Randal Burd – Joe Rainey wants to form a Department in Arkansas.

Ed Kriser – The Department of Missouri had to approve the forming of the new department.

Eagle Scout Coordinator - Sumner Hunnewell - See Report

ROTC Coordinator - Dale Crandell - See Report

Dale Crandell – There is a new Form 7 – includes Space Force and National Defense Force

Sumner Hunnewell - Clearing house of units in the state?

Dale Crandell - Reviewed each fall to confirm units in the state.

Ed Krieser – Each branch of the military has their own ROTC program – Each branch has a slightly different variation of awards.

Bob Amsler – Can we contact the services to determine what units are active?

Does the information available include the unit commander's name and contact information?

Walt Busch – Colonel Hecker Monument – Would like the Department to issue funds for the project. Would like \$200.00 from the Department.

Made out to the German American Committee.

Dale Crandell - Who was Hecker?

Walt Busch - Hecker was born in 1811 in Germany. He was an agitator of the 1848 German Revolution. He immigrated to the United States. During the Civil War he started out as a Private and moved up to Colonel of the 24th Illinois Infantry Regiment.

<u>Department Encampment</u> - On Friday June 2nd John Rutherford will be giving a tour of the Battlefield in down town Springfield, MO – Pay John \$50.00

Bob Amsler – Should we increase the registration fees for the encampment. The Depart should not lose money on the encampment.

Walt Busch - Plaque with brass at Arch Engraving for about \$30.00.

Randal Burd - Maybe just the Blair Award

Mark Coplin – When I was awarded the Blair Award in 2005 – I was very honored by the awarded the plaque and it hangs up in my room along with my membership certificate signed by Richard Orr and Steve Leicht.

Randal Burd – Use a raffle to raise funds for the awards.

Bob Aubuchon – Meritorious Service Award would also be a good award to be on paper.

Bob Amsler - Would prefer a plaque.

Don Palmer – Meritorious Service Award is for above and beyond.

Randal Burd - Normally for over 10 years - it is the bylaws.

Bob Aubuchon – SVC is a member of the Awards Committee and they will discuss this and report at the Department Encampment in June. If they decide to reinstitute plaques they will do so at the up coming encampment in June.

Vern Stottlemeyre- He had heard that a Medal of Honor grave was to be dedicated in Trenton. Wanted to know if anyone knew anything about it. Dale Crandell mentioned that Westport Camp was holding the event Sunday at 2 PM.
