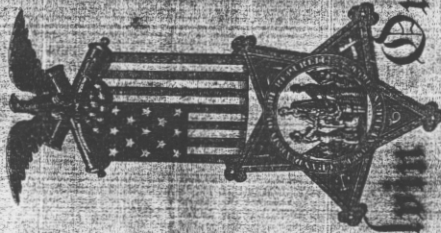

Dated at the Head Quarters of the Department of Missouri of the Grand Army of the Republic at St. Louis on the 16th day of January in the year of our Lord One thousand Eight hundred and Eighty nine and of our Independence the One hundred and thirteenth.
