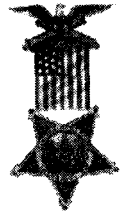

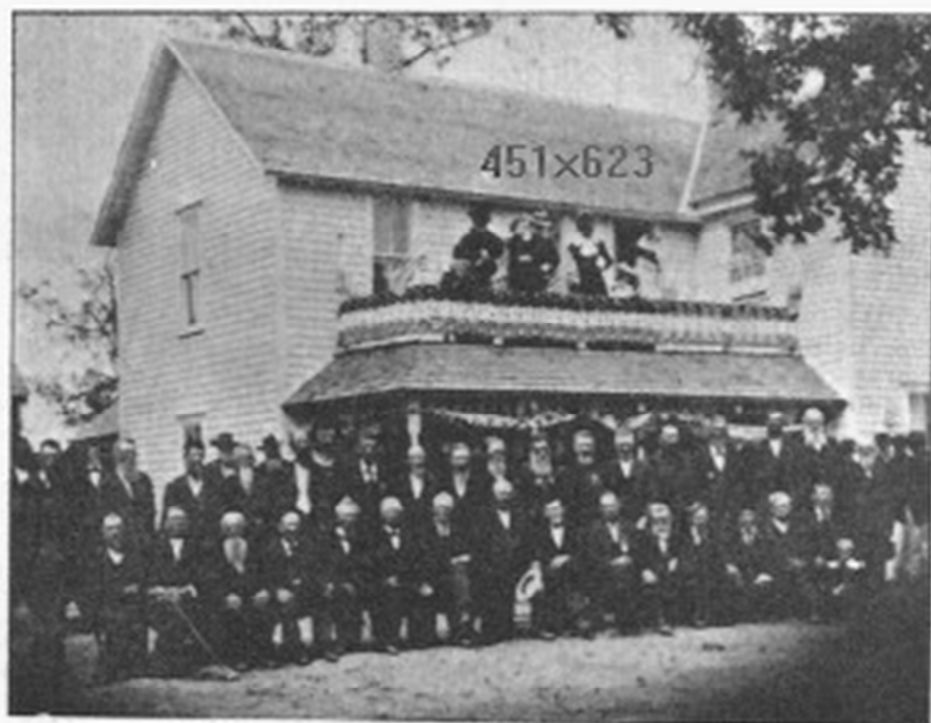

Burris building in the upper story on the east side of Main street. This building was occupied in the first story by Dr. Leeper's drug store. About 1895 the building burned, the loss being about \$1,000. The equipment of the Post was consumed. As there was no place for the

lodge to meet they sent back their charter in the same year as the fire.

The last officers were: Lem McDonald, commander; George Goddard, lieut. vice com. There are about fifteen old members still living.
