Report of the Missouri Department Council
Sons of Union Veterans of the Civil War
20 June 1998

The Department Council was saddened to learn of the resignation of Missouri Department Secretary Bill Jackson. Two candidates, John Rutherford and PDC Robert Petrovic, were considered for replacing Brother Jackson. The camp council decided for Brother Petrovic to succeed Brother Jackson as Missouri Department Secretary. *5 1/2 year*

The Department Council also reviewed proposed charges against the William T. Sherman-Billy Yank Camp 65. It was the decision of the council that the alleged offenses regarding Camp 65's activities were actually the independent actions of officers within the camp rather than official actions of Camp 65, so a recommendation was made to seek remedies only against the officers. The Department Commander took action.

In May, 1998 the National Order overturned the powers enacted by the Missouri Department, so charges were again reviewed against officers of Camp 65. In June 1998, the Department Council endorsed forwarding the charges to the National Order.

18. Handled over 1,000 written communications as Department Commander.

Missouri Department Encampment Minutes
November 21, 1998
Springfield, Missouri

Call to Order

Missouri Department Commander Steve Leicht called the Department Encampment to order at 1330 hrs. A roll call was made of the following Missouri Department officers.

Bud Marks read the minutes of the June 20 Encampment. Approved as read.

Old Business

Commander Leicht updated the Department on the status of the trial of C. Funk and P. Leistratz. Open discussion followed regarding the background and history of ongoing disputes between members of the Department and Sherman Camp. The relationship between the SVR and SUVCW camps was discussed as well.

A question from the floor asked about the legitimacy of the Department requesting records going back to before the existence of the Department. Commander Leicht answered that the past and present National Commanders in Chief have stated that a Department may only review annual records going back one year, except in cases involving fraud. The Commander also pointed out that public law states that the financial records of not-for-profit institutions are public records.

Westport Camp Commander John Martin made a recommendation that all camp commanders write to the National Commander in Chief to express the positions of their respective camp's on this matter. Commander Leicht pointed out that any member is free to express his opinion to the national organization and is encouraged to do so, but should, as a matter of courtesy, provide a copy to the Departmental organization as well.

New Business

Griswald Cannon Legal Fund . Senior Vice Commander Vern Stottlemyre reported that a VFR Post in Iowa has attempted to sell some GAR cannons entrusted to them by the local GAR when it became inactive in the 1930's. The SUVCW Iowa Department Commander, Brad McGowan is filing an injunction to stop this illegal selling of GAR Memorials. A legal fund has been established and is soliciting donations in care of Brad McGowan, 344 S. Maple St., Westbranch IA 52358 (phone 319-643-2806).

Kirksville Cannon. Senior Vice Commander Stottlemyre then updated the Department on the status of the Kirksville Cannon. The cannon is now safely held in storage, the city has abandoned all plans of selling or disposing of it, all local veterans organizations are aware of this matter and, as Vern puts it, "nothing will happen to that cannon as long as a breathing veteran is still in Kirksville."

Commander Leicht added that the Department needs to complete its inventory of Civil War memorials in order to update the SUVCW national database.

Raffle Sales. \$126 in ticket sales was turned in at the encampment. Final totals will be reported at the next encampment. The drawing was held and Bud Marks of the Westport Camp was the winner of the Emmetsburg Road print. It was voted on and approved to hold off on the next raffle sales till at least next April, since back-to-back raffle sales tend to do poorly.

Department Budget. Open discussion was held regarding the proposed budget. After discussing normal operating costs for the Department, it was agreed to only issue the Departmental newsletter twice a year in order to hold down printing and postage costs. At the conclusion of discussion, the following budget was approved by acclamation, subject to the availability of funds.

Notes:	All expenses subject to review and approval of council as provided in C&R. Extraordinary expenses, or cost overruns/underruns in various line items may be adjusted by shifting funds from other line items, upon approval of the council.

Department Funds. Discussion was held whether the Department should raise dues to cover actual operating expenses or continue to depend on fundraisers and out-of-pocket expenses. A consensus was reached that the Department dues should cover the normal anticipated operating expenses, and that fundraisers should be earmarked for specific projects. Therefore, motion was made, seconded, and passed by a vote of 5/2 that the Department dues shall be raised from \$2.00 to \$6.00 per year.

Future Fundraisers. Some confusion existed regarding the purpose of the raffle sales. Some members thought the sales had been earmarked for the National Encampment in 2001. Commander Leicht explained that the raffle sales had not been specifically identified for that purpose, but with Department dues set to cover expenses, there was no reason the raffle sales could not be applied to such a fund. (No motion was made to identify raffle sales for this purpose, so the matter remains open.)

2001 National Encampment. The location will be in Springfield, Missouri at the University Plaza Hotel (Holiday Inn). This will be jointly hosted by the Departments of Missouri and Kansas, with estimated costs of \$6,000.00 to be shared between the two departments. Each department is to form a planning committee, with the chairmen to coordinate

between the two departments. The following brothers were nominated and voted into this committee by acclamation: J. Rutherford (Chairman); B. Petrovic; B. Marks; and Z. Caldwell.

NMAL Dues. Commander Leicht explained that National Members at Large must now be affiliated with the department in which they reside. Because they become, in effect, Departmental Members at Large, the Department must establish the annual dues to charge. Motion was made, seconded, and passed to charge National Members at Large annual dues of \$26.00 per year.

Administrative Note. Commander Leicht announced that when the camps file their 4th quarter per capita taxes, they need to also provide the following information to Secretary Bob Petrovic: dates and locations of camp meetings (i.e., third Tuesday of the month, etc.) and the annual dues charged by that camp.

Closing

Commander Leicht closed the Department Encampment at 1615 hrs.

Dep't. Council: reported they reviewed the books.

Bill Jackson resigned as Treas., they had three names submitted,
and Bob Petrovic was chosen.

Missouri Department Bylaws were returned from National NOT APPROVED.

Council reported, three bills have not been paid. (1) Secy, (2) Nat.
Rep. Dean Speaks, (3) Dep't. Cmdr. \$250.00 for postage and
mileage. Dep't. Cmdr. Leicht said he would take \$50.00 per
quarter as payment. (\$50.00 per quarter till October 1999)

Motion was made and passed these bills be paid.

Council Members: Jeff Patric, Bob Marks, John Piller

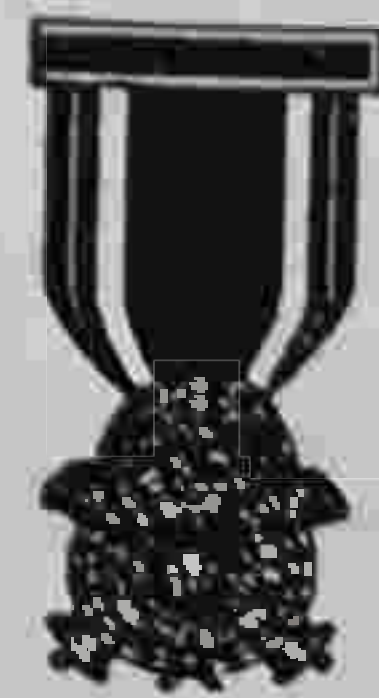


