Standing Committee Reports:

Bylaws Committee, Sumner Hunnewell – There were no Bylaw changes to report, however, there were recommendations to the Policies and Procedures. To remove non-functioning links. Passed.

Awards Committee, Sumner Hunnewell – As Proposed in written committee report pages 39 through 49. Two additions were approved to the Eads Award,

- (1) Under the Participation Activities add "Active Camp Juniors group."
- (2) Under Program Activities add "Setting up a recruiting table at any public event."

Of the Awards Committee recommendations, the first and third were referred to the Awards Committee for the October business meeting. The second was withdrawn.

Department Encampment Site Committee, Walt Busch –

Recommendation #1 Amended to read: *In the event we are cancelled from a venue or the venue is closed due to unforeseen circumstances, the committee will automatically seek a venue in the center area of the state. An online meeting shall be only an absolute last resort and that decision shall be made solely by the encampment committee chair.*

Passed as Amended.

Recommendation #2 Amended to read: *Once the commander appoints the committee and the department members meeting in encampment or business meeting decide the general location to hold the encampment, the committee chair shall have total and sole discretionary power to:*

- 1. *make additional appointments to his committee as needed.*
- 2. *choose a venue in the approved area.*
- 3. *The committee shall stay within any budget given them by the department encampment and shall go to councils, officers, or business meeting votes only when a variance is needed.*
- 4. *The committee shall have ribbons prepared for the encampment and make hotel reservations for visiting national officers.*
- 5. *Individual officers/members having property of the department (altar, bible, station banners, etc) are responsible for bringing these to meetings.*
- 6. *Copies of reports are the responsibility of the officer preparing the reports. The committee is not responsible for these.*

Passed as amended.

Recommendation #3 Amended to read: *The budget for encampment next year only is as follows with no more than a 10% variance in any listed item.*

1. Meeting Room – not more than	\$250.00
2. Expenses gifted to the national visiting officer	\$125.00
3. Ribbons estimated @\$1 ea	\$ 50.00
4. Miscellaneous (refreshments)	<u>\$ 50.00</u>
	TOTAL: \$475.00

Passed as amended.

Recommendation #4: I make a motion that we reimburse the hosts bringing refreshments for breaks an amount not to exceed \$50. Seconded and Passed.

Recommendation #5: I make a motion that we gift to the owners of the meeting place an amount not greater than \$150 for the use of their facility. Seconded and Passed.

Recommendation #6: I make a motion that we pay expenses of the National Representative up to \$150.00. Seconded and Passed.

Special Committee Reports

2021 National Encampment Host Committee, Walt Busch on behalf of Bob Petrovic.

Programs Committee, Don Palmer spoke about possible different programs, time and places. Nothing in place at this time.

Brief reports from the camps that had representatives present.

Council Audit reported that the books are in order.

Walt Busch moved to transfer \$1591.99 from the General Fund to the Past Commander's Fund and to place \$1.00 from each Per-Capita in future into the Past Commander's Fund. Randal Burd Second. Motion passed.

Officer Recommendations Committee Report, Martin Aubuchon:

Jr. Vice Commander Recommendation: Helping prospective member seek ancestral requirements. The committee agrees it would be good to do, but the exact implementation is not known. Committee recommends the next Jr. Vice research the method of implementation. Recommendation passed.

Department Commander Recommendations: Both Recommendations were not approved, and they need to be reviewed by the Bylaws Committee to be presented in October.

Walt Busch moved to make the JROTC Essay Award permanent. Motion was seconded and passed.

Randal Burd moved the Secretary cast one vote when there is only one candidate for the office.

Senior Vice Commander: Ed Krieser nominated Joseph Rainey for Senior Vice Commander. There were no other nominations.

Junior Vice Commander: Randal Burd nominated Gary Scheel for Junior Vice Commander. There were no other nominations.

Secretary/Treasurer for two-year term: Sumner Hunnewell nominated Edward Krieser for Secretary/Treasurer. There were no other nominations.

Department First Council Position for two-year term: Sumner Hunnewell nominated Randal Burd. J. Purkapple nominated Dale Crandall. Walt Busch nominated Robert Aubuchon who declined. There were no other nominations.

Camps caucused. Brother Burd won the election.

Department Second Council Position for two-year term: Walt Busch nominated Robert Aubuchon. Sumner Hunnewell nominated Dale Crandall.

Camps caucused. Brother Crandall won the election.

Delegates to the National Encampment: Sumner Hunnewell Nominated John Palmer, Joseph Rainey and James Beckman. There were no other nominations. Passed.

Randall Burd nominated all other Brothers of the Department as alternate Delegates to the National Encampment. Passed.

Still Unreported Civil War Markers in Missouri

1. Union Prison Collapse – 1425 So Grand KC - Have Picture and some info supplied by Westport Camp but have not completed form yet.
2. Battle of Munday Hollow South Hwy 7 near Richland – Info completed thanks to PDC Randal Burd
3. Harris Stowe Teacher's College dedicated April 2019 – No Information filed yet
4. Ray Family Marker – Dedicated 2020 – Form 61 supplied by DC Sumner Hunnewell, but not reviewed yet

I've also done the following since the meeting, but have not compiled final documents yet.

1. Updated one monument with better pictures in Vincennes, IN
2. Found 3 new monuments in Vincennes (the Co Courthouse has a monument imbedded in it, plus two historical markers – one of which includes a gravestone)
3. Two courthouse cannons in Illinois (one at Vienna and the other at Golconda)
4. 2 historic markers at Smithland KY
5. Took better pictures at Washington MO of two historic markers

Finally, McPherson Camp has raised some funds and has asked national for some more to clean up the monument at Judsonia, AR. As national monuments officer I have told the committee that I approve of the project.

GAR/SUV RECORDS

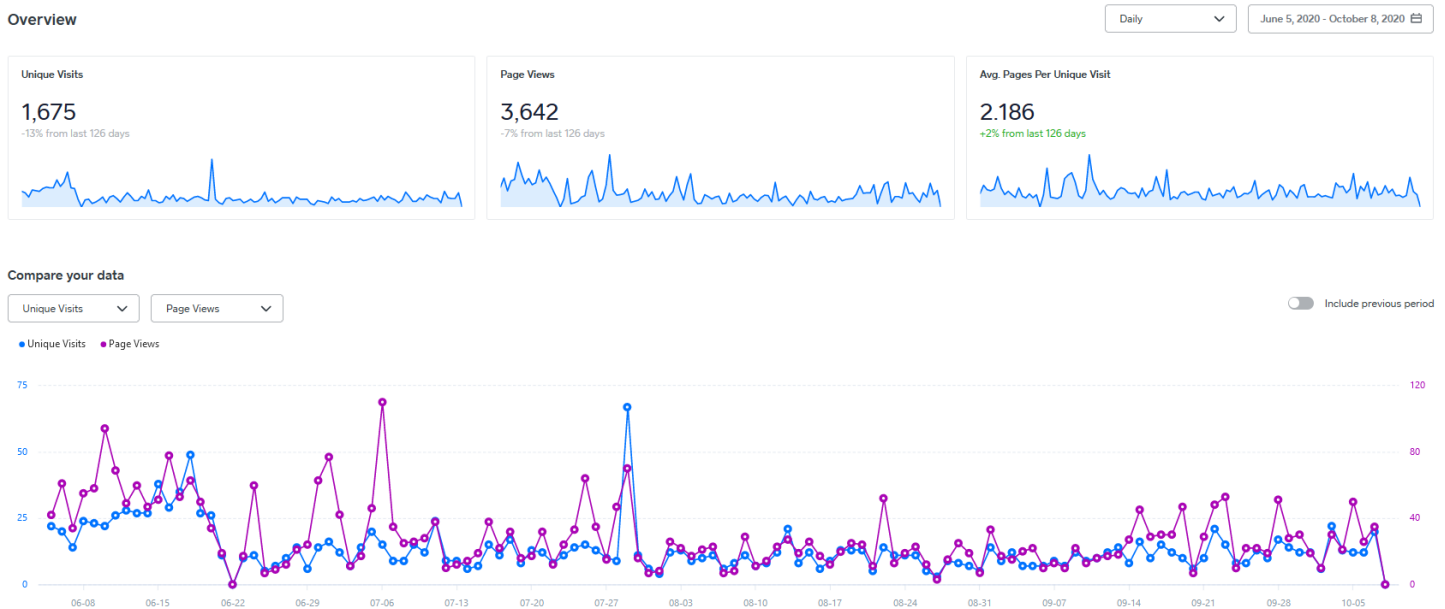
1. Had slides of 1969 St Louis Encampment Digitized
2. Dropped off Sherman Camp records and Custer GAR Post records at Western Historical Manuscripts – UMSL Branch
3. Went to Washington MO Historical Society and documented the books they just received from the Spring Bluff GAR Post. Also there were several years of Dept of MO GAR Records there so they were photographed as well. We have permission from the museum to post them online.
4. During conversation with the Washington Historical Society Museum manager I learned that the building the Wilhelmi post met in in Washington MO still exists. Took picture of the building and of some information the Society had about it (creating Post record)

RECOMMENDATIONS FROM THE GAR RECORDS SECTION

1. ***We thank the Washington Historical Society by presenting them either a check to provide protective archival folders/boxes for the GAR Records. Take photograph and see if we might be able to get local paper involved.***
2. ***Since Wilhelmi camp is closest, see if they can ask city of Washington if they would be interested in us providing a plaque to be placed in the sidewalk in front of the old GAR Hall? We could pay for the plaque and some materials for them to install.***

Department Encampment Committee Chair

No action yet. Plan on having 2021 at Missouri Civil War Museum. Museum has ok'd us renting the building cheaply (forget if it was \$100 or \$150 for use). Their address is 222 Worth Ave., Lemay, MO 63125.

The motel I found is just off of the Meramec Bottom Road-Exit 193 of I-55. Best Western St. Louis Inn, 6224 Heimos Industrial Park Dr, Saint Louis, MO 63129. (314) 416-7639. Pricing is very reasonable and they are a relatively new motel located just behind the Cracker Barrel. Rates are \$74 + plus tax for 2 double bed room. Discounts include AAA ARP or GOV, Retired Military. It is a 10-minute drive to the Civil War Museum.

Food – We can arrange for food or there are several local restaurants. I do not have a recommendation for this (some catering in the area is rather expensive, everyone just going to lunch and us providing soda, tea and water along with a snack & donuts (from the great Donut shop on Lemay Ferry near the post office) for breakfast would be my best recommendation.

Recommendation: I recommend we approve the above and it be posted ASAP on the web.

Patriotic Instructor Report
10 October 2020

Patriotic Holidays and Observances. A plan is proposed to post short summaries of federal, Missouri, and Arkansas patriotic holidays and observances in the *Missouri Unionist* and Department's Facebook pages. A proposed list is attached. The Navy Birthday is an example.

Navy Birthday – 13 October 1775

Tuesday, October 13th is the 245th birthday of the U.S. Navy. The Continental Congress authorized the procurement and manning of two ships on 13 October 1775 for service against the British navy. From this simple beginning the Continental Navy grew to 20 ships by the end of the Revolutionary War including the Ranger and her famous commander, John Paul Jones, but this fleet was sold-off in 1783 at the end of the war. A standing naval warfare fleet was re-established in 1794 and has remained in service to our current U.S. Navy.

The Union Navy's primary mission during the American Civil War was blockade of Confederate ports, a form of economic warfare to starve the Confederacy from selling their cash crop –cotton. They also assisted the Union Army with their invasion of coastal cities in the Carolinas and capture of New Orleans. Important to naval history was the Battle of Hampton where the USS Monitor and CSS Virginia, the first two ironclads battled.

Missouri and Arkansas Civil War Timeline. A plan is proposed to post short summaries of the local Civil War battles and events in the *Missouri Unionist* and Department's Facebook pages. A proposed Missouri battle list is attached. The Battle of Westport is an example.

The Battle of Westport –the Gettysburg of the West –was fought October 23, 1864 and represents one of the largest American Civil War battles west of the Mississippi River. It was also a turning point in the war and closing chapter for Confederate General Sterling Price's 1864 Missouri raid. 30,000 soldiers were part of the engagement with an estimated 1,000 soldiers killed or wounded. The battle was the last major operation Confederate forces launched in the Trans-Mississippi Theater leaving Missouri firmly under Union control for the remainder of the war.

General Price's Missouri raid was a bold attempt by Confederate forces to attack a Northern State; capture St. Louis; and disrupt Lincoln's re-election campaign. General Price started with 18,000 troops in his Army of Missouri, but at each encounter he met Union cavalry and Missouri militia resistance, compelling him to shift his target to Fort Leavenworth. Upon reaching Kansas City disease, casualties, and desertions left the Confederates with 8,500 soldiers, confronting 22,000 from Union cavalry that had been chasing Price across Missouri and Kansas infantry including the Jayhawkers, unified under Union General Samuel Curtis' Army of the Border.

General Price had moderate success just days prior at the Battles of Lexington, Little Blue, and Blue River; and they held a tactical advantage overlooking Brush Creek. The Confederates repealed the Union's daybreak skirmish across Brush Creek. However, General Curtis' better supplied artillery, cavalry, and infantry in the afternoon's second wave outnumbered and overwhelmed the Confederates who were forced to hastily retreat.

Inventory. The inventory of Army-Air Force bronze leaves and Navy-Marine Corps bronze stars used for the JROTC Outstanding Cadet are lost.

ROTC Coordinator Report
10 October 2020

ROTC. There are 17 college-level ROTC units in Missouri and Arkansas, each assigned to a local camp. Wilhelmi Camp is not near an ROTC unit and the Department covers three ROTC units in central Arkansas.

JROTC Missouri. There are 57 high school level JROTC units in Missouri, each assigned to a local camp. Lillie Camp is not near a JROTC unit. There is a net change of four less Missouri JROTC units.

JROTC Arkansas. There are 43 high school level JROTC units in Missouri. Four are assigned to a Spradling Camp and the Department covers the rest.
