SUVCW honors 56th USCT with remembrance ceremony

US Grant Camp 68 – St Louis held a remembrance ceremony for the 56th US Colored Troops at their mass grave in Jefferson Barracks on Oct 20. The keynote speaker was retired Major General Byron Bagby, who had relatives in that unit. After a great ceremony covered by 2 local news channels and one newspaper, the group, including students from two local schools, had refreshments and met with the General at the Missouri Civil War Museum. The Camp also paid for the students to tour the museum, making it a great school outing for the middle school students.

After the color guard marched in, Walter Fox, a local Gospel singer,

began the ceremony with the Star-Spangled Banner. Other music was provided on bagpipes by Grant Past Camp Commander Daniel Jackson and Fletcher Camp member Duncan Noack on fife. Local historian of African-American history, Angela da Silva, remarked on the importance of Black troops to the Union cause. General Bagby covered the history of the 56th and his connection to it. This was the largest ceremony for the 56th since it was instituted by historian Sarah Cato in 2012. Sarah passed away just prior to this event and was remembered with a moment of silence.

The event had people representing all the US armed forces except for Space Force. Gateway STEM Air Force JROTC led by MSGT Gregory Stephan provided a color guard. While the Marine Corps League Detachment 183 provided color and honor guards. Rev. Ryan Rupe, Our Savior Lutheran Church, recently retired as Command Chaplain, US Navy and Coast Guard, assist our member Monsignor Michael Witt as remembered that all things are not possible without our Heavenly Father. Members of the Wilhelmi, Fletcher, and St. James Camps helped out and presenting wreaths were representatives of the Missouri Daughters of Union Veterans of the Civil War, Julia Dent Grant Tent DUVCW, Missouri MOLLUS and Missouri DOLLUS, students from St. Louis University studying Civil War history with Dr. Silvana Siddali, and middle school students from Salem Lutheran School – Affton.

After the ceremony a luncheon of sandwiches, chips, and soft drinks was provided by the camp and the Julia Dent Grant Tent DUVCW at the Missouri Civil War Museum. All had the chance to meet with General Bagby. The General addressed the middle school students on the importance of volunteerism. We then offered the students tours of the museum for which the camp paid.

KMOV and KSDK TV had film crews at the event and the local St. Louis American newspaper was also there. Fox2Now didn't cover the event, but did make a comment advertising the event earlier in the morning.

All in all a great time made possible with the support of all the above, Mark Trout – Missouri Civil War Museum, and Jefferson Barracks National Cemetery.

FROM THE EDITOR: MOVING FORWARD, LOOKING BACK



Christmastime. New Years. This is the time of year both for reflecting on the past and for looking towards the future. It is a time to remember the overwhelming joy and hope of a child born in a manager. For many it is, for different reasons, a time of grief and sadness. A friend of mine reposted on social media a quote about holiday grief being a mixture of wanting what once was, but trying not to miss out on what is. Hearts are burdened throughout the year, but often especially during such times of celebration. Empty chairs were a common fixture in households during the Civil War, and they persist in being grim reminders of loss in the present day. Remember your brothers and their families whose loved ones are especially missed during the holiday season.

Speaking of dichotomies of emotion and social media and burdened hearts, I have noticed an unfortunate revival of Lost Cause ideology creeping into the cross-section of America I encounter on social media. I imagine it is likely due to the polarizing times we live in, but to see disaffected, supposedly educated individuals posting ridiculously absurd and inflammatory critiques of Lincoln and other disinformation while glorifying Confederate generals and wearing and displaying the Battle Flag of Northern Virginia as a modern political statement is as appalling as it is bewildering.

General Grant summarized the issue most succinctly when he stated “I felt like anything rather than rejoicing at the downfall of a foe who had fought so long and valiantly, and had suffered so much for a cause, though that cause was, I believe, one of the worst for which a people ever fought, and one for which there was the least excuse.” I have used the quote repeatedly in past issues, but I feel it is of the utmost importance this quote should resonate for students of the American Civil War and those historians and genealogists who still seek to learn the lessons it offers. “...**the worst for which a people ever fought, and one for which there was the least excuse.**” I do not believe this sentiment is up for debate. I don’t care what your political beliefs are, nor about your degree of disaffection for the state of the nation we currently live in, but the American Civil War was not a sporting event; the armies of our ancestors who fought this war are not teams to cheer or jeer depending on the geographical latitude of the place you call home. We as a nation are profoundly blessed by an outcome that secured liberty for all and union forever, and it is this blessing, this irrefutable truth, that we must hold close to our hearts and ensure others never, ever forget.

IRS 990-N. Part of maintaining our 501(c)(3) non-profit charity status is filling an annual 990-N with the IRS. Camps are required send copies of their annual 990-N filing to the Department Treasurer (treasurer@suvchwmo.org) by **1 March 2024**. Please send the accepted confirmation page not the submission page. Typically, you need to wait an hour or day for your submission to change from pending to accepted. You can file a 990-N online at the IRS website: <https://www.irs.gov/charities-non-profits/annual-electronic-filing-requirement-for-small-exempt-organizations-form-990-n-e-postcard>. Just scroll down and

click on Submit Form 990-N (e-Postcard).



A NOTE FROM THE JUNIOR VICE-COMMANDER

JVC IS NOT JUST A “SIT BACK AND WAIT AND SEE JOB”

The JVC's primary role is to assist with the recruitment and retention of Brothers (Members, Associates, and Juniors) of the camp or the department. The JVC assists the Commander as needed. To be available for programs and projects that the camp organizes. The JVC needs to be ready to contact new members and help them understand the paper work and fee structure of dues and what type of membership the potential member qualifies for. The JVC may need to assist the new member with seeking out their genealogical history on their Civil War ancestor. (If you don't feel like you are able to help in this area – don't worry. Someone in the camp or in the department will be glad to assist you and share their knowledge of navigating Ancestry.com or the National Archives.)

With the convenience of the National website, all the materials for membership applications are at your fingertips. Information on the SUVCW organization is also available on the website for the new member to read and understand the history behind the organization. If a potential member is interested to learning more about the organization invite him to a camp meet or event.

Make sure you see the applicant's progress all the way through. Some members who don't feel valued simply stop showing up to meetings and eventually are dropped from the camp. Talk with other officers and camp member to check in on those brothers that have not attended meeting or events. See if the camp is able to help them if needed. Maybe a Brother is having an issue with their family and needs to care for a loved one. Offer to help or see if members of the camp can help.

As an example - When Past Department Commander Avery came down with an illness that required the use of a power wheel chair a few members of Grant Camp went over to assist the contractor in putting in a ramp so John could get into and out of his home. So, as you have read – the JVC is not a “Sit Back and Wait and See Job.” It is a job that helps the camp grow. We are all Brothers in the camp and we need people to step up and become leaders of the camp. If you ever need help with a new member or want help in the process of looking into genealogical records please reach out to me. I am not just sitting around. Thank you for your time.



The Ribbons of Pearl Drew

I have been a collector my entire life. The first thing I purchased was a Civil War musket. I was about 13 at the time and have been collecting ever since. Over the years I searched flea markets and antique shows and purchased many relics which I stored away and have long since forgotten. Recently, I was cleaning out an old cabinet and ran across an old tie box. When I opened it, it was filled with Women's Relief Corp ribbons and badges. I remembered that I had purchased this collection many

years ago at the 3rd Sunday Antique Flea Market which is held in Bloomington, Illinois. The box contained about 75 ribbons and badges of the Women's Relief Corp. Several ribbons included a name tag with the name Pearl Drew, Lansing, Michigan. Pearl had been very active in WRC and several other organizations, as the box contained several of their

ribbons. Michigan WRC annual department conventions and WRC national conventions ribbons were also found in the box. The ribbons date from 1901 to 1971 with the majority dating from the 30's, 40's, 50's and 60's.

Also found in the box was Pearl Drew's Presidents badge and her tattered membership badge along with two 1962 Eightieth National Convention ribbons with her name on the top pin bar.








Printed on this celluloid pin with an American flag is 35th Annual Convention, Dept. of Indiana, WRC, Logan's Port, Ind, June 1918.

One ribbon found in the tie box was made for the Department of Missouri's 40th annual encampment of the G.A.R. held in Jefferson City, May 17-18, 1921. Another Missouri ribbon was made for the Ninth Annual Reunion, Dallas County Soldiers' Association, Buffalo, Missouri, Aug. 18-19-20, 1904. Both Missouri ribbons are very rare. One ribbon has the name Jonathon W. Bachman Camp 709, Sons of Confederate Veterans Chattanooga, Tennessee. (no date) Two other ribbons belonged to the Ladies of the GAR.

Pearl's personal badges included one membership badge and a Presidents badge on a blue ribbon. Also attached to the blue ribbon is a 25-year badge, a small gold WRC lapel pin is also present. While it is common to find individual ribbons and badges, it is quite uncommon today to find such a large collection of items that can be traced to one individual. Many of the red ribbons have Delegate Third District Grand Ledge. A peculiar feature on some of these ribbons is the WRC badge design is upside down. I am not sure of the reason, but it may represent the death of a president or past president. As no ribbon is dated later than 1971, and I purchased this collection in the mid 70's, it is probable that Pearl Drew passed away around that time and these ribbons were part of an estate sale. I have not been able to trace her, but I do know from the ribbons that she held several positions in the Women's Relief Corp. These ribbons represent years of service to the WRC organization and to the Department of Michigan.

On Saturday & Sunday, September 16th & 17th, 2023, the Fletcher Camp and Volker Auxillary set up historical demonstrations at the Greentree Festival in Kirkwood. Members presented soldier's equipment, bullet casting, period toys and games, Civil War music, and cooking skills of the mid-1800s. The groups also helped spearhead a brand new scavenger hunt for the event by handing out cards and prizes, and also stamping for five different spots on the cards (historic toys, Louisa Volker history, cannonballs, bullet casting, and Civil War music).



The event had thousands of visitors and the organizers were also very impressed with our groups abilities and knowledge (and begged us to return next year!).



OCTOBER 13, HITTING THE ROAD, NEWARK, OHIO

On the way to the MOLLUS national meeting in Gettysburg, Sumner, the Camp's monument officer, decided to stop midway to record some monuments on [Form 61](#). These markers are found in the Newark, Licking County, Ohio. This county seat has set aside a park for veteran memorials.



The most impressive is a moment erected by Tent 25 of the DUVCW 1861-85 in May of 1929. It has a soldier facing a plaza of monuments. The back of the monument has a 48-star flag. It was later flanked by relief sculptures of American wars from the Revolution to (probably) the Iraq war.

The G. A. R. had their state encampment in Newark during June 1933. This monument was a memorial to the event by the Department of Ohio Woman's Relief Corps.



The Col. Charles Young W. R. C. No. 354 dedicated a tree to the park in July 1937. However, it seems that the tree did not survive as long as this marker did. If anyone want to take on a project to find out *who* Col. Charles Young is...


OCTOBER 20, 56TH USCT, JEFFERSON BARACKS NATIONAL CEMETERY, ST. LOUIS




NOVEMBER 18, HITTING THE ROAD, CENTERVILLE, EAST GERMANTOWN, CAMBRIDGE CITY, AND RICHMOND (ALL WAYNE COUNTY), INDIANA

With the new SUVCW.org website, National Officer Walt Busch has been updating the [National Monuments and Memorials Project](#)'s database and website. Having some free time traveling to Richmond, Indiana, Sumner, the Camp's monument officer, decided to stop there and back again to record some monuments on [Form 61](#). After he was done, he passed them on to Walt to clean-up and enhance.

Most of these markers, monuments, and paintings are found as you travel U. S. 40. So, if you are not in a rush, this becomes an alternative to the faster I-70.



The first marker was found outside of someone's home (320 E. Main St.) in Centerville for abolitionist, George Washington Julian. His views (like his namesake's) was truly revolutionary. (The marker evidently does not get much attention because the home owner decided to take a walk with his dog around his house...just to see what was going on...)



"When I was a young fellow, I remember some of the old band members and had quite a few talks with them concerning the band and their experiences during the Civil War. It always seemed to me that none of them would talk very much about it or tell me very much....I came to the conclusion that what they all had gone through with, they did not care to talk about it much." (*The Palladium-Item*, 7 July 1965). The marker is at US 40 and Milton St. in East Germantown.

Cambridge City sports quite a few markers but what sets it apart are murals by Pamela Bliss & Carly Mattingly Dec. (You can see some of Pamela Bliss's other work at her website PamelaBliss.gallery.)



The first is a painting of Meredith Solomon, purported to be the only Quaker general for the Union. This is found at 19 W. Main St.



The second is a painting of Lincoln and his funeral train, which traveled through Cambridge City. The house in the background is General Solomon's. It is found in a courtyard with a flagpole at 1 W. Main St.



Cambridge City is rightly proud of Gen. Meredith, whose Iron Brigade fought admirably at Gettysburg. This marker is found at 420 E. Main St.

Richmond is the county seat, which became a mustering point for men of the area. This was known as Camp Wayne. There is a monument and a marker placed where these regiments were mustered in. The monument was placed in 1926 by the Wm. P. Benton Camp No. 28 and Wm. P. Benton Camp Auxiliary No. 43. In 2014, the monument was moved and a time capsule was found. The monument now resides at the east side of the building at 831 S. E St.



A nearby marker is found at the Intersection of South 10th St. and Park Place.



The Wayne County Veterans Memorial Park is in Richmond. It is in a rather uninspired part of town but opens into a pleasant dell. There are monuments dedicated to all wars and is a focal point for veterans events. This monument was put in place by the Wm. P. Benton Camp No. 28 in 2008 and is very impressive.

McPherson Camp #1 – Springdale, AR



(Above) On December 5th, members of the McPherson Camp #1 helped fill 3100 snack packs for needy kids. The Samaritan Community Center in Rogers, Arkansas, provides these snack packs for NW Arkansas Elementary School kids with food insecurities. Sadly, Arkansas is the #1 state in the nation for kids with food insecurities. **(Below)** On Sunday December 10th, members of the McPherson Sons of Union Veterans Camp restored the "Camp Shadow" soldier silhouettes at the Steele Stevens Park in Elm Springs Arkansas. Camp Shadow was put up by Elm Springs Historical Society in 2016. Since that group disbanded, sadly the display had been damaged with most of the Silhouettes on the ground.



McPherson Camp #1 – Springdale, AR (Continued)



Elm Springs Arkansas is a historic little community with a rich Civil War history. Three different Confederate regiments train there in the fall of 1861 and again in the fall of 1862. It was also the site of a Confederate Hospital. The entire Confederate Army camped there on the evening before the Battle of Pea Ridge. Union General Blunt had his entire division there in January 1863 just weeks after the Battle of Prairie Grove. General Schofield came down to inspect Blunt's division while it was there.

According to the *Warren County Record*, the graves are located in the cemetery at Harmonie Church in Innsbrook. An unknown number of soldiers, both Union and Confederate are buried at this site. No one known when they died or were buried, but it is said they died of diphtheria during the Civil War.

Membership in the Sons of Union Veterans of the Civil War (SUVCW) is open to all male descendants, whether through lineal or collateral line, and not less than 14 years of age who: (1) are a blood relative of a soldier, sailor, marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers between April 12, 1861 and April 9, 1865; (2) have never been convicted of any infamous or heinous crime and (3) have, or whose ancestor through whom membership is claimed, has never voluntarily borne arms against the government of the United States.
