SUVCW honors General W. T. Sherman in annual ceremony

(St. Louis, Missouri) — Sherman Remembrance Day was held on March 11, 2023, at his family gravesite in Calvary Cemetery, St. Louis, MO.

Members of US Grant Camp #68 held the ceremony, assisted by: General Thomas Fletcher Camp #47, Lt. Colonel Franz Wilhelmi Camp #17, and from Illinois: Colonel Frederick Hecker Camp. Also assisting were members of the Julia Dent Grant Tent 16 - DUVCW; Louisa Volker 215 - ASUVCW; Missouri MOLLUS; Randy Baehr - Inspector General of the 4th Military District SVR, and members of the reenacting group - Turner Brigade.

During the ceremony, the old flag was retired to be preserved for later presentation to a patriotic American. US Grant Camp #68 has taken on the duties of maintaining the site and are planning a remembrance plaza there in the future.

For those of you unfamiliar with groups.io, it is a website and handles forwarding of emails, files, calendar events, and other data for groups. Spoons: Souvenirs of the Grand Army

The collecting of spoons has always been a popular hobby. Buying a spoon was a way of remembering a long-planned vacation and a reminder of good times. While the collecting of spoons has lost its popularity in recent years, it was at the turn of the 20th century a popular hobby. Veterans taking a trip to a Civil War battlefield or other historical sites purchased a spoon to remember the trip or as a gift for a loved one. At Gettysburg and other famous battlefields spoons were sold to the tourist. These spoons might have a battle scene or a portrait of a general.

Many veteran organizations and associations wanting to put up a battlefield monument sold spoons as a way to raise money and these are referred to as dedication spoons. The Grand Army of the Republic had spoons made for annual and national encampments. Enterprising venders sold these spoons at encampments along with other souvenirs.



This rifle spoon made by St. Clair Fechner was a souvenir of the 28th National Encampment of the GAR, which was held in Pittsburgh, September 1894.

Grand Army spoons are highly collectible today. Some collectors have as many as 150 varieties. No one is for sure how many of these spoons exist, but they must be in the hundreds. Just when you think you have them all, another one pops up. The spoons were made of brass with silver or nickel plate. Other spoons are sterling. Bronze spoons were made from cannon barrels which had been melted down.



The first spoon has the membership badge of the Grand Army with an enameled bowl. The middle spoons are made from captured cannon and the third has a soldier standing guard.

These spoons have a small cannon on the back indicating this. They were supposed to have been made from Confederate cannon which had been captured during the war. The firm of Heeren Bros. & Co. of Pittsburgh produced large numbers of bronze, "Captured Cannon" spoons. Many spoons have been enameled with patriotic designs. The size of the spoon varied greatly from teaspoons to tablespoon sizes.

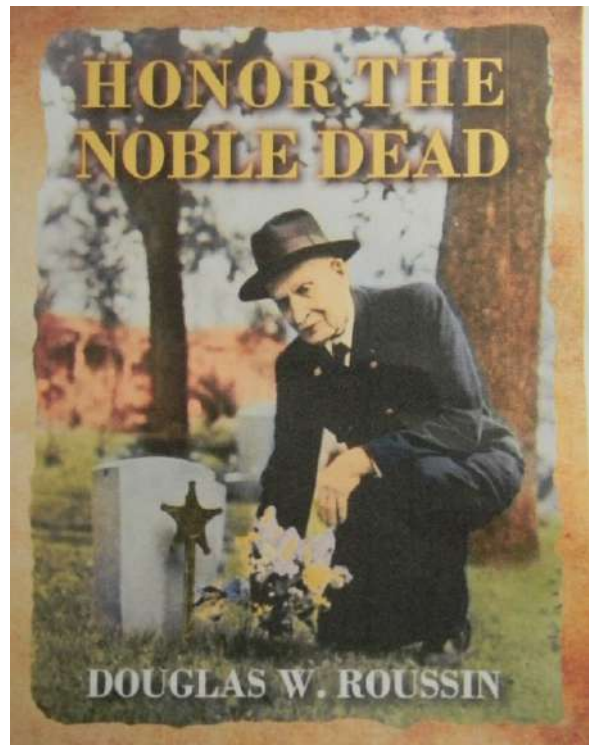


This large spoon shows the craftsmanship that went into the designing of these spoons. The spoon is sterling. It has the Grand Army of the Republic membership badge at top. This is followed by cross swords, a canteen, and cross rifles. The bowl is quite unique. It shows a panoramic view of the Gettysburg battlefield.



The teaspoon on the left has GAR at the top and St. Paul, 1896 in the bowl. The teaspoon on the right has a portrait of General Grant at top and GAR 1892 in the bowl.

CAUSES WHICH LED TO THE ORGANIZATION OF THE G.A.R. AND ITS CO-WORKERS

Over a quarter century ago the people of the North were startled as never before by the report that Fort Sumter had been fired upon, and that the war between the North and the South had indeed commenced in earnest. A call for volunteers to defend the "Stars and Stripes" was made. That call was answered. Brave men left the farm, the workshop, the office, the store, home, and loved ones—everything, and rushed forward to protect the nation's honor. Battles were lost—battles were won. Long and weary were the marches, and fierce and bloody were the battles that marked the years from 1861 to 1865. The comrade who, at morning, answered "here," at eventide could nevermore respond. Never before in the annals of history was any similar struggle waged on so grand a scale or with so great a destruction of men and material as in

this "the great American conflict."

At last the final day came. The South, no longer able to withstand the prowess and overwhelming forces of the North, was compelled to surrender, and then "The Brave Boys in Blue" marched home again; but not until nearly half a million of their number were killed outright on the field, died of disease and wounds, or were crippled or maimed for life.

May returned home to find themselves penniless and helpless, but strong in their determination to grapple with the world. The promises made to the men who left their families to go forth to fight for the integrity of the nation were poorly kept, and though some were provided with employment by the Government, and many patriotic citizens, who remembered and appreciated their services, came nobly forward and gave them the preference in their enterprises, still a great number remained unemployed and unprovided for. This state of affairs caused deep anxiety in the hearts of their more fortunate comrades, who had stood shoulder to shoulder with these men during the death storm of battle, but who had come out of war with happier fortune, and who were now better able to cope with the world.

It was this condition of affairs that caused the pioneers in the Grand Army of the Republic to conceive the idea of forming an organization that would, to a certain extent, look after the disabled and unemployed veterans, and to the welfare of the widows and orphans of those who had fallen in the conflict. Such were the circumstances which led to the organization of the G.A.R., made brothers under the cloud of war, brothers in a thousand common dangers, brothers in a thousand common sufferings, brother they must remain in the sunshine of peace.

The history of "The Great American Conflict" would be incomplete without a record of the heroism and self-denying deeds of the mothers, wives, and daughters of those who sprang to arms to support the integrity of the Republic and the honor of the "Stars and Stripes."

Thousands of Northern women of all classes and every rank of society, willingly sacrificed much of what is dear to a woman, urged their friends and loved ones to rally around the flag; and they eagerly sought the privilege, as they deemed it, of doing what they could for the cause. At home they managed the business, the factory, or the farm, at the same time caring for the little ones; and when tidings of defeat or

disaster reached them, their hearts trembled with anxiety for the welfare of their loved ones and the success of the cause.

Every moment of the day and night of that trying time, hearts were lifted up in silent prayer to the "God of Battles" that the right might prevail and the absent ones might be returned safe in peace and honor. In the stillness of the night, as the little ones were put to rest, their young voices were taught to lisp a prayer, that "God might spare papa and preserve the Union." Nor was this all. What a woman does she does with her whole heart. Almost every home in the North was turned into a manufactory of lint; the closets and chests were ransacked and valued articles of linen were cheerfully brought forth and sacrificed to be shredded into lint for "the poor wounded soldiers."



Societies were organized throughout the country, and the women vied with each other in offering delicacies and dainties, to be sent to the hospitals for the

weak and suffering who had been wounded on Southern battlefields. How devotedly they worked in the interest of the "Christian Commission" and the "Sanitary Commission." Their busy fingers even found time, in numerous cases, to pen words of cheer and encouragement to the brave men, strangers to them, except that they were bound together by the strong bonds of loyalty and patriotism.

Nor can we forget those dauntless ones, who, not tied by the cares of a family, so gladly volunteered for active service as nurses on the battlefield and in the hospital; who left the ease and refinement of home to suffer toil and privations to administer to the wants of the wounded. As ministering angels, they passed from cot to cot, stopping here to breathe a word of encouragement to a young sufferer racked with pain and far away from friends and home, and pausing there to raise the pillow of another that he might rest a little more comfortably. At times she was to be found writing a last message to loved ones from one about passing away, and whispering words of hope and consolation—in short, in a thousand different ways doing what only a woman, with her tact, gentleness, and sympathy, can do.

After the struggle was over and

the sword was turned into a pruning hook—when the gallant defenders returned to the vocations of peace; alas, many of them, incapacitated by wounds or disease, were unable to resume their former calling, and helplessly saw their families without proper provision for their maintenance, the women, faithful to their interests and true in their devotion, sprang to the rescue and organized the various auxiliaries known as the "Women's Relief Corps," "Loyal Ladies' League," or the "Ladies of the G.A.R.," etc., etc.

The lessons of patriotism learned at the knee of their mothers were not lost on the children of the soldiers. On the return of their fathers and brothers from the conflict, the stories of battles and victory were told and retold by the fireside, and such was their charm that they were ever new. Their words burned into the hearts of the young listeners, and they made such an impression that with advancing years the children came to feel that they, too, could claim a common interest and heritage in the deeds of their fathers. This feeling seemed to unite them and form a common tie, leading eventually to the organization of the "Sons of Veterans," "Ladies' Aid Societies," and the "Daughters of Veterans," respectively.

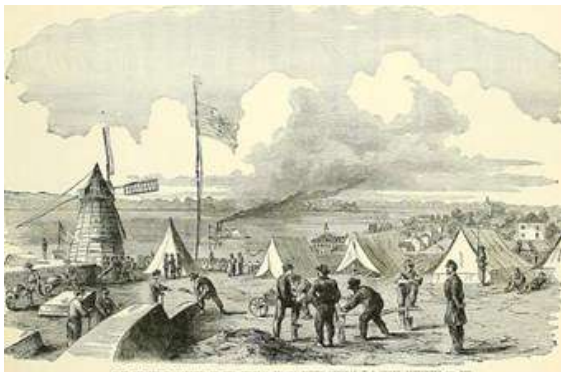

Battle of Cape Girardeau

The Battle of Cape Girardeau occurred April 26, 1863. It was the final leg of Marmaduke's Missouri Raid to disrupt supply lines and pressure the Union's Army of the Frontier to withdrawal from Arkansas. General John Marmaduke's 5,000 Confederate soldiers positioned themselves to re-take Cape Girardeau from General John McNeil's garrisoned 4,000 Union soldiers. Control of Cape Girardeau and its four recently constructed forts meant control of the Mississippi River supply line.

The Union Army evacuated civilians from the city and positioned gun boats along the Mississippi River, allowing artillery and infantry to concentrate along the city's western edge, anticipating the Confederate's attack. General Shelby's Brigade approached from the west and repelled Union Cavalry attacks, but Shelby's efforts to advance were stopped by the Union's fortified artillery fire lines. Neither side could overtake the other after five hours of combat, leading General Marmaduke to withdraw and end the 2nd Missouri Raid.

Truman's Birthday

President Harry S Truman's birthday is May 8th, a state holiday in Missouri. Truman was born in 1884 in Lamar, Missouri and died December 26, 1972, in Kansas City, Missouri. He was the 33rd and only President from Missouri, assuming office during World War II when President Franklin Roosevelt died in office on April 12, 1945.

Harry Truman was a public servant, enlisting in the Missouri National Guard in 1905, serving in the U.S. Army during World War One reaching the rank of Captain, elected a Jackson County Judge in 1922 and Presiding Judge in 1926, and elected a U.S. Senator in 1934 during the Great Depression. Truman was elected Vice President in 1944 for President Roosevelt's fourth term, becoming President three months later and elected to a second term as President in 1948.

Truman served during times of conflict and controversy –the Pendergrass Machine, Atomic bombing of Imperial Japan, the Korean Conflict, 1952 coal strikes, and McCarthyism; however, he maintained his famous “the buck stops here” stance.

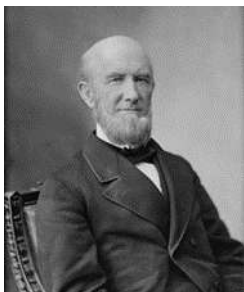

Armed Forces Day

Armed Forces Day is Saturday, May 20, 2023. First observed in 1950 following consolidation of the military branches within the U.S. Department of Defense, Armed Forces Day celebrates service members and their families in the Army, Navy, Marine Corps, Air Forces, Coast Guard, and Space Force. Armed Forces Day is the 3rd Saturday in May and concludes a week of activities. Military bases often invite the public to open houses and air shows and local communities sponsor parades and festivals during Armed Forces Week.

James Eads

James Buchanan Eads (1820-1887)

May 23rd is James Buchanan Eads' birthday. James was born in 1820 in Lawrenceburg, Indiana but grew up in St. Louis, Missouri. He was the son of Thomas Eads and Ann Buchanan. James was a self-tough innovator and engineer, leaving school at 13 but making use of public libraries and experiences while clerking on steamboats. Eads leveraged his knowledge of river currents and steel production to build his fortune salvaging lost cargo from the Mississippi River.

Eads' Civil War contribution was the design and production of 30 ironclads used to patrol river waterways and the Gulf of Mexico coastline. Although falling short on his promise to produce seven ironclads in sixty-five days, Union Marine Works in Carondelet, Missouri and Marine Railway & Shipyard in Mound City, Illinois delivered the promised gunboats by day 100. These gunboats supported Union victories at Fort Henry, Fort Donelson, Vicksburg, and Mobile Bay.

After the war, James continued his innovative steel work with the design and construction of the first rail bridge across the Mississippi River at St. Louis. Completed in 1887, the bridge is still used for vehicle traffic between Missouri and Illinois.

The SUVCW Department of Missouri's outstanding camp award, the James Buchanan Eads Award, is presented to camps exceeding goals and standards for the year.

Observed Memorial Day

Memorial Day is Monday, May 29, 2023. This national holiday known originally as Decoration Day commemorated deceased Union soldiers from the Civil War. The holiday was extended after World War One to honor and mourn all veterans who have died in all wars. The modern custom is to place flowers and a U.S. flag at each veteran's gravesite. Traditionally, the U.S. flag is flown at half-staff in the morning and raised to full staff at noon. Many communities, veteran groups, and SUVCW camps participate in

Memorial Day parades and services scheduled to coincide with raising the national colors at noon.

Traditional Memorial Day

Traditional Memorial Day is Tuesday, May 30, 2023. First observed in 1868 when General John Logan, Commander-in-Chief of the Grand Army of the Republic (GAR) issued General Order #11 establishing Decoration Day to honor and mourn the soldiers and sailors who died during the American Civil War:

Let us, then, at the time appointed gather around their sacred remains and garland the passionless mounds above them with the choicest flowers of spring-time; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us a sacred charge upon a nation's gratitude, the soldier's and sailor's widow and orphan.

Decoration Day expanded to Memorial Day following World War One when veteran gravesites of all wars were honored. Decoration Day and Memorial Day were held on May 30th until the Uniform Monday Holiday Act of 1968 moved Memorial Day to the fourth Monday in May. The SUVCW along with the GAR Allied Orders and veteran groups including the Veterans of Foreign Wars (VFW) advocate returning Memorial Day to May 30th.

Flag Day

Flag Day is June 14, 2023, which commemorates adoption of the thirteen stars and stripes flag by the 2nd Continental Congress on June 14, 1777. The U.S. Army was also established on that day. The first National Flag Day was established by Woodrow Wilson's Presidential Proclamation in 1908 and by an Act of Congress in 1949.

A 1942 Congressional Joint Resolution consolidated flag etiquette between the Army and Navy to form the foundation for our current public law: Title 4, United States Code, Chapter 1 The Flag. This United States Flag Code establishes the policy for federal agencies and the national standard for the display and use of our flag.

The United States flag had 33 stars at the start of American Civil War and added a 34th for Kansas in 1861 and 35th in 1863 for West Virginia's succession from Virginia. The Union did not remove any stars when the eleven Confederate States succeeded.

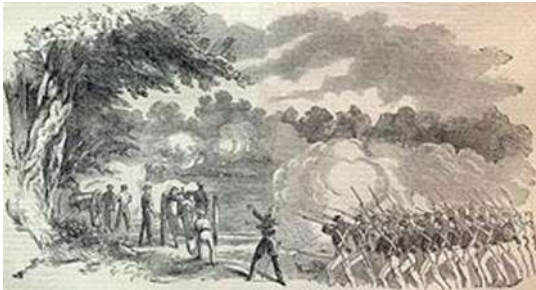


Army Birthday

Wednesday, June 14, 2023, is the 248th birthday of the U.S. Army, oldest of six branches of our Armed Forces. When the American Revolution started there was no standing army, rather local militia units engaged British troops in the separate Colonies. Although there is no official record of the action, John Adams reported that the 2nd Continental Congress adopted the Connecticut, Massachusetts, New Jersey, and Rhode Island militia troops on June 14, 1775, which were blockading British troops at Boston following the Battle of Lexington-Concord and authorized the formation of the 1st Continental Regiment with George Washington as commander-in-chief.

At the outbreak of the American Civil War, the United States Army consisted of 16,000 soldiers, with a third defecting to the Confederate Army. President Lincoln called up 75,000 militia for three months and Congress authorized recruitment of an additional 500,000 volunteers. As the war escalated, the Union Army grew with an estimated 2 million serving between 1861 and 1865, including 179,000 African Americans and 100,000 Unionists from Confederate states.

Battle of Boonville (June 17, 1861)

The Battle of Boonville occurred June 17, 1861, with 1,700 Union infantry and militia under Captain Nathaniel Lyon skirmishing with 1,500 from the pro-secessionist Missouri State Guard commanded by Colonel John Marmaduke. With few casualties, it was a minor military victory for Union forces but provided an important political and strategic accomplishment.

Missouri like other border states was divided between supporting the Union or Confederacy. Captain Lyon's forces were pursuing Governor Claiborne Jackson who was positioning Missouri for the Confederacy. After securing the state capitol in Jefferson City, the Union Army reached Governor Jackson and the Missouri State Guard at Boonville. The better trained and organized Union Army ousted the newly formed Missouri State Guard within a few hours. The strategic significance, was pro-secessionist abandoning central Missouri, regrouping in southern Missouri, and setting up the Battle of Wilson Creek that followed three months later.

ROTC Awards Program

As colleges and high schools return to some normalcy, it is time to rebuild our ROTC awards program. Missouri and Arkansas have 17 college ROTC and 99 high school JROTC programs. If your camp is resuming or looking to expand its participation, the steps are simple, and the ROTC medals are free:

1. Contact your college ROTC or high school JROTC unit that your camp is supporting their ROTC medal award presentation.
2. Confirm with the Department's ROTC coordinator at rotc@suvcwmo.org which ROTC and JROTC units your camp is supporting.
3. Order the ROTC medal from the Assistant National Quartermaster at rotc@suvcw.org using SUVCW Form 7 ROTC Award Application. They are provided at no cost.
4. Volunteer to present the ROTC medal at the college/school's spring awards program.
5. Report each ROTC award with the cadet's name, date, and school to the Department's ROTC coordinator at rotc@suvcwmo.org.



JROTC Outstanding Cadet Competition

The deadline to submit nominations for the annual JROTC Outstanding Cadet competition is July 1, 2023. This competition is open to high school JROTC cadets in Missouri and Arkansas. The Outstanding Cadet receives a ROTC medal-ribbon bar with bronze leaf/star and a \$200 prize. The rules and steps to participate in the competition are simple:

1. The JROTC cadet must be a 2023 recipient of a SUVCW ROTC medal for his/her high school JROTC unit.
2. The JROTC unit or cadet must provide a 100- to 300-word summary of the cadet's accomplishments. No form, just a simple write-up or email.
3. Each Camp may nominate one cadet for the competition from among the JROTC high school units they sponsor.
4. Submit the Camp's nominee with the 100- to 300-word summary to the Department's ROTC coordinator at rotc@suvcwmo.org. Deadline to receive Camp nominations: July 1, 2023.

Camp's may want to consider a local prize for their nominee to encourage participation, such as one-year SUVCW associate membership, invitation to a camp dinner, or a cash prize. For assistance or questions contact the Department's ROTC coordinator at rotc@suvcwmo.org.



Department Awards Program

The Department's Awards Program provides recognition for camp, member, and non-member contributions to the SUVCW and American Civil War history. Any member or camp can make a nomination using the application forms posted at: <http://www.suvcwmo.org/awards.html>. The deadline for individual award nominations is April 15, 2023. The deadline for the Eads Award is May 15, 2023. Applications should be sent to the Department's Senior Vice Commander at svc@suvcwmo.org.

Francis Blair, Jr. Award is presented annually to an outstanding member of the Department of Missouri, Sons of Union Veterans of the Civil War. It is for the member who has made the greatest collective contribution during a specific year to the Department and his Camp through its programs and activities. The member must have been in good standing and exemplify the virtues of Fraternity, Charity, and Loyalty for the entire year. An award recipient is not eligible for repeat consideration for five years.

Meritorious Service Award is presented to a member of the Department of Missouri, Sons of Union Veterans of the Civil War. It is for the member who has made a significant contribution or collective contributions over a period of time to the Department and his Camp through its programs and activities. The member must have been in good standing for five or more years, and exemplify the virtues of Fraternity, Charity, and Loyalty. An award recipient is not eligible for repeat consideration.

Grand Army of the Republic Award is presented to an Allied Order member or group. It is for members or groups who have made a significant contribution or collective contributions over a period of time to promote fraternal relationships between the Allied Orders in perpetuating the memory of the Grand Army of the Republic (GAR) and our ancestors who fought to preserve the Union. An award recipient is not eligible for repeat consideration for three years.

Wayne Sampson Show Me Spirit Award is presented to an individual who has made a significant contribution or collective contributions over a period of time to promote the SUVCW, Allied Orders, or Civil War history, and who demonstrates a shared interest in the SUVCW mission. An award recipient is not eligible for repeat consideration for three years.

James Eads Award is presented annually to all qualifying camps. The award recognizes camps that meet the eligibility criteria published in the nomination application. A qualifying camp receives a ribbon streamer.

Samuel Curtis Award is presented to the member who recruits the greatest number of new members within the Department during the period 1 May through 30 April. There is no application with selection based on information provided in the Membership Applications (Form 3) received by the Department Secretary by April 30th.

Nathaniel Lyon Award is presented to the Camp with the greatest percentage increase in membership during the period 1 May through 30 April. There is no application with selection based on information provided in the Membership Applications (Form 3) received by the Department Secretary by April 30th.

Department Under Forty Award is presented to a Camp with three or more new members under age forty (40) during the period 1 May through 30 April. There is no application with selection based on information provided in the Membership Applications (Form 3) received by the Department Secretary by April 30th.

HISTORICAL NOTES

PRAIRIE GROVE, ARK. Narrow Escape of Two Iowa Soldiers

Editor National Tribune: Stories of our great Civil War possess as much charm for this generation of young people as those of the Revolution did for our grandsires, and all interesting incidents and reminiscences gathered from the lips of our rapidly aging veterans should be preserved and read, that patriotism may be instilled into the youthful mind of those readers who may themselves take a soldier's part in the defense of our great country.

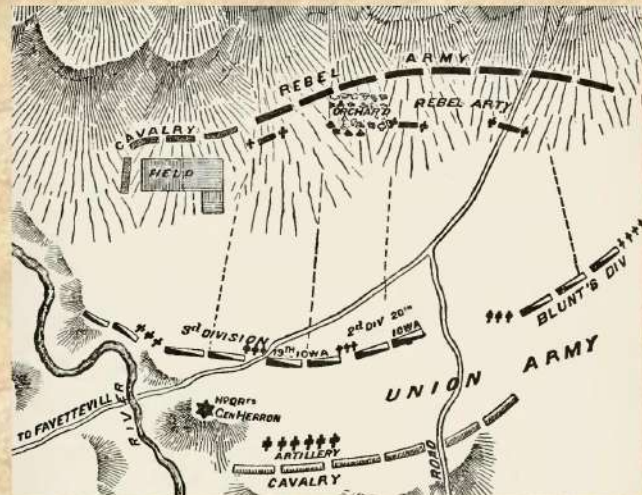
... The following was gathered from the lips of Henry P. Gertz, of Shelby, Iowa, who at the age of 21 enlisted in Co. A, 20th Iowa, and served through the war. . . At the battle of Prairie Grove, Ark., Dec. 7, 1862, he made one of the most daring escapes from capture by the rebels on record. His regiment made three gallant charges over open ground and up a gentle slope to a dense woods, where the rebels were in heavy force, in the face of a severe fire of artillery and musketry, and were three times repulsed with great loss. On the last charge the line of battle was three miles long, and the field was covered with dead and wounded. The 20th Iowa was ordered to lie down behind a stake-and-rider rail fence, and here they remained about half an hour, keeping up a rapid fire upon the enemy.

Gertz and two comrades, Abraham Pickards and Dick Richards, of his company, were in a corner of the fence, somewhat separated from their regiment, firing at the rebels. They were so absorbed in their work and the noise of the artillery was so great that they did not hear the command for the regiment to retreat, which was soon at a considerable distance.

The enemy suddenly appeared on the charge in double files and only a few paces distant. Richards, thinking retreat impossible, remained at the fence, but young Gertz and Pickards started on the run of about half a mile, which then separated them from the Union lines. When about 30 paces from the fence a ball struck Gertz and passed through his left thigh, and he exclaimed, "I am shot!" Pickards stopped and allowed Gertz to place his arm around his shoulder, and they ran as one man under a heavy fire, the balls falling around them thick as hail. Gertz's bayonet scabbard was shot away, and balls passed through his hat and the sleeve of his blouse. Pickard's haversack, canteen and clothing were riddled with balls. They ran toward the lines of the 10th Ill. Cav., who opened ranks to receive them, on the order of the officer commanding, who asked to what regiment they belonged, and, upon being answered, exclaimed, "You are brave men!"

HISTORICAL NOTES

Of all the reminiscences of Chickamauga's iron hail-storm, Jim Brotherton's experiences was the hardest strain on credulity.

Jim was fighting the "best he knew how." He was in the thickest of the assault on Snodgrass Hill. As he charged across the road and over the field to the Dyer farm, Jim caught a glimpse of the house he was born in. But valor did not make Jim forget discretion. He took advantage of all the pine trees he could when going into and coming out of the fight. On his back was strapped his knapsack and over his knapsack was rolled his blanket. The two made a hump which projected beyond the trees behind which Jim took temporary shelter.

When Jim unloaded his knapsack and blanket the night after the battle, he found that thirty-seven bullets had penetrated it. "Yes, sir," said Jim, looking the listener straight in the eyes, "thirty-seven bullets had gone into my blanket and knapsack—thirty-seven bullets and two buckshot. If I had that blanket and knapsack now I wouldn't take \$1,000 for them. After the battle I gave them to mother and told her to keep them for me until I came back from the war. But you know how it is when folks are moving around. Things get lost. I don't know what became of the blanket or knapsack."

There was only one veteran who told a story which approached that of Jim Brotherton in picturesque-ness. He was Private Sinnatt. . .

[He] was particularly anxious to meet and renew acquaintances with some of the Twelfth Georgians. A big man of the Twelfth Georgia saved his life, Private Sinnatt said. He explained how. When he got into what seemed to him the hottest place he had ever found, Private Sinnatt lay down behind a tree which wasn't more than eight inches through and made himself as small as possible. While he lay there wondering how long it would be before he would be hit, a strapping fellow from the Twelfth Georgia grabbed him by the leg, lifted him from behind the tree, and lay down where he had. Sinnatt says the Georgian was about twice as big as he was. He couldn't lick him, so he made the best of a bad situation, crawled up behind the Georgian, and kept quiet. It wasn't but a few minutes till a bullet struck the big Georgian and killed him. Sinnatt lay still behind the body, which stopped fifteen bullets before the wave of battle passed on. That is why Private Sinnatt says he will always cherish a kindly feeling for the Twelfth Georgia.

General Order #16, 13 January 2023— The Passing of Past C-in-C Keith G. Harrison

Brothers, Again, and all too soon it is my solemn duty to report the passing of another great Brother and friend. Brother Keith G. Harrison, PCinC has sadly passed away on 12 January 2023 at the age of 73.

PCinC Harrison of Holt, Michigan, was a member of the Order since 1981 and a life member since 1986, was elected Commander-in-Chief of the National Organization of the Sons of Union Veterans of the Civil War (SUVCW) on August 13, 1994, at the 113th National Encampment in Lansing, Michigan. Brother Harrison's ascension represented the fourth Michiganian in the then 113-year history of the Order, and the first in 46 years, to serve as Commander-In-Chief becoming the 108th Brother to hold that esteemed office in the SUVCW.

In addition to serving as Commander-in-Chief, Brother Harrison served the Order in several national capacities, including Senior Vice Commander-in-Chief, Junior Vice Commander-in-Chief, Patriotic Instructor, Membership-at-Large Coordinator, History Book Coordinator, and Council of Administration member. Within his native state of Michigan, he had served as Department Commander for three years, Senior Vice Commander for two years, Department Council Chair for two years, and Department Chief of Staff for seven years. He was a

charter member of the Lansing-Sunfield Curtenius Guard Camp #17, which he organized in 1983. Within his local camp, he had served as Camp Commander, Camp Secretary, Camp Treasurer, and Camp Historian.

Since serving as Commander-in-Chief, Brother Harrison had continued to serve the Order as a member of the National Council of Administration, Constitution and Regulations Committee, National Signals Officer, National Webmaster, Backup National Webmaster, Editor for 10 National Proceedings, and National Webmaster for the SUVCW's Sons of Veterans Reserve (SVR). In 1999, he was awarded the Order's Meritorious Service Award and in 2001, he was awarded the Order's Cornelius F. Whitehouse Outstanding Brother Award. Past Commander-in-Chief Harrison traces his ancestry to 45 Union Civil War soldiers, forty of those soldiers served from Michigan. The Michigan units in which his ancestors served included the 1st, 2nd, 3rd, 11th, 12th, 14th, 15th, 18th, 19th, 23rd, 25th, 27th, and 28th Volunteer Infantries; the 3rd, 4th, 5th, 8th, 10th, and 11th Volunteer Cavalries; 1st Light Artillery, and 13th and 14th Batteries. The remaining five Union Civil War ancestors served in the 60th United States Colored Troops, the 1st Colorado Volunteer Infantry, 15th United States Infantry, 3rd United States Artillery, and the Army of the Ohio (Major General Don Carolos Buell), respectively.

Brother Harrison had been a Civil War reenactor since 1982 and rose through the ranks. He remains a member and former Captain of the 7th Michigan Volunteer Infantry, Company B., an honorary member of the 3rd Michigan Volunteer Infantry, Company K, 5th Michigan Volunteer Infantry, Company K and 14th Michigan Volunteer Infantry, Company A, 15th Michigan Volunteer Infantry, Company B, and a Major, periodically serving in the capacity of Chief of Staff or Assistant Adjutant General with the Cumberland Guard, a nationally recognized Civil War reenactment association. Within the SUVCW's Sons of Veterans Reserve (SVR), he served as Brevet Brigadier General and Commanding Officer during 1996/97 and held the rank of Major (Retired) in the SVR. He had participated in more than 550 reenactments, parades, living histories, and ceremonies, and served innumerable times at reenactments as an infantry company commander, infantry battalion commander, and overall Union army commander. Major Harrison was very knowledgeable and well-practiced in Hardee (1855), Casey (1862), and Coppee (1862) Field Manuals, and highly competent in 1861- 1865 U.S. Army company, battalion, brigade, and army-level infantry drill and tactics. He had participated in most of the national 125th - 150th anniversary Civil War battle reenactments.

Brother Harrison belonged to several historical, patriotic, and civic organizations, including the Military Order of the Loyal Legion of the United States (MOLLUS), in which he served as National Commander-in-Chief from 2009 to 2011. He is one of four Brothers to have served as the Commander-in-Chief of both the SUVCW and the MOLLUS; the other three being US Grant III, Gordon R. Bury, and Lowell V. Hammer. Within the Michigan Commandery of the MOLLUS, he served as Commander from 1986 to 2003. He belonged to the Society of Mayflower Descendants; William Brewster Society; Society of Colonial Wars; Sons of the Revolution; Society of the War of 1812; Morgan's Men Association Inc.; Military Order of the World Wars; and Honorable Order of Kentucky Colonels (Commissioned twice, once in 1988 and again in 2003). He was a member of the Masonic Lodge #252 of Okemos, Michigan and life member of the Civil War Research Lodge #1865 of Highland Springs, Virginia. He also served as President of the Eaton Rapids, Michigan GAR Memorial Hall and Museum, Inc., as Treasurer of the state-affiliated Friends of Michigan History, Inc. and as Chair of the state-affiliated Michigan Civil War Sesquicentennial History Partners, which is formally charged with the responsibility to assist the Michigan Civil War Sesquicentennial Commission in the planning, promotion, and implementation of the Civil War Sesquicentennial commemoration in the state. Special Message #5, 31 January 2023— IRS 501(c)3 Status Update, Publication 78 Listing

Dear Brothers of the Order, As you know, in 2020 the Internal Revenue Service granted 501(c)3 status to the Sons of Union Veterans of the Civil War (see General Order #6, Series 2020-2021, IRS Determination of 501(c)3 Status, dated 6 December 2020). Since that time, we have been diligently working to get included on the official IRS list of charitable organizations, known as Publication 78 ("Pub 78").

I have the honor to report that the SUVCW is now listed on the Internal Revenue Service Publication 78 ("Pub 78"), which is available online. Our letter of determination is also posted on the site. Of note, subordinate organizations (Departments, Camps, and SVR units), remain under the National Organization's umbrella.

This is of great importance to our Order. Pub 78 is a document published by the IRS that lists organizations that are qualified to receive tax-deductible contributions, as described in Section 170(c) of the Internal Revenue Code of 1986.12. Pub 78 is the primary reference that donors use to check an organization's eligibility to receive tax-deductible charitable cash and non-cash contributions.

Brothers, this is a notable milestone. Thanks are owed to our National Treasurer, to the Council of Administration, and to all Departments and Camps for their perseverance in a rigorous process with the IRS, also thanks to PC-in-C Brian Pierson for writing this message.

**General Order #18, 10 February 2023— Revocation of General George C. Meade Camp #5,
Department of Chesapeake's Charter**

Department Commander Brian W. Horgan of the Department of the Chesapeake has requested that the Charter of General George G. Meade Camp #5 be revoked. (Regulations, Chapter I, Article I, Section 13).

Regarding the closure of General George G. Meade Camp 5, Department of the Chesapeake, the following outlines the situation that led to the closure and includes the steps taken at the Camp level to affect this action:

- Over several years, membership in the Camp had declined from approximately 22 Brothers to 10, of which only 6 Brothers could be considered truly active.
- Steps to recruit new members into the Camp/Order (distribution/placement of recruiting brochures, etc.) were largely unsuccessful.
- Numerous officer positions for several years prior to the onset of Covid were either unfilled or filled via the recycling of just a few Camp Brothers.
- As a result of the onset of Covid restrictions instituted by the State of Maryland, all opportunities for inperson Camp activity terminated at the end of March of 2020.
- All efforts to conduct Camp business, meetings, etc. via remote meeting platforms (i.e., Zoom) from the above date forward were unsuccessful.
- Once restrictions were lifted by the State of Maryland in July of 2021, attempts to schedule Camp inperson meetings resumed, however only one or two Brothers responded. It was the intent to discuss/decide on the topic of the closure of the Camp however, due to lack of attendance, all attempts to convene a meeting failed. As such, there are no minutes to reflect subsequent actions.
- Camp Brothers were contacted during the first few months of 2022 seeking their wishes to formally close and surrender the Camp charter. No objections were received. (These communications were conducted mostly by telephone as previous efforts to connect regarding conducting Camp business in person via email/U.S. mail rarely elicited any response.)
- Concurrently, Brothers were provided detailed information on how to obtain a Transfer Form (Form 4) as well as info on obtaining an Honorable Discharge from the Order, should they choose. Additionally, they were provided contact information for nearby Camps within the Department. (It is my understanding that Camp Brothers in good standing have also been contacted by Department officers and been provided with information about Camps in the area along with providing them Transfer Forms for their use.)

The Department Commander Brian W. Horgan's request is therefore approved and the Charter of the General George G. Meade Camp #5, Department of the Chesapeake, is hereby revoked. (Constitution, Article VI, Section 2).

Brothers of the General George G. Meade Camp #5 who are in good standing may have transfer cards issued so that they may join another Camp of their choice. (Constitution, Article VII, Section 4).

General Order #19, 24 February 2023— Infamous or Heinous Crime, Flagging a Former Brother's File at the National Headquarters

WHEREAS, from time to time, it is discovered that a brother of the Order has been convicted of an infamous or heinous crime in a court of law and thereafter he resigned from the Order. The Order needs to have a mechanism in place to protect the Order from the former brother trying to rejoin the Order.

IT IS THEREFORE ORDERED: Whenever a brother has resigned from the Order and it is discovered the brother has been convicted in a court of law of an infamous or heinous crime, upon notification and confirmation, the Commander-in-Chief shall instruct the Executive Director to place a flag upon the brother's file at National Headquarters to notify the Order if this brother attempts to rejoin the Order. Such flag shall contain the name and address of the court, the crimes convicted of and the date of conviction.

An infamous or heinous crime was defined by Commander-in-Chief Freshley in his General Order# 7, found of page 223 of the Proceedings of the 133rd National Encampment, "is a crime that is punishable by death or imprisonment in a state penal institution, with or without hard labor, for more than one year. A pardon, gubernatorial or presidential, does not erase the conviction or the criminal record".

IT IS FURTHER ORDERED the definition is modified to read: "An infamous or heinous crime is defined as a crime that is punishable by death or imprisonment in a correctional facility, with or without hard labor, for a period of one year or more. A pardon, gubernatorial or presidential, does not erase the conviction or the criminal record."

General Order #20, 8 March 2023— Revocation of Joshua L. Chamberlain, Camp #69, Department of the Maine's Charter

Department Commander Peter Redman of the Department of the Maine has requested that the Charter of Joshua L. Chamberlain Camp #69 be revoked. (Regulations, Chapter I, Article I, Section 13).

The Department of Maine was notified by National Treasurer Michael Beard in 2021 that Joshua L. Chamberlain Camp #69 had failed to file their form 990N and as such the IRS revoked their status and the ability to be listed as a subordinate of the SUVCW under its group exemption.

After the receipt of this information and in accordance with Chapter 1, Article 1, Section 13 of the Constitution & Regulations of the SUVCW, Department Commanders Larry Bonney on 28 March 2021 issued Department Order #2, Series 2020 - 2021 suspending Joshua L. Chamberlain Camp #69.

It has been reported that attempts have made to work with the officers of the Camp and at the 2022 Department Encampment was ready to submit the proper paperwork, since that time and after several email and phone calls, no one from the Camp has replied and the status with the IRS hasn't changed.

It is therefore with very heavy heart that the Department Commander Peter Redman's request is therefore approved and the Charter of the Joshua L. Chamberlain, Camp #69, Department of Maine, is hereby revoked. (Constitution, Article VI, Section 2).

Brothers of the Joshua L. Chamberlain, Camp #69 who are in good standing may have transfer cards issued so that they may join another Camp of their choice. (Constitution, Article VII, Section 4).

General Order #21, 15 March 2023— Revocation of General Alvin C. Voris, Camp #67, Department of the Ohio's Charter

Department Commander Donald Darby, PC-in-C of the Department of the Ohio has requested that the Charter of General Alvin C. Voris, Camp #67 be revoked. (Regulations, Chapter I, Article I, Section 13).

General Alvin C. Voris, Camp #67 was placed on suspension 11 March 2022 for failing to submit the SUVCW Form 22 to the Department Secretary/Treasurer by the 15 February 2022 deadline.

Since that time the Camp has been contacted and has still failed to submit the required form for 2022 and is now delinquent in submitting that form for 2023.

In Accordance with the SUVCW C & R Article VI, Formation and Disbandment Section 16, and as stated in Ohio Department Order 16 dated 11 March 2022, the Camp was suspended by then Department Commander R.A. Davis. Section 13 of the same Article and page states that a Camp that has been suspended and is one year in arrears may be disbanded and the Charter therefore revoked.

Section 2 of the same Article and on page 25 of the SUVCW C & R States "The Commander-in-Chief upon the recommendation of the Department Commander shall have the power to revoke the Charter of any Camp which does not conform to the Constitution and Regulations of this Order."

It is therefore that the Department Commander Donald Darby, PCinC's request is approved and the Charter of the General Alvin C. Voris, Camp #67, Department of Ohio, is hereby revoked. (Constitution, Article VI, Section 2).

Brothers of the General Alvin C. Voris, who are in good standing may have transfer cards issued so that they may join another Camp of their choice. (Constitution, Article VII, Section 4).

All General Alvin C. Voris, Camp #67, Department of Ohio property and assets shall be turned over to the National Commander-in-Chief of the Sons of Union Veterans of the Civil War via the Department Commander of the affected Camp acting as his duly authorized representative, to collect and hold all such property in trust for the National Organization Sons of Union Veterans of the Civil War, an organization exempt from taxes under section 501(c) 3 of the Internal Revenue Code. (Regulations, Chapter I, Article I, Section 5).

Membership in the Sons of Union Veterans of the Civil War (SUVCW) is open to all male descendants, whether through lineal or collateral line, and not less than 14 years of age who: (1) are a blood relative of a soldier, sailor, marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers between April 12, 1861 and April 9, 1865; (2) have never been convicted of any infamous or heinous crime and (3) have, or whose ancestor through whom membership is claimed, has never voluntarily borne arms against the government of the United States.
