**Department Order No. 3**  
22 May, 2013

1. The Department Secretary reported the Richard J. Oglesby Camp No. 61 has not submitted Form 22, Election of Officers Report, nor the Form 27, Annual Report with per capita dues. The Department Secretary made numerous attempts to contact the camp commander to obtain these reports. The Department Commander visited the camp in January 2013 and stressed to the Camp Commander the importance of submitting the forms. Copies of the required forms were provided for their use.
2. Per Chapter I, Article VI, Section 4(b) of the Regulations, the Secretary shall forward to the Department Secretary the Installing Officer's Report (Form 22) on or before February 15 of each calendar year.  
Per Chapter I, Article VI, Section 9 of the Regulations, the Secretary of each Camp shall be required to send to the Department Secretary -- together with the annual report required in Section 4 of Article VI, Chapter I, of these Regulations to be sent in on the 30th day of April in each year -- a list of the names and address (including zip code numbers) of all Brothers there carried on the rolls of the Camp.
3. The Richard Oglesby Camp No. 61 has not submitted Form 22 Election of Officers Report and Form 27, Annual Report with per capita dues to the Department Secretary. The Camp Commander has not responded to phone calls or emails from the Department Secretary or Department Commander.
4. Consequently, the Richard Oglesby Camp No. 61 is placed under suspension. While under suspension, the Richard Oglesby Camp No. 61 may not meet or conduct business.
5. The Richard Oglesby Camp No. 61 has until July 1, 2013 to submit Form 27, Annual Report with per capita dues to the Department Secretary. If the Form 27, Annual Report with per capital dues is not submitted by this date, further actions will be taken regarding the continuance of the camp and the ownership of camp properties as stated in the Regulations.
