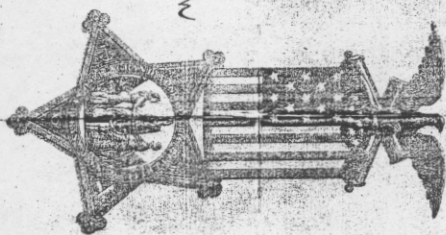

Dated at the Head Quarters of the Department Commander of the Grand Army of the Republic at St. Louis, Mo. on the twenty-first day of March in the year of our Lord One thousand Eight hundred and Eighty-four and of our Independence the One hundred and Eightyth.
