# MINUTES:

Commander Taylor called the meeting to order at 9:04 a.m. with all the above present except Mark Coplin, Chris Warren, Keith Coplin, Bob Schmidt and Rod Price who showed up later.

The meeting was opened with prayer by acting chaplain Vernon von der Heydt.

Commander Taylor then led us in the pledge of allegiance to the flag.

Commander Taylor then assigned Robert Champlin to assume the post of the JVC. At approximately 9:09 a.m., JVC Rod Price showed up and assumed his duties. Commander Taylor appointed Rod Price, chair, and Don Palmer to be a committee on resolutions from officer's reports.

Commander Taylor then recognized Robert Petrovic as the representative of the commander-in-chief. Robert Petrovic expressed the regrets of the C-in-C for not being able to make the encampment. He also reminded the group that if the proposed national by-laws changes are approved they need to be sent to national.

OFFICER REPORTS:

Commander Taylor then gave his report (attached)

Senior Vice Commander Brian Smarker then gave his report (attached)

Junior Vice Commander Rod Price reported that 3 persons were sent to various camps to be initiated this past year.

Secretary-Treasurer Walt Busch presented his report (attached) and provided a brief update report (also attached).

Monuments Officer Walt Busch presented his report and during this report (attached), Harold James brought up discussion on a tombstone in the Sturdivant area that was found apparently placed to the side as the area was being developed for other reasons. He asked what could be done? Robert Petrovic suggested getting the tombstone. Commander Taylor suggested that the camp might take it on as a project. Jack Grothe commented that the since it was a government stone it can be reissued if damaged.

Eagle Scout Coordinator Rod Price advised that 18 eagle scout certificates have been sent out. Robert Petrovic reported that he had sent more to Rod, but Rod commented that he has not received them although it has been more than a month. Rod also commented that he had postage to pay. Robert Petrovic made a motion to pay the eagle scout bills. This was seconded by Brian Smarker and or ordered.

Department Organizer Robert Petrovic reported a new camp in Ste Genevieve called the Lt. Col. Felix St. James Camp. He reported that both he and Emmett Taylor worked on organizing meetings.

GAR Posts Records Officer Brian Smarker stated there was nothing to report.

Last Soldier Project Officer John Martin not present. Walt Busch reported that he had received information from a brother out east of Civil War veterans in Missouri surviving

into the 1940s. Because of this all but about 35 counties have people listed that further research could confirm as the last soldier.

Marketing & Promotions Officer Rod Price requested a committed be established. Walt Busch commented that as the Marketing Officer he can appoint his own committee. Rod also stated that he wants a budget for promotions. The budget will be discussed later and attached to this report.

Congressional Medal of Honor Officer Bill Groth commented that on March 25th, National MHO Day, there were 2 ceremonies presented by the SUV. One at Valhalla Cemetery in No St. Louis County and another in western Missouri. He advised that next year there will be more recipients honored. A report has also been submitted to the national MHO Society.

Council Robert Champlin (only council currently present) reported that as far as he was concerned the books were in better shape than in previous years. [See Note: To conform with directions from last year's encampment, the books were closed on this year after the per capita was paid. This allowed all three councils to receive the spreadsheet almost a month before the encampment for their review. The current year will run from May 15, 2009 through the per capita next year which will be around May 15).

# LETTER:

Commander Taylor read the letter asking for our support from Brad Schall for JVC 2009. He also read the letter form Sam Wang regarding incorporating the state of Arkansas into the department of Missouri.

Robert Petrovic announced that there is also a National Council of Administration vacancy and wondered if anyone else had sent letters requesting support. Commander Taylor and Secretary Busch were not aware of any.

# UNFINISHED BUSINESS:

By-Laws Ad-Hoc Committee (Walt Busch, Rod Price, with absent Chris Warren):

- 1. Junior and Junior Associates. Don Palmer explained the history of this problem and what was going on. The proposed department by-laws change was then presented (attached) and the committee motioned that the change be passed. Passed by voice vote.
- 2. Grant Camp By-Laws Change for Juniors/Junior Associates(attached) approved by voice vote.
- National C&R change allowing for the commander to set aside by-law changes Of the encampment if they are considered to present a legal problem (attached). Robert Petrovic made a motion to accept the change. Second by David Busch.

4. Walt reported that Asboth, Tiger, and Westport camps all show that Juniors/junior associates are from age 8 to 13 and not 6 to 13. All recommended to change their by-laws accordingly.

#### Reconvene 10:59 a.m.

Robert Champlin absented himself from the activities. David Busch Absented himself temporarily due to health concerns. Gary Scheel and Greg Decker presented their credentials and were admitted to the encampment.

# Past Commander's Fund:

Don Palmer gave a talk on the past commander's fund which is now close to the \$1,000 which was voted on as the amount that should be in the fund before any monies are expended. The fund was set up to give some money to camps to help with projects. We may have the \$1,000 before calendar year's end.

Minutes (attached) were then reviewed from the March meeting. Jack Grothe made a motion to accept. Gary Scheel seconded. Passed by voice vote.

#### ROTC Related:

Jack Grothe commented that there are other military groups around that are similar to ROTC and wanted to know if we can recognize them. Robert Petrovic stated that to do so would require the approval of national and that the army had some issues with incorporating these groups into the ROTC award program. Commander Taylor appointed Jack Grothe to come up with a department Resolution concerning ROTC by the October Meeting.

#### NEW BUSINESS:

2009 Budget Reviewed. (Attached) Comments made that it shows per capita going out but not coming in. This accounts for the seemingly lop-sided flow of money. Robert Petrovic motioned for passage. Jack Grothe seconded. Approved by voice vote.

Commander Taylor brought attention to a "Civil War Camp" living history to be held in Ste. Genevieve supported by the Felix St. James Camp on July 11-12.

Jack Grothe called attention to a School of the Piece to by held by the SVR at Jefferson Barracks on June 27 and 28th.

Recessed 11:50 a.m.

# Reconvene 1:30 p.m.

Members presenting credentials: Chris Warren, Bob Schmidt, Keith Coplin and Mark Coplin. David Busch is present again. Chris Warren introduced his wife Twyla, president of the McCormick Camp Auxiliary to the encampment.

# NEW BUSINESS:

1 Robert Petrovic stated that we need to decide today where the 2011 department encampment will be. This lead to a lot of general discussion regarding the need to plan these things well ahead of schedule 2010 at present will be in Kansas City Area. Commander Taylor suggested that for 2011 we delay setting the date, since No one is ready, until the October meeting. Agreed.

Robert Petrovic then made motion to decide where and who will run department Encampments 2 years ahead of the date. Second by David Busch Passed by voice Vote.

# Camps wanting to propose having an encampment have to submit their request by October for 2011. For 2012, at the 2010 department encampment.

- 2 Bryan Bradford asked about registering supplemental ancestors like the Sons of the American Revolution do. Don Palmer advised that national Probably will not do this ever.
- 3 Brian Smarker then asked bout sesquicentennial celebrations. Walt gave an Overview of the two committees he's been on and that while there is some Joint effort, we need to be planning ourselves.

General discussion covered getting a presence out at reenactments (recruiting), Last solider ceremonies as we have some now that probably qualify; grave Dedications; medal of honor grave ceremonies; monuments; Captain Blandowski Memorial (first Union Officer killed).

Walt Busch then made a motion that each camp is to present ideas (preferably three or more) concerning sesquicentennial celebrations by the March 2010 meeting for the next encampment to consider supporting. Second by Robert Petrovic. Passed by voice vote.

- 4 Don Palmer reported that we have a department seal but we do not have an Embosser and that would run \$100 to \$125. It would be used for documents, Sealing charters (there is a space on them for a department seal), etc. Agreed To and ordered that price not to exceed \$150.
- 5 Ad for national encampment. Motion made by Robert Petrovic and seconded By Don Palmer. Passed by voice vote.
- 6. Walt reported that there is a Jo Shelby monument dedication coming up and that We should have some one represent the group at Waverly

<u>To All Compatriots, Friends, and anyone else who has an interest in witnessing a bit of history</u>: This coming Saturday afternoon, Jun. 27th, at 3:00 PM at Waverly, MO (approximately 185 miles west of the St. Louis area) there will be a ceremony dedicating a life-size statue and monument to CSA Gen. J.O. Shelby, the "Undefeated Rebel" cavalryman! The Governor of Kentucky, the Honorable Steven Beshear, will give the keynote address, and the Gov. of Missouri, Jay Nixon, and MO US Rep. Ike Skelton will also give speeches. In addition, there will also be a B-2 flyover in tribute to Gen. Shelby. This is probably an unprecedented event as far as the dignitaries go in this age of "political correctness"! I would like to encourage as many of you as possible to attend this special event - honoring one of our Missouri Confederate "Heroes"!

In order to get to Waverly proceed westward on I-70 toward Columbia and Boonville. Continue past Columbia until about 25 miles west of Boonville where US 65 (northbound/southbound) crosses I-70. Take US 65 north toward Marshall. US 65 goes along the west side of Marshall and then turns northwestward toward Waverly. From the intersection of I-70 and US 65 (about 160 miles west of the St. Louis area) it is about 25 miles to Waverly. Waverly is on the south side of the Missouri River.

Waverly is a very small town (less than 1,000) and the event is in the center of town (downtown Waverly) at Shelby Park. There are also re-enactment events starting Saturday morning at 9:00 AM and finishing up with a fireworks show and cannon firing across the river at 9:00 PM Saturday evening! Sunday (28th) activities also include re-enactment events and a skirmish at 1:00 PM. See the attached flyer for a complete schedule of events. Hope you will make every effort to attend the statue and monument dedication at 3:00 PM on Saturday, June the 27th!

7. Walt mentioned that the DUV in the Springfield Mo Area is creating a book Regarding the monuments in Southwest Missouri and that we should support this Project if by doing nothing else, by buying a book.

#### Book to list Civil War markers, monuments in southwest Missouri

With the 150th anniversary of the American Civil War approaching in 2011, the Springfield Daughters of Union Veterans of the Civil War will publish a book of Civil War historical markers and monuments located in southwest Missouri, a spokesperson from the Mary Whitney Phelps Tent 22 announced recently.

Research began this spring in the following southwest Missouri counties: Barry, Barton, Cedar, Christian, Dade, Dallas, Douglas, Greene, Hickory, Howell, Jasper, Laclede, Lawrence, McDonald, Newton, Ozark, Polk, St. Clair, Stone, Taney, Texas, Vernon, Webster and Wright.

The project has been undertaken to aid Civil War buffs, researchers and educators who are interested in southwest Missouri's involvement in the Civil War. It is also believed that the book will positively impact tourism for the Sesquicentennial of the Civil War in Missouri.

Although tent members are descendants of Union veterans, their project includes both Union and

Confederate markers and monuments. However, cemetery headstones on graves will not be included. Members of the tent are donating their time and energy, researching and traveling at their own expense. The organization's treasury will assume publishing costs.

Anyone who has knowledge of the existence of markers or monuments in the counties mentioned is asked to contact the book's compiler and editor, Fran Black, at 744-4541 or e-mail frances\_b\_65705@yahoo.com.

Research will continue through September, and publication of the book is anticipated in February 2010.

Mary Whitney Phelps Tent No. 22 has 66 members (including two Real Daughters — women whose fathers actually served in the Civil War). Membership is through a direct ancestor who served for the Union in the Civil War; girls as young as eight years old are eligible to join.

Gary Scheel for starting a new camp and for getting the Unionist Newsletter Out in a continually timely and well organized fashion.

Paul Summitt (absent) for taking over duties as signal officer.

David Busch for representing true characteristics of Fraternity, Charity & Loyalty.

Brad Schall nomination for national JVC. Robert Petrovic made motion to Support Schall. Seconded by Walt Busch. 13 Aye 1 Nay. Walt to send Letter to Schall.

Don Palmer wants to run for JVC in 2010. David Busch made motion to Support his nomination for JVC. Seconded by Wayne Sampson. Pass By voice vote. Walt to send letter.

Credentials Report was then given. Walt gave a report of how many votes each camp was entitled to by delegates and past camp commanders.

Commander Brian Smarker Nominated by Chris Warren Seconded by Robert Petrovic. There were no other nominees. Passed Unanimously.

Senior Vice Commander Rod Price nominated by Robert Petrovic and Seconded by David Busch. There were no other nominees. Passed Unanimously.

Junior Vice Commander Chris Warren. Nominated by Rod Price and seconded by Doug Roussin. There were no other nominees. Passed Unanimously.

Council (2 year term) Emmett Taylor, PDC nominated by Walt Busch and Seconded by David Busch. There were no other nominees. Passed Unanimously.

Council (1 year for Chris Warren's vacated term). Ron Burke nominated by Walt Busch and seconded by Glen Alsop. There were no other nominees. Passed Unanimously.

[NOTE: The other council member still serving is Mark Coplin].

Chris Warren requested the floor and asked for a moment of silence for Keith Coplin's parents both of whom died in the last six months. Moment of Silence Given.

Rod Price then stood to asks that we give thanks to Keith who was here today because of the funerals and is heading back to active service in the Middle East. Applause.

Delegate Nominations to National Encampment

Walt reported that we stand at just under 200 members and as such are entitled to one vote as a department and one vote for each twenty-five members we have. Therefore nine delegates. We also have nine past department commanders still active who are entitled to vote and 1 department commander entitled to vote for a total of 19 votes.


All other members of the department of Missouri were elected as alternates.

Department Commander's Report 2009 Department Encampment June 13, 2009



# **BY-LAWS COMMITTEE**

A committee consisting of Walt Busch, Rod Price, and Chris Warren appointed at the last business meeting met to review camp by-laws and any department by-law changes. The meeting was on 5-14-2009 in Park Hills, MO.

We reviewed the following submittals:

- The committee recommends passage of the amendment to the national C&Rs to allow The commander-in-chief to rescind by-laws passed by the national encampment if Legal counsel deems there is a problem with the language. Attachment 2
- 3. Department recommended by-laws change to accept juniors and junior associates. Recommended as do pass. Attachment 3
- Lt. Col. Felix St. James Camp By-Laws. After review, a clarification of what constituted a junior member as to age. Upon determination that the by-laws as written were correct, the committee recommends the encampment accept them and do pass. Attachment 4
- Francis Wilhelmi Camp By-Laws. After review, the group voted to not approve them as the section on disposition of camp property is contrary to the national by-laws. We recommend that these by-laws not be accepted by the encampment. Not Attached

# Attachment 1

The Camp of U.S. Grant Camp Number #68, of the Department of Missouri, with all of its Officers and Brothers seated in quorum, there on the 6th day of May 2009, met in camp meeting and voted on the following amendments to the Constitution and By-Laws of said camp of the Sons of Union Veterans of the Civil War.

Article IV Section C Number 1 JUNIOR: A JUNIOR shall be any male descendant, whether through lineal or collateral line, not less than six (6) years of age and not more than thirteen (13) years old, who are blood relatives to a Soldier, Sailor, Marine Corps or the Revenue Cutter Service. Who was regularly mustered and served honorably in, or was honorably discharged from the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America during the war of the rebellion of 1861-1865; and has never been convicted of any infamous or heinous crime; or who has, or whose ancestors through whom membership is claimed, have never voluntarily borne arms against the Government of the United States of America.

Article IV Section C Number 2. JUNIOR ASSOCIATE: A JUNIOR ASSOCIATE shall be any male, not less than six (6) years of age and not more than thirteen (13) years old, as defined by the National Constitution & Regulations, who cannot document ancestral lineage to a Union Veteran of the War of the rebellion of 1861-1865; and who has never been convicted of any infamous or heinous crime and who has never voluntarily borne arms against the Government of the United States of America.

Article IV Section D. Each application for membership, whether it is for MEMBER, ASSOCIATE, JUNIOR or JUNIOR ASSOCIATE shall be recommended by a MEMBER or ASSOCIATE of the CAMP who shall vouch for the applicant's eligibility and moral character.

Article IV Section I. Voting rights are reserved for MEMBERS and ASSOCIATES of the CAMP, and not applicable to JUNIORS or JUNIOR ASSOCIATES until reaching the age of fourteen and becoming a MEMBER of the CAMP.

Article V Section A. Each BROTHER, Associate, Junior and Junior Associate of the CAMP shall be assessed annual dues as voted on the previous year by the camp. Annual dues shall become payable the 1st day of January of each year. During the November meeting of each year a report shall be give by the CAMP TREASURER stating the planned operating expenses of the CAMP for the new year. The Camp membership will increase or decrease the level of dues required of each BROTHER for the new year using this report as its basis for decision. New BROTHERS initiated into the CAMP during months other than January, shall be subject to appropriate dues structure based on the number of months remaining in the calendar year.

Article VI Section G. No JUNIOR or JUNIOR ASSOCIATE of the CAMP shall hold a elected or appointed office of the CAMP.

A majority vote of the Council of Administration is required to the proposed General support Order authorizing the Commander-in-Chief to proceed, the Commander-in-Chief abstaining from participating in such vote the Senior Vice and Commander-in-Chief may only vote to break a tie. Such and presentation vote may be taken by electronic means of The communication. Commander-in-Chief must propose a resolution to the conflict by the next National Encampment.

**Section 5.** Juniors or Junior Associate applicants shall observe all procedures of application as outlined in their respective camp by-laws and the Order's C&R. Juniors and Junior Associates are exempt from the department per capita tax.

**Section 6.** A rejected applicant for Junior or Junior Associate enrollment shall not be eligible to apply again for Associate enrollment until six (6) months have elapsed after such rejection.

**Section 7.** No Junior or Junior Associate shall hold an elected or appointed office of the department.

# LT. COL. J. FELIX ST. JAMES CAMP 326 SONS OF UNION VETERANS OF THE CIVIL WAR DEPARTMENT OF MISSOURI

#### **CAMP BYLAWS**

#### PREAMBLE

We, the members of the Lt. Col. J. Felix St. James Camp # 326 have joined this Patriotic and Fraternal Order for the purpose and objectives set forth by the National Organization, Sons of Union Veterans of the Civil War, and in so doing pledge ourselves to commemorate the deeds of those who served in the Army, Navy and Marines of the United States of America, during the War of the Rebellion of 1861-1865. We also pledge to render services to the citizenship with respect for and to honor our National Flag.

#### ARTICLE 1: NAME

The name of the Order shall be the LT. COL. J. FELIX ST. JAMES CAMP # 326 OF STE. GENEVIEVE, DEPARTMENT OF MISSOURI, SONS OF UNION VETERANS OF THE CIVIL WAR-ALLIED ORDERS OF THE GRAND ARMY OF THE REPUBLIC, hereafter referred to as the CAMP.

#### ARTICLE II: PURPOSE

The purpose of the camp shall be to perpetuate the memory of the Grand Army of the Republic and memory of the men who served the Union 1861-1865; to assist in every practicable way in preservation and making available for research of documents and records pertaining to the Grand Army of the Republic and its members; to cooperate in doing honor to all who have patriotically served our country in war; to teach patriotism and the duties of citizenship, the true history of our country and the love and honor of our flag; to oppose every tendency or movement that would weaken loyalty to, or make for the destruction or impairment of, our constitutional Union; and to inculcate and broadly sustain the American principles of representative government, of equal rights and impartial justice for all.

# ARTICLE III: PROHIBITED ACTIVITIES

Section A. The Camp shall not be conducted for profit. Section B. The Camp being strictly non-sectarian and non-partisan.

Section C. The Camp shall not discriminate on the basis of Race, Creed or Religion.

#### ARTICLE IV: MEMBERSHIP

Section A. MEMBER: A member shall be any male descendent, whether through lineal or collateral line, not less than fourteen (14) years of age, who are blood relatives to a Soldier, Sailor,

Marine or member of the Revenue Cutter Service. Who was regularly mustered and served honorably in, or was honorably discharged from the Army, Navy, Marine Corps or the Revenue Cutter Service of the United States of America during the War of the Rebellion of 1861-1865; and has never been convicted of any infamous or heinous crime; or who has, or whose ancestors through whom membership is claimed, have never voluntarily borne arms against the Government of the United States of America.

Section B. ASSOCIATE: An associate shall be any male, not less than fourteen (14) years of age who cannot document ancestral lineage to a Union Veteran of the War of the Rebellion of 1861-1865; and who has never been convicted of any infamous or heinous crime and who has never voluntarily borne arms against the Government of the United States of America. The number of associates shall not exceed 1/3 of the total membership of the Camp.

Section C. JUNIOR: A junior shall be any male descendant, whether through lineal or collateral line, not less than six (6) years of age and not more than thirteen (13) years old, who are blood relatives to a Soldier, Sailor, Marine Corps or the Revenue Cutter Service. Who was regularly mustered and served honorably in, or was honorably discharged from the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America during the War of the Rebellion of 1861-1865; and has never been convicted of any infamous or heinous crime.

Section D. JUNIOR ASSOCIATE: A junior associate shall be any male, not less than six (6) years of age and not more than thirteen (13) years old, who cannot document ancestral lineage to a Union Veteran of the War of the Rebellion of 1861-1865; and who has never been convicted of any infamous or heinous crime.

Section E. Each application for membership under any of the levels of membership listed in Sections A, B, C or D of this ARTICLE IV, shall be voted on by camp members present at meeting application is presented and if applicable along with proper written verification and/or proof of eligibility.

# ARTICLE V; DUES & FEES

Section A. Each member of the camp shall be assessed annual dues. Annual dues for members and associates shall be a minimum of \$30.00 (\$18 to National Organization and \$6 to Department of Missouri with \$6 to remain with CAMP). Annual dues for junior and junior associate members shall be a minimum of \$10.00 with no per capita tax due them to National Organization or the Department of Missouri. Annual dues shall become payable upon or before FEBRUARY 27<sup>TH</sup> the anniversary of camp date of rank.

Section B. MEMBERSHIP DUES shall be considered delinquent if not paid to the camp by March 31<sup>ST</sup>.

Section C. An APPLICATION FEE of \$10.00 (\$5.00 to be sent to National Organization via Department of Missouri Secretary and \$5.00 will remain with the CAMP) and shall be assessed from each level of membership as described in ARTICLE IV, SECTIONS A, B, C & D.

# ARTICLE VI: CAMP OFFICERS

Section A. Camp officer shall be of two types: elected and appointed. The elected officers shall be Commander, Senior Vice Commander, Junior Vice Commander, Secretary, Treasurer, Camp Council, Camp Delegate and Alternate Delegate to State Encampment. The Camp Council shall be compiled of three members of the CAMP not holding the office of any of the other Elected Officer position. The appointed officers of the camp shall be Chaplain, Patriotic Instructor, Historian, Guide, Color Bearer, Guard, Graves Registration and Counselor.

Section B. The elected Camp Officers shall be elected at a regular or a special meeting of the Camp in the month of January. A majority vote shall be required to elect all elected officers. The Camp Commander Elect shall appoint the non-elected officers prior to Installation of Officers.

Section C. The Camp Officers shall be installed at a Camp meeting in February.

Section D. Any vacancy which may occur in an elected office of the Camp shall be filled temporarily by the Officer next in rank. Such vacancy shall be approved for the un-expired term by the Camp Council or by the members at the next regular or special camp meeting.

Section E. No Junior of the camp shall hold an elected or appointed office of the camp.

# ARTICLE VII: DUTIES OF CAMP OFFICERS

Section A. The Camp Commander should preside at all meetings of the camp, become familiar with all SUVCW forms that are utilized for conducting the business of the camp and insure that all reports are submitted to the Department by the specified times, represent the camp at community functions, become familiar with the Bylaws of the Camp and Department, become familiar with the duties of the office as set forth in the Order's Ritual and Ceremonials and serve as liaison between the Camp and Department.

Section B. The camp Senior Vice Commander and Junior Vice Commander shall assist the Commander and shall perform such duties as outlined by National Job Descriptions for these elected officers. They shall preside over camp meetings in the absence of the Camp Commander.

Section C. The Camp Council shall devise and recommend measures for preserving and increasing funds of the camp, make its investments, leases and other contracts; secure a place meeting; settle and dispose of all disputed accounts between the treasurer and members of the camp; examine the books and other papers of the different officers, and at the end of each quarter render a complete report showing its transactions and the financial condition of the camp. The council, may fill any vacancy which may occur in an elected camp office with a majority vote of the Camp Council.

Section D. The Camp Secretary shall perform all duties pertaining to his office, keep all books of record, make duplicate quarterly reports to the Department Secretary on the 1<sup>st</sup> days of January, April, July and October upon forms prescribed by the National Order and furnished by the Department Secretary, showing all gains or losses in membership and the total membership; and forwarding said report along with per capita tax to the Department Secretary on or before the 10<sup>th</sup> of the month. He shall ensure that a duplicate of the report is placed in the camp's file. He shall

draw requisitions upon the camp treasurer for reimbursements of camp expenditures, and submit the same to the camp commander for his approval. He shall also provide a current copy of the camp membership list to the Camp Commander, Senior Vice Commander and the last Past Commander available.

Section E. The Camp Treasurer shall be accountable for receipt and disbursement of camp funds and have charge of its property not otherwise provided for; keep the accounts between the camp and its members; collect all moneys due the camp, given in all cases receipts therefore; notify all members in arrears by the first day of April that they are delinquent, provide monthly or quarterly and yearly financial reports to the camp membership and the fund balance in his hands. He shall make quarterly financial reports through the camp secretary to the Department Secretary. He shall exhibit the account books of the camp to any elected camp officer upon reasonable request; file all tax and other financial reports required of the camp, cause an audit to be performed on an annual basis; shall provide completed dues notices, to be sent by the Secretary, perform all duties that are incident to the office of the treasurer.

Section F. The Patriotic Instructor, Chaplain, Guide, Guard, Color Bearer and Counselor shall perform such duties as prescribed by the Ritual of the Order or directed by the Commander.

Section G. All officers of the camp shall upon their retirement from office turn over to their successor all property of the camp within thirty (30) days after leaving office.

# ARTICLE VII: MEETINGS

Section A. Regular meetings of the camp shall be held monthly throughout the year unless changed by the membership. At the minimum the camp should hold a meeting quarterly. The meeting of the camp shall be at such time and place as chosen by the Camp Commander. All regular meetings of the camp shall be held within the boundaries of the Department of Missouri.

Section B. Special meetings of the camp shall be called by the Camp Commander or be announced at the regular camp meeting.

Section C. Notification of Regular and Special meetings to the Members shall be the responsibility of the camp secretary. A minimum of five (5) days notice shall be given members for either Regular or Special meetings.

Section D. Special meeting of the elected camp officers may be called by the camp commander. All business conducted as said meeting shall require ratification by the camp membership at the next Regular or Special meeting of the camp.

Section E. A minimum of three (3) members or a minimum of 10% (whichever is larger) of the number of camp members shall be required to be present in order to conduct business at a Regular or Special meeting of the camp. Said members minimum shall not be composed of associates that exceed 49% of those in attendance, pursuant to Article IV, Section A of the bylaws. All matters brought before the camp at a Regular or Special membership meeting shall be decided by a majority vote of those present and entitled to vote at said meeting with one exception, that

being the election of camp council, delegates and alternate delegates who shall be elected by plurality vote.

Section F. Any members of the Auxiliary to the Sons of Union Veterans of the Civil War, the Women's Relief Corps, the Daughters of the Union Veterans of the Civil War, and the Ladies of the Grand Army of the Republic, may be admitted to the session of the camp only after announcing their organization and proving membership in above named affiliate organizations.

Section G. All meetings of the camp shall have the United States Flag and the Camp Charter displayed.

Section H. All meetings of the camp shall be conducted by the guidelines of the Ritual of the Order and the current edition of Robert's Rules of Order, in that order.

#### ARTICLE IX: COMMITTEES

Section A. Special committees may be created by action of the Camp Commander and shall be for the period of time designated in the creation thereof. Duties and responsibilities of the Special Committee shall be defined by the Camp Commander.

Section B. The Camp Commander shall serve as ex-officio on all Special Committees unless otherwise noted.

Section C. The Military Affairs Committee shall establish, maintain and coordinate communications between Camp Guard or SVR Unit with Sons of Veteran Reserve District #4 and its officers.

#### ARTICLE X: BOOKKEEPING

Section A. The fiscal year of the camp shall begin on February 27 and end on February 26 of each year to correspond with Camp Date of Rank anniversary.

Section B. Annual financial statements of the camp, prepared in accordance with generally accepted accounting principals, that offers full general ledger accounting, shall be prepared shortly after the end of each fiscal year and be presented at March meeting. All financial statements and records shall be subject to an annual audit by the Camp Council; the results of which shall be reported to the camp meeting after the audit is conducted.

Section C. The camp may have a checking and savings account, and may establish such financial accounts as necessary for the camps welfare. Two members of the camp will have their names on the signature card on all accounts. Receipts are required for all expenditures in order to be reimbursed. Any camp expenditures may be reimbursed by check from the camp treasurer. All expenditures must be approved by camp prior to monies being spent. Members of camp may request the camp to reimburse them if camp approves the expenditure (accompanied by receipt) at the next camp meeting. Camp treasurer may transfer funds from one account to another in order to keep accounts balanced.

### ARTICLE XI: DISCIPLINARY ACTION

All discipline of members of the Camp shall be carried out as specified in the National Constitution and Regulations; Chapter 5, Article 6, Sections 1-11.

#### ARTICLE XII. CAMP GUARD

The camp may have an independent military organization (Camp Guard) composed of members of the Sons of Union Veterans of the Civil War.

#### ARTICLE XIII: COLOR GUARD

The camp may have a Color Guard unit composed of members of the Sons of Union Veterans of the Civil War. Color guard shall not consist of more than fourteen (14) members with the highest rank being that of a Captain. At such time, Color guard is larger than fourteen (14) members, they must join the Sons of Veterans Reserve (SVR) and follow the guidelines of the National Military Affair Committee.

#### ARTICLE XIV:

Included herein by reference and made a part of these Bylaws are the following rules and regulations, and any subsequent amendments or modifications thereto.

- 1. Constitution and Regulations of the Sons of Union Veterans of the Civil War.
- 2. Bylaws of the Department of Missouri, Sons of Union Veterans of the Civil War.

#### ARTICLE XV: DISSOLUTION AND DISPOSITION OF ASSETS

In the case of the surrender or forfeiture of the Camp Charter all Camp funds in all accounts and all property of the Camp shall be turned over to the Department Commander or to his duly authorized representative. Any such transfer or disposal within six (6) months of disbandment or surrender of the Camp's charter without the written consent of the Department is prohibited. The property and funds of the camp shall not be divided among its members.

#### ARTICLE XVI: SUSPENSION OF BYLAWS

There shall be no suspension of these Bylaws during any meeting of the camp.

#### ARTICLE XVII: BYLAWS AMENDMENTS

These Bylaws may be amended at any meeting of the Camp by a 2/3 vote of the members present at the camp meeting, provided however that a copy of the proposed amendment has been submitted in writing to the Department Commander and the camp membership at the previous camp meeting.

#### ARTICLE XVIII: CAMP AWARDS

Camp awards shall be given by the Camp Commander, as per recommendation of the Camp Council.

## MONUMENTS OFFICER REPORT

I've submitted this past year the needs for database fields to Paul Summitt, signals officer and am awaiting a database to begin entries for an on-line system.

I am pleased to report that we have only 104 known monuments left to record (some may be duplicates). Of these 30 have yet to be installed because they are part of the Missouri Civil War marker program, and there are a few others that other organizations are getting ready to put out. A list of these is attached.

Since the Daughters of Union Veterans did their survey in the 1960s, 2 monuments have apparently disappeared (one is a Frank Blair Monument in Louisiana MO, the other is one in Ste. Genevieve).

We currently have 203 monuments recorded. Total monuments (including those awaiting installation): 307.
