
hour and a half, the Civil War veteran's stone was fixed.

Auxiliary's January meeting, a phone call was received and a surprise occurred. A descendant of Louisa Volker called Twyla Warren and after chatting for a while, they were able to get a photograph of their auxiliary's namesake. Volker was the first woman telegraph officer, West of the Mississippi , for the United States Military Telegraph Service, and was stationed at Mineral Point , Missouri during the famous Price's 1864 Raid.

### Last Soldier Project Report

#### Brother Bob Schmidt

At the March 13, 2010 Sons of Union Veterans Department Meeting, Walt Busch brought the group up to date on the Last Soldier Project meant to identify the last Union soldier in each of Missouri's Counties. In his discussion, he identified thirty-five counties left unsearched. In May, 2010, I contacted Walt offering my help on these remaining counties, such work I began the next month. Always interested in finding and providing service on civil war veterans, I had the challenge to search out soldiers from counties I had never researched before.

It proved to be a rewarding effort, as the unsearched counties were in literally all regions of the State leaving open the likelihood of some great finds. In my search, which was all online, I used some basic finding aids that included the 1930 Census (ancestry.com), Death and Military Records from the Missouri State Archives (sos.mo.gov), cemetery records (findagrave.com), Compiled Service Records and the Union Pension Index (footnote.com).

Genealogists will agree that the Census Enumerators accounted for Civil War veterans in three decades being, 1890, 1910 and 1930. The 1930 Census is the best source to start the search, with the other two used in a minimal fashion. I began the search by reviewing the 1930 Census for each county and making a note of each civil war veteran proved invaluable were matched with death certificates for the same county, with the goal of finding some half-dozen or so potential candidates. Next came the task of proving service. Here the Soldier's Records on line with the Missouri State Archives were used with great success. Men not found with service in Missouri, were checked against Rosters from the State in which they were born, using the Soldiers and Sailors website. In some cases, Compiled Service Records were consulted along with the Union Pension Index. The Pension Index will not only confirm the regiment in which the soldier served but often will reveal date and place of death, confirming the identity of the soldier. Lastly, death certificate data showing place of burial, was matched against cemetery records so as to determine if a stone was present.

Being ever so cautious, a second effort was made, starting with the year of death for the last probable soldier and checking each of the county's death records for all males for each following year until 1943. To speed the search, the year 1848 was used as the likely latest year of birth for most potential civil war soldiers. Using this format, it was conceded that only veteran aged 88 and up would likely have service. Only those men who died at that age and upwards, were noted. With this data in hand, service could be proven and cemetery records checked.

Finding the <u>last soldier</u> ultimately meant finding and proving (or disproving) service on many men, but the work was rewarding. My recent interests in researching the Enrolled Missouri Militia, Provisional Enrolled Missouri Militia, General Order No. 3 and General Order No. 107 troops proved invaluable for a task of this type as several of the soldiers were in these organizations. A couple notable veterans were Pvt. Joseph Briggs buried in Mississippi Co. who died in 1945. He had service in the 51st Illinois Infantry. Another was the drummer boy, Charles D. Prince of the 48th Missouri Infantry who died in Cole County in 1939.

Not on Walt's list to search was my nearby Ste. Genevieve Co. A couple potential soldiers were offered, one dying in 1934, that being Pvt. John Reeder of the 3<sup>rd</sup> Missouri State Militia Cavalry. As many other counties' last soldier died in the mid 1930's, his

candidacy for this honor would not be surprising. Too, I had registered scores of civil war graves there and had found none later. I felt another search would confirm my early findings. As usual, a couple candidates met the criteria and died after 1934—further research proved they served the South. My final choice was John Miles Duvall who died October 30, 1939 but due to the similarity in names, his identity and service could not be proven. Finally, a newspaper obituary was located on him which proved he was the soldier in Co. G 50th Missouri Infantry.

In closing, I view many persons on the Last Soldier Project Roll as **candidates.** Other research may prove that a more worthy individual should have this honor. Whether your work identifies another soldier for the List or not, you like I will have a great in the process.

Department of Missouri's Last Soldier Project Coordinator Walt Busch would like to thank Bob Schmidt for all of the hard work that he has accomplished. He also agrees with Bob that there is always the chance that the soldier listed on the web site may not be the last soldier in a county. If you happen to find one that died after the year on the web site let Walt know.
