In Memory of Samuel D. Wang, P.C.C. McPherson Camp #1 – Little Rock, Arkansas

Samuel D. Wang, 83, of Fort Smith died Friday, Oct. 21, 2011, in his home. He was born in North Georgetown, Ohio. He was a retired vice president of Hiram Walker, worked as an arbitration judge, graduated from Wittenberg University and from Case Western Reserve University Law School, was a member of both the Ohio state and Sebastian County bar associations, was a Koran War veteran, a member of the American Legion, ATO Fraternity, Noon Civics League, Friends of the Library, and St. Luke Lutheran Church and was a past president of the Old Fort Museum. He was the widower of Nancy Wang.

In addition, Sam was also a founding member and served as the first Camp Commander for the McPherson Camp # 1, Little Rock, Arkansas – Sons of Union Veterans of the Civil War. He had also previously served as a member of the Arkansas Civil War Sesquicentennial Commission.

Memorial service with military honors was held at 1 p.m. Saturday, October 29, 2011 at St. Luke Lutheran Church with burial of cremains at U.S. National Cemetery under the direction of Ocker-Putman Funeral Home in Fort Smith.

He is survived by a daughter, Linda Hamilton of Fort Smith; three sons, Mark Wang of East Peoria, Ill., Gary Wang of Valley Stream, N.Y., and Earl Wang of Summerfield, N.C.; six grandchildren; and one great-grandchild.

ARCHIVING PLAN for DEPARTMENT of MISSOURI

- 1. The State Historical Society of Missouri (herein known as the SHSMO) has graciously agreed to archive record material for the camps of the department and the department.
- 2. The commander of each camp and the department commander will, upon receipt of this plan, appoint an archivist to implement the plan. I request that the department commander and all camp commanders send me the name and contact points (both phone number and email addresses) for the archivists they appoint. The department commander, all camp commanders and the appointed archivists for each camp will receive a list of these names
- 3. The first "call" for records to be sent to the SHSMO will not be until late spring, 2012. The first "call" will be for all the records the camps and the department have generated since they were formed and up to 31 Dec, 2011. Thereafter there will be a "call" every late January. The time between now and late spring, 2012, will allow time for the first collection of records. From 2012 on camps and the department should be collecting material "as they go."
- 4. Types of material to be gathered are meeting minutes, financial reports, JROTC presentations, Eagle Scout presentations, community events and ceremonies, e-mail traffic, etc., etc. The SHSMO would rather you send in hard copies, photos, spread- sheets, computer generated material and other paper material. You may also send computer disks. They do not want bank statements, and they would rather you don't send CDs, DVDs, tapes etc. When you send the material the preference is that it be in chronological order. It will be up to the archivist and his commander to determine what other material to send and how much. If for some reason any records are overlooked when they are supposed to be submitted they should be sent as soon as possible after the regularly scheduled submission.
- 5. When it becomes time to send your material in I will give you the name and address of the office and person to send it to. You may send the records any way you wish to, e.g. U.S. mail, UPS, hand deliver, etc.
- 6. I would suppose this program is not mandatory. Some camps will do it and some will probably not do it, but remember this: If you choose not to send in your material your camp's history will be forever lost to future generations. I do not intend to check on camps to see if they are sending their records.
- 7. If you have any questions please contact me.
- 8. Please disseminate this information to all members of your camps at the earliest possible time.

<u>Missouri History Museum – The Civil War in Missouri Exhibit</u>

November 13, 2011 - March 16, 2013

Missouri may best reflect the Civil War's rending of our nation. Prior to the Civil War, the state was bitterly divided between pro-slavery secessionists and those determined to preserve the Union. The Missouri Compromise, the Dred Scott Case and the Missouri-Kansas border conflicts exposed the simmering tensions. Claimed by both the Union and the Confederacy, two state governments grappled for control of Missouri.

Today, Missouri and its role in the Civil War continue to generate controversy among historians, academics and Civil War enthusiasts. To commemorate the Civil War sesquicentennial--and to explore the complexities of the Civil War in the twenty-fourth state--the Missouri History Museum's comprehensive exhibit, The Civil War in Missouri, will feature compelling artifacts, imagery and interactive elements. Although the exhibition addresses issues with which our entire nation wrestled, topics that are distinctively Missourian will take center stage.

Montgomery City, Cemetery



On Sept 23, 2011 at 5 pm a grave stone dedication was held at the Montgomery City Cemetery in Montgomery City, Mo. The event was organized by the Montgomery County Historical Society and Co. C, 5th Missouri Cavalry Regiment.

A new marker was placed to mark the grave of Pvt. William H.H. Pease. On July 18, 1861, Pvt. Pease of Co. C, 8th Missouri Infantry became the first casualty at the Battle of Wentzville.



Capt. Emmett Taylor of the 5th Missouri Cavalry Regiment conducted the grave stone dedication ceremony. Three members of Capt. Taylor's unit fired a salute. Joseph Difani, Jr. of Co. C, 34th Illinois Infantry stood guard at the grave. Lt. Colonel Jack Grothe also addressed the small crowd of about 15. Maggie Grothe of the ASUVCW laid a wreath at the grave. The ceremony lasted abut 45 minutes.

James B. Eads Memorial Ironclad Cannon



A dedication for the James B. Eads Memorial Ironclad Cannon was held on Oct 8, 2011 at South St. Louis Square Park, located at 7700 S. Broadway in St. Louis. This Signature event was sponsored by the William T. Sherman Camp #65, Co. A, 1st Missouri Engineers, and the South Broadway Merchants Association.

The new monument commemorates the achievements of James Buchanon Eads, the builder of the ironclad gunboats used on the Mississippi River during the Civil War and the brave sailors

and soldiers who manned these ships.

The ceremony began at 11:00 am with a welcome and brief biography of James B. Eads by brother Noel Stasiak of the William T. Sherman Camp. The crowd of about 70 people were delighted to hear from Frederick Douglass, James B. Eads, Alderman Tom Villa, Congressman Russ Carnahan, Missouri Department Commander Chris Warren (The Importance of Historic Education for Children) and the keynote speaker was Rear Admiral Lee Metcalf, USNR Ret.

The ceremony concluded at about noon with the unveiling of the cannon and a rifle salute given by members of the SVR that included Co. A, 1st Missouri Engineers; Co. C, 34th Regiment Illinois Volunteer Infantry; Co. E, 47th Missouri Infantry, and also members of the Turner Brigade.

Fredericktown



The Battle of Fredericktown, Missouri was commemorated was on October 21, 2011 at the site of the Battle. The ceremonies started at 1:00 pm with Union and Confederate reenactors marching in. Lewis the eagle from the Wild Bird Sanctuary in Valley Park, MO. portrayed Old Abe the War Eagle, the mascot of the 8th Wisconsin Volunteer Infantry Regiment. Posting of the colors was performed by members of the ROTC from Fredericktown High School. Missouri Department Commander Chris Warren was the Master of Ceremonies for the event. Certificates were handed out to descendants of some of the soldiers who fought at Fredericktown. This session of the ceremony closed with a rifle salute from the Union and Confederate reenactors and then an artillery salute. The next portion of the

ceremonies was done in the cemetery next to the battlefield. It was a dedication of a new granite marker commemorating the Battle of Fredericktown. The dedication was performed by Commander Warren, again followed by a joint rifle and cannon salute. The last event of the day was the re-dedication of a monument in the Masonic Cemetery to the Confederate dead from the Battle of Fredericktown. Members from the J. Felix St. James Camp #326 (and its Auxiliary), McCormick Camp #215 (and Volker Auxiliary 215), William T. Sherman Camp #65, U.S. Grant Camp #68, Fletcher Camp 47, were present for all of the ceremonies. The SVR was represented by Co. A, 1st Missouri Engineers; Co. F, 78th Enrolled Missouri Militia; Co. E, 47th Missouri Infantry; and Co. C, 34th Regiment Illinois Volunteer Infantry.

U.S. Grant Camp # 68 - St. Louis, MO



Arcadia Valley Commemorates the 150th Anniversary of U.S. Grant's Promotion to Brigadier General

On Saturday, July 30th in Ironton, MO, the U.S. Grant Camp #68 commemorated Colonel Grant receiving the news of his promotion to brigadier-general. The signature event was sponsored by the U.S. Grant Camp, Sons of Union Veterans of the Civil War, the Arcadia Valley Chamber of Commerce, and the Iron County Historical Society, in cooperation with the Friends of Fort Davidson State Historic Site and Ste. Marie du Lac Catholic

Church. Shortly after his arrival in Ironton in August, 1861, Colonel Ulysses S. Grant received the official notification of his promotion to Brigadier General. Grant, the leader of the Union forces stationed in the Arcadia Valley at that time,

received the news at his headquarters near a cool spring on property owned by Col. James Lindsay on August 7th, 1861. Years later, in 1886, surviving members of the 21st Illinois Infantry Volunteers (Colonel Grant's unit) erected a monument on the spot where he received the official notification of his promotion. The ceremonies on the 30th will have the monument as a center point. The organizers extended special invitations to the Grant family, Col. Lindsay's family and descendants of the 21st Illinois. 4th Military District SVR Commander Lt. Col. Jack Grothe is descended from Pvt. Levi McDowell, Co. D of that unit. At the celebration, Ulysses Grant VI and brother Levi, along with members of their family, were in attendance. Also in attendance were



members of Col. Lindsay's family and members of several SUV camps. The Grant brothers were presented with the challenge coins made by the US Grant Camp #68. The signature event also featured music by the Pilot Knob Mountain Boys, a historical re-creation of Grant receiving the news, speeches and displays from various groups. This was the second signature event of the U.S. Grant Camp in the last several months. The first was at Camp Jackson, St. Louis, in May in remembrance of the first military action in the state and Union victory.

Real Son Joins U.S. Grant Camp

Phelps Camp # 66 – Springfield, MO



Phelps Camp #66, in cooperation with the Springfield-Greene County Park Board, recognized the sesquicentennial anniversary of Zagonyi's Charge on October 22. The ceremony was held near the battle site in Springfield's Zagonyi Park. On October 25, 1861, Union cavalrymen under the command of Major Charles Zagonyi attacked pro-



Southern Missouri State Guard forces on the outskirts of Springfield, Missouri.

A Hungarian immigrant, Zagonyi bravely led his men in a charge down the Mount Vernon Road. The Missouri State Guard withdrew after hard fighting and Zagonyi's troops occupied Springfield. Although Union forces retreated from the Ozarks in early November, the skirmish made national headlines and was an important part of the early struggle for control of Missouri.



Approximately fifty people attended the forty-five minute program. Speakers described Springfield in 1861 and provided a history of both the Missouri State Guard and Zagonyi's command. The program concluded with a cannon firing courtesy of staff and volunteers from Wilson's Creek National Battlefield. Special thanks to the members of Mary Whitney Phelps Tent #22 DUVCW for their attendance, and our guest speakers, John Rutherford, Jeff Patrick, Sally McAlear, and Kip Lindberg.

Gen. James R. McCormick Camp #215 – Park Hills, MO



The Gen. James R. McCormick Camp has been extremely busy since the last issue of the "Missouri Unionist." On June 25, 2011 members of the McCormick Camp participated in the "School of the Piece" artillery school event at Jefferson Barracks Park in St. Louis, MO. Then, on July 4, 2011 members of the McCormick Camp 215 (and Volker Auxiliary) joined members of the St. James Camp 326 and Sherman Camp 65 to participate in a day of Civil War education and demonstrations at the Perry County Veterans Museum. It was at this event in Perryville, MO that these dedicated members performed infantry drills, gave short educational speeches, demonstrated Civil War clothing/gear, and helped to raise \$500 in donations for the museum.



Next, we participated in the St. James camp's Living History event, which was also a SUVCW Sesquicentennial Event, on July 9th, where we had members with booths set up selling Civil War relics and books, and also some members participated in the infantry and artillery drills, as well as the local bank robbery. A few days later saw us back at it again, when we were asked to set up (in period attire) at the local "Big River Chautauqua" event (which was Civil War themed) in Bonne Terre, MO, on July 15-16, 2011. We set up



a membership table and answered questions about our attire and equipment.



Then, on July 30, 2011, McCormick Camp (and Volker Auxiliary) participated in the U.S. Grant Camp #68's SUVCW Sesquicentennial Event "150th Anniversary of U.S. Grant's Promotion to Brigadier General" held in Ironton, MO, on the site where Grant received his commission to Brigadier-General. This event was well represented by the Department of Missouri – SUVCW and included such dignitaries as U.S. Grant VI and his brother Levi (with their families).

One week later, McCormick Camp co-sponsored its own SUVCW Sesquicentennial Event; "Fort D Days, in Cape Girardeau, MO on August 6, 2011. This was to commemorate the building of the four earthen forts that protected Cape Girardeau and the Mississippi River from the possibility of Confederate attack. Also during this month, Chris & Twyla Warren (of McCormick Camp & Volker Auxiliary) were visiting relatives in Ontario, Canada, but this did not deter their Civil War interests. After much searching, they ended up placing American flags on the graves of three Union soldiers buried in various cemeteries in Southwestern Ontario.





Things did not slow down as September approached. On September 10, 2011, members of the McCormick Camp assisted the newly forming Fletcher Camp #47 (De Soto, MO) with a Living History encampment. The guys demonstrated a soldier's life, weapons and gear, and even cooked their food over a fire. We also found a few Confederates in the vicinity and quickly deposed of them. Later that same day, in a different part of the state, members of McCormick Camp (and Volker Auxiliary) traveled to Patterson, MO to assist in a ceremony honoring Union and Confederate soldiers who fought at Fort Benton (and who are buried in the cemetery at the foot of the hill below the earthen fort). They were joined by members of the Wilhelmi Camp

#17, Sherman Camp #65, St. James Camp #326 (and its Auxiliary), and U.S. Grant Camp #68, as well as Union & Confederate reenactors, joined together to perform a modified variation of the 1917 GAR monument dedication ceremony for this event.





A few days later found members, Chris & Twyla Warren, presenting a first-person performance titled "Washington County's Unknown Civil War Couple" which represented the lives of Capt. Thomas H. Macklind (3rd Missouri State Militia Cavalry & later St. Louis Street Engineer) and his wife Louisa E. Volker Macklind (first female U.S. Military telegrapher & later licensed physician). This program was given to the Mine Au Breton Historical Society and members of the public at the Potosi, MO library on



Then, the following Saturday (September 17th), members of the camp and auxiliary presented a Civil War Fashion Show and "Bushwhacked" programs at St. Francois State Park's amphitheater, near Bonne Terre, MO. They presented Civil War uniforms, gear, weapons, as well as civilian clothing (men's, women's, and children's). The "Bushwhacked" was an educational program about the pursuit of local bushwhacker, Sam Hildebrand, by the local militia followed by a team scavenger for Civil War items throughout the entire campground.



By the end of September, members of both groups were asked to volunteer for a Civil War day field trip for 3rd graders at Fort Davidson State Historic Site in Pilot Knob, MO on September 30th. Once again they presented about a soldiers camp life, cooked lunch over a campfire, demonstrated weapons and soldiers' gear, as well as ladies and children's clothing, writing equipment, and period toys. These students were even put through the basics of marching drills and formation of companies.

Next, October kept us just as busy, with members participating in the "Gathering Ceremony" in honor of the 150th Anniversary of the

Battle of Fredericktown, MO, on October 21, 2011. There was also a monument dedication ceremony and a re-dedication of a Masonic monument as well, but we will let you read that portion under the Sherman camp's news. That same weekend found members being asked to join in on the Arcadia Valley Music Festival, in Ironton, MO. This year's event was Civil War themed and members of McCormick Camp, Volker Auxiliary, St. James Camp and its Auxiliary, demonstrated various Civil War related activities from wool spinning, soldier's life, women's civilian life, and a newspaper artist/correspondent.









Finally, to end this long list of activities, we find members of the camp and auxiliary attending a reception dinner for the first Commander-in-Chief ever elected from Missouri, Don Palmer. This event was held at the Ste. Genevieve, MO Hotel & Restaurant on October 29th. Camp Commander, Jeff Asberry, as well as Past Auxiliary President and current Secretary/Treasurer, Twyla Warren, presented Dr. Palmer with a gift from the two groups. In addition, Department Commander (and McCormick Camp founder) Chris Warren, presented CinC Palmer with a Missouri State Senate Resolution, on behalf of the entire Department of Missouri.

On 5-7 August, there were seven members who participated in the Sesquicentennial event. Our ladies Auxiliary were also present.



By the President of the United States of America:

A Proclamation.

The year that is drawing towards its close, has been filled with the blessings of fruitful fields and wealthful skies. So these bounties, which are so constantly enjoyed that we are prove to forget the source from which they come, others have been added, which are of so extraordinary a nature, that they cannot fail to penetrate and soften even the heart which is habitually insensible to the over watchful previ dence of Almighty God. In the midst of a will war of unequalled magnitude and severily, which has sometimes seemed to foreign States to invite and to provoke their aggression, peace has been preserved with all patiens, order has been mainlained, the laws have been respected and obeyed; and harmony has prevailed everywhere except in the theatre of military conflict; while that theatre has been greatly contracted by the advancing armies and maries of the Union. Seedful diversions of wealth and of strongthe from the fields of peaceful industry to the national defence, have not urrested the plough, the

shuttle or the ship; the are has enlarged the borders of our settlements, and the mines, as well of iron and coal as of the precious metals, have yielded even more abundantly than heretofore. Population has steadily inercased, notwithstanding the waste that has been made in the camp, the siege and the battle-field; and the country, rejoicing in the consciousness of augmented strongth und vigor, is permitted to exheck continuance of years with large increase of freedow. It has seemed to me fit and proper that they should be selemnly, reverently and gratefully acknowledged as with one heart and one voice by the whole American Reofile. I do therefore invite my fellow vilizens in every part of the United States, and also these who are at sew and these who are sojourning in foreign lands, to set apart and observe the last Thursday of Nevember next, as a day of Thanksgiving and Fraise to our beneficent Jather who dwelleth in the Heavens. And I recommend to them that while offering up

the ascriptions justly due to thim for such singular deliverances and blefsings, they do also, with humble frenitines for our national perversences and dischedience, commend to this tender care all these who have become widows, or phans, mourners or sufferers in the lamentable civil strife in which we are unavoidably engaged, and fervently implere the interposition of the Almighty thand to heal the wounds of the nation and to restore it as soon as may be emissiont with the Divine purposes to the full enjoyment of peace, harmony, tranquillity and Union.

In testimeny whereof, I have hereunte set my hand and caused the Seal of the United States to be affixed.

Done at the bity of Washington, this Third day of October, in the year of our Lord one thousand eight hundred and sixtythree, and of the Independence of the United States the Eighty-eighth.

Lincoln's Thanksgiving Proclamation

Washington, DC—October 3, 1863

The year that is drawing toward its close has been filled with the blessings of fruitful fields and healthful skies. To these bounties, which are so constantly enjoyed that we are prone to forget the source from which they come, others have been added which are of so extraordinary a nature that they can not fail to penetrate and soften even the heart which is habitually insensible to the ever-watchful providence of Almighty God.

In the midst of a civil war of unequaled magnitude and severity, which has sometimes seemed to foreign states to invite and to provoke their aggression, peace has been preserved with all nations, order has been maintained, the laws have been respected and obeyed, and harmony has prevailed everywhere, except in the theater of military conflict, while that theater has been greatly contracted by the advancing armies and navies of the Union.

Needful diversions of wealth and of strength from the fields of peaceful industry to the national defense have not arrested the plow, the shuttle, or the ship; the ax has enlarged the borders of our settlements, and the mines, as well as the iron and coal as of our precious metals, have yielded even more abundantly than heretofore. Population has steadily increased notwithstanding the waste that has been made in the camp, the siege, and the battlefield, and the country, rejoicing in the consciousness of augmented strength and vigor, is permitted to expect continuance of years with large increase of freedom.

No human counsel hath devised nor hath any mortal hand worked out these great things. They are the gracious gifts of the Most High God, who, while dealing with us in anger for our sins, hath nevertheless remembered mercy.

It has seemed to me fit and proper that they should be solemnly, reverently, and gratefully acknowledged, as with one heart and one voice, by the whole American people. I do therefore invite my fellow-citizens in every part of the United States, and also those who are in foreign lands, to set apart and observe the last Thursday of November next as a day of thanksgiving and praise to our beneficent Father who dwelleth in the heavens. And I recommend to them that while offering up the ascriptions justly due to Him for such singular deliverances and blessings they do also, with humble penitence for our national perverseness and disobedience, commend to His tender care all those who have become widows, orphans, mourners, or sufferers in the lamentable civil strife in which we are unavoidably engaged, and fervently implore the imposition of the Almighty hand to heal the wounds of the nation and to restore it, as soon as may be consistent with the divine purpose, to the full enjoyment of peace, harmony, tranquility, and union.

In testimony whereof I have hereunto set my hand and caused the seal of the United States to be affixed.

Done at the city of Washington, this 3d day of October, A.D. 1863, and of the Independence of the United States the eighty-eighth.
