Memorial dedication service honors Civil War veteran

mikeedmarkhfaltmail.com Thomas Keeling, a corporal with Company F, 4th Missouri Infantry in the Union Army during the Civil War, had his final resting place officially as an effect of the second with members of a pair of Civil War organizations, as the veteran's headstone was unveiled amidst fanfare including an honor guard, a recitation of a portion of the Gettysburg Address and a performance of the "Battle Hymn of the Republic" Jeff Patrick, senior vice commander of Phelps Camp Jos 65, Sons of Union Veterans, opened the proceed-ings to honor Keeling, who was honorably discharged toy months before the war ended in March 1865. Patrick was among several with the Sons of Union Veterans at the ceremony, along with a number of representatives of Daughters of Union Veterans, Mary Whitney Phelps Tent No. 22.

The Keeling family bought 160 acres east of the cemetery along Route W in 1906. Keeling passed away in 1909 and is buried in the cemetery, along with his wife, Mary, son Oscar, daughter Nettie and twin grandsons Billie and Ioe.

At Saturday's event, Keeling's greatgreat-granddaughther Tammy Soverns

explained how she made efforts to secure a historically accurate headstone for her descendant. "The idea of Thomas and part of his

family here without headstones trou-bled me," Soverns said. "It has been a whirlwind of activ-

ity to plan and organize, but with everyone's help, I think it has all come together great. ... Thomas, you finally together great. ... Thomas, you finally have a headstone," she concluded.

Phelps Camp participated in two area parades on the weekend of November 10-11. On Saturday, November 10, members of Phelps Camp formed a Civil War colorguard and portrayed General and Mrs. Ulysses S. Grant for the Springfield parade. The new, 1.3 mile parade route was lined with spectators, many of whom applauded and cheered the "boys in blue," the Stars and Stripes and the Grants. On Sunday, November 11, camp members formed the "Parade of the American Soldier" unit for the Branson parade. Despite threatening weather, the stalwart members of Phelps Camp "soldiered on" and were within sight of the end of the parade route when it started to rain. A very large crowd of spectators thoroughly enjoyed our entry, and cheers and applause rang out all along the route.

## <u>Westport Camp #64 – Kansas City, Missouri</u>

#### **Battle of Island Mound Dedication**

Westport Camp #64 and Grant Camp #68 members attended the dedication and ribbon cutting ceremony of the Battle of Island Mound State Historic Site on Saturday, October 27, 2012. The dedication coincides with the 150th anniversary of this Civil War battle in Sauthwest Missouri

Southwest Missouri.

Long before the Emancipation Proclamation, Captain Ward had organized freed slaves from Missouri and Arkansas into the 1st Kansas Colored Volunteers Infantry. In August

1862, the 1st Kansas had not yet been accepted into federal service but was ordered to Bates County, Missouri with the 5th Kansas Cavalry to patrol for Confederate guerilla

forces. In an unexpected encounter, 250 Union and 350 Confederate soldiers clashed on October 29, 2012 in a skirmish until the Confederates were forced to withdraw.

Historians agree the battle had little military significance, neither side gained territory or advantage over the other. However, it was an historical moment and first occurrence in the Civil War of African-American soldiers in combat. The Confederate government was outraged at the image of former slaves taking arms against the south, and ordered no quarter given to black soldiers or white officers commanding them. In contrast, the Union Army recognized the military effectiveness of the troops and accepted the 1<sup>st</sup> Kansas into federal service. They were reorganized two years later as the 79th United States Colored Troops.

#### McPherson Camp #1 – Little Rock, Arkansas



The James McPherson Camp supported several monument dedications in the central Arkansas area. On September 8, Camp members attended the dedication of a battlefield marker n Searcy, AR, noting the location where Federal troops attempted to cross the White River in the spring of 1862 during MG Samuel Curtis' unsuccessful campaign to take Little Rock, as well as a grave marker dedication later in the day for Confederate General Dandridge McRae.

October 21st saw the camp march to Batesville, AR, to assist with dedicating a grave marker for Sergeant Charles Case, a former slave and member of the 5th Arkansas Colored Troops, and later a prominent Batesville citizen. On

Robert Petrovic currently serves on the Council, but his term expires this year and will choose not to seek reelection.

#### **History Corner**



From the *Alton Telegraph* Nov 15, 1883 Gen. Sherman's Reception

St. Louis, Nov. 13. – Gen. W.T. Sherman arrived here yesterday morning and proceeded immediately to his residence, 912 Garrison avenue. There was not any band playing "See, the Conquering Hero Comes"; no ostentation whatever, and the old soldier passed the day in the house, which was being put into shape for housekeeping purposes. He was practically undisturbed, only a few old friends calling upon and shaking hands with him.

At 7 o'clock in the evening the members of the various posts of the Grand Army of the Republic assembled at West St. Louis Turner hall [27<sup>th</sup> and Morgan Sts.]. There were present Frank Blair post, under Maj. Eugene F. Weigel; Gen. Lyon post, under Gov. Thos. C. Fletcher; Hassendeubel post, under Capt. Niederweiser; Harding post, under Capt. H.B. Keone; a detachment of veterans under Col. David Murphy, and Fletcher post from DeSoto, Mo. The entire body was under command of Col. Nelson Cole, and his adjutant, S.O. Fish. The assemblage of veterans numbered something like two or three hundred. Forming into line, and headed by the Arsenal band, the soldiers marched to the residence of Gen. Sherman, where, notwithstanding the cold weather, quite a crowd of people not of the Grand Army had gathered. Arrived at the residence the soldiers were drawn up in line facing the house, and the band, surrounded by torchbearers, rendered some excellent music. At the conclusion of the music the door of the general's residence opened and "Old Tecumseh," accompanied by Gens. Harney, Smith and Noble, Maj. Pope and Mr. Fitch and a few others, stepped out on the porch. The commanding officers of the various posts had ranged themselves at the gate, and ex-Gov. Fletcher, stepping forward, delivered the

#### ADDRESS OF WELCOME.

He said the soldiers of St. Louis and vicinity who had served in the national forces, organized now in fraternity, had authorized him to welcome him home, not only upon their part, but upon the part of the people of this commercial and manufacturing centre, the very heart of the republic. They came to welcome him back to his home to rest upon the laurels he had so faithfully won. They desired to express to him their esteem and their confidence and the hope that he might be granted a long life of strength and prosperity. They came to voice their affection and the pride the entire country had in the great soldier, the commander of the army of the Republic. They came to report to him and to assure him that they would be encamped about him until the campaign of life should end.

#### GEN. SHERMAN'S REPLY,

Gen. Sherman then, standing on the porch bare-headed, replied to the address very calmly. Calling them comrades and neighbors, he said he was glad to know that they welcome him back again to St. Louis. It was not the first time that he had made St. Louis his home. Before many of those present were born he had come here to buy pork and flour, taking the place of the venerable Gen. A.J. Smith who sat by his side. In 1861, when the growlings of civil war was heard all over the land, he came here again. They used to meet at the Planters' mutually suspicious of each other. Then he was summoned to the field by the president to fulfill the oath he had recorded in heaven to protect the country against all enemies from abroad or at home. "How I fulfilled that oath," he said, "I think you boy all know." He hoped they would live long and prosper and build on a sure foundation. The time was when the country was an arch from Massachusetts to Georgia then the arch grew and Pennsylvania became the Keystone state. The arch was no longer a single arch, but a grand arch reaching to far-off Alaska, California, Maine, and Florida, and this was the keystone. He came back to reside among them full of pleasant memories of the past and bright hopes for the future and would as cordially welcome one of his old friends from Louisiana as one from Massachusetts, as all was now a common Union. He wished them all a long life and while he could not hope to live as long as many among those present he would continue to watch the progress of the city and the country and the people. Many of his old friends had passed away but others of their race remained and many old friends are still alive. In conclusion he thanked the boys again and assured them of his continued interest in their wellfare [sic], in their increasse [sic] in virtue, in their hospitality in the future. He said that his house and his home would always be open to them.

At the conclusion of the general's speech, the members of the Grand Army came forward, and he, standing on the steps, shook hands with them heartily, while the band in the street struck up "Way Down Upon the Suwanee River," which reminded some of the old vets and the general himself standing in the m\_\_\_\_\_, of the days "When We Were Marching Through Georgia."
