Only getting 2 bounce backs on emails went sent out. Checked officers on Form 22 against what we have and seems to be up to date.

Award committee report – held to new business

Department Activity Committee— Marty Aubuchon – No report

Department Encampment Committee – Ed Krieser– New books for encampment on table in room. Everything ready to go. [Walt's note- only two people signed up so far]

Vicksburg Monument Committee – Larry Dietzel – committee met twice, Don Palmer's report attached. Ribbon proposed (cost \$4.25/ea). Dale Crandell – Move to authorize \$1500 for medals, ribbons, brochures. Alan Heidbreder 2nd Passes. (Note: Some money can come from Past Commander's Fund, rest general revenue). Camps, Roundtables and other large groups may commit to buying block set of ribbons. Have until March 31 for them to give to Treasurer.

2019 Missouri National Encampment – EK can't deal with national committee chairman, Jim Crane. Springfield/Branson did not pan out. St. Louis may be option. Dissolve committee and restart committee with Bob Petrovic shooting for St. Louis. Grant camp has voted to front the effort if necessary.

Old Business:

HB53 Missouri Heritage Protection Act as written of this date – Rep. Love's bBill. Marty Aubuchon motions to support bill, despite some issues with some of the wording, Dale Crandell 2nd. Walt mentions that while supporting bill, there are issues as many Confederate monuments are not truly historical, but rather posit a one sided view. Mentioned marker in Arab, MO. Also mentioned that many older Confederate monuments present a Social Darwinist – Political View, and that those should not be considered historical. While the language protects them, we probably need to pass the bill and then work on refining it so a better definition of what is historical exists.

Minute approval: Commander Burd states will handle *ad seriatim* March 2016 meeting – passes; Dept Encampment – passes; October 2016 meeting- corrected by DC in two spots – Glen Alsop Oct 8 wedding date change. – passes.

New Business:

Walt called for people to look through **old computer and hard copies** for department orders, minutes, encampment reports so we can scan them and put on web. Website should serve as an archive of all our department activity.

Also Walt stressed that per capita is due and everyone needs to push their secretaries to get these in. Also if a PCC or PDC fails to get membership in on time, they lose their status and we have to go through a long procedure to get it back for them.

New Mo National Encampment Committee – Bob Petrovic - no new action as of yet

JRTOC Cadet of the Year Committee – Dale Crandell – covers what he has reported as attached

Awards Committee – Dale Crandell– do we want to do something with EADS award. Do away with Quarterly Report Requirement? Department Meeting Attendance? Someone from the camp attending department meetings was held to be important as this is a department award and recognizes working for department goals. Walt made motion to do away with Quarterly report criteria in the Eads Award so that camps are not penalized because their secretary isn't doing what is required, but to retain the report as a requirement for camps to submit. Dale Crandell 2nd Bob Petrovic abstains as his position is that the removal is supporting bad behavior.

Essay Competition Award –Dale Crandall as written. Walt suggests setting it up with Mo Humanities Council (he believes that is the right group that runs essay competitions) to choose history essay winner and we provide money to their winner. Walt to send Dale info on Humanities council – work sent back to committee.

By-Law Changes: Dale - Reduce amount of officers/committees actually listed in the by-laws and leave it to the commander to appoint the officers necessary. Dale and Marty speaking to the issue. General nods of head in agreement. This must be voted on in encampment.

Patriotic Instructor: Dale Crandell speaking as to what do we want PI to do. Report from-to national on yearly basis is a national requirement. Should he provide info of patriotic nature to camps? Unionist articles? Or are we treating it as a ceremonial position only?

Pilot year ROTC – Dale Crandell going to submit it to encampment as permanent award. Submittal deadline is too early. Can it be changed to May 15th and sent directly to department? Or a year late. Walt – what about camp giving out the dept. award? Could then have a June deadline for apps.

2018 Dept Encampment - Walt Busch mentioned that he and Sumner Hunnewell have come up with Lebanon - Bennett Spring State Park. The park charges \$100 for all day use of an enclosed shelter with kitchen. Restaurants in area. Can also rent condo/room or campsite at park. Plenty of hotels in area and park lodge is open for lunch. Needs to be decided by encampment. Commander to send out communiqué for other proposal.

Lincoln Memorial Day – JVC Sumner Hunnewell planning to attend. Commander assigning him to present wreath and have dept flag?

Senior Vice Commander Report 11 March 2017

Annual Awards Committee. The committee members are Marty Aubuchon, Glenn Alsop, and Larry Dietzel. Thanks to our Assistant Signals Officer Walter Busch, the updated award nomination forms with the new April 15th submission deadline are posted for:

- Blair Award
- Meritorious Service Award
- GAR Award
- Samson Show-Me Spirit Award

I'm planning a virtual-email meeting in late-April to select our Department awardees and consider two action items.

- 1. <u>Eads Award Form</u>. I'm asking the committee to review our award history with the new criteria where only two camps are qualifying, and recommending the committee reduce the requirements or consider a 'mulligan' option to skip one unattainable criteria. And do an administrative review-update of the form for items like the missing Form 41 Department Patriotic Instructor Report and determine if the application deadline should be moved from May 15th to April 15th to match the other award forms.
- 2. <u>History Essay Competition</u>. The Department's October Business Meeting tasked the committee to develop a high school history essay competition. I'll ask the committee to consider the enclosed pilot program, which is modeled after our JROTC competition and SAR's essay competition.

Bylaws Committee. The committee members are Marty Aubuchon, Ed Krieser, Don Palmer, and Brian Smarker. Due to the committee chair's procrastination, it has not meet. I'm planning a virtual-email meeting in early-May with a possible pre-Encampment meeting 3 June 2017 to consider several items:

- 1. Youth Protection Policy. I'm asking the committee to finalize a youth protection policy to meet the intent of General Order #11, dated 3 January 2017 and General Order #22, dated 15 June 2014, to be placed in our Department's Policy & Procedures Manual instead of our Department's Bylaws (see attached draft).
- 2. <u>Wearing Membership Badges</u>. I'm asking the committee to consider removing wearing membership badges from the bylaws since it is covered in the P&PM (see attached draft).
- 3. <u>Appointed Officers</u>. I'm asking the committee to simplify the appointed officer list to just those mandated by the National Order, allowing the Department Commander and P&PM flexibility and an easily means to add, delete, and consolidate other appointed officers (see attached draft).

- 4. <u>Committees</u>. I'm asking the committee to simplify the standing committee list to just those with active program. This leaves the Department Commander and Encampment the option to use Special Committees to develop new programs (see attached draft).
- 5. <u>Patriotic Instructor</u>. I'm asking the committee to develop recommendations on the future role of the Patriotic Instructor: is it a ceremonial office like the guide and guard; is it a hybrid ceremonial-working office like the chaplain; or is it a working office like the Signals office with oversite programs like ROTC and Eagle Scout awards.



PCinC Don Palmer Jr – Vicksburg Monument Report

Brothers:

Unfortunately, I ran out of time before we headed out on vacation, so the Vicksburg Monument Committee report will be somewhat informal. As such I will not be attending the Department meeting on Saturday. Larry Dietzel will be the only member of the committee attending and will be able to fill in the blanks if there are any questions.

In summary, the planning is going well. Our committee has met twice this year....January 29 in Warrenton and March 5 in O'Fallon...but have been communicating regularly via e-mail. As has already been published, the re-dedication of the Missouri Monument at Vicksburg will take place on Saturday, May 27 at 1 pm. We have been getting excellent cooperation from the National Park Service and the Friends of Vicksburg organization. Some of the highlights of the planning so far:

- Challenge coins you are already aware that challenge coins have already been produced to commemorate the event. The superintendent at Vicksburg was interested in stocking some coins prior to the event, but he is waiting to hear back from his marketing director to see if that can be done. He was also going to get a formal answer for us on our interest in selling the coins at the park on the weekend of the event.
- Ribbons we are proposing to produce a number of ribbons to further commemorate the event. The coins produced really didn't capture the essence of the event....100th anniversary re-dedication. These ribbons will serve that purpose. Brother Dietzel will have the details at the meeting and a proposed cost.
- Commemorative program books we are proposing to produce a 10-16 page program book that provides details on Missouri's involvement in the battles and siege, details on the monument itself and the original dedication, and the agenda for the present day dedication. The chief of interpretation at Vicksburg has offered to help us with the historical details. Brother Dietzel will provide more details and a proposed cost to produce the booklets.
- Invitations a list of VIP's, including the governor and his staff, Missouri's US senators and US house reps and the Missouri general assembly. The National Park Service offered to send their own invitations to these individuals in addition to ours to further encourage their attendance.
- Musket and Artillery displays the superintendent did not want us to do black powder displays due to safety issues, but offered to coordinate with the local National Guard unit to bring a modern day artillery piece if we wanted a salute. Actually, during the original dedication in 1917, a modern day (at that time) artillery piece was used to fire a salute...not a Civil War era artillery piece.
- Music Brother Dietzels wife, who is a recognized singer, offered to sing at the event. The Friends of Vicksburg offered to help us find a local choral group or instrumental group if we wanted to pursue a broader musical performance.
- Stage, sound system, chairs the ranger staff at Vicksburg will have all of this set up for us.
- Special event for Missourians the night before the Friends of Vicksburg offered to work with the Chamber of Commerce to have a barbeque Friday night before at an antebellum mansion in old town Vicksburg. This is similar to what was done for the lowa group prior to re-dedication of their monument in 2013. But we need to get them a ballpark figure on how many will be down the night before and want to attend this event. They would like a rough number by mid-April. We will be seeking RSVP's from all

Camps with numbers of their groups planning to attend, including family, friends, etc. The committee is preparing a registration form to be distributed to Camps within the next two weeks to help in this endeavor.

- On-site coordination - the superintendent requested that some of our committee come down to Vicksburg during the first week in May for some advance scouting and to finalize the details with the National Park Service and Friends of Vicksburg. He also requested that one or two of us come down a couple of days before the event to make sure everything is in place.

These are the key highlights of the planning to date. As mentioned before, Brother Dietzel will be available to answer questions and provide more details if required. It is shaping up to be a memorable event.

AN ACT

To amend chapter 253, RSMo, by adding thereto one new section relating to historic preservation.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 253, RSMo, is amended by adding thereto one new section, to be known as section 253.414, to read as follows:

253.414. 1. This section shall be known and may be cited as the "Missouri Heritage Protection Act".

- 2. As used in this section, the following terms shall mean:
- 4 (1) "Council", the Missouri advisory council on historic preservation;
- 5 (2) "Department", the department of natural resources;
 - (3) "Designated veterans' grave marker", any veteran grave marker that has been determined by a majority vote of the council to be of sufficient historical military significance to be designated for inclusion in the registry;
 - (4) "Historic property", as defined under section 253.395;
- 10 (5) "Historic site of significant military history", all sites currently recognized by 11 the department as state historic sites with designations that are based, at least in part, on
- 12 their significance to Missouri military history; these may include, but shall not be limited
- 13 to, the Battle of Athens state historic site, the Battle of Lexington state historical site, the
- 14 Confederate Memorial state historic site, the Fort Davidson state historic site, and sites in
- 15 honor of the French and Indian War, American Revolution, War of 1812, United States-
- 16 Mexican War, the War Between the States, Spanish American War, the Mexican border
- 17 period, World War I, World War II, the Korean conflict, the Vietnam War, Operation

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

Urgent Fury (Grenada), Operation El Dorado Canyon (Libya), Operation Just Cause 19 (Panama), Operation Desert Shield/Desert Storm (Persian Gulf War I), Operation 20 Enduring Freedom (Afghanistan), and Operation Iraqi Freedom (Persian Gulf War II);

- (6) "Historical marker program", the program conducted by the council that qualifies any marker for which the design and narrative has been voluntarily submitted and approved by the council; is erected on state, municipal, or private property under procedures adopted by the council; and which commemorates the marking of the locations of sites, persons, and events significant in the history of Missouri including, but not limited to, military history;
- (7) "Marker", any marker identified and recognized by the historical marker program;
- "Military monument or memorial", any monument, memorial, object of remembrance, or other designation, including a statue, portrait, plaque, seal, flag, symbol, building name, street name, historic site, or other real estate name, that:
- (a) Honors a citizen or group of citizens of Missouri or honors a person or group of persons for military or war-related service conducted within or in the name of or on behalf of the state of Missouri or honors the soldiers as identified in section 253.110, or honors military veterans of the United States of America; and
- (b) Is located and has been continuously, repeatedly, or permanently displayed in the state for a period of time exceeding two years or that has been included in the registry;
 - (9) "Park", as defined under section 253.010;
- (10) "Permitted public ceremony", any act or series of acts by individuals, groups, or organizations that have been conducted by practice or tradition or as may be requested by individuals, groups, or organizations and approved by the council, after August 28, 2017, including temporary grave decorations, reenactments, meetings, or gatherings to honor and recognize a citizen or group of citizens as identified in paragraph (a) of subdivision (8) of this subsection;
- (11) "Registry", a list of all state historic military monuments or memorials, markers, and designated veterans' grave markers that are located on state, municipal, private, or other land that have been voluntarily submitted and approved by the council for inclusion on the registry or statutorily designated monuments or memorials adopted by the general assembly for statutory inclusion on the registry. No site shall be designated and included on the registry without the written consent of the landowner or landowners in recordable form sufficiently describing the site so that it may be located on the ground. Such consent shall be recorded in the deed records of the county in which the land is

(12) "Statutorily designated monument or memorial", any monument, memorial, or other designation, including a statue, portrait, plaque, seal, flag, symbol, building name, street name, historic site, or other real estate name that is adopted by the general assembly for statutory inclusion on the registry.

- 3. No agency, political subdivision, or entity with the power of eminent domain shall relocate, rename, rededicate, erect, modify, remove, or otherwise disturb any state historic military monument or memorial, any marker, any designated veterans' grave marker, or any statutorily designated monument or memorial on any site under the control of the department or otherwise located on state lands which are listed on the registry or amend any practice of permitted public ceremony on any registered state historic site without holding a public hearing and without a majority vote of the council approving the action to relocate, rename, rededicate, erect, modify, remove, or otherwise disturb any state historic military monument or memorial, any marker, any designated veterans' grave marker, or any statutorily designated monument or memorial, or any practice of permitted public ceremony on any state historic site. Prior to any such public hearing and vote of the council, the department shall provide public notice of the hearing, which notice shall be published in the Missouri Register at least sixty days prior to any action to seek the council's approval to relocate, rename, rededicate, erect, modify, remove, or otherwise disturb any such state historic military monument or memorial, any marker, any designated veterans' grave marker, or any statutorily designated monument or memorial or amend any practice of permitted public ceremony on any state historic site, and the department shall publish a notice of such hearing once a week for two consecutive weeks in any newspaper qualified under section 493.050 to publish legal notices in the local area containing the site. The second notice shall be published at least ten days before the hearing is scheduled.
- 4. The provisions of subsection 3 of this section shall not apply to any agency, political subdivision, or entity responsible for maintaining any state historic military monument or memorial, any marker, any designated veterans' grave marker, or any statutorily designated monument or memorial from taking proper and appropriate measures and exercising proper and appropriate means for the protection, preservation, care, repair, or restoration of such historic military monument or memorial, marker, designated veterans' grave marker, or statutorily designated monument or memorial.
- 5. The provisions of subsection 3 of this section shall not apply to actions undertaken by the Missouri department of transportation.
- 6. (1) Any decision made under this section by the council may be appealed and in such instance shall be reviewed by the joint committee on administrative rules.

American Civil War Historical Essay Competition

Purpose. This program provides a competition among high-school level students to annually select an outstanding American Civil War Historical Essay. The program's stated objectives are to:

- 1. Build stronger relationships between the SUVCW and local high schools;
- 2. Provide enriched programing for our SUVCW Camps and program support for our schools;
- 3. Support the SUVCW's education objective by bringing Civil War history to high schools;
- 4. Support the SUVCW's patriotism and citizenship objective by rewarding high school students that explore the American history and heritage;
- 5. Improve the SUVCW's charitable work; and
- 6. Establish a pilot program for a SUVCW national competition.

Eligibility. This competition is open to any high-school student, grades 10 through 12.

- 1. Student must be enrolled and in good standing with a public, private, or parochial school within the geographic boundaries of the SUVCW Department of Missouri.
- 2. Student may only apply once in a single academic year.
- 3. Student's teacher, counselor, or principal must support the student's nomination by signing the application form.

Process. The steps for a high school student and SUVCW Camp to participate in the competition are intentionally simple:

- 1. The student must compose an original essay of 800- to 1,200-words on a topic important to events before, during, and after the American Civil War.
- 2. Each school may nominate only one student essay from its student population. Selection is at the discretion of the school.
- 3. For the school's selected student essay, the student or school most complete the one-page application form accompanied by the typed essay, which is submitted to the SUVCW Camp sponsoring that school. Where there is no local Camp sponsor, schools may submit their nominations directly to the Department's Patriotic Instructor (pi@suvcwmo.org).
- 4. Each Camp may nominate one student for the competition from among the schools they sponsor. For schools not sponsored by a Camp, the Department's Patriotic Instructor may select one student essay to advance in the competition.
- 5. Each Camp forwards their one student essay with the application form to the Department's Essay Selection Committee. Deadline to receive Camp nominations: April 15th.
- 6. The Department Essay Selection Committee selects the outstanding American History Essay by May 15th.
- 7. The selected student and family are invited, but not required, to the Department Encampment for presentation of the award.

Essay Selection Committee. The Department Commander will appoint an Essay Selection

Committee, with a preference for SUVCW members that are historians, or past or present school educators. The Department's Patriotic Instructor is a non-voting member of this committee.

Award. The Department's award for the outstanding American Civil War Historical Essay includes:

- 1. A \$200 prize.
- 2. A SUVCW essay medallion.
- 3. A SUVCW certificate unique to the award and Department of Missouri.

Bylaws Committee Agenda

These are draft changes for the Bylaws Committee's consideration.

Wearing Membership Badges. The requirement to wear membership badges is covered in the current P&PM making the Bylaws section redundant.

Article II – Meetings

Section 5. A quorum of members of the Department is met by those present and entitled to vote when the meeting was called following any of the above procedures. A member needs to have his membership card and present it when requested at the start of the meeting. The member should wear his membership badge or the appropriate Camp Commander's badge. Past Department Commanders may wear the membership badge or the past Department Commander's badge.

Section 6. All elected officers must wear their membership badge or appropriate Camp Commander or Past Department Commander's badge. The Department Commander must wear the Department Commander's badge. Any elected officer not wearing a badge is subject to a \$10.00 fine, payable to the Department Treasurer.

¶ 100 Membership Badge. All elected and appointed Department Officers and Past Department Commanders must wear at least one of their SUVCW membership or officer badges at Department Encampments and Business Meetings. A Department Officer or Past Department Commander violating this policy may be assessed a \$10 fine, payable to the Department's Past Commander Fund.

Appointed Officers. The appointed officer list is reduced to the minimum required by the National Order with the intent that a Department Commander and the P&PM have flexibility to add, delete, and consolidate other appointed officers.

Article III - Officers and Their Duties

Section 2. The Commander, after his election, shall appoint other officers for the term of one (1) year as per the C&R. The appointed officers shall include, but not be limited to, the following: Patriotic Instructor, Chaplain, Counselor, Historian, Graves Registration Officer, Camp Organizer, and Civil War Memorials Officer. The Commander may also appoint Chief of Staff, GAR Records Officer, Signals Officer, Eagle Scout Coordinator, ROTC Coordinator, Medal of Honor Records Officer, Historical Records Coordinator, Archivist of Records, Marketing & Promotions Officer, Missouri Unionist Editor, Encampment Site Committee Members, Guide, Color Bearer, Guard, and any other positions required by the C&R, these bylaws and/or the Order's Ritual and Ceremonies.

Section 2. The Commander, after his election, shall appoint other officers for the term of one (1) year as per the C&R. The appointed officers shall include, but not be limited to, the following: Patriotic Instructor, Chaplain, Counselor, Historian, Graves Registration Officer,

GAR Records Officer, Camp Organizer, Color Bearer, Guard, and Guide. The Commander may also appoint any other positions required by the C&R, these bylaws, or the Order's Ritual and Ceremonies.

Standing Committees. The standing committee list is reduced to just those with active programs. All other committee work will need to utilize special committee appointed by the Department Commander and Encampment, or established by the P&PM.

Article VIII Department Committees

Section 1. The Standing Department Committees shall be as follows: Bylaws, Legislative, Membership, Awards, and Encampment Site Graves Registration, Civil War Memorials, G.A.R. Records, Sons of Union Veterans /Sons of Veterans (S.U.V./S.V.) Records, Camp Organizer, Marketing & Promotions, and Communication and Technology. Said chairmen of said committees may appoint brothers to assist them in their Department functions at their discretion.

Section 2. Special Committees may be created by action of the Commander or Department Encampment and shall exist for the period of time designated in the creation thereof. Duties and responsibilities shall be defined at the time of Committee creation.

Section 3. All Standing and Special Committees shall, except as where otherwise noted, consist of brothers of the Department of Missouri in good standing within their respective camps. The Commander shall appoint the Chairman of each Committee unless otherwise specified. The Commander shall serve member ex-officio on all Standing and Special Committees, unless otherwise noted.

Section 4. The Bylaws Committee shall be chaired by the Senior Vice Commander and shall review these Bylaws in even years, bringing any necessary revisions to the attention of the Department membership.

Section 5. The Legislative Committee shall keep itself informed of all legislation which may be introduced in the Missouri State Legislature, of such nature as to affect the interest of this Order and / or the Other Allied Orders of the Grand Army of the Republic, or the patriotic interests of the people, and may recommend to the Camps, subject to the approval of the Department Commander, any action that the committee deems advisable or expedient, The Legislative Committee shall consist of the Department Commander, Secretary, and three other brothers of the Department appointed by the Commander.

Section 6. The Membership Committee shall be chaired by the Junior Vice Commander and shall consist of all Camp Junior Vice Commanders. The purpose of the committee shall be to put forth proposals and implement programs for the recruitment of brothers into the order.

Section 7. The Graves Registration Committee shall seek and identify all graves of Civil War veterans in the State of Missouri. The Committee shall bring to the attention of the Department any disrespect or lack of maintenance shown to any Civil War grave. The Committee shall be chaired by the Graves Registration Officer.

Section 8. The Civil War Memorials Committee shall seek, locate, catalog and promote the preservation of all monuments and memorials to Civil War veterans within the State of Missouri. The Committee shall be chaired by the Civil War Memorials Officer.

Section 9. The GAR records Committee shall seek, locate and catalog all GAR records within the State of Missouri. The Committee chair shall be the GAR Records Officer. Section 10. The Communications and Technology Committee shall advise officers and committees about the latest computer and related technologies pertinent to the Department. The Committee shall be chaired by the Signals Officer.

Section 11. The SV/SUV Records Committee shall seek, locate and catalog all SV/SUV Records within the State of Missouri. The Chairman may appoint additional brothers to assist him as needed.

Section 12. An Annual Awards Committee, consisting of the last 3 Past Department Commanders and chaired by the Senior Vice Commander, shall oversee the process to nominate and present awards to Camps, brothers, and people outside the Order who are worthy of the awards presented by the Order. They shall review the current rules governing each award and may recommend modifications to the criteria for future awards. The Secretary, Treasurer and other Past Department Commanders may act in advisory capacities to this Committee.

Section 13. The Marketing Committee shall seek, propose, and with approval initiate ways to promote the Department of Missouri and its Camps. The Chairman may appoint additional brothers to assist him as needed, except that the Junior Vice Commander because of his role as Chairman of the Membership Committee shall be a member of this Committee also. The Committee shall be chaired by the Marketing & Promotions Officer.

Section 14. The Encampment Site Committee, consisting of at least two (2) members appointed by the Department Commander, shall find potential meeting locations for the Department Encampment, investigate costs, make arrangements, and report their actions at a regular business meeting. The Encampment Site Committee shall strive to rotate the Department Encampment location. Any Camp that would like to make arrangements will forward their request to the Encampment Site Committee for consideration.

Outstanding JROTC Cadet Competition

Purpose. This program provides a competition among high-school level JROTC Units to annually select an Outstanding JROTC Cadet. This program is an enhancement of the existing SUVCW ROTC/JROTC awards program with the stated objectives to:

- 1. Build stronger relationships between the SUVCW and local high schools;
- 2. Provide enriched programing for our SUVCW Camps and program support for our JROTC Units;
- 3. Support the SUVCW's education marketing objective by bringing Civil War history to high schools;
- 4. Support the SUVCW's patriotism and citizenship marketing objective by rewarding high school students pursuing military and public service;
- 5. Improve the SUVCW's charitable work; and
- 6. Establish a pilot program for a SUVCW national competition.

Eligibility. This competition is open to any high-school JROTC cadet. College-level ROTC cadets and midshipmen are not part of this program.

- 1. Cadet must be enrolled and in good standing with a JROTC Unit at a high school within the geographic boundaries of the SUVCW Department of Missouri.
- 2. Cadet must be the recipient of the SUVCW's ROTC medal for the current year, which is selected by the local JROTC Unit senior military instructor.
- 3. JROTC Units senior military instructor must support the cadet's nomination by submitting a summary of the cadet's accomplishments.

Process. The steps for a high school JROTC cadet and SUVCW Camp to participate in the competition are intentionally simple:

- The JROTC cadet must be a recipient of a SUVCW ROTC medal for his/her high school JROTC unit in the current, sponsored by the local SUVCW Camp or SUVCW Department.
- 2. The JROTC unit must provide a 100- to 300-word summary of the cadet's accomplishments. A simple email text is sufficient but the SUVCWMO Form 7 can be used.
- 3. Each Camp may nominate one cadet for the competition from among the JROTC high school units they sponsor. For JROTC Units sponsored by the Department, the Department ROTC Coordinator may nominate one cadet.
- 4. Submit the Camp's nominee with the JROTC unit's 100- to 300-word summary to Department's ROTC Coordinator. Deadline to receive Camp nominations: April 15th.
- 5. A JROTC Selection Committee selects the Outstanding JROTC Cadet by May 15th.
- 6. The selected Outstanding JROTC Cadet and family are not required to attend, but are invited to the Department Encampment for presentation of the award.

Selection Committee. The Department Commander will appoint a JROTC Selection Committee, with a preference for SUVCW members that are military veterans, ROTC/JROTC

alumni, or past or present school educators. The Department ROTC Coordinator is a non-voting member of this committee.

Award. The Department's award for the Outstanding JROTC Cadet includes:

- 1. A \$200 prize.
- 2. The SUVCW medal and ribbon bar with a bronze leaf (Army and Air Force) or bronze star (Navy and Marine Corps).
- 3. A SUVCW certificate unique to the award and Department of Missouri.

The SUVCW sponsors an ROTC award program that honors a cadet selected by the local ROTC-JROTC unit's senior military science instructor who "shows a high degree of patriotism to his/her Nation and has demonstrated a high degree of academic performance and leadership." The award includes a medal, ribbon bar, and certificate provided at no cost by the National Order. This nationwide ROTC award program is one of our best community outreach programs and a rare opportunity for a local camp to connect to area colleges and high schools.

Best continued growth practice for this worthy program is for the Department to stabilize the local camp and ROTC-JRTOC unit partnerships in Missouri, focus on ROTC unit recruitment in Arkansas, expand Department assistance for Arkansas locations not near a camp, and set new three-year goals:

Three-Year Goals

- Goal 1: 90% camp participation
- Goal 2: 90% ROTC unit participation
- Goal 3: 40% JROTC unit participation
- Goal 4: 50% JROTC Outstanding Cadet program participation

Youth Protection Policy

This policy statement is proposed for inclusion in the Department's Policy & Procedures Manual to meet the intent of General Order #11, dated 3 January 2017 and General Order #22, dated 15 June 2014:

¶ 105 Youth Protection. All Brothers and guests under the age of 18 years of age shall be accompanied by a parent, legal guardian, or chaperon when participating at any SUVCW Department event. A chaperon must be 18 years of age or older, and have written authorization from a parent or legal guardian.

All Brothers must comply with all applicable laws pertaining to child abuse. Any Brother who witnesses or suspects any type of physical, mental, or sexual abuse of any other Brother or guest under the age of 18 is obligated to report such suspensions to local authorities and the Department Commander.

Every Brother who may have direct contact with or oversight of another Brother or guest under the age of 18 (other than their child) at a SUVCW Department event must complete a child protection course offered by a government agency or other reputable source. Evidence of course completion must be provided to the Department Commander.

Each Camp shall establish their youth protection policy and procedures for their Camp events.

Recommendations:

- 1.) That the roll call of deceased brothers as took place at the beginning of this encampment be written into the policy manual to be included at all future Department Encampments.
- 2.) That the flag stands for the U.S. and Department flags be replaced with new stands and the old stands be loaned or sold to any camp that needs them. The old stands are bulky, worn, and the gold paint is coming off.
- 3.) That the flag holder for the Department flag be repaired or replaced. There is a 1" hole in the bottom where a pole keeps falling out of the holder. Duck tape could be used if nothing else, but the hole could possibly be sewn...
- 4.) That the Department forms a committee tasked with building and dispensing a benevolent fund. We zeroed out the fund to help a brother this year (\$118.00), and there is no replenishing mechanism for the fund at this time. The fund could be used for cards and flowers as well as assisting brothers in need. This committee would also need to formulate a policy for use of the fund to be included in the policy manual.
- 5.) That the Department purchases at least two archival storage tubes of the size needed to store revoked charters. We can then repurpose the frames with charters for new camps and reduce bulk and potential breakage in Quartermaster's inventory.
- 6.) That the Department forms a Veterans Committee tasked with creating a Department-wide program for providing services for living veterans. This committee would need to come up with possible activities to assist living veterans, a system for recording service hours, and possibly a recognition system for brothers who complete so many hours of such service.
- 7.) This recommendation is not in response to this year's recipient. That recipients of the Blair Award, being that it must be awarded every year to the most outstanding brother for that administrative year, be eligible again for the award after a five year period which includes the year the award was received. Example: if received in 2015, recipient would be eligible to receive the award again in 2020. Without this change, we might run into a point in the future where the mandatory recipient was not only NOT the most outstanding brother in that administrative year, but not the 1st or 2nd runner up either.

Department Awards. Updated the Policy & Procedures Manual and application forms for the Department's four awards. With assistance from our Assistant Signals Officer Walter Busch, the new forms are posted:

- Blair Award
- Meritorious Service Award
- GAR Award
- Samson Show-Me Spirit Award

Only two Camps are qualifying for the Eads award under the new criteria, which led to emails among the Department officers and discussions at the Department's March Business Meeting. However, the Department's Awards Committee was not able to address this topic. The enclosed update is offered as an alternative to a committee recommendation.

Recommendation 1. Authorize revisions to the James B. Eads Award contained in Form 710 draft document, including updates to the Policy & Procedures Manual.

History Essay Competition. The Department's October Business Meeting tasked the Awards Committee to develop a high school history essay competition. However, the committee was not able to address this topic. Brother Jim Stebbings, Grant Camp, provided extensive research and well crafted program proposals for the Department to sponsor a \$200 prize within the National History Day in Missouri competition. The enclosed proposal is offered as an alternative to a committee recommendation.

Recommendation 2. Authorize a pilot program to sponsor a \$200 prize within the National History Day in Missouri competition and as outlined in the American Civil War Essay proposal; and further recommend appointment of a Department Essay Coordinator to develop and administer the program.

American Civil War Essay Competition

Purpose. This program sponsors a prize in the National History Day in Missouri competition administered by the State Historical Society of Missouri and Missouri Humanities Council. The prize recognizes a high-school student's essay on the American Civil War from the end of the War of 1812 through Post-Civil War Reconstruction period. Preference is given for Missouri's role in the American Civil War. The program's stated objectives are to:

- 1. Build stronger relationships between the SUVCW and local high schools;
- 2. Support the SUVCW's education objective by bringing Civil War history to high schools;
- 3. Support the SUVCW's patriotism and citizenship objective by rewarding America's youth that explore their American history and heritage;
- 4. Improve the SUVCW's charitable work; and
- 5. Establish a pilot program for a SUVCW national competition.

Eligibility. This competition is open to any high-school student, grades 10 through 12.

- 1. Student must be enrolled and in good standing with a public, private, or parochial school within the geographic boundaries of the SUVCW Department of Missouri.
- 2. Student must apply and compete within the National History Day in Missouri competition, meeting all of their eligibility and fee requirements.

Process. The steps for a high school student and SUVCW to participate in the competition are intentionally simple:

- 1. The SUVCW sponsors the annual \$200 prize and supplies judges if requested.
- 2. The student submits their original essay to the National History Day in Missouri, meeting their submission requirements and deadlines.
- 3. The National History Day in Missouri administers the competition and selects the annual recipient.

Award. The Department's award for the outstanding American Civil War Essay includes:

- 1. A \$200 prize.
- 2. A SUVCW essay medallion.
- 3. A SUVCW certificate unique to the award and Department of Missouri.



James B. Eads Award Department of Missouri Sons of Union Veterans of Civil War Application Form



The James B. Eads Award is presented annually to Camps in the Department of Missouri, Sons of Union Veterans of the Civil War, who distinguish themselves in carrying out the aims of the order in their local community and interactions with other Camps, the Department, and the National Order. Camps must document their activities and meet minimum thresholds to be eligible. The application period runs April 1st thru March 31th. Each qualifying Camp receives a ribbon streamer.

James Eads moved to St. Louis, Missouri as a young teenager and took odd jobs to sustain himself. Though Eads' formal education ended before he was 14, he learned mathematics and the sciences on his own. Eads' energy and inventiveness resulted in his becoming a prominent riverine engineer by the time of the Civil War and turned out to be an invaluable asset in helping the Union regain control of the Mississippi River.

To my knowledge, we have an additional Life Member, Alan Trodus from the Gen. Thomas C. Fletcher Camp #47.

I continue to find some camp offices and individual e-mail addresses / phone numbers to be invalid. I am unsure about how we can true this up. Often it takes multiple emails and follow-up phone calls to make sure the applicant is cared for. Camp JVCs may not be prepared or trained in their position or their role might be delegated to another.

Brother Joseph Rainey mentioned in an email that the Gen. James B. McPherson Camp No. 1 is

looking into starting a camp in and around Conway, Arkansas. I am unaware of any progress.

Scott Sarley wrote regarding the creation of a camp in Joplin, Missouri. I provided guidance but he is too busy with the SCV identifying Confederate graves in Jasper and Barton counties. He passed along information about a G. A. R. memorial (Find a Grave #41779789) in the Carterville Cemetery, Carterville, Jasper Co., Missouri, which is in need of cleaning up.

I plan on requesting another lot of tri-fold recruitment forms (SUVCW Form 70) from the National Quartermaster before the National Encampment in Lansing, Michigan. They will be made available to camps if they are retrieved at Department meetings, transferred via courier, or paid for by the camp (postage).

I continue to validate application genealogical information (when provided) as well as scan the application and proofs. These will be passed onto the next JVC to start a digital archive.

One of the JVC's responsibility is membership retention.

Recommendation: Continue to promote the Life Member option. The benefits include no per capita National dues or Department dues (under current by-laws). This is particularly attractive for those members 61 years or older. The Life Membership can be paid during a three-year period with up to three payments. It is pro-rated by age. See attached SUVCW Form 9.

The JVC should remove bottlenecks in member applications, many of which take months to move from the National JVC to the Department JVC.

Recommendation: The Department JVC should contact the Camp JVCs to see if they are prepared
to receive applications or if that procedure is another member's responsibility.

Finally, I have not made any progress on the Department's Membership-Camp Expansion Plan adopted at the Department October 2015 Business Meeting. Again, I would appreciation some help and direction in this area.

Subject: Missouri Monument @ Vicksburg Committee Annual Report

To: 22nd Missouri Department Encampment

In 2014, the Department of Missouri established a project to restore and ultimately re-dedicate the Missouri state monument at Vicksburg National Military Park (NMP). The Missouri monument, purchased by the state of Missouri, was originally dedicated in October 1917. Department Commander Glen Alsop appointed the committee, which consists of PCinC Don Palmer, serving as chairman, PDC Larry Dietzel and PCC Mark Coplin. PCC Gary Scheel joined the committee in 2015.

In our report at the Department Encampment last year, it was noted that the National Park Service was able to secure the \$385,000 needed to restore the monument due to elevation in priority relative to park service discretionary funding needs. The restoration began in early March 2016 and was completed by the end of last summer. Nearly all of the committee activities since the last Department Encampment have been working towards the re-dedication.

The committee first secured approval from the National Park Service to hold the re-dedication on Saturday, May 27, 2017. The park was keenly interested in this date due to the variety of activities held over Memorial Day weekend and the potential for attendance from general public visitors to the park, which is relatively large over Memorial Day weekend.

A challenge coin was designed and approved for production by the Department in December. The coin design had the Missouri state monument on one side and GAR PCinC Leo Rassieur, who was largely responsible for creation of the monument, on the other side. The total cost to produce 300 coins and ship totaled about \$900. The Department began selling the coins at a cost of \$10 each late Winter/early Spring 2017. The committee coordinated with Vicksburg NMP to determine if the Department could sell the coins on park property. The response was that sales of the coin on park property may only be done through their Eastern National affiliate under a consignment arrangement. An agreement was reached to sell the coins for \$6.25 each. As of this report, the Department sales totaled about 60 coins and the initial report from Vicksburg was that an additional 40 were sold under the consignment arrangement. Therefore, it appears that total revenue generated from the coins stands at about \$850, or \$50 shy of the break-even point.

The committee met a number of times throughout the Winter and Spring 2017 and weekly conference calls with Vicksburg NMP began in late February 2017. The committee presented the Department with several other ideas to support the re-dedication and a ceremony for the Missouri soldiers buried at Vicksburg National Cemetery. These included the production of commemorative ribbons, programs for the weekend events, certificates of appreciation for the park service personnel supporting the events and Missouri flags to be placed on the graves of the Missouri soldiers. The Department approved these actions and allocated an additional \$1500 to support them. The total expenses reported for these items totaled about \$880, well short of the Department allocation. Other miscellaneous costs originally envisioned by the committee were covered by the National Park Service.

The program came together well and almost everything requested by the committee was granted by the National Park Service. The notable exception was a request to fire salutes with black powder weapons and artillery, which was denied due to safety procedures required by the government. As such, Vicksburg NMP assisted us in securing the services of the Mississippi Army National Guard, who provided artillery salutes consistent with the original dedication in 1917.

In addition to the support from Vicksburg NMP, the Friends of Vicksburg and the Vicksburg Chamber of Commerce combined to provide a Friday night social/dinner for the arriving Missourians attending the re-dedication events on Saturday. This turned out to be a nice event with about 100 Missouri Sons of Union Veterans and Sons of Confederate Veterans and their families attending. A video of the original Peace Jubilee from 1917 that contained the Missouri Monument dedication was played for the attendees.

The re-dedication event on Saturday, May 27 went very well. The National Park Service estimated that about 200 Missourians and random park visitors attended the event. It was a hot day and the heat affected several people, but in general, everything went according to plan. The committee would like to thank Nora Dietzel, wife of PDC Larry Dietzel, who provided vocals for the National Anthem and her stirring rendition of An American Trilogy.

After the re-dedication, between 20-30 members attended a special ceremony at the National Cemetery for the Missouri soldiers buried there. Vicksburg NMP placed the Missouri flags purchased by the Department on the graves of the 260 known and 5 unknown soldiers from Missouri. PDC John Avery coordinated this ceremony, which followed the format of an 1880's GAR commemoration ceremony. The National Park Service thought that we were the first to honor a large group of soldiers from a given state at Vicksburg National Cemetery in the manner that we did.

As committee chair, I would like to personally thank PDC Larry Dietzel, PCC Mark Coplin and PCC Gary Scheel for all of their work in helping to make this all happen. This was truly a team effort and the success of re-dedication weekend can be attributed to this fact. I would also like to thank the aides to the committee: PDC John Avery and PDC Marty Aubuchon. They provided valuable support in developing the program for the National Cemetery observance and addressing logistical needs prior to the events.

Recommendations:

- The committee should be reappointed for another year to investigate possibilities in supporting Vicksburg NMP in cleaning/repairing the numerous red granite Missouri regimental markers.
- 2. Since there were funds remaining from the original \$1500 allocation, the Department should consider development of a commemorative booklet with details from the original dedication and the re-dedication events from this past weekend.

- 3. Missouri flags the Department owns 270 12" x 18" flags which will be shipped back to the Department this week. The Department should consider using these flags for ceremonies at other National Cemeteries around the country where large groups of Missouri Union soldiers are buried (e.g., Shiloh). Or consider dividing the flags amongst Missouri Camps to support their local activities in honoring Union veterans from Missouri.
- 4. Challenge coins the Department should consider selling the coins at the upcoming National Encampment in Lansing, MI. Sales at this event would push revenue beyond the break-even point.
- 5. Ribbons the Department should consider selling the remaining ribbons at various events. The original intent was to provide the ribbon to those attending the re-dedication free of charge. Since the cost per ribbon ended up less than \$2 each, maybe we could try and sell for \$3 each?

Bylaws Committee Report to the Department of Missouri Encampment 3 June 2017

The Bylaws Committee members are Dale Crandell (chair), Marty Aubuchon, Ed Krieser, Don Palmer, and Brian Smarker. The committee exchanged emails and dialoged at Department Business Meetings, but did not take actions or produce recommendations. As an alternative, listed here is a summary of the committee's general direction. Lacking the required 30 days noticed, the Department can only review these recommendations.

Preamble. The preamble needs updated to include Revenue Cutter Service and Marine Corps. Recommended revisions:

We, the descendants of soldiers, sailors or marines who served in the army or navy Army, Navy, Marine Corps, or Revenue Cutter Service of the United States of America during the War of Rebellion of 1861-1865, have joined this patriotic and fraternal order for the purpose and objects set forth by the National Organization, Sons of Union Veterans of the Civil War, and in so doing pledge ourselves to commemorate our forefathers' deeds, to render loyal service to our country, and to promote the maintenance of unqualified American citizenship with respect for and honor to the flag.

Youth Protection Policy. General Order #11, dated 3 January 2017 and General Order #22, dated 15 June 2014, requires a youth protection policy. Recommended wording for a new article XX – Youth Protection Policy:

Section 1. All Brothers and guests under the age of 18 years of age shall be accompanied by a parent, legal guardian, or chaperon when participating at any SUVCW Department event. A chaperon must be 18 years of age or older, and have written authorization from a parent or legal guardian.

Section 2. All Brothers must comply with all applicable laws pertaining to child abuse. Any Brother who witnesses or suspects any type of physical, mental, or sexual abuse of any other Brother or guest under the age of 18 is obligated to report such suspensions to local authorities and the Department Commander.

Section 3. Every Brother who may have direct contact with or oversight of another Brother or guest under the age of 18 (other than their child) at a SUVCW Department event must complete a child protection course offered by a government agency or other reputable source. Evidence of course completion must be provided to the Department Commander.

Section 4. Each Camp shall establish their youth protection policy and procedures for their Camp events.

Membership Badges. The requirement to wear membership badges is covered in the current P&PM making the Bylaws section redundant. Recommended edits to Article II – Meetings:

Section 5. A quorum of members of the Department is met by those present and entitled to vote when the meeting was called following any of the above procedures. A member needs to have his membership card and present it when requested at the start of the meeting. The member should wear his membership badge or the appropriate Camp Commander's badge. Past Department Commander's may wear the membership badge or the past Department Commander's badge.

Section 6. All elected officers must wear their membership badge or appropriate Camp Commander or Past Department Commander's badge. The Department Commander must wear the Department Commander's badge. Any elected officer not wearing a badge is subject to a \$10.00 fine, payable to the Department Treasurer.

Appointed Officers. The appointed officer list is reduced to the minimum required by the National Order with the intent that a Department Commander and the P&PM have flexibility to add, delete, and consolidate other appointed officers. Recommended replacement of Article III – Officers and Their Duties, Section 2:

Section 2. The Commander, after his election, shall appoint other officers for the term of one (1) year as per the C&R. The appointed officers shall include, but not be limited to, the following: Patriotic Instructor, Chaplain, Counselor, Historian, Graves Registration Officer, Camp Organizer, and Civil War Memorials Officer. The Commander may also appoint Chief of Staff, GAR Records Officer, Signals Officer, Eagle Scout Coordinator, ROTC Coordinator, Medal of Honor Records Officer, Historical Records Coordinator, Archivist of Records, Marketing & Promotions Officer, Missouri Unionist Editor, Encampment Site Committee Members, Guide, Color Bearer, Guard, and any other positions required by the C&R, these bylaws and/or the Order's Ritual and Ceremonies.

Section 2. The Commander, after his election, shall appoint other officers for the term of one (1) year as per the C&R. The appointed officers shall include, but not be limited to, the following: Patriotic Instructor, Chaplain, Counselor, Historian, Graves Registration Officer, GAR Records Officer, Camp Organizer, Color Bearer, Guard, and Guide. The Commander may also appoint any other positions required by the C&R, these bylaws, or the Order's Ritual and Ceremonies.

Committees. The committee list is reduced to just those with active programs. All other committee work will need to utilize special committees appointed by the Department Encampment, Department Commander, or established by the P&PM. Recommended edits to Article VIII Department Committees:

Section 1. The Standing Department Committees shall be as follows: Bylaws, Legislative, Membership, Awards, and Encampment Site Graves Registration, Civil War Memorials, G.A.R. Records, Sons of Union Veterans /Sons of Veterans (S.U.V./S.V.) Records, Camp Organizer, Marketing & Promotions, and Communication and Technology. Said chairmen of said committees Committee chairs may appoint brothers to assist them in their Department functions at their discretion.

Section 2. Special Committees may be created by action of the Commander or Department Encampment and shall exist for the period of time designated in the creation thereof. Duties and responsibilities shall be defined at the time of Committee creation.

Section 3. All Standing and Special Committees shall, except as where otherwise noted, consist of brothers of the Department of Missouri in good standing within their respective

camps. The Commander shall appoint the Chairman of each Committee unless otherwise specified. The Commander shall serve as ex-officio member on all Standing and Special Committees, unless otherwise noted.

Section 4. The Bylaws Committee shall be chaired by the Senior Vice Commander and shall review these Bylaws in even years, bringing any necessary revisions to the attention of the Department membership.

Section 5. The Legislative Committee shall keep itself informed of all legislation which may be introduced in the Missouri State Legislature, of such nature as to affect the interest of this Order and / or the Other Allied Orders of the Grand Army of the Republic, or the patriotic interests of the people, and may recommend to the Camps, subject to the approval of the Department Commander, any action that the committee deems advisable or expedient, The Legislative Committee shall consist of the Department Commander, Secretary, and three other brothers of the Department appointed by the Commander.

Section 6. The Membership Committee shall be chaired by the Junior Vice Commander and shall consist of all Camp Junior Vice Commanders. The purpose of the committee shall be to put forth proposals and implement programs for the recruitment of brothers into the order.

Section 7. The Graves Registration Committee shall seek and identify all graves of Civil War veterans in the State of Missouri. The Committee shall bring to the attention of the Department any disrespect or lack of maintenance shown to any Civil War grave. The Committee shall be chaired by the Graves Registration Officer.

Section 8. The Civil War Memorials Committee shall seek, locate, catalog and promote the preservation of all monuments and memorials to Civil War veterans within the State of Missouri. The Committee shall be chaired by the Civil War Memorials Officer.

Section 9. The GAR records Committee shall seek, locate and catalog all GAR records within the State of Missouri. The Committee chair shall be the GAR Records Officer. Section 10. The Communications and Technology Committee shall advise officers and committees about the latest computer and related technologies pertinent to the Department. The Committee shall be chaired by the Signals Officer.

Section 11. The SV/SUV Records Committee shall seek, locate and catalog all SV/SUV Records within the State of Missouri. The Chairman may appoint additional brothers to assist him as needed.

Section 12 5. An Annual Awards Committee, consisting of the last 3 Past Department Commanders and chaired by the Senior Vice Commander, shall oversee the process to nominate and present awards to Camps, brothers, and people outside the Order who are worthy of the awards presented by the Order. They shall review the current rules governing each award and may recommend modifications to the criteria for future awards. The Secretary, Treasurer and other Past Department Commanders may act in advisory capacities to this Committee.

Section 13. The Marketing Committee shall seek, propose, and with approval initiate ways to promote the Department of Missouri and its Camps. The Chairman may appoint additional brothers to assist him as needed, except that the Junior Vice Commander because of his

role as Chairman of the Membership Committee shall be a member of this Committee also. The Committee shall be chaired by the Marketing & Promotions Officer.

Section 14 6. The Encampment Site Committee, consisting of at least two (2) members appointed by the Department Commander, shall find potential meeting locations for the Department Encampment, investigate costs, make arrangements, and report their actions at a regular business meeting. The Encampment Site Committee shall strive to rotate the Department Encampment location. Any Camp that would like to make arrangements will forward their request to the Encampment Site Committee for consideration.

ROTC/JROTC Awards. Assistant National Quartermaster/ROTC Coordinator reports 57 ROTC medals were presented in Missouri-Arkansas; this is the fifth highest Department medal count. Grant, McPherson, Sherman, St. James, Westport, and the Department have shared their 31 ROTC/JROTC award presentations, which are listed below.

➤ **Recommendation 1**: that the Department recommends to the National Encampment for the Assistant National Quartermaster/ROTC Coordinator to publish the ROTC award presentations to the Department.

2017 JROTC Outstanding Cadet. Colton Kerr from Independence Chrisman High School's Army JROTC unit was selected as the Department's JROTC Outstanding Cadet. Only one camp submitted a nomination. This year's JROTC Selection Committee was appointed by Department Order #11 and consisted of Jim Martin, Westport Camp; Bill Groth, Sherman Camp; and John Avery, Grant Camp.

JROTC Outstanding Cadet Program. The Department's JROTC Outstanding Cadet competition has ran for two years, however only one camp is participating. The Department's March Business meeting recommended pushed back the submission deadline to May 1st for next year's competition, which was incorporated into revised program description.

Recommendation 2: authorize submission deadline change and continuation of the JROTC Outstanding Cadet competition for two years, 2018 and 2019.

ROTC Medals. The Department's has an inventory of nine ROTC medals-ribbon bars. Two were loaned to Tigers Camp #432 and one was presented to the 2017 JROTC Outstanding Cadet.

JROTC Outstanding Cadet Program

Purpose. This program provides a competition among high-school level JROTC Units that annually select a JROTC Outstanding Cadet. This program is an enhancement of the existing SUVCW's ROTC awards program with the stated objectives to:

- 1. Build stronger relationships between the SUVCW and local high schools;
- 2. Provide enriched programing for our SUVCW Camps and program support for our JROTC Units;
- 3. Support the SUVCW's education objective by bringing Civil War history to high schools;
- 4. Support the SUVCW's patriotism and citizenship objective by rewarding high school students pursuing military and public service;
- 5. Improve the SUVCW's charitable work; and
- 6. Establish a pilot program for a SUVCW national competition.

Eligibility. This competition is open to any high-school JROTC cadet. College-level ROTC cadets and midshipmen are not part of this program.

- 1. Cadet must be enrolled and in good standing with a JROTC Unit at a high school within the geographic boundaries of the SUVCW Department of Missouri.
- 2. Cadet must be the recipient of the SUVCW's ROTC medal for the current year.
- 3. JROTC senior military instructor must support the cadet's nomination by submitting a summary of the cadet's accomplishments.

Process. The steps for a high school JROTC unit to SUVCW Camp to participate in the competition are:

- 1. The JROTC cadet must be a recipient of a SUVCW ROTC medal for his/her high school JROTC unit in the current year, sponsored by a local SUVCW Camp or the Department.
- 2. The JROTC senior military instructor must provide a 100- to 300-word summary of the cadet's accomplishments. A simple email text is sufficient but the SUVCWMO Form 7 can also be used. Deadline to receive nominations from JROTC units: May 1st.
- 3. Each Camp may nominate one cadet for the competition from among the JROTC high school units they sponsor. For JROTC Units sponsored by the Department, the Department ROTC Coordinator may nominate one cadet.
- Submit the Camp's nominee with the JROTC senior military instructor's 100- to 300word summary to the Department's ROTC Coordinator. Deadline to receive Camp nominations: May 15th.
- 5. A JROTC Selection Committee selects the JROTC Outstanding Cadet.
- 6. The selected JROTC Outstanding Cadet and family are not required to attend, but are invited to the Department Encampment for presentation of the award.

Selection Committee. The Department Commander appoints a JROTC Selection Committee, with a preference for SUVCW members that are military veterans, ROTC/JROTC alumni, or past or present school educators. The Department ROTC Coordinator is a non-voting member of the committee.

Selection Criteria. The JROTC Selection Committee bases their decision on the 100- to 300-word summary of the cadet's accomplishments provided by the JROTC's senior military instructor. The committee can consider GPA or class standing, JROTC leadership and aptitude, and school and community involvement along with other information from the 100- to 300-word summary.

Award. The Department's award for the JROTC Outstanding Cadet includes:

- 1. A \$200 prize.
- 2. The SUVCW's ROTC medal and ribbon bar with a bronze leaf (Army and Air Force) or bronze service star (Navy and Marine Corps).
- 3. A SUVCW certificate from the Department of Missouri.

To my knowledge, we have an additional Life Member, Alan Trodus from the Gen. Thomas C. Fletcher Camp #47.

I continue to find some camp offices and individual e-mail addresses / phone numbers to be invalid. I am unsure about how we can true this up. Often it takes multiple emails and follow-up phone calls to make sure the applicant is cared for. Camp JVCs may not be prepared or trained in their position or their role might be delegated to another.

Brother Joseph Rainey mentioned in an email that the Gen. James B. McPherson Camp No. 1 is

looking into starting a camp in and around Conway, Arkansas. I am unaware of any progress.

Scott Sarley wrote regarding the creation of a camp in Joplin, Missouri. I provided guidance but he is too busy with the SCV identifying Confederate graves in Jasper and Barton counties. He passed along information about a G. A. R. memorial (Find a Grave #41779789) in the Carterville Cemetery, Carterville, Jasper Co., Missouri, which is in need of cleaning up.

I plan on requesting another lot of tri-fold recruitment forms (SUVCW Form 70) from the National Quartermaster before the National Encampment in Lansing, Michigan. They will be made available to camps if they are retrieved at Department meetings, transferred via courier, or paid for by the camp (postage).

I continue to validate application genealogical information (when provided) as well as scan the application and proofs. These will be passed onto the next JVC to start a digital archive.

One of the JVC's responsibility is membership retention.

◇ Recommendation: Continue to promote the Life Member option. The benefits include no per capita National dues or Department dues (under current by-laws). This is particularly attractive for those members 61 years or older. The Life Membership can be paid during a three-year period with up to three payments. It is pro-rated by age. See attached SUVCW Form 9.

The JVC should remove bottlenecks in member applications, many of which take months to move from the National JVC to the Department JVC.

 Recommendation: The Department JVC should contact the Camp JVCs to see if they are prepared to receive applications or if that procedure is another member's responsibility.

Finally, I have not made any progress on the Department's Membership-Camp Expansion Plan adopted at the Department October 2015 Business Meeting. Again, I would appreciation some help and direction in this area.
