Walt Busch moved to accept Minutes of the 5 March 2022 Business meeting. Seconded and Approved.

Communications from Department of Michigan were introduced seeking support for National CofA for Robert R. Payne PDC and Donald W. Shaw, PCinC for National Quartermaster.

Officer Reports given, recommendations referred to Encampment Committee. Motion by PDC Randal Burd, the Financial Report of the Treasurer be approved subject to audit. Seconded and passed.

ByLaws and Program and Policy Committee Report given with changes approved at the March 2022 Business meeting. PDC Randal Burd moved, "as well as the Unionist Editor," be added to 101 Group E-Mail Distribution. PDC Randal Burd moved in Section 800 -Programs, paragraph 841 that "Eagle Scout Coins" be changed to "Eagle Scout Patches." PDC Randal Burd then moved to approve the amendments. Seconded and passed. PDC Randal Burd moved to approve the Policy and Procedures Manual with amendments. Seconded and passed.

Memorial Service held for deceased Brothers whose names were read.

DEPARTMENT AWARDS – Sr. Vice Commander Robert J. Amsler Jr.

Francis P. Blair Award presented to PDC Walt Busch.

James B. Eads Award Presented to U.S. Grant Camp #68, Ste. James Camp #326 and Fletcher Camp #47. Grand Arm of the Republic Award to Joan Koechig, Missouri Past Department President of the Daughters of Union Veterans of the Civil War and Kathy Bower Past National President of the Woman's Relief Corps. Samuel Curtis Award for recruiting the most new Brothers tied to U.S. Grant Camp #68 and James B. McPherson Camp #1 both with nine new Brothers this year.

Nathaniel Lyon Award for Greatest Percentage of new Brothers to James B. McPherson Camp #1.

Most new Brothers Under 40 Award had no camp qualified with minimum of three.

Commander Gary L. Scheel presented a Certificate of Accommodation to PDC Glen Alsop.

PDC Dale Crandell gave a Patriotic Instruction on the proper placement of the U.S. Flag whether in meetings or carried on a staff.

Walt Busch of the Encampment Site Committee moved to hold the Department Encampment in the Springfield Missouri Area in 2023, the Kansas Area in 2024 and the South of St. Louis Area in 2025. Seconded and passed.

PCinC Donald Palmer gave report of the Department Programs Committee on the Shiloh event this past 2 April and the more recent survey on what events to do next.

Recommendation #1. The Department Programs Committee begin coordination with Phelps Camp for a Missouri Remembrance Day at Wilson's Creek National Battlefield (and possibly Springfield National Cemetery) in 2023 and conduct research and a logistics assessment for a potential Missouri Remembrance associated with the Chattanooga Campaign (Chickamauga, Lookout Mountain, Missionary Ridge, Chattanooga National Cemetery) in 2024. Passed.

Recommendation #2. The Department Programs Committee review the inputs received relative to Department-wide events and/or initiatives and bring back specific recommendations to the Fall Department meeting. Passed with one nay.

Camp reports were given with Ste. James Camp #326 the only Camp submitting a written report.

ENCAMPMENT COMMITTEE REPORT - OFFICERS REPORTS

Randall Burd gave the Department Council Audit Report as the Books are in order.

Officer Recommendations: #1 The next Department Commander issue a Department Order directing Camps to amend their ByLaws to comply with National Regulations, Chapter 1 Article XIII That a Camp Color Guard is composed of the Camp Guard with the highest rank of Captain. With no objections it passed.

Recommendation #2: Develop a Department policy to honor an individual or company or agency with a SUVCW plaque for Flag Patriotism on Flag Day. Committee concurred and recommended to be referred to the ByLaws Committee. With no objections it passed.

Recommendation #3: set up website@suvcwmo.org as the forwarding account in GoDaddy. Committee recommends Walt and James Dixon do what is necessary to get it done.

Recommendation #4: That all paper, reports etc. associated with Department of Missouri Annual Encampments be placed in a binder labeled as to date and location. A copy of this binder be given to the Department Quartermaster for safe keeping. Committee concurred and recommends that it be referred to the ByLaws Committee. Walt Bush moved to assign to committee with the object to preserve the records until they go to Western Manuscripts but that we also maintain a Cloud Service initially and preferably for free. Randall Burd seconded Walt's motion. Motion passed.

Recommendation #5: That an application for the Most Outstanding Cadet of the Year be sent to the cadet from each school who receives the SUVCW National Award that year. From those applications the monetary Department award is chosen. With no objections it passed.

Recommendation #6: To change wording in the Eads Award requirements regarding duplicate Graves Registrations. Committee recommends referral to the Awards Committee. With no objections it passed.

RESOLUTIONS COMMITTEE REPORT

From walt Busch: Whereas, one of the objects identified in Article II of the Constitution of the Sons of Union Veterans of the Civil War is to "cooperate in doing honor to all who have patriotically served our country in any war, to teach patriotism," and

Whereas, it is our duty in all things to promote Fraternity, Charity, and Brotherhood, and Whereas, departments, even within just one state, may be such a large geographical area that it presents a burden on some brothers to attend department meetings and encampments that are heldat long distances, and Whereas, the Grand Army of the Republic recognized this issue and in doing so, promoted and allowed the creation of battalions or sectional associations within a Department, and,

Whereas, some camps within departments because of their proximity need to work closely together on projects; and,

Whereas, Departments consisting of multiple states should have it as a goal to, at sometime in the future, have a state separate and form its own department; and

Whereas, having camps within a state that may eventually form its own department begin working as a group to promote brotherhood,

Now therefore, the Department of Missouri has voted to recommend the following changes to the Constitution and Regulations of the Sons of Union Veterans of the Civil War, reading as follows:

Section 3. Any Department whose Brothers reside in different communities may arrange its Brothers into battalions or sections corresponding to such communities; may give each such battalions or sections a distinctive name; may prescribe its organization; and may delegate to it such of the work of the Department in that community as the Department may specify.

- a. Any such battalion or section shall have at least two officers; a battalion commander and a battalion secretary.
- b. Any such battalion or section shall not have their own treasury. All funds and funding strings shall be handled by the Department Treasurer and any funds raised by such battalion or section shall be the property of the Department.
- c. Any such battalion or section must be approved by the Department Commander or the department encampment prior to formation. After lengthy discussion it was moved and seconded to table which passed with one nay vote.

NEW BUSINESS

Robert Aubuchon on behalf of Grant Camp #68 requests reinstatement of Past Camp Commander status for Noel Stasiak and moves for such. Seconded and passed.

Dale Crandell moved to authorize somebody to post our entire directory of Name, Phone number, e-mail address and current Department office held on the "Officers Only" page making it available to all currently elected and appointed officers. Passed with one nay vote.

Randall Burd moved that the Re-Sale Quartermaster distribute the merchandise after today as he sees fit. Seconded and passed.

Randall Burd moved that Walt Bush and Doug Roussin devise form(s) for inventory, and when completed submit them to the Policy Committee. Seconded and passed.

Dale Crandall moved to release the full \$500 pledged at the October 2021 business meeting for the Mountain Grove GAR Foot Soldier monument assessment report and cleaning with \$375 payable to the City of Mountain Grove for half of the assessment cost and \$125 payable to Phelps camp #66 for future restoration work. Walt Busch moved to add additional \$200 to the future restoration money going to Phelps Camp #66. Walt's amendment was seconded and passed. Original motion seconded and passed.

Sumner Hunnewell moved to donate \$200.00 GAR Museum in Springfield Illinois due to their recent failure of their HVAC system. Seconded and passed.

Walt Busch moved for the Mountain Grove Monument funds previously moved, seconded and passed to be paid from the Past Commander's Fund.

Monuments that I have recorded during the past year are listed in my itinerary above.

One thing that I found out this year that is horrible concerns the fate of the Frank Blair, Jr, Monument in Louisiana, MO. I was speaking to a person who use to write newspaper articles up in Louisiana and mentioned my hunt for the Blair Monument that use to be in front of the old Louisiana Hospital. He then told me that for reasons unknown a bunch of people one night took it down (and another plaque about something elsewhere in town) and pitched both of them in the Mississippi River. So Frank Blair rests somewhere below the water.

- 555 Missouri Monuments Recorded. 4 Last Soldier Monuments Created.
- 12 Arkansas Monuments Recorded out of 255 Arkansas Known Monuments
- 59 Cannons located in Missouri kept track of (recorded as Monuments above)
- 36 Cannons known in Arkansas as found in a privately owned copyrighted database
- MO Monuments in Vicksburg, 49 MO Monuments in Shiloh (3 an Illinois Unit filled by Missouri Boys) and 1 MO Monument in Washington DC (Frank Blair, Jr). All these are kept track of as best as possible.

Other Historical Records

Any GAR Post Records, Records of Past GAR/SV/SUVCW Commanders, Last Veterans, Etc that I have recorded in the past are listed above in the itinerary.

Recommendation of Webmaster

James Dixon is the "owner" of the SUVCWMO website. So that we can continue to access this website if something happens to James or me, we need to set up a **suvcwmo** email account (on godaddy like our others) and use that as the main access to the owner of the account. James and I can then share the password and act as owner. We can also share this with at least one other member of the SUVW (I have done this with 3 of my other clubs and Grant camp with Jim Morrison). He is a member of Grant camp and is a member of all the organizations so he has my password, so he may be a good one to have this info as well. In this way the organization can access, edit, etc all info if something happens to James, me (or if we both quit).

Right now, if something happened to James and we got locked out of paying the renewal, we are screwed and would have to recreate the entire website.

So I recommend that:

Just a General Recommendation from Walt concerning other issues:

Petition of the Department of Missouri Sons of Union Veterans to the National Organization to add Section 13 to Chapter II, Article 1 of the Constitution & Regulations of the Sons of Union Veterans of the Civil War.

Whereas, one of the objects identified in Article II of the Constitution of the Sons of Union Veterans of the Civil War is to "cooperate in doing honor to all who have patriotically served our country in any war, to teach patriotism," and

Whereas, it is our duty in all things to promote Fraternity, Charity, and Brotherhood, and

Whereas, departments, even within just one state, may be such a large geographical area that it presents a burden on some brothers to attend department meetings and encampments that are held at long distances, and

Whereas, the Grand Army of the Republic recognized this issue and in doing so, promoted and allowed the creation of battalions or sectional associations within a Department, and,

Whereas, some camps within departments because of their proximity need to work closely together on projects; and,

Whereas, departments consisting of multiple states should have it as a goal to, at sometime in the future, have a state separate and form its own department; and

Whereas, having camps within a state that may eventually form its own department begin working as a group to promote brotherhood,

Now therefore, the department of Missouri has voted to recommend the following changes to the Constitution and Regulations of the Sons of Union Veterans of the Civil War, reading as follows:

Section 3. Any Department whose Brothers reside in different communities may arrange its Brothers into battalions or sections corresponding to such communities; may give each such

battalions or sections a distinctive name; may prescribe its organization; and may delegate to it such of the Work of the Department in that community as the Department may specify.

- a. Any such battalion or section shall have at least two officers; a battalion commander and a battalion secretary.
- b. Any such battalion or section shall not have their own treasury. All funds and funding strings shall be handled by the department treasurer and any funds raised by such battalion or section shall be the property of the department.
- c. Any such battalion or section must be approved by the department commander or the department encampment prior to formation.





DEPARTMENT PROGRAMS COMMITTEE REPORT

To:

27th Annual Missouri Department Encampment

The Department Programs Committee focuses on identifying, planning and executing Department-wide programs both in and outside of Missouri and Arkansas. The following is a report on 2022 activities with recommendations for future activities:

- Missouri Remembrance Day at Shiloh The event was held at Shiloh National Military Park on Saturday, April 2, with 33 attendees and 6 Camps represented, as well as the Louisa Volker Auxiliary and a member of the Woman's Relief Corps. Those that arrived on Friday gathered at Taylor's Restaurant in Corinth for dinner. On Saturday, the group convened at the outdoor pavilion at Shiloh and was welcomed by Ranger Matthew McMillen. Bob Mueller from St. James Camp #326 provided the keynote address and a catered lunch from Kenny's BBQ was provided. The group then toured the battlefield with stops and informational presentations at the 13th Missouri monument, the Peabody monument, the 23rd Missouri marker at the Hornet's Nest, and a ceremonial at the Missouri state monument. The event concluded with a ceremony and individual reflections at Shiloh National Cemetery, where the graves of the known Missourians were adorned with wreaths and U.S. flags. Those that remained gathered at the Cracker Barrel in Corinth for dinner.
- Financial Summary A budget of \$1200 was approved for this event by the Department Council. After reconciling expenses including ribbons, postage, copies, food and the cost of the special use permit, along with the refunded deposit and registration fees, the total cost to the Department ended up at \$292.29, which was well under budget.
- Survey Results A post-event survey was sent to those that attended the event at Shiloh for feedback on the event as well as thoughts on future events and/or programs the Department of Missouri should consider. Approximately 80% of those that attended submitted responses to the survey. The following is a summary of results:
 - 100% of survey respondents indicated that they enjoyed the event.
 - The aspect of the event attendees enjoyed most was fellowship with 33%, followed closely by both educational and ceremonial with 28% each.
 - o 69% of the attendees believed that the Department should conduct another program at Shiloh in the future, with 40% responding each responding with 2 years and 5 years.
 - On the question about future Missouri Remembrance events, Wilson's Creek had the highest ranking with a 2.8 average (lower is better) and 6 top priority responses. The Chattanooga Campaign was third on average score with a 4.2, but had a strong response with 4 top priority responses. Additional suggestions for consideration included Franklin/Nashville and Stone's River (Murfreesboro).

Recommendations:

- The Department Programs Committee begin coordination with Phelps Camp for a Missouri Remembrance Day at Wilson's Creek National Battlefield (and possibly Springfield National Cemetery) in 2023 and conduct research and a logistics assessment for a potential Missouri Remembrance associated with the Chattanooga Campaign (Chickamauga, Lookout Mountain, Missionary Ridge, Chattanooga National Cemetery) in 2024.
- The Department Programs Committee review the inputs received relative to Departmentwide events and/or initiatives and bring back specific recommendations to the Fall Department meeting.

The committee welcomes any feedback on proposed events and/or ideas for new events. It is the committee's desire to develop programs that would draw interest of Brothers across the Department and stimulate participation from all Camps in the Department of Missouri (including Arkansas).

REPORT ON MISSOURI REMEMBRANCE DAY AT SHILOH

In January 2022, the sent our request for the Special Use permit to Shiloh National Miliary Park. Prior to this Brother Mark Coplin sent thirty-four invitations to Tennessee and Missouri politicians both local and state and other organizations in the area but as was evident at the event no one invited appeared. We invited the Superintendent of Shiloh Park to attend but he and his family were on a cruise. Park Ranger Matthew McMillen who retired from the U.S. Army as a Lieutenant Colonel gave us the honor of representing the staff of Shiloh National Military Park. He represented the Park well.

Prior to the opening ceremony, several members volunteered to meet at the cemetery and lay wreaths and place flags at forty-seven graves of men of Missouri who are laid to rest in the cemetery. Brothers Don and John Palmer drove our planned route and placed Missouri flags at the monuments where our ceremonies were going to be held.

Opening ceremony was held at the pavilion with Brother Don Palmer acting as MC. We had 33 members and guests present. Brother Don introduced Park Ranger Matthew McMillen and he greeted us on behalf of Shiloh Park. Brother Robert Mueller gave a presentation on Missouri participation in the battles of Fort Donelson and Shiloh. His presentation was enjoyed by all. Brother Scott Reed and his wife arrived with lunch and we enjoyed our meal. We cleaned the pavilion and headed to our next destination.

We arrived at the 13th Missouri Infantry Monument where Brother Walt Busch of the U.S. Grant Camp placed the wreath. He had a step great-great Grandfather who served in the 13th Missouri Infantry. Brother Robert Mueller gave a presentation on the 13th Missouri Infantry Regiment participation in the Battle of Shiloh which included information on Lt. Col. J. Felix St. James, who was the second in command of the 13th Missouri Infantry, was mortally wounded on April 6th and died on April 8th at Savannah, TN. Brother Gary Scheel then introduced Ian Jones, who is a great-great grandson of Lt. Col. St. James. He was presented with a photo of the Grand Army of the Republic taken in 1888 which included his great-great grandmother in the back of the photo. He also received an original copy of the pension his great-great grandmother applied for and had her signature. He expressed his appreciation for the generosity.

Our next stop was the Colonel Peabody Monument on Peabody Road. Brother Doug Roussin of the Fletcher Camp laid a wreath at the monument. Brother Don Palmer gave a presentation about Colonel Edward Peabody who was killed on April 6th not far from where his monument is located. Colonel Peabody was the commander of the 25th Missouri Infantry Regiment and his unit fired the first shots of the battle. His presentation was appreciated. Sister Susan Breland of the Louisa Volker Auxiliary who was present had an ancestor who served in this regiment.

Our next stop was at the Hornet's Nest at the 23rd Missouri Infantry Regiment marker. Sister and Brother Lindberg of the Phelps Camp placed the wreath at the 23rd Missouri Infantry Marker. Brother Don Palmer gave a presentation on Lieutenant Colonel Jacob T. Tindall, commander of the 23rd Missouri Infantry, who was killed in the Hornet's Nest while in command of his regiment. His presentation was informative and enjoyable.

Our next stop was at the Missouri Monument. Brother Gary Scheel of the St. James Camp, placed a wreath at the monument. The flag detail consisted of Sergeant Bob AuBuchon, commanding, Private Glenn Alsop and Private Dale Crandell, who placed the U.S. Flag, Missouri Flag and Department Flag near the monument. Brother Don Palmer performed the

responsibilities of MC. Brother Scott Reed gave the history of the Missouri Monument and how Boy Scout Troop 600 of Florissant, Missouri was instrumental in raising the funds in order that the monument would be placed to recognize the Missouri men who fought at the Battle of Shiloh. Before this, there was no Missouri Monument at Shiloh National Military Park to recognize all the men from Missouri who participated in the battle. Brother Don Palmer then introduced Brother Ed Krieser, of the Phelps Camp, and he read the names of men who died from the 13th Missouri Infantry Regiment. Brother Kip Lindberg, of the Phelps Camp, was introduced and he read the names of the men of the 18th Missouri Infantry Regiment and 21st Missouri Infantry Regiment. Brother Randal Burd, of the Fletcher Camp, read the names of the men of the 23rd Missouri Infantry Regiment. The 23rd Missouri Infantry suffered the most in mortally wounded in the Battle of Shiloh. Brother Jeff Patrick of the Phelps Camp was introduced and read the names of the 25th Missouri Infantry Regiment. Brother John Palmer, of the U.S. Grant Camp, was introduced and he read the names of the 1st Missouri Light Artillery who died. There were one-hundred and forty names read that day of those who were killed and mortally wounded. Chaplain Martin Aubuchon rang the bell after each name was read. While the names were being read, we could hear the cannons firing at the 160th Battle of Shiloh re-enactment. It was very fitting and appreciated.

Our final stop was at the Shiloh National Cemetery. We assembled at the gate and Brother Don Palmer made some announcements and explained how there were wreaths and flags at the site of the resting place of Missouri men. At 3:30 pm we assembled back and Chaplain Martin Aubuchon said a closing prayer. Brother Doug Roussin then played taps. When he played taps, cars stopped on the road and people walking around and talking stopped and listened with respect. It was a somber moment. Brother Don Palmer then made some announcements and Chaplain Martin Aubuchon gave the benedic. The program ended shortly after 4:00 pm and we were released for the day.

The Programs Committee met via ZOOM beginning November 6, 2021. The committee met seven times prior to the event. Committee member Scott Reed, who is a member of the St. James Camp and lives near Memphis, TN was our man on the ground. He made several trips to Shiloh to verify our plans and was instrumental in guiding us to the monuments and the route. The other committee members are PCinC Don Palmer who is chair of the committee, PCC Mark Coplin and Department Commander Gary Scheel. Brother Mark Coplin was missed because he flew to Ireland to visit family.

There were six Camps present and one Auxiliary. There were a total of 33 members and guests present. We are grateful to PDC Martin Aubuchon for the use of his sound system which really came in handy during the opening ceremony. We are grateful for PDC Walter Busch who made up the registration form for this event and collected the fees. He kept us well informed of who and how many were coming which was greatly appreciated.

 - Hotel choice was good and the food choices were good (lunch and restaurants).
 The Friday night dinner was not as well organized as those that ordered the buffet were finished before those that ordered off the menu even received their food.
 - Due to geographic challenges, I feel ceremony was well planned.
 - Aside from the state monument, how important are the regimental markers?
 - Everything was good!
 - Informal "gab" session, change to discuss thoughts about the Allied Orders
 - Talks at each stop, while informative, were a bit on the long side

slow. But Saturday was really not worth me staying around for. Going to Cracker Barrell for morning breakfast (and not losing your cellphone) is ok. Personally, I don't like fish, but I know it is a Southern thing, so if we would have gone to a catfish buffet, even though I may not eat much, I am sure others would have enjoyed the local flavor.

- Be flexible with times. Start off on time (we delayed only a brief time, but it was very acceptable). However, we ended the event earlier than planned and had 2 1/2 hours until dinner. For people wanting to hit the road, this is inconvenient. Also, most old people (and SUVCW is mostly old people now) eat earlier than 6 or 7pm. Unless the event lasts until late evening, no dinner should be planned after 6pm. We could have adjusted to 5pm announcing it at the end of the event as everyone was there. Budget early for event (as was done in this one).

The Camp has returned to having in-person meetings In January but continue to provide access via Zoom for those who interested.

Beginning with the March meeting, we began having an activity after the monthly meetings. In March, Brother Tom Greminger presented a program on sidearms during the Civil War. Brother Gary Scheel gave a presentation on Missouri unit name changes during the Civil War at the April meeting. In May, Brother Greminger presented a program on two Ste. Genevieve families during the Civil War.

Brothers Gary Scheel, Greg Wolk, Scott Reed, Marty Aubuchon, and Bob Mueller participated in the Department of Missouri event at Shiloh Battlefield

Brothers Gary Scheel and Paul Kist conducted honor guard duty at the grave of our camp namesake, Lt. Col. J. Felix St. James in Memorial Cemetery on April 14th.

The camp awarded its annual scholarship to Justin Basler whose ancestor was a Civil War soldier.

On April 30th, the camp set up a Civil War Exhibit at the Ste. Genevieve County library. Brother Bob Mueller and Becky Millinger, wife of Vice Commander, Ed Millinger, gave a presentation on local and internet genealogy resources that can be used to trace Civil War ancestors. Brother Schaaf, Scheel, Greminger, and Millinger answered questions throughout the event. A similar event is planned for later in the year.

On May 14th, the camp conducted a ceremony at the tombstone of Reuben Brown, a Civil War soldier who previously had no tombstone. The camp worked with family members to procure the tombstone and Brothers Schaaf and Scheel erected the tombstone.

Later that day, the camp conducted the dedication of a memorial stone recognizing John M. Duvall as the last surviving Civil War veteran in Ste. Genevieve County. The great, great-great, and great-great-great grandsons of John M. Duvall and other family were present at the dedication ceremony. We appreciate that members of the Grant and Fletcher camp assisted in the dedication ceremony.

On May 22nd, Camp Members will participate in a dedication ceremony at the Ste. Genevieve Museum and Learning Center honoring Moses Riney, an African American Civil War soldier.

Forms 22, 27, 40, and the first quarterly report were submitted on time. A submission was made for the Eads Award on May 7^{th} .

Marty Aubuchon was elected Captain of our Camp Guard.

Gary Scheel will be presenting a ROTC medal at Poplar Bluff High School on Thursday, May 19th.

I would like to ask the Department of Missouri to become involved with the saving of the Chapel at the Missouri Veterans Home in St. James, Missouri.

I have talked to Stephen R. Conrad, President of the Missouri Veterans Home Assistance League and to Keith Livingstone, who is on the Board of Directors as well as Treasurer of the Missouri Veterans Home Assistance League.

I called during their Board Meeting on 2 June 2022 and they discussed the Chapel and told me that the building looks great on the outside but no one has been in the building for years. They said that there are bats and other vermin inside. They said they are planning to talk to some Colonel to find out if they will approve the restoration.


They also stated that the City of St. James wants the building restored because they believe it is the oldest building in St. James.

St James is the site of the first state veterans home. It was originally opened in 1896 by the Women's Relief Corps Soldier's Home Association, and was deeded to the State of Missouri in 1897. Mrs. Hollen E. Day, President of the General Lyons Corp, No. 38, Women's Relief Corps, St. Louis, MO, pushed for the opening of the home. The town of St. James presented the William James Mansion and the surrounding 60 acres to the Corp in 1895 to serve as 34 room home.

Our National Constitution and Regulations, and Department Bylaws take precedence over the PPM. As a living document, the PPM can be amended by a simple majority vote of any Department Encampment, Department Business Meeting, or Department Order. Maintenance of the PPM is entrusted to the Department's Bylaws Committee.

Section 100 - General Policies

¶ 100 Membership Badge. All elected and appointed Department Officers and Past Department Commanders must wear at least one of their SUVCW membership or officer badges at Department Encampments and Business Meetings. A Department Officer or Past Department Commander violating this policy may be assessed a \$10 fine, payable to the Department's Past Commander Fund.

A device may be attached to the top bar, being the symbol of the Department: a silver edged octagon with a red interior, which has an "M", a downward feathered arrow, and an "O" inside the octagon. Such device shall not extend beyond the edges of the ribbon of the badge, nor shall such device cover more than 50% of the ribbon of such badge.

¶ 102 Record Retention and Archiving. Department records are archived with Western Historical Manuscript Office (Historical Society of Missouri) at Columbia, Missouri. The intent is to ensure a central location for Department archives.

¶ 103 Mourning Period. The Department-wide mourning periods are:

- 30 Days Department Commander (past and present)
- 14 Days Camp Commander and Department Officer (past and present, elected and appointed)
- 7 Days member and special friend of the Department

Camps are free to set additional and longer mourning periods as they deem appropriate.

Members with frequent contact with youth are encouraged to provide a no cost background check conducted by the Missouri Department of Social Services and Missouri State Highway Patrol

Section 200 - General Procedures

¶ 200 New Membership Applications. Once a new member is accepted by a Camp, there is a six-step intake process:

1. Camp forwards packet to the Department Secretary containing Form 30 Camp Status Reports (or Form 27 Camp Annual Reports), Form 3 Membership Applications, check for pro-rated National and Department per capita fees, and National application fee.

2. Camp e-mails confirmation of new member to the Department Junior Vice Commander and Department Secretary; and updates Camp roster.

3. Department Secretary forwards Camp's check to Department Treasurer and e-mail's request for Department Treasurer to forward check for pro-rated National per capital and National application fee.

4. Department Treasurer forwards check to Department Secretary for pro-rated National per capital and National application fee.

5. Department Secretary completes the Form 30 (or Form 27), retaining copies for the Department records, adds Department check, and forwards the packet to National.

6. Department Secretary e-mails confirmation of new member to Camp and Department elected officers; and updates Department roster.

¶ 201 Internet New Membership Applications. Prospective members have the option to submit an online Form 3 Membership Application, which triggers a four-step process:

1. National forwards Form 3 and prospective member's check to the Department Junior Vice Commander (JVC).

2. Department JVC forwards the Form 3 with check to the Camp located closest to the prospective member's home address, following the Appendix G and H maps.

3. Camp has 60 days to determine whether to accept the prospective member's application.

- a. If the Camp accepts the prospective member, the Camp follows paragraph 200 above.
- b. If the Camp declines, they return the Form 3 and check to the Department JVC, where the Department JVC will repeat this process with the next closest Camp.

Section 300 - Reports

¶ 300 Quarterly Reports. Camps must submit a Quarterly Report Form of their activities, plans, and status to the Department Commander. Use the electronic PDF form posted on the Department's website. Reports are due by the 15th of the month following the quarter.

¶ 301 IRS 990 Filing. Camps are required to maintain their IRS 501(c) tax exemption status with annual submission of an IRS 990 Return of Organization Exempt from Income Tax. Section 400 - Encampment and Business Meetings

¶ 400 Encampment Voting Rights. In order to vote at a Department Encampment, a delegate must present to the Department Secretary: 1) SUVCW membership card for the current year, and 2) credential card from his camp. Department Officers and Past Department Commanders receive their credential cards from the Department Secretary. The Department Secretary will determine if the member is entitled to vote under the Department's Bylaws and National Regulations.

¶ 402 Written Officer Reports. All elected and appointed officers shall provide a written report of activities and recommendations at each Department Encampment and Business Meeting. The report for a Department Encampment is due by May 15th and for a Business meeting it is due two weeks prior to the meeting.

¶ 500 Property Inventory. All incoming and outgoing officers shall document their exchange of Department property and records, and copy the Department Secretary.

The Signals Officer shall be the Department point of contact for the National Signals Officer. The Department Commander or Signals Officer may appoint Assistant Signals Officers as needed.

¶ 503 Camp Organizer. The Department Senior Vice Commander shall serve as the Department's Camp Organizer with responsibility to support formation of new Camps. The Senior Vice Commander shall be the Department point of contact for the National Organization Expansion Officer.

¶ 504 Editor. The Department Commander shall appoint an Editor with responsibility for publishing the Missouri Unionist, the Department's official newsletter. Camp's and Department Officers shall submit their articles to the Missouri Unionist Editor. Department Eagle Scout Coordinator. Missouri Unionist Editor shall be the Department point of contact for the National Banner Editor. The Department Commander or Editor may appoint Assistant Editors as needed.

¶ 505 Grave Registration Officer. The Department Commander shall appoint a Grave Registration Officer with responsibility to administer the SUVCW's grave registration program. The Grave Registration Officer shall be the Department point of contact for the National Grave Registration Officer. Camp's shall report and coordinate their grave registration activities with the Department Grave Registration Officer.

[Department Encampment, June 2018]

¶ 506 Eagle Scout Coordinator. The Department Commander shall appoint an Eagle Scout Coordinator with responsibility to administer the SUVCW's Eagle Scout recognition and awards program. The Eagle Scout Coordinator shall serve as an assistant to the Patriotic Instructor. The Eagle Scout Coordinator shall be the Department point of contact for the National Eagle Scout Certificate Coordinator. Camp's shall report and coordinate their Eagle Scout program activities with the Department Eagle Scout Coordinator.

[Department Encampment, June 2018]

¶ 507 ROTC Coordinator. The Department Commander shall appoint a ROTC Coordinator with responsibility to administer the SUVCW's ROTC awards program and JROTC Outstanding Cadet

competition. The ROTC Coordinator shall serve as an assistant to the Patriotic Instructor. The ROTC Coordinator shall be the Department point of contact for the National Assistant Quartermaster/ROTC Coordinator. Camp's shall report and coordinate their ROTC program activities with the Department ROTC Coordinator.

¶ 508 Historical Records Coordinator. The Department Commander may appoint a Historical Records Coordinator to consolidate the responsibilities of the Historian, Civil War Memorials Officer, and GAR Officer along with their programs. The Historical Records Coordinator shall be the Department point of contact for the National Historian, Civil War Memorials Officer, GAR Highway Officer, and GAR Records Officer. Camp's shall report and coordinate their historical records activities with the Department Historical Records Coordinator.

¶509 Medal of Honor Coordinator. The Department Commander may appoint a Medal of Honor (MOH) Coordinator with responsibility to administer a Medal of Honor program. The MOH Coordinator shall serve as an assistant to the Patriotic Instructor and Historical Records Coordinator. Camps shall report and coordinate their MOH program activities with the Department MOH Coordinator.

¶ 510 History Award Coordinator. The Department Commander shall appoint a History Award Coordinator with responsibility to administer the American Civil War History Award as a special prize in the National History Day in Missouri competition. History Award Coordinator shall serve as an assistant to the Patriotic Instructor.

Section 600 - Committees

¶ 600 Encampment Site Committee. The Encampment Site Committee arranges for the Department Encampment and reports their actions at Department Encampments and Business Meetings. The Committee must announce the Encampment location no later than the October Business Meeting preceding the Encampment; and report final arrangements no later than the March Business Meeting preceding the Encampment.

Section 700 - Awards

¶700 Award Nomination. Any camp or member may submit an award nomination or application. Consideration for one of the annual awards presented at the Department Encampment must be submitted to the Awards Committee by May 15th for service from April 1st of the prior year through March 31st of the current year. The nomination and application forms (PDF format), posted on the www.suvcwmo.org website, must be used. They can be submitted by e-mail (preferred) or postal mail to the Department Senior Vice Commander.

¶ 701 Award Selection. The Annual Award Committee will conduct a simple majority approvedisapprove vote on all award nominations and applications. ¶ 713 Grand Army of the Republic Award. The GAR Award may be awarded to one or more individuals selected from among the nominations. Recipients of the GAR Award receive a plaque. The stated award criteria are:

The Allied Order member who has made a significant contribution or collective contributions over a period of time to promote fraternal relationships between the Allied Orders in perpetuating the memory of the Grand Army of the Republic and our ancestors who fought to preserve the Union. An award recipient is not eligible for repeat consideration for three years.

¶ 714 Wayne M. Sampson Show-Me Spirit Award. The Sampson Award may be awarded to one or more individuals selected from among the nominations. Recipients of the Sampson Award receive a plaque. The stated award criteria are:

The individual who has made a significant contribution or collective contributions over a period of time to promote the SUVCW, Allied Orders, or Civil War history, and who demonstrates a shared interest in the SUVCW mission. An award recipient is not eligible for repeat consideration for three years.

¶ 715 Certificate of Appreciation. A Certificate may be awarded to one or more members or non-members where another Department Award is not warranted. The member must have been in good standing at the time of award, exemplify the virtues of Fraternity, Charity, and Loyalty. A Certificate recipient is eligible for repeat consideration.

¶ 716 Member Anniversary Recognition. Reserved.

¶ 717 JROTC Outstanding Cadet. The JROTC Outstanding Cadet is awarded to one cadet from among the recipients of the SUVCW's ROTC award. The recipient receives a \$200 cash prize. If it is not awarded, the \$200 is added to the next year's award but capped at \$700.

The JROTC cadet nominated by their military science instructor from among the recipients of the SUVCW's ROTC award recipients for the current academic year. Selection is based on the cadet's academic accomplishments, JROTC leadership and aptitude, and school and community service. An award recipient is not eligible for repeat consideration.

¶718 American Civil War History Essay Award. A special prize awarded for a senior individual entry in the National History Day in Missouri competition administered by the State Historical Society of Missouri and Missouri Humanities Council. The recipient receives a certificate and \$200 cash prize. If it is not awarded, the \$200 is added to the next year's award but capped at \$700.

The best senior individual entry in National History Day in Missouri competition relating to American Civil War or Grand Army of the Republic (GAR) history in the period before, during, and after the American Civil War including Reconstruction, and throughout the life of the GAR, 1865-1949.

¶ 719 Samuel Curtis Award. This award is presented to the individual Brother who recruits the greatest number of new members within the Department during the period 1 May through 30 April. An award recipient receives a certificate and is eligible for repeat consideration.

The Camp receives a ribbon streamer and is eligible for repeat consideration.

¶ 721 Department Under Forty Award. This award is presented to a Camp with three or more new members under age forty (40) during the period 1 May through 30 April. James Eads moved to St. Louis, Missouri as a young teenager and took odd jobs to sustain himself. Though Eads' formal education ended before he was 14, he learned mathematics and the sciences on his own. Eads' energy and inventiveness resulted in his becoming a prominent riverine engineer by the time of the Civil War and turned out to be an invaluable asset in helping the Union regain control of the Mississippi River.

The member must have been in good standing and exemplify the virtues of Fraternity, Charity, and Loyalty for the entire year. An award recipient is not eligible for repeat consideration for five years.

From secession to Reconstruction, Francis Blair of Missouri made an unbroken series of major contributions to the Union cause. No man did more to block Missouri's move to the Confederacy in 1861. As a U.S. Congressman, he battled for President Lincoln's early war programs. As a soldier, he was a distinguished divisional and corps commander during the Vicksburg and Atlanta campaigns. Finally, as a post-war senator, he confronted the radical Republicans in an attempt to bring reconciliation to a shattered union.

An award recipient is not eligible for repeat consideration for three years.

The GAR was a fraternal organization composed of veterans of the U.S. Army, Navy, Marine Corps, and Revenue Cutter Service who served the Union during the American Civil War. It's five auxiliaries make up our present day Allied Orders: Sons of Union Veterans of the Civil War (1881), Woman's Relief Corps (1883), Auxiliary to the Sons of Union Veterans of the Civil War (1883), Daughters of Union Veterans of the Civil War (1885), and Ladies of the Grand Army of the Republic (1896).


