## Minutes of the Department Business Meeting 14 October 2023

**Open Meeting**. Commander Robert Amsler called to order a Business Meeting of the Department of Missouri, Sons of Union Veterans of the Civil War at 10:45 am, Saturday, 14 October 2023, at Missouri River Regional Library, 214 Adams Street, Jefferson City, Missouri. Chaplain Mark Coplin gave the invocation. Patriot Instructor Randal Burd led the Pledge of Allegiance.

Ten members were present, meeting quorum: DC Robert Amsler, SVC Robert Abuchon, JVC Mark Coplin, Sec-Trea Dale Crandell, Council Gary Scheel, PCinC Ed Krieser, PCinC Donald Palmer, PDC Walter Busch, PDC Randal Burd, and CC Pete Oetting.

**Minutes**. Department reviewed the minutes from the Department Encampment on 3 June 2023.

Motion by Dale Crandell, seconded by Walter Busch, to approve the minutes subject to correction. Approved.

**Orders and Communications**. Department reviewed orders and communications.

1. Department of Rhode Island message, 27 Sep 2023: JVC candidate Joseph Hall.

#### Officer Reports

- 1. Commander. Robert Amsler reported on efforts to establish General Ulysses S. Grant Day.
- 2. Senior Vice Commander. Robert Aubuchon provided a written report.
- 3. Junior Vice Commander. Mark Coplin provided a written report.
- 4. Secretary. Dale Crandell provided a written report.
- 5. *Treasurer*. Dale Crandell provided a written report with two recommendations. Dale Crandell requested reviewing the 2024 Department per capita.
  - Motion by Dale Crandell, seconded by Randal Burd, to maintain the Department per capita at \$6.00. Approved.

Commander Amsler appointed a Financial Planning Committee: Randal Burd, Walter Busch, Mark Coplin, and Dale Crandell with the charge: present recommendations at the March Department Business Meeting on the per capita rate, funding activities, and fund-raising options.

6. Chaplain. Mark Coplin provided a written report.

- 7. *Counselor*. Robert Amsler asked members to not respond to inquiries concerning transgender membership.
- 8. *Quartermaster*. Walter Busch provided a written report, highlighting that Department property has been relocated to him.
- 9. *Grave Registration Officer*. Glen Alsop provided a written report. Department noted 1,578 registrations from Wilhelmi Camp.
- 10. *Signals Officer*. Walter Busch provided a written report, highlighting that the Department website and domain were renewed.
- 11. *Historical Records*. Walter Busch submitted a written report, highlighting that when all Missouri-Arkansas monuments are entered in SUVCW National database, the Department database will be shut down.
- 12. *Unionist Editor*. Randal Burd reported the next issue coming 31 December 2023; submission deadline 23 December 2023.

#### **Standing Committee Reports**

- Bylaws. Robert Aubuchon reported committee members: Robert Aubuchon (chair), Dale Crandell, and Randal Burd. Commander Amsler tasked the committee to review the Department's Bylaws for consistency with the SUVCW Constitution amendments on membership qualifications and biological male definition.
- 2. *Awards*. Robert Aubuchon requested award nominations, submission deadline 15 March 2024. Robert Aubuchon is reviewing design options for member award plaques.
- 3. Encampment Site. Walter Busch reported on 2024 Department Encampment in Kansas City.

Walter Busch proposed combining the camp quarterly and camp PI reports.

- Motion by Walter Busch, seconded by Randal Burd, to adopt the Missouri Quarterly Patriotic Report Form. Withdrawn.
- Motion by Walter Busch, seconded by Gary Scheel, to eliminate the Camp Quarterly Report. Approved.

#### **Special Committee Reports**

- 1. *Programs*. Donald Palmer reported committee members: Donald Palmer (chair), Gary Scheel, and Mark Coplin. Wilson Creek program planned for 2023 is cancelled. Donald Palmer presented options for future programs:
  - a) Price's Missouri Raid, 29 August 2 December 1864.
  - b) Battle of Fort Donelson, Tennessee, 11 16 February 1862.

Consensus was to pursue a 2024 program for the 260th anniversary of Price's Missouri Raid.

#### **New Business**

- 1. *56th U.S. Colored Troops*. Walter Busch extended an invitation from Grant Camp #68 for their Annual Ceremony Honoring the 56th U.S. Colored Troops: 11:00 am, Friday, 20 October 2023.
- 2. *Missouri Veterans Home Chapel*. Gary Scheel presented a report and request from St. James Camp #329 to support restoration of the Chapel at the Missouri Veterans Home, St. James, Missouri.
  - Motion by Dale Crandell, seconded by Randal Burd, to adopt a statement of support. Approved.

SUVCW Department of Missouri supports a renovation project of the Missouri Veterans Home Chapel given its GAR and WRC historical significance; however, a business plan is needed to determine the Chapel's future use.

- 3. Financial Policy. Dale Crandell presented financial policies for consideration.
  - Motion by Walter Busch, seconded by Randal Burd, to approve policy 900, 901, and 902 with changes. Approved.

¶ 900 Past Department Commanders Endowment. The Past Department Commanders (PDC) Endowment supports the Department's and Camp's charitable work. The Department, Camps, members, Allied Orders, and non-members may donate to the fund. All donations to the PDC Endowment shall be invested in long-term instruments to produce annual income. All annual income from the PDC Endowment shall be used for the Department's charitable work. The Department Treasurer shall invest PDC Endowment funds and provide regular financial reports. The Department Council shall provide guidance and regular audit reports in accordance with the SUVCW Constitution and Regulations (C&R).

¶ 901 Charitable Fund. One dollar (\$1.00) from each member's annual Department per capita shall be restricted to the Department's charitable work. The Department Treasurer shall maintain a separate Department charity fund and provide regular financial reports.

¶ 902 Reserve Fund. The Department Treasurer shall reserve two-years operating expenses to manage annual cash flow, provide special project seed money, and ensure long-term financial stability. Reserve funds may be invested in short-term instruments. A Department Encampment or Business Meeting may suspend this policy to meet a specific financial obligation or requirement.

- 4. Accounts. Dale Crandell requested review of the proposed starting balances.
  - Motion by Dale Crandell, seconded by Walter Busch, to establish the following fund and account balances. Approved.

- 5. *Investments*. Commander Amsler appointed an Investment Committee: Mark Coplin, Robert Aubuchon, Walter Busch, Donald Palmer, Dale Crandell, and Gary Scheel with the charge: present recommendations on investment strategies for the PDC Endowment and other Department funds.
  - Motion by Mark Coplin, seconded by Gary Scheel, that when the Department's \$10,000 CD matures, invest \$5,000 in a market index stock fund, such as S&P 500 and \$5,000 in a CD. Approved.

**Close Meeting**. Commander Robert Amsler closed the Department Business Meeting at 1:15 pm. Chaplain Mark Coplin gave the benediction.

Opening Prayer – Mark Coplin - Department Chaplain

Oct and March meeting minutes approved – Dale Crandell 1st and Randal Burd  $2^{nd}$  – Approved

\*Walt Busch made a motion that if a member did not have a written report, then he would only have 5 minutes of discussion. Craig Mathews  $1^{\rm st}$  and Randal Burd  $2^{\rm nd}$  – Approved

Commander Report — Bob Amsler Jr — Started out by mentioning the Sherman Flag program — General Petraeus was given a flag last year at the Grant Event in New York. Gave a flag to the Grant Tomb director Frank Scaturro — The tomb was in disrepair — He was able to get the government to correct the problems. He also mentioned the apology of Brother Petrovic to the department for his actions against Dale Crandell. Walt Busch — Question — will we see the report? Per the DC the report is in the committee's hands. Don Palmer — The hearing council has to review and make a decision — then send their finding to the DC. Then the findings can be released to the entire department. McNeil Camp has officially folded. See Report for more details

## Senior Vice Commander Report - Bob Aubuchon See Report

Junior Vice Commander – Randal Burd– Multiple new members – A gentleman from Maryland had ancestor who fought for Missouri. He suggested that the new member join a camp I Maryland so he could participate. Dead Line for the Unionist is June 30<sup>th</sup> - Essay Committee – not appropriate essays submitted. Recommendations 1) Quartermaster e501 – rewrite (see report) 2) Adjust the State map to better reflect the areas each camp cover since the lost of McNeil from Northern Missouri. (see report) 3) Department Commander to review all past orders in the Department – (see report)

Point of order – Walt Busch and Don Palmer - Need an Encampment Committee to review all the recommendations, by law and order presented at the Encampment. Bob Amsler Jr. appointed Don Palmer Jr, Joe Rainey and John Palmer to review the items mentioned above. Since only recommendations were made Don asked Sumner to assist in the review.

Essay – Randal Burd – Need to review if want to continue the essay contest. Need also contact the schools so they know what the scope of the essay should be.

Bob Amsler Jr – May want to contact Greg Wolk to see if his organization would be willing to assist with the essay reviews. Need to review and see how best to move forward.

John Palmer – Focus on 7<sup>th</sup> to 12<sup>th</sup> grade. They start American History in 7<sup>th</sup> and review in High School.

#### Unionist -Randal Burd - Dead line for information is June 30th

Mark Coplin – Mentioned the passing of a member of the Talkington Camp in Arkansas – David Nelson Alexander - 69 of Van Buren, Arkansas – Information to be sent into Randal and to the National Chaplain.

#### Secretary Report - See Report

Walt Busch suggested that we need to decide if we can have a cut off day earlier in March. To give the Secretary more time to prepare the Per Capita Tax forms. It also gives him more time to chance down problems and make corrections. Maybe a March 15<sup>th</sup> date? Ed Krieser CinC mentioned that National Sets the deadlines. He did not think a department could change those deadlines. Walt – Withdrew his Suggestion and reported we need to think about it and address at a later date.

#### Treasurer Report - See Report -

Recommendations - 1) Approve the Budget today. 2) Past Department Commander's fund — What is the fund for? 3) *Charitable Fund* (defer this until the October meeting) 4) Would suggest the Department have 2 years of operating funds on hand. Contact Department members to make sure they are aware of the Department's 501C3 status.

Don Palmer Jr – Has anyone requested funds? Dale – No one has requested any funds. He has gotten a request for a project for Grant Camp.

Bob Amsler Jr – We need to have a written definition of what a charity is.

Randal Burd - Is there already a definition out there already? Ed Krieser No – Your use the funds for what you think is for charity and the IRS will see if it meets their requirements.

Walt Busch – Honoring the Civil War or something dealing with Patriotism, Confederate Essay was awarded funds in the past

Bob Amsler Jr - We should not be rewarding someone for a Confederate Essey.

Don Palmer Jr – Just to give a historic perspective the Past Department Commander fund was started 20 years ago

Ed Krieser - Charitable means there is a need. Restricted fund – articles in the bylaws – articles of incorporation

Walt Busch – Can Dale and I meet and put together a form to pass out to the camps on what is e expectable as charity? This will be presented in the October meeting.

Don Palmer Jr and Bob Amsler Jr. - Now that we are a 501C3 we need to be very careful.

Dale Crandell - May need to reword the definition of what the Department can do.

Walt Busch - Currently has \$10,000 in a CD with a 4% interest rate for 8 months

Bob Amsler Jr. - Can invest in conservative investments – 501C3 Vanguard - Fidelity or Edward Jones. Stock market is doing better than the rate of inflation. Low risk – Will look at this and present at the October meeting – in the meantime will help look into the type of products we would be interested in investing in. Vanguard takes 1% on the money you make.

Walt Busch – Money Market? Bob Amsler Jr – Looking at what product to place the funds of the department.

Glen Alsop – Mercy where he works uses Vanguard for their 401K and is happy with the product. Don Palmer Jr – Boeing uses Fidelity – Sumner Hunnewell – Wise to look into investments to grow the funds of the Department

Kirk Singleton – Is there a minimal amount to invest? Bob Amsler Jr - \$5000,00 and you can pull money out without a penalty.

Budget - See Report – Walt Busch  $1^{st}$  and Randal Burd  $2^{nd}$  – Approved the budget section with the cash section put on hold.

- <u>Patriotic Instructor</u> Dale Crandell Recommendation The Department send a donation to the Springfield National Cemetery Patriotic US National Cemetery to Flag Day. Submitted to National
- <u>Eagle Scout</u> Sumner Hunnewell This past year we had 7 Courts of Honors We have a patch, challenge coin and certificates. Kevin Miller West had 2, Travis Cummings in Arkansas also had 2, Chris Warren has talked with his Scouting Troop to make sure they knew of our free program for their Eagle Scout Events.
- ROTC JROTC Dale Crandell No report Arkansas awarded the most, Westport came in 2<sup>nd</sup> JROTC 1 nominee for outstanding cadet Joe Rainey Major Clay contacted all the ROTC and JROTC units. Will be presenting him with an award for all his work. He is a member of Spradling Camp Was suggested by the encampment that he be an assistant to help with covering the state of Arkansas. Joe will ask him.

Walt Busch – Are the members in Arkansas still trying to establish enough camps to form their own Department? – Suggestion – to have an assistant Patriotic Instructor, Eagle Scout and ROTC/JROTC in Arkansas. That way when you are ready to form your own Department you will already have the frame work set for the leadership in those areas.

Graves Registration Officer – Gary Scheel is stepping down as grave registration officer. Randal Burd – Recommended Glen Alsop to take over the position of Grave Registration Officer. Glen agreed to taking over the position. Bob Amsler Jr. – Recommended that Glen contact Gary if he had any questions or needed help with the position. Gary was one of the hardest working grave registration officers. Glen mentioned that grave registration was one of the reasons he joined the Sons.

Medal of Honor - Randal Burd - No report

<u>Historical Records Officer</u> – Walt Busch (See Report) In July 21 and 22<sup>nd</sup> - The director of Fort

Donnelson to give a talk at The Soldier's Memorial and also at Grant Remembrance Day at U. S.

Grant Historical site. October 20<sup>th</sup> at Jefferson Barracks – US Grant Camp will be holding their annual 56<sup>th</sup> Colored Infantry Remembrance – two JROTC units will be providing a color guard.

Will have a bag piper. Bob Aubuchon is setting up the uniformed units and color guard. Retired General Bagby will be the speaker at the ceremony.

<u>Awards Committee</u> - Bob Aubuchon - Blair Awarded to Dale Crandell. Meritorious Service Award to Alan Trodus. Two GAR Awards - Louis Volker at Fletcher Sharon Michael Member of the Julia Dent Tent - Can either meet her or can give it to her at the Grant Remembrance Day. Two Eads Awards - US Grant Camp and Fletcher Camp.

the roll of ribbons to Sumner Hunnewell – Maybe he can use them for some project. Reminded
the Encampment that the Central Regional Meeting this year will be in Dayton OH

<u>Quarter Master</u> – He suggested that all the meeting minutes need to be in binders – Recommendations.

- Physical book of all the encampments – Retiring from the post. Time to give it up. Walt Busch is to take over the position. He has a large garage.

<u>Camp Reports</u> - Arkansas submitted the only camp report. (See Report) Items not mentioned in the report include – McPherson Camp members volunteer at the Pea Ridge Battlefield and Prairie Grove sites. They run Children's Programs, Artillery Crews. Murphy Camp – Mark Price working on putting up a Colored Infantry Monument – 5 artists so far have submitted their ideas. There will be a review. Shawne Lynn CC – is on the committee in Little Rock – Is requesting funds from the Department and National for the monument.

Dale Crandell – There are funds in the budget for monuments.

Joe Rainey – We have started to receive fund but still don't know the final cost of the project. Mark Coplin- Have the members in Arkansas asked for funds from any state or local agencies? Joe Rainey – Central Library is making a donation for the project.

#### Reference for Communication – No Report

New Member - Charles Holt of Phelps was initiated during the Encampment by Brother Ed Krieser

Sumner Hunnewell – Has sent up to the Commander in Chief the Unionist and the Best Camp news letters of the Department. Don Palmer – Reviewed multiple camps and departments can send in more then one report or newsletter. Bob Amsler Jr – Will review the C & Rs.

Ed Krieser – With the computer age more Department and Camp Newsletters are being reviewed by the C in C.

Reconvened at 12:42

Randal Burd – Are Department members using it? How do you we move forward? Issue with the program – There are free version or similar programs that do the same thing?

Glen Alsop – Motion – That we use the Group IO program for one year starting in March.

Dale Crandell - Camps will have a subgroup - top down

Ed Krieser and Don Palmer – They know that most of the camps will not be able to set this up. If all the camp can put up the information on Groups IO – put there calendar up on the Group IO – It will need to be set up initially.

Bob Amsler Jr - Would benefit from the camps to put in basic and information to the members. Not to replace the Unionist and could up load all the older Unionist editions.

Walt Busch – You can't require at camp to use this program.

Dale Crandell – Have a hard enough time getting the camps to get their EIN – Or send in the forms. About  $1/3^{rd}$  of them will try it for the year.

Motion to continue the trial period for Groups IO – Glen Alsop 1st - 2nd by Joe Rainey

Majority of those present voted yea and 2 objected. – Approved

#### Award Committee - Plaque - Cost increase

Don Palmer – Awards were plaques – other awards for other certificates. He is in favor of returning to using plaques for the top awards – Blair Award, Meritorious Service and Show Me Spirit Awards – We need to stop the cheapness in the Department. We are sitting on funds and can use them to help thank those that have helped the Department.

Walt Busch – Prefers certificates – Made a motion to purchase plaques at \$50.00 or less per plaque. This would include the Blair Award, Meritorious Service Award and the Show Me Spirit Awards. Craig Mathews 2<sup>nd</sup>

Randal Burd – Why are we asking for an increase in dues?

Mark Coplin – The Blair Award is received in 2005 still hangs on my bedroom wall. I look at it and realize I need to continue to strive to do my best for the Department. The plaque means more to me then a piece of paper in a cheap frame.

Motion to return to plaques as noted above - Unanimous vote -Approved

<u>Treasurer</u> – Dale Crandell - Will move the funds from different accounts and amend the budget. Would prefer to move for the budget to be considered.

Quarter Master - Post to be filled by Walt Busch.

**GAR monument** in Mountain Grove

<u>Transgender Policy</u> – Randal Burd – Wrote a revised version of the police and read it aloud to those at the Encampment. The Department of Missouri does not concur with the policy as it is currently written. Sumner Hunnelwell – Can this be sent on to National as an amendment to the policy.

Randal Burd – Yes that is the plan. yes, Walt Busch made a motion to approve what Brother Burd has written.

Dale Crandell – Likes the wording from National.

Sumner Hunnelwell – Prefers this new version as it provides intent. (Talking to Randal Burd) Can this be drawn up into a resolution. Randal Burd – Agreed to finalize the resolution and send it to the Department Commander. This will then be sent onto National in time for the National Encampment.

Dale Crandell – Wants to make it clear in the resolution that the Department of Missouri is against the current version as written.

Motion 2<sup>nd</sup> by Craig Mathews – 1 Dissenting vote – Approved to be made into a resolution and sent onto National.

<u>New Business</u> – Walt Busch -Do we want to present gifts to the Commander in Chief and if so, what? Memorabilia form Shiloh? Vicksburg medal, books? Set of coins?

Sumner Hunnewell – He reported he has a 16 x 20 Red Sox signed photo – will donate as a gift.

Financial Policy. The Department has accumulated \$15,248.28 in cash assets and would benefit by setting financial policies for the Department Treasurer.

Recommendation 1: Approve the following three Department Policies and authorize the Bylaws Committee to add them to the Department Policy and Procedures Manual (P&PM):

¶ 900 Past Department Commanders Fund. The Past Department Commanders (PDC) fund is an endowment to support the Department's charitable work. The Department, Camps, members, Allied Orders, and non-members may donate to the fund. All donations to the PDC fund shall be invested in long-term instruments to produce annual income. All annual income from the PDC fund shall be used for the Department's charitable work. The Department Treasurer shall invest the PDC funds and provide regular financial reports. The Department Council shall provide guidance and regular audit reports in accordance with the SUVCW Constitution and Regulations (C&R).

¶ 901 Charitable Fund. One dollar (\$1.00) from each member's annual Department per capita shall be restricted to the Department's charitable work. The Department Treasurer shall maintain a separate Department charity fund and provide regular financial reports.

¶ 902 Reserve Fund. The Department Treasurer shall reserve two-years operating expenses to manage annual cash flow, provide special project seed money, and ensure long-term financial stability. Reserve funds may be invested in short-term instruments. A Department Encampment or Business Meeting may suspend this policy to meet a specific financial obligation or requirement.

Accounts. With approval of the financial polies, the Department should set starting balances for each fund.

Lt. Col. J. Felix St. James Camp #326, would like to ask the Department of Missouri to consider becoming involved with the saving of the Chapel at the Missouri Veterans Home in St. James, Missouri.

Camp Commander Michael Schaaf and I met with Tim Hoyer, Director, Facilities Operations, Missouri Veterans Commission; Shane Bullock Construction Project Specialist, Missouri Veterans Commission; Brittany Ritter, Facility Administrator. The main reason for this meeting was because of the concern of the destruction of the Chapel.

I explained that we would not be able to donate

enough money to accomplish their goals for this building.

The inside of the building is in great shape having been renovated in 1971.

They are hoping that we can support them with monetary donations, also expressing we would be the most beneficial as a heredity organization of the Grand Army of the Republic appearing in front of the legislature the importance of supporting the restoration of the Chapel

When asked the projected use for the building once it is restored, Facility Administrator Brittany Ritter sent the following answers. Found below are the questions and answers

- 1. What is the purpose of the restoration? (Brittany) I feel that the purpose of the restoration is really for the community, as this has sentimental value to the community. This building represents significant historic roots for the city of St. James.
- 2. If the building is restored are there plans to use the building in any capacity? (Brittany) At this time, for the Home, I don't see utilizing this building on a regular basis. I think it could be used for special occasions, such as certain activities, family events, etc.

The immediate concern is the removal of the bats that live in the attic.

There were three GAR Posts in St James and two of them were at the Soldiers Home. Veterans at the Soldiers Home had joined Post 297 but when the two posts were formed at the Soldiers Home they joined these two posts.

St James is the site of the first state veterans home. It was originally opened in 1896 by the Women's Relief Corps Soldier's Home Association, and was deeded to the State of Missouri in 1897. Mrs. Hollen E. Day, President of the General Lyons Corp, No. 38, Women's Relief Corps, St. Louis, MO, pushed for the opening of the home. The town of St. James presented the William James Mansion and the surrounding 60 acres to the W. R. C. in 1895 to serve as 34 room home.

In the cemetery in there are three hundred and twenty graves of Civil War Veterans buried in the cemetery on site. Of these approximately two hundred of them died after the Chapel was built.

Our hope is that helping to restore the Chapel, that we may be able to preserve the memory of the members of Post 586 and Post 593 of the Grand Army of the Republic that existed on this site.

#### SOLDIERS' HOME

The Soldiers' Home at St. James, Mo., while not under the immediate care of our organization, comparatively speaking. It is, from the fact that the majority of its officers and board of directors are Comrades or the wives of Comrades, and on that account the institution is one that the old soldiers of Missouri have a direct interest in, and one that we as Comrades are justly proud of. It is beautifully situated at the foot of the knobs of the Ozark Mountains, six miles from the Meramec River. It contains sixty acres of land, comprising orchards and lawn. It has accommodations for about sixty people; but when I visited the Home on January 27th it had seventy-six inmates, old soldiers and their wives.

On August 18, 2023 Lt. Col. J. Felix St. James Camp #326, Camp Commander Michael Schaaf and Gary Scheel traveled to St. James for a meeting with representatives of the St. James Veterans Home. The reason for our going there was to look at the condition of the historic 1906 Chapel on its property.

This is the last remaining building that is still in existence that has an affiliation with the Grand Army of the Republic.

There is much concern of the possibility the State of Missouri has interest in tearing it down.

Those we met with want the building to remain. The City of St. James has expressed interest in the building remaining because of its historic significance to the site.

On September 12, 2023 at our Camp Meeting a motion was made by Marty Aubuchon that Camp #326 support the efforts to restore this building to keep it from being destroyed. It was seconded by Paul Kist and approved unanimously by those present at the meeting.

Our hope is by helping to restore the Chapel that we may be able to preserve the memory of the presence of the members of Post 586 and Post 593 of the Grand Army of the Republic that were active on the site.

-Returning from the Civil War, 175 African American Infantrymen contracted Cholera and died just south of St. Louis. Refused burial at Jefferson Barracks National Cemetery, they were buried in a mass grave. In the 1930s the members of the African American community spearhead the re-interment at the national cemetery and the creation of a monument in 1939. In 2014, Sarah Cato, an educator in African American History, led a movement to add to the monument the names of the interred soldiers. The Sons of Union Veterans of the Civil War were active with Ms. Cato throughout the event and with her guidance have taken over the responsibility to honor these patriotic men on a regular basis.

To remember and pay tribute to these men, the U.S. Grant Camp #68, Sons of Union Veterans of the Civil War, located in the St. Louis Metro Area, annually holds a graveside ceremony in their honor. We are dependably assisted by other patriotic organizations such as the Julia Dent Tent, Daughters of Union Veterans of the Civil War 1861-1865; the Woman's Relief Corps; Auxiliary to the Sons of Union Veterans of the Civil War; the Sons of Veterans Reserve; and the Veterans of Foreign Wars amongst others.

This year, we are honored to welcome a descendant of one of the veterans of the 56<sup>th</sup> USCT, retired Army Major General Byron Bagby, US Army (Ret.), as our featured speaker. Major General Bagby, who retired after 33 years active duty while serving in a multitude of leadership positions, will deliver our keynote speech: "The 56th USCT, They Served Proudly!". A native Missourian, he currently serves on the Board of Trustees at William Woods University in Fulton, Missouri, and also is a member of the Board of Trustees at Columbia Southern University (Orange Beach, Alabamale), Byron also serves as chair of the Board of Advisors for the Ryan Consulting Group, is a; member of the Board of Directors for Management Support Technology Inc., and was a member of the Westminster College Board of Trustees from 2012 to 2017.
