Post (use separate document if necessary): Perry County Sun, 30 April 1886. Several old soldiers, some thirty-four in number, met in the office of Judge Weber, last Friday, for the purpose of organizing a post of the G.A.R. in Perry County. There were thirty-four present and talked over the matter of organizing. It was agreed that a post should be established and known as the Difani post, in honor of Lawrence Difani, who was one of Perry County's sons who found his grave while battling for the preservation of the Union. An application for a charter has been sent off and upon favorable reply a permanent organization will be effected, known as Difani post. Perry County Sun, 21 May 1886. A G.A.R. post known as Difani post, consisting of 44 members, 39 enrolled, was mustered in as Monday by Reuben Albert of Fredericktown, MO. It was agreed that regular meetings of the post be held every Saturday of each month at 2 o'clock P.M. in Markwort's Hall.! **Meeting Facility** Structure Still Exist?






Lorenz Difani


Lorenz Difani was born on August 9, 1835 in Zusenhofen, Baden, Germany. He emigrated to Missouri on April 17, 1851 with his mother and other siblings and settled around Perryville, Missouri. At the beginning of the Civil War, he was among the first to respond to President Lincoln's call for troops. Lorenz enlisted as a Private in Company A, 3rd Regiment Missouri Volunteers on June 8, 1861 in St. Louis, Missouri. He fought at the Battle of Wilson's Creek and was discharged on September 3, 1861. He re-enlisted with Company F, 17th Regiment Missouri Volunteer Infantry on October 16, 1861 in St. Louis, Missouri. He participated in the Battle of Pea Ridge, Arkansas. On May 19, 1861 he was killed at the Battle of Whitney's Lane at Searcey's Landing, White County, Arkansas. In May of 1886, Difani Grand Army of the Republic Post #273 was established in his honor in Perryville, Missouri. THE COURTHOUSE SQUARE IN 1895

Beginning on the southeast corner of the County Court House the first building to attract the eye is the handsome two story brick Opera House block erected in 1879 by A. H. & W. A. Cashion at a cost of \$8,000.00 The building, at that time was one of the substantial ones of the town. The block in 1895 was owned by John Ziegler and was occupied as a saloon in the corner room, with the law office of D. C. Farrar and the Sewing Machine Shop of John Cashion. The remaining part of the block was occupied by The Republican Office and its extensive printing shop. The greater part of the second floor was used as an Opera House. It was leased by the McNeil Carup. Sons of Veterans who used it as their lodge room in connection with the Difani Post No. 273 G. A. R. The Ladies Auxiliary to the Son's of Veterans Camp also occupied this place as their Lodge Room. We next come to the frame building of the Thomas Hooss Agricultural Implement Co. where all kinds of farm machinery were to be had. Next inorder came the building owned by Frank Steiber. It is still standing. It is a frame structure and was occupied in part by G. Halter harness emporium. The other part was operated as J. Baker Shop. Peter Jung lived in the rear of the Bakery. We then come to the Mrs. J. F. Bey property. Beckman & Weber had a big Hardware Store here with stoves and tinware of all kinds, they are still with us, though both retired. corner part of the Bey building was the headquarters of the L'hote and Muench General Merchandise, They had a fine store and were deservedly por merchants. The Globe Shoe Store carried all kinds of foot wear and was housed in a frame Building owned by Jos. Duerr on the south side of the Square. came the law office and residence of J. J. Seibel. We now come to the large brick house on the corner of St. Joseph and Jackson Streets still the property of Mrs. Bey, here J. V. Moore sold groceries and furniture and J. Hooss & Co., general merchandise. The second floor is the residence of Dr. J. E. Bey. On the opposite corner where now stands the K. of C. Building was located the South Side Market. On the opposite corner, namely the Northwest of St. Joseph and Jackson Streets Henry Schade had his Grocery Store. Next to the Schade Grocery Store, F. L.Tucker had a Hardware Store. Then came the two story brick structure still standing owned by Mrs. Christine Hudson which then
