Randal Burd moved that an Award for Outstanding ROTC or Humanities Scholarship be capped at \$700.00 maximum. Motion was seconded and passed.



Monuments, GAR/SUVCW Record

Took Pictures of 5 Monuments – all out of state.

Added 5 monuments to the website that I've been sitting on a while (due to the National Encampment). One was from Brian Smarker.

Added one marker – 2-16-2022 Sumner and I took pictures of the marker on Broadway of Sherman's Business Office in St. Louis.

The German-American Consortium in St Louis is working on restoring the round bas-relief sections of the Col. Hecker Monument in Benton Park. Grant Camp is part of the work on this and we are also working with Hecker Camp in Belleville, IL, to provide informational markers at Benton Park and at Hecker's gravesite or nearby town.

I have not heard anything on how the repairs to the GAR monument in Laclede Missouri are going.

Nothing else concerning historical records. I am finally done with a lot of work and now processing more monument records etc. So, I will post them as needed on the web.

DEPARTMENT ENCAMPMENT COMMITTEE:

As head of the committee for department encampments I would like to thank Bryan Bradford for his work on trying to get an encampment in Columbia. Unfortunately, I was unable to resolve us paying over \$300 for the Legion Hall and also finding reasonable accommodations (rooms for members) in the area.

I tried checking out not only Columbia, but also Boonville, Kingdom City, and Fulton. I could not find decent rates for a meeting room & lodging combined. For this reason, I checked Jefferson City and the Best Western Plus there. I knew they had a meeting room as I had attended regular meetings there when I was a ranger. Below is a contract for a room set up for 40 people (I know it will seat more if need be). The hotel can be had right now for rates of \$117 before taxes. HOWEVER, I was told by Mr. Grogan (below) that if I can guarantee at least 10 room nights we can get a discounted rate (ex. Gov't discount is at \$101.00). So, do we have enough people wiling to take a room for one or more nights so that I can get a discounted rate for the group? **The contract for this meeting room has been signed.**

Friday Evening...Do we want a social get-together? We aren't far from our Mexican restaurant. Das Stein Haus is less than a mile over the overpass. It's been a while since I've been there, but their Irish Coffee had 1/2 thick creme floating on the coffee and was to die for as was their French Onion soup. Here is their menu http://dassteinhaus.info/services...As you can see, their menu is much more than German.

What do we want for lunch? We should have enough space in the meeting room that we could get Pizza, Subway, Jimmy Johns (yuck), or something delivered in.

Also, for your officers. Mr. Grogan runs a management company that is aggressively trying to get local motels/hotels to use their services in Missouri. Right now, we could get a hotel in St. Charles (no meeting room) or a hotel in Kirksville (with meeting room). We need to keep his info. He is willing to give us good rates and hopefully by next year may have more hotels in Missouri. I do not want to run this committee again, so someone needs to step up. My recommendation to my successor and the department is that since we have Arkansas Camps, we really ought to only consider meeting places along I-44 and south.

NOTE: I have only heard from four people about this. Two are good with pretty much everything/anything decided and will be there Friday night. Don Palmer suggested the Prison Brewery on Friday night instead of Das Stein Haus. That's about it! I have only heard from Ed Krieser, Dale Crandell, Gary Scheel and me about staying Friday night. That is not enough for room discount rates.

I need the commander or someone to find out who is attending from National so I can contact them about room arrangements.

SO,

- 1. Shall we have a Friday night meal?
- 2. Shall we group order food that morning, all go out for lunch, or provide a list of restaurants that people can order from and get delivery around lunch?

GRANT CAMP REPORT:

- I am afraid we may be losing 12 members in 2022. I've sent out membership renewals and 9 have not yet responded. 2 have responded advising they are dropping, 2 have passed away.
- We have picked up 3 new members (one under 40) and two more have expressed interest and sent in forms, but as of yet no payment. Our new members are Jay Evans (associate), Gunner Decker (under 40); and Dan Woodruff.
- On another membership note, we now have 14 life members.
- We are running on April 9 & 10 a genealogical table with recruiting info at US Grant NHS (White Haven) during the 157th Anniversary of Appomattox event.
- We are working on creating a "plaza" in the area of Sherman's Grave. We should begin selling "memory" bricks this year. We will be selling some larger one that the SUVCW or other logos can be put on. Costs have yet to be determined.
- Sherman Remembrance Day at Calvary Cemetery on 13 March at 1PM. The Daughters are joining us in this event. [attachment to report].

UNFINISHED BUSINESS:

SUVCW Property Forms [See attachments]. Wasn't a committee appointed to review and give this up or down vote? If not, when will we review this.

WALT'S GENERAL RECOMMENDATIONS (CALL THEM MOTIONS FOR OLD BUSINESS):

1. Why hasn't the Show-Me Award for Catherine Bell been made and presented to her?

The time lapse is embarrassing. If it has not been made, I move we immediately make it so that Westport Camp can present it to her (if they are still willing to do so). [Note: If need be give me a budget for it and I will have Arch Engraving make it for us.]

WALT'S GENERAL RECOMMENDATIONS (CALL THEM MOTIONS FOR NEW BUSINESS):

- 1. We revised the policy that e-mails to the membership at large have to have the approval of three officers. I recommend that we say that all e-mails going out to all department members, unless it is an emergency e-mail coming from our department commander, <u>must</u> be sent through the department secretary. My reasoning on this is that most e-mails at the national level go out through the chief of staff. We have none and correspondence is generally conducted through a secretary. This allows for spelling and other errors in department order or correspondence to have a better chance of being caught so as not to embarrass us. I would also recommend that misuse of department group e-mail addresses by any member of the department can be punished as per department and national by-laws.
- 2. Motion: Since we have the national encampment win fall, I recommend that to conserve it as best as possible that we require any monument funds requested from it, must show that there is paperwork submitted to national SUVCW &/or the SUVCW Charitable Foundation requesting they provide funding.
- 3. Motion that ROTC/JrROTC, Eagle Scout, and History Paper/Humanities Scholarship often have funds that are unused from year-to-year. These funds have been approved to grow but there is no limit on them. Motion that we limit the total given out to any one awardee to be no more than \$700. That is a worthy amount. If an award is given for, say, a Humanities Scholarship and the family is known to be a poor family, I would have no problem voting at that time to give them a little more money to assist with travel expenses to receive the award.



Department of Missouri – Sons of Union Veterans of the Civil War Procedures for Acquiring Artifacts and Items

Position: The Sons of Union Veterans of the Civil War are pledged to preserve the memory of the boys in blue and the Grand Army of the Republic. To that end, preserving artifacts of the soldiers is part of our sacred duty. The department of Missouri wants to be clear and honest when dealing with people who wish to donate items to the department or any of its camps. Therefore, any gifts of artifacts or other items (such as a Ipad, etc.), shall have either an article of bailment or an article of gift completed for it.

General Procedure: Artifacts or items can be taken into camp or department possession in two ways.

- 1) Bailment: This is where a person is loaning the department or camp an item for a period of time (an example of this would be someone presenting an original GAR post flag and allowing us to display it at an encampment) but then wanting it returned. The form *Articles of Bailment* will be filled out.
- 2) Gift: A person wishes to donate an item to the department or camp. This becomes the property of the camp or department to do with as they wish. An *Articles of Gift* will be filled out.

Each form will be filled out as completely as possible. If a camera, for example, is being donated to a camp, the brand of camera, model and serial number is the minimum information that should be recorded on a form. If an artifact is being donated, more than one picture of the item (different angles, identifying marks) should be taken and attached with the form.

Special Provision for *Articles of Gift*. A section of the form indicates the intent of the camp/department for the future use of the item. An individual may want to donate a GAR sword, for example, to a camp and want the camp to possess it so that it is preserved for public enjoyment. The camp, on the other hand, may look at it as something they want to sell on E-Bay and make some money. Therefore, the intent must be filled out so that the donor knows upfront what the camp intends to do with it. Example: The department has taken some GAR records recently to be photographed and documented for our website. Both donors were advised that upon completion of the photographing we would donate the artifacts to a museum or library of consequence.

Additionally, especially for gifts, if the donor puts conditions on the gift, those need to be listed on the form. Example: They want it displayed at all meetings with a plaque that says it was donated by them. If those are the restrictions and the camp/department accepts the gift, we must adhere to them.

Forms will be signed by camp commander or department commander depending on who is taking possession of the property. Property taken in by the department may be assigned to a camp's care.

ALL COMPLETED FORMS FOR EITHER CAMP OR DEPARTMENT PROPERTY WILL BE SENT TO THE DEPARTMENT SECRETARY SO THAT PROPER FILES CAN BE MAINTAINED. THE DEPARTMENT SECRETARY WILL PROVIDE A COPY OF THE FORM TO THE QUARTERMASTER FOR ALL PROPERTY OWNED BY THE DEPARTMENT! CAUTIONS:

- 1. We rely on our members to keep many of the items in their houses due to a lack of storage owned by camps/the department. People wanting to donate true artifacts to us should often be encouraged to instead donate them to a museum/library of consequence. By consequence, we mean such as the State Historical Society in Columbia, the Department of Natural Resources Historic Sites and State Museum, Wilson's Creek NHS, US Grant NHS, Missouri Historical Society, etc. Local museums should generally be avoided because many do not have good procedures and security to ensure the preservation of the artifacts.
- 2. Should a camp or department accept an artifact, it is the responsibility of the camp or department to retrieve the item from individuals who leave the organization or pass away. This means that if a member passes, you must retrieve the property! If the family refuses to give it to the camp/department, the camp or department is expected to proceed with court action, such as through a lawsuit or through replevin. The department considers it the camp's and department's fiduciary responsibility to retrieve artifacts that are in our possession.
- 3. Accepting a donation of an artifact may well cost a camp or department money not only to recover it above, but to preserve it. It is for that reason that artifacts are often better in the possession of a museum/library.

It would be hoped that some day in the future, the department will possess its own building. That would be great! At that point we would be in a position to obtain, hold, and display artifacts. Finally, for all property of a camp or department, yearly accountability should be practiced. Any member that has property of the camp/department should sign a form provided by the department (or similar statement) that acknowledges possession of SUVCW property.

ALL COMPLETED FORMS FOR EITHER CAMP OR DEPARTMENT PROPERTY WILL BE SENT TO THE DEPARTMENT SECRETARY SO THAT PROPER FILES CAN BE MAINTAINED. THE DEPARTMENT SECRETARY WILL PROVIDE A COPY OF THE FORM TO THE QUARTERMASTER FOR ALL PROPERTY OWNED BY THE DEPARTMENT!

CAUTIONS:

- 1. We rely on our members to keep many of the items in their houses due to a lack of storage owned by camps/the department. People wanting to donate true artifacts to us should often be encouraged to instead donate them to a museum/library of consequence. By consequence, we mean such as the State Historical Society in Columbia, the Department of Natural Resources Historic Sites and State Museum, Wilson's Creek NHS, US Grant NHS, Missouri Historical Society, etc. Local museums should generally be avoided because many do not have good procedures and security to ensure the preservation of the artifacts.
- 2. Should a camp or department accept an artifact, it is the responsibility of the camp or department to retrieve the item from individuals who leave the organization or pass away. This means that if a member passes, you must retrieve the property! If the family refuses to give it to the camp/department, the camp or department is expected to proceed with court action, such as through a lawsuit or through replevin. The department considers it the camp's and department's fiduciary responsibility to retrieve artifacts that are in our possession.
- 3. Accepting a donation of an artifact may well cost a camp or department money not only to recover it above, but to preserve it. It is for that reason that artifacts are often better in the possession of a museum/library.

It would be hoped that some day in the future, the department will possess its own building. That would be great! At that point we would be in a position to obtain, hold, and display artifacts.

Finally, for all property of a camp or department, yearly accountability should be practiced. Any member that has property of the camp/department should sign a form provided by the department (or similar statement) that acknowledges possession of SUVCW property.



William Tecumseh "Cump" Sherman, perhaps best known for his 1864

United States Military Academy at West Point in 1840. He became acquainted with the people and Carolina between 1840 and 1846. After serving during the Mexican War of 1846–1848, he resigned brigade of inexperienced troops at First Bull Run (First Manassas) before being transferred to the he West in March 1864, Sherman vigorously implemented the Union's then-prevailing "hard war": Sherman's postwar career was marked by a fifteen-year tenure as commander in chief of the U.S. Army (1869–1883), publication of his memoirs in 1875, and his popularity as a speaker and writer. developed a close working relationship with Grant. Replacing Grant as the overall commander in taking possession of Atlanta on September 1, 1864, Sherman ordered his army of 60,000 men on Jlysses S. Grant at Shiloh, where Sherman's gallant conduct resulted in his promotion to majormilitary strategy, in the process making his name infamous to generations of Southerners. After his commission in 1853. A strong Unionist, Sherman volunteered for duty in the United States general. With this battle and later engagements at Vicksburg and Missionary Ridge, Sherman infrastructure and personal property from these marches, particularly the one through South 1864. From there, Sherman sent his forces north through the Carolinas. The destruction of "March to the Sea," (1820–1891) was born in Lancaster, Ohio. Sherman graduated from the Army in May 1861. Initially appointed colonel of the 13th Infantry Regiment, Sherman led a Western Theater. After garnering some unflattering publicity in Kentucky, he served under a nearly 300-mile march through Georgia, ending with the fall of Savannah on December 21, Carolina, devastated areas in his army's path and played a key part in ending the Civil War. geography of the South when the U.S. Army stationed him in Florida, Georgia, and South Sherman was a member of Grand Army of the Republic Ransom Post 131 in St. Louis.
