

## CEDAR HILL, JEFFERSON COUNTY, Mo., February 17, 1892.

DEAR SIR: I see you are going to investigate the Pension Office. I herewith inclose papers from George E. Lemon to a comrade of my post, Frederick Lundermann, received December 26 last. The circumstances are: Luderman is a pensioner under the act of June 27, 1890, and more than a year expired before he received an order to go before an examining board, although he wrote to Pension Commissioner asking for an order, and December 26 he received the order through George E. Lemon.

Ludemann was his own agent; never employed Lemon in his life; did not send his

papers back to Lemon, but sent it to the Pension Commissioner.

The trick is this: had he sent it to Lemon it would have been filed by him, and then Lemon would have sent him a contract to sign to pay him \$10. Now, Lemon must have a bargan with some one in the Pension Office to send to him the papers belonging to parties having no attorney (like Hamlin, of Maine, when rafts were broken up he claimed all the unmarked logs), and it ought to be easy to find who sent that paper to Lemon. Ludemann's number is 517698, B, 47th Mo. Inf.

This is not by any means the first time this dodge has been played, but it is the first time the papers have been kept. The es. paper is not there, of course, but it can be sworn to by the commander and quartermaster of John D. Rohye Post, 314

It is no use bucking against Lemon, but the one who sent him the papers ought to be made to squeal.


