### **Special Committees**

Article VIII, Section 2 of the Department of Missouri Bylaws states that Special Committees may be created by action of the Commander and shall exist for the period of time designated in the creation thereof. Duties and responsibilities shall be defined at the time of Committee creation. Pursuant to Article VIII, Section 2, I hereby create/amend the following Special Committees of the Department of Missouri as follows:

1.) **Vicksburg Monument Restoration Committee** – This committee was created to lobby for state funds to be used in the restoration of the Missouri Monument at Vicksburg. As a special committee with no sunset date, this committee technically ceased existence upon the close of the 2015-2016 administration. I hereby reinstate the Vicksburg Monument Restoration Committee–PCinC Donald Palmer, chair—with the responsibility to:

- A.) Coordinate and plan a rededication ceremony of the Missouri Monument at Vicksburg, currently scheduled (by vote of the 2016 Department Encampment) to take place on Memorial Day Weekend 2017.
- B.) Use momentum from previous efforts to obtain state funding for regimental marker restoration at Vicksburg, and/or coordinate a Department project involving funding from National to accomplish the needed restorations.

This committee shall have a sunset date of 3 Jun 2017 at the close of my administration.

2.) **Department Activity Committee** – This committee was created—PDC Martin Aubuchon, chair—following installation of new officers at the 2016 Department Encampment in response to a recommendation from PDC Martin Aubuchon's officer report, which called for such a committee to coordinate with Allied Orders in Missouri on a yet undefined joint project. The Officer Reports Committee concurred with this recommendation provided a sunset clause is attached. This committee shall have a sunset date of 3 Jun 2017 at the close of my administration. It will be up to the next Department Commander to reappoint the committee at that time.

3.) **2019 National Encampment Committee** – Originally the 2018 National Encampment Committee, this committee was set up to explore the possibility of hosting the 2018 National Encampment in Branson, Missouri. It was quickly learned that 2018 was already spoken for, and thus sights were set on 2019. The defined duties and sunset date on this committee were not set with the 2019 National Encampment in mind. Therefore, the 2019 National Encampment Committee's task shall be making arrangements for the Department of Missouri to host the 2019 National Encampment in Branson, Missouri, and planning said Encampment.

Garland Pool was born on November 4, 1927, in Blackburn, Arkansas. He was the son of Pvt. Charles Parker Pool, Co. D, 6th West Virginia Volunteer Infantry. Pvt. Pool mustered into service on August 20, 1861, and served until August 27, 1864, when his term expired.

- **1.)** The Commander-in-Chief has issued General Order #30, ordering that the National Website, the charters of all Departments and Camps, and all membership badges will be draped in black for 30 days in honor of Real Son Garland Pool, until 8 Sep 2016. ### Passing of Brigadier General (Father) Philip J. Conlon

In 1963, Father Conlon enlisted in the Air Force and served as Chaplain on bases in Taiwan and Thailand until 1967. He then returned to the Madison Diocese until 1994, serving as pastor of four different parishes. During this time, he also continued to serve his country as a member of the Wisconsin Air National Guard. He earned the rank of Brigadier General and in 1990 was honored with induction into the Wisconsin Air National Guard Hall of Fame. More recently, Father Conlon served as a "retired" priest in the Branson area and was Camp Commander of Abraham Lincoln #2, Department of Missouri, Sons of Union Veterans of the Civil War.

## Department Order No. 10, Series 2016-2017

## Consolidation of McCormick Camp #215 with Fletcher Camp #47

Chapter I, Article 4, Section 6, of the National Regulations of the Sons of the Union Veterans of the Civil War states in its entirety:

"Camps may consolidate with one another, provided a two-thirds vote of such Camps shall so decide and provided further that notice of such intended consolidation shall have been sent to the Brothers thereof by mail at least thirty days prior thereto. Such action to be approved by the Department Commander. In such case the books, papers and property shall belong to the consolidated Camp."

General James R. McCormick Camp #215 of the Department of Missouri and General Thomas C. Fletcher Camp #47 of the same requested that their two camps be consolidated into one. The arrangement duly agreed upon by both camps and approved by the Department Commander is as follows:

Both camps sent notice via U.S. Postal Service to their entire membership roster with details of a vote regarding this consolidation to be taken in 30 days. Both camps held separate votes for their camps 30 days from the date of their letter and found in excess of the necessary 2/3 super majority of each total camp membership in favor of the consolidation. The terms of such consolidation were mutually decided to be that McCormick Camp #215 will be absorbed into Fletcher Camp #47, which will retain its charter, original name, books, papers, property, meeting place, and current elected officers.

In light of the votes taken by the aforementioned camps and by the power invested in me by Chapter I, Article 4, Section 6, of the National Regulations of the Sons of Union Veterans of the Civil War and by my authority as Commander of the Department of Missouri, I hereby approve this consolidation effective 22 Oct 2016 and order the following:

**1.)** Thomas C. Fletcher Camp #47 and James R. McCormick #215 are hereby consolidated into one camp under the existing name and charter for Thomas C. Fletcher Camp #47.

**2.)** James R. McCormick Camp #215 will henceforth be denoted as "consolidated with Thomas C. Fletcher Camp #47."

**3.)** In accordance with Chapter I, Article 4, Section 6, of the National Regulations, all books, papers, and properties previously belonging to James R. McCormick Camp #215 shall be transferred to Thomas C. Fletcher Camp #47, except for a Camp Commander badge bearing the inscription "U.S. Grant Camp #68," which will be surrendered to the Department Quartermaster.

**4.)** Officers of James R. McCormick Camp #215 will complete the administrative tasks necessary for this consolidation, including issuing Form 3 transfers for all camp members to Thomas C. Fletcher Camp #47\*, closing any bank accounts belonging to James R. McCormick Camp #215 and presenting all camp funds, papers, and property to Thomas C. Fletcher Camp #47.

\* Any McCormick Camp #215 member may transfer to another camp or receive an Honorable Discharge in lieu of transferring to Fletcher Camp #47 if they so choose; however, no member can remain a member of James R. McCormick Camp #215.

**5.)** No further camp business outside of tasks necessary to complete this consolidation will be conducted by the officers of James R. McCormick Camp #215. James R. McCormick Camp #215 will no longer meet or vote as an independent camp of the Department of Missouri, Sons of Union Veterans of the Civil War.

**6.)** The geographical territory previously recognized as the domain of James R. McCormick Camp #215 will now be consolidated with the territory previously recognized as the domain of Thomas C. Fletcher Camp #47, and all such territory will now be recognized as the domain of Thomas C. Fletcher Camp #47. The Department Junior Vice-Commander is directed to forward any applications from the National Organization for potential members from either territory to Thomas C. Fletcher Camp #47 for consideration.

**7.)** Insomuch as cooperative relationships can be transferred, the Department of Missouri hereby recognizes any relationships between James R. McCormick Camp #215 and SVR units, Allied Orders, and other community groups to be relationships between Thomas C. Fletcher Camp #47 and these groups.

**8.)** Past Camp Commander voting status for applicable McCormick Camp #215 members must be reinstated via the procedure described in the Constitution and Regulations of the Sons of Union Veterans of the Civil War. McCormick Camp #215 members seeking to have their Past Camp Commander voting status restored must first apply for such in writing to Thomas C. Fletcher Camp #47. Past Camp Commander voting status of those whose primary membership was in Thomas C. Fletcher Camp #47 is not affected by this consolidation.

## **Excess Payment Policy**

Chapter II, Article VII, Section 1a of the National Regulations of the Sons of Union Veterans of the Civil War states that "the Department Commander shall be the executive officer of the Department, charged with the duty of administering the affairs of the Department."

As the executive officer of the Department of Missouri, I hereby instate the following policy to be effective immediately and included in the Department's Policies and Procedures manual:

Effective 11 March 2017, when any payment of per capita dues or any other payment due from a camp to the Department of Missouri includes an excess of less than \$5.00, that excess will be considered a donation to the Department of Missouri, Sons of Union Veterans of the Civil War. Such excess funds will be deposited by the Department Treasurer in the Department's primary operating account.

This policy relieves the Department of Missouri of any obligation to spend time or postage processing unnecessary refunds due to minor camp accounting errors.

#### James B. Eads Award Criteria

At the 2013 Department Encampment in Mehlville, Missouri, the encampment approved the current criteria of the James B. Eads award, changing the award from an annual "best all-around camp" award to an annual commendation award available to all camps which successfully meet the award criteria. The goal of these changes was to see more Department-level participation among camps and to recognize such participation in multiple camps when applicable.

It was the consensus of the majority of voting members at the March 2017 business meeting that the mandatory requirement to submit all quarterly reports by the dates specified is the main criterion keeping camps from receiving this award. Failure to meet this criterion can cause a camp which had otherwise contributed much to the Department in every other way to be disqualified due to a failure to file these reports on time or at all. A majority of those present at the March 2017 Department business meeting voted in favor of removing this criterion.

Policy 710 in the policies and procedures manual of this department states "any changes to the eligibility criteria or application form must be approved by a Department Encampment or Business Meeting." In many circumstances, it would be unfair to change the criteria for an award so close to the Department Encampment where the award would be issued. In this particular case, the removal of the aforementioned criterion at this time does not penalize any camp.

Therefore, in accordance with the vote taken at the March 2017 business meeting, the criterion No. 3 under "Reporting" which requires the submittal of quarterly reports to qualify for the James B. Eads award is hereby immediately removed for the 2016-2017 award year. I encourage all camp secretaries to review their camp's eligibility for the award in light of this change and submit applications if applicable by the appropriate deadline. I also hereby task the Awards Committee with rewording Policy 710 to help prevent this award's criteria from being unfairly changed between encampments in the future.

Note that the removal of quarterly reporting from the Eads award criteria does not remove the obligation of camps to submit quarterly reports. Quarterly reports are vital to keeping the Department aware of the many positive activities at the camp level which further the mission of the Order.

#### Dissolution of 2019 National Encampment Committee & Formation of National Encampment in Missouri Host Committee

Duties and responsibilities shall be defined at the time of Committee creation. Pursuant to Article VIII, Section 2, I hereby create/amend the following Special Committees of the Department of Missouri as follows:

The **2019** National Encampment Committee, PCinC Ed Krieser—chair, was unable despite their best efforts to come to a satisfactory agreement with the National Encampment Site Committee. Deadlines set by the national committee and financial obligations bound on this Department should our bid continue necessitated the immediate withdraw of our bid to host. The Department of Missouri thanks PCinC Ed Krieser and his committee for their work. I hereby dissolve the 2019 National Encampment Committee, effective 31 Mar 2017.

I hereby create the **National Encampment in Missouri Host Committee, PDC Bob Petrovic—chair**. This committee is tasked with completing and submitting a proposal to the National organization for the Department of Missouri to host a National Encampment in St. Louis within the next five years. The chair may appoint brothers in good standing and representatives of the Allied Orders to the committee as needed to accomplish the appointed task. The chair will maintain with the Department Commander an updated list of all committee members throughout the life of this committee. Pursuant to Department Bylaws, the Department Commander is an ex-officio member of this committee. This committee will have a sunset date of 31 Oct 2021.

### Dr. Mary Edwards Walker Award – Twyla Warren
