The award is presented by the Department Commander based upon the information provided by the Membership Applications (Form 3) received by the Department Secretary no later than 30 April. An award recipient receives a certificate and is eligible for repeat consideration.

The recommendation from the Committee became a motion with a second and was passed.

Recommendation #2 – approve adding paragraph 720 to the PPM.

¶ 720 The Nathaniel Lyons Award. This award is presented to the Camp with the greatest percentage increase in membership during the period 1 May through 30 April. The award is presented by the Department Commander based upon the information provided within the Camp Annual Report (Form 27) received by the Department Secretary no later than 30 April. The Camp receives a ribbon streamer and is eligible for repeat consideration.

The recommendation from the Committee became a motion with a second and passed.

Recommendation #3 – approve adding paragraph 721 to the PPM.

¶ 721 The Department Under Forty Award – This award is presented to the Camp with the greatest number of new members under age forty (40) during the period 1 May through 30 April. The award is presented by the Department Commander based upon the information provided within the Camp Annual Report (Form 27) received by the Department Secretary no later than 30 April. The Camp receives a ribbon streamer and is eligible for repeat consideration.

The recommendation from the Committee became a motion with a second and failed.

Randal Burd moved, camps with three or more new members under the age of 40 during period 1 May through 30 April to receive the Under 40 Award. The award is presented by the Department Commander based upon the information provided within the Camp Annual Report (Form 27) received by the Department Secretary no later than 30 April. The Camp receives a ribbon streamer and is eligible for repeat consideration. The motion was seconded and passed.

The Bylaws Committee reviewed and approved a proposal from Department Commander Hunnewell to authorize adding a Past Department Commander's name and Department Corps badge to the Past Department Commander's badge. This is authorized by the SUVCW Constitution and Regulations (C&R), Regulations Chapter V, Article VI, Section 3, Subsection M Past Department Commander Badge

□ **Recommendation #4** – approved the proposed graphic as the Department's Corp Badge and approve adding the following to paragraph 100 in the PPM.

The Past Department Commander, without cost to the Department, may affix to his Past Department Commander badge a top bar of sterling silver on which may be inscribed his name. A device may be attached to the top bar, being the symbol of the Department: a silver edged octagon with a red interior, which has an "M", a downward feathered arrow, and an "O" inside the octagon. Such device shall not extend beyond the edges of the ribbon of the badge, nor shall such device cover more than 50% of the ribbon of such badge.

The recommendation from the Committee became a motion with a second and passed.

equire submission of Form 40 as a mandatory item for the Eads Award. The Committee concurred but the motion failed.

Unionist Editor

The Department Logo be copyrighted and any camp or person wanting to use it must receive permission from a Department Business meeting or Department Encampment to do so. The Committee concurred but the motion failed.

Don Palmer made a substitute motion to Trademark the Department Logo. It was seconded and passed.

Monuments Officer

The Department submit to the National Organization a petition to have the Memorials information compiled and be made available online. The Committee concurred but the motion failed.

Walt Busch moved to make appropriate changes to the petition to meet the National criteria for approval by the Department Officers, then to submit it to National. It was seconded and passed.

Historical Records Officer

Accept the forms submitted as inventory control and for receiving gifts of property or on loan. The Committee concurred but the motion was tabled to the October business meeting.

NHDMO Essay Committee/History Selection Committee

Recommendation #1 – When the \$200.00 ROTC prize is not awarded in any given year, that amount is added to the prize for the subsequent year, so that the total increases every year until it is awarded. The Committee concurred and the motion passed.

Walt Busch moved to donate \$150.00 to the Missouri Civil War Museum for allowing us to use the building. Seconded and passed.

Walt Busch moved to purchase a brick from the Missouri Civil War Museum. Seconded and passed.

Robert Petrovic moved to donate the WRC rug to the WRC-GAR Museum. Seconded and passed.

Walt Busch move to give Brian Smarker one of our 1941 GAR Excelsior Springs Ribbons to go to the Excelsior Springs Museum. Seconded and passed.

Nominations of Department Officers:

Randal Burd moved the Secretary cast one vote when there is only one candidate for the office.

At the Camp Level, I have been active in the General McPherson camp as Camp Commander and the G.N. Spradling camp as Secretary/Treasurer. I submitted applications to start a new camp in Little Rock. Completed the application for a Charter. Wrote the Bylaws for the new camp. Elected the Officers for the new camp which will be called the Isaac Murphy Camp.

Junior Vice Commander Report, Department of Missouri/Arkansas SUVCW

Brothers,

Junior Vice Commander activities since our June 2020 Department Encampment

On July 26, I received an application via mail of Thomas Hindsley of Liberty, MO. After contacting JVC of the Westport Camp I mailed the application and check to him on August 6^{th} .

On August 22, I received via Department of Missouri web page an inquiry from a man in Georgia who was interested possibly joining an Arkansas Camp because his great-great Grandfather served in Company M, 1st Arkansas Cavalry. He also expressed maybe joining an Georgia Camp. I contacted McPherson Camp JVC and forwarded him the contact information.

Brother Christopher Bribiesca, Jr. their JVC contacted the inquirer via e-mail and gave him McPherson Camp information. He copied me in the e-mail for which I was very grateful

October 20th. Richard Thornton contacted me through Department of Missouri SUVCW website. He lives in St. Robert and inquired about how much service information on his Civil War ancestor to include on a membership form. After several emails I suggested that he might join the Phelps Camp in Springfield being the closest one but over 80 miles away. He said he had no problem driving to Springfield because he drives to Marshfield for his reenactment unit. I then contacted Brother Ed Krieser who is Junior Vice Commander of Phelps Camp and he took over from there.

November 14, Brother Edward Krieser notified us that he had received a request from Brother David W. Demmy, Sr. who is Executive Director at National. Brother Peter Somerville was requesting to transfer his membership from a camp in South Carolina to a Camp in Missouri. His ancestor was in the 44th Missouri Infantry Regiment and was from Unionville, MO. We decided that we should contact the McNeil Camp in Unionville, MO. Department Commander Sumner Hunnewell called him and he expressed to Commander Hunnewell that he would like to join the McNeil Camp. Department Commander Hunnewell then asked me to follow up. I called Brother Somerville and learned his email. I contacted the McNeil Camp via Department email for that camp. I received an email from Brian Hudnall that he was not an active member but he gave me a phone number for Greg Walters who I believe is the Camp Commander. I called him and he called me on 11/21 and I gave him the information that I had on Brother Somerville. Brother Walters said he would call Brother Somerville the next night.

December 24, Lynn Chipperfield sent in an application via Department of Missouri SUVCW website. He lives in the area of the U.S. Grant Camp #68 in St. Louis. I forwarded his email to Brother Craig Matthews who is the Junior Vice Commander of the Grant Camp. I also copied Department Commander Hunnewell also.

January 12, 2021. I received an email from National Junior Vice Commander-in-Chief where he wanted to set up a zoom meeting with the Department Junior Vice Commanders to discuss new Form 3. We had our meeting on January 16th with many emails for suggestions on changes that should be done to Form 3. February 2nd our last discussion most of us decided that the form should remain as changed in November 2020. The interesting aspect of this Zoom meeting the Department Junior Vice Commander of Great Brittan attended. He asked us where all of our Civil War personal collections were. I think he believes that each of us must have a Civil War museum. I did show him my Burnside Carbine and a couple of other items.

January 17, 2021 I received an email from prospective member, Peter Somerville, who first contacted the Department on November 14, 2020 through the National Organization through Brother Ed Krieser. In his email he states that he had mailed a transfer to the McNeil Camp from a camp in South Carolina but has received no communication from the camp. That day I informed him that I would try to contact the Camp. I apologized about the delay and also sent a copy of his email to Department Commander and to the JVC of the Westport Camp. On March 19th I emailed the Camp Commander of the McNeil Camp informing him of the concern by Brother Somerville. On March 19th the Department Commander emailed that he had called Vern Stottlemeyer, Secretary-Treasurer of the McNeil Camp and told him about and was assured by Brother Vern that they would be happy to have him. On March 21 I received an email from Brother

Somerville stating that he was mailing a copy of Form 4 and Form 30 to Brother Stottlemeyer along with a check for dues to the McNeil Camp and \$65 check to cover National and Camp dues. I explained that he should only send the \$40 that Brother Stottlemeyer had told him was the dues and that National dues came out of that \$40.00. He was going to contact Brother Stottlemeyer the next day to verify I was correct. I have not heard from him since.

January 31, 2021. Brother Bruce Frail, National Junior Vice Commander-in-Chief, sent us an email to answer some of the questions we had, specifically the question of what of our members referred to as the Perjury termon on Form 3. He told us Brother James Pahl (Assistant National Counselor) stated it to be completely legal and enforceable. The National Coucil of Administration chose to leave this statement in place. In this email he informed us of the possibility of the SUVCW authorizing Blood and Food drives. I then forwarded the Blood and Food Drive information to Department Commander Hunnewell this information.

February 23, 2021, Ramond Browning contacted me through our Department website today. He had a 816 prefix phone number so I contacted J. Purkable who is/was the Junior Vice Commander and also a member of the Westport Camp in the Kansas City area. I also sent him an email stating that I had shared his information with the members of the Westport Camp. Raymond had two ancestors in the Civil War and he had his one ancestors discharge.

March 22, 2021. Received an email from National Junior Vice Commander in Chief who stated that he had received many letters and an application from a person wanting to join Camp #68. After communications with Walter Busch it was determined that this guy was already a member of their camp and was trying to place another family Civil War veteran by having a second membership form. I sent Walt the information.

March 29, 2021. Received an email via Department website from J. D. Mayo about wanting to join a Camo in Missouri because his ancestor was from Missouri. He is a member of Major General Stonemans Camp #6. I responded on same day explaining that since his ancestor served near Kansas City that I would refer him to the Westport Camp and carbon copied Department Commander Hunnewell and Westport JVC J. Purkaple and Brother Dale Crandell. He responded by saying Thank you and that he had ancestors who served in the Confederacy. On April 4th I received an email from Brother Dale Crandell with his communications to Brother John D. Mayo.

April 13, 2021. Received an email via Department website from Trent Cornelison with his name, phone number and email. Via text messages he stated he was seeking information about the SUVCW and after several emails and text messages explaining what we do, he expressed interest in membership. I sent him an application and contact information for Brother Vern Stottlemeyer of the McNeil Camp #62 since Brother Trent lives in Memphis, Missouri which makes the McNeil Camp the closest to him. As always, I have kept Department Commander informed of all communication.

April 17, 2021. Received an email via Department website from Barry Small with his name, phone number and email and a short message in the comment box. He expressed interest in joining our organization. I responded to his email and because he had a 417 area code I also carbon copied Brother Ed Krieser of the Phelps Camp and Department Commander Hunnewell both my response and sent them a copy of the email from Barry Small.

April 17, 2021. Sent an email to the Department officers and council of administration asking that we add to the form that prospective members fill out on our web site that are sent to the Department JVC. I believe it would be beneficial to put on the form town they live in and state. The request of Trent Cornelison (April 13 note) made him available to be a prospective member for 4 different camps depending on where he lived in the 660 phone area.

May 13, 2021. Presented a Jr. R.O.T.C. in Poplar Bluff and after the ceremony I was approached by a man who wanted to talk to me about the SUVCW. He had sent in his paperwork to National and was interested in joining our Department. I was discussing with him about the possibility of forming a Camp in Poplar Bluff. I have sent him some information and have had no response since our initial contact.

Patriotic Instructor Report to the Department Encampment 5 June 2021

Patriotic Instructor Annual Report. Two camps submitted their Form 40 Camp Patriotic Instructor Report: St. James Camp #326 and Westport Camp #64.

Recommendation. Require submission of Form 40 as a mandatory item for the Eads Award.

Patriotic Holidays and Observances. The project to post short summaries of 21 federal, Missouri, and Arkansas patriotic holidays and observances is progressing. Several were posted in the *Missouri Unionist*. Next step is to post on the Department's Facebook page. Below is an example:

Flag Day

Flag Day is June 14, 2021, which commemorates adoption of the thirteen stars and stripes flag by the 2nd Continental Congress on June 14, 1777. The U.S. Army was also established on that day. The first National Flag Day was established by Woodrow Wilson's Presidential Proclamation in 1908 and by an Act of Congress in 1949.

A 1942 Congressional Joint Resolution consolidated flag etiquette between the Army and Navy to form the foundation for our current public law: Title 4, United States Code, Chapter 1 The Flag. This United States Flag Code establishes the policy for federal agencies and the national standard for the display and use of our flag.

The United States flag had 33 stars at the start of American Civil War and added a 34th for Kansas in 1861 and 35th in 1863 for West Virginia's succession from Virginia. The Union did not remove any stars when the eleven Confederate States succeeded.

Missouri and Arkansas Civil War Timeline. The project to post short summaries of 30 local Civil War battles and events has started with two published in the *Missouri Unionist*. Below is an example:

Battle of Boonville

The Battle of Boonville occurred on June 17, 1861, with 1,700 Union infantry and militia under Captain Nathaniel Lyon skirmishing with 1,500 from the pro-secessionist Missouri State Guard commanded by Colonel John Marmaduke. With few casualties, it was a minor military victory for Union forces but provided an important political and strategic accomplishment.

Missouri like other boarder states was divided between supporting the Union or Confederacy. Captain Lyon's forces were pursuing Governor Claiborne Jackson who was positioning Missouri for the Confederacy. After securing the state capitol in Jefferson City, the Union Army reached Governor Jackson and the Missouri State Guard at Boonville. The better trained and organized Union Army ousted the newly formed Missouri State Guard within a few hours. The strategic significance, was pro-secessionist abandoning central Missouri, regrouping in southern Missouri, and setting up the Battle of Wilson Creek that followed three months later.

Missouri and Arkansas Civil War People. A project is proposed to post short summaries of local Civil War era people to publish in the *Missouri Unionist* and Department's Facebook page. Below is an example:

James Buchanan Eads (23 May 1820 – 8 March 1887)

James Eads was an entrepreneur and self-taught engineer who designed salvage ships, bridges, and railway systems. For his knowledge of river navigation and ship construction, he was often given the courtesy title, Captain Eads. At the start of the American Civil War, he was recruited by Attorney General Edward Bates to plan for the defense of Mississippi River and later contracted to build 30 ironclads for the Union Navy. These first-generation ironclads outclassed the Confederacy's gunboats giving the Union a tactical advantage in the western theater. After the war,

Bylaws Committee Report to the Department Encampment 5 June 2021

The Department's Bylaws, Article VII, Section 4 tasks the Bylaws Committee to review the Policy and Procedures Manual (PPM) in odd years. Updates were approved at the Department's March 2021 Business Meeting and published as the 13 March 2021 addition.

The Awards Committee recommended three new recruitment awards for consideration by the 2021 Department Encampment. If approved, the Bylaws Committee recommends adding the awards to the PPM.

➤ **Recommendation #1** – approve adding paragraph 719 to the PPM.

¶ 719 The Samuel Curtis Award. This award is presented to the individual Brother who recruits the greatest number of new members within the Department during the period 1 May through 30 April. The award is presented by the Department Commander based upon the information provided by the Membership Applications (Form 3) received by the Department Secretary no later than 30 April. An award recipient receives a certificate and is eligible for repeat consideration.

Recommendation #2 – approve adding paragraph 720 to the PPM.

¶ 720 The Nathaniel Lyons Award. This award is presented to the Camp with the greatest percentage increase in membership during the period 1 May through 30 April. The award is presented by the Department Commander based upon the information provided within the Camp Annual Report (Form 27) received by the Department Secretary no later than 30 April. The Camp receives a ribbon streamer and is eligible for repeat consideration.

Recommendation #3 – approve adding paragraph 721 to the PPM.

¶ 721 The Department Under Forty Award – This award is presented to the Camp with the greatest number of new members under age forty (40) during the period 1 May through 30 April. The award is presented by the Department Commander based upon the information provided within the Camp Annual Report (Form 27) received by the Department Secretary no later than 30 April. The Camp receives a ribbon streamer and is eligible for repeat consideration.

The Bylaws Committee reviewed and approved a proposal from Department Commander Hunnewell to authorize adding a Past Department Commander's name and Department Corps badge to the Past Department Commander's badge. This is authorized by the SUVCW Constitution and Regulations (C&R), Regulations Chapter V, Article VI, Section 3, Subsection M Past Department Commander Badge

➤ **Recommendation #4** – approved the proposed graphic as the Department's Corp Badge and approve adding the following to paragraph 100 in the PPM.

The Past Department Commander, without cost to the Department, may affix to his Past Department Commander badge a top bar of sterling silver on which may be inscribed his name. A device may be attached to the top bar, being the symbol of the Department: a silver edged octagon with a red interior, which has an "M", a downward feathered arrow, and an "O" inside the octagon. Such device shall not extend beyond the edges of the ribbon of the badge, nor shall such device cover more than 50% of the ribbon of such badge.

The Awards Committee has developed three new Recruitment Awards to recognize those Camps and Brothers who have done an outstanding job in Recruiting new members to the SUVCW. These Awards follow along the lines of the National Recruitment awards.

Subject: DEPARTMENT PROGRAMS COMMITTEE REPORT

To: 26th Annual Missouri Department Encampment

The Department Programs Committee focuses on identifying, planning and executing Department-wide programs both in and outside of Missouri and Arkansas. The following is a status on the planning for a 2022 event:

Programs Committee, with approval from the Department, has been planning a commemorative event at Shiloh in 2022 (160th anniversary of the battle). Brothers Mark Coplin and Scott Reed visited Shiloh and Corinth and made initial contacts with park management during this period. Storm damage in late 2019 and subsequent repair activity, as well as transition of a new park superintendent, made communication and coordination difficult. The pandemic added to this difficulty. However, progress was made during the first quarter of 2021.

Brother Gary Scheel visited Shiloh in April and met with the new superintendent Allen Etheridge to discuss ideas for a program at Shiloh for April 2022 (tentative). Preliminary ideas were presented for a "Missouri Day" at Shiloh and feedback was provided:

- Speakers we will be allowed to have speakers as part of a program. No speakers would be allowed in the National Cemetery; however, it would be permitted at the Missouri monument or other locations on the battlefield. We still need to find out if we could have speakers/program at the Visitor's Center.
- Flags we will be allowed to have the Missouri state flag placed at the Missouri monument or other Missouri regimental markers. We will not be allowed to place small Missouri flags on the graves of Missouri soldiers at the National Cemetery. We would be allowed to place U.S. flags on these graves.
- Transportation the National Park Service will not provide any shuttles or other transportation. Each attendee must provide their own transportation on park property.
- Seating the National Park Service will not provide chairs. Each attendee will be allowed to bring their own folding chairs and placed at event sites.
- Uniforms & Weapons we will be able to wear Union uniforms and bring replica weapons, however, gunpowder will not be allowed. No weapons may be fired on park property.

The committee will work to finalize a plan with draft agenda to be presented to Shiloh National Military Park for review and approval at the Fall Department business meeting. Three main items to be resolved include:

 Date for the event – presently looking at April 2 or April 9 as they are close in proximity to the anniversary of the battle (April 6-7). However, other dates in April would probably be acceptable.

- Inclusion of Corinth as Corinth is only about 20 miles from Shiloh, it presents an opportunity to extend our event. Missouri soldiers contributed significantly to the second Battle of Corinth. Shiloh National Military Park also administers the Corinth Interpretive Center.
- Ribbons, Medal, and/or Coins do we want to have commemorative ribbons, medals and/or coins for this event? The committee will include recommendations along with costs as part of the plan to be approved by the Department.

Potential programs for future consideration include:

- Department Events at other National Park Civil War Sites (2023-2025) continue to commemorate the contributions of Missouri soldiers at major battles and campaigns outside of Missouri:
 - Fort Donelson National Battlefield (Tennessee) included were the 8th and 13th Missouri Infantry regiments, the 1st Missouri Light Artillery and the U.S.S. St. Louis and U.S.S. Carondelet, two of James Eads' gunboats.
 - Chickamauga & Chattanooga National Military Park (Tennessee/Georgia) at Chickamauga, included were the 2nd and 15th Missouri Infantry regiments and the 1st Missouri Light Artillery. One of our SVR units in the 4th Military District represents the 2nd Missouri Infantry. During the Chattanooga Campaign, 12 Missouri infantry and two Missouri artillery units participated.
- Department Event Commemorating Union Responses to Price's Raid of 1864 (2024) develop program involving battle sites across Missouri associated with Price's Raid similar to what was originally envisioned during the Civil War sesquicentennial before insurance restrictions effectively ended the program. This event or series of events would help educate the public about a critical period during the Civil War in Missouri.

The committee welcomes any feedback on proposed events and/or ideas for new events. It is the committee's desire to develop programs that would draw interest of Brothers across the Department and stimulate participation from all Camps in the Department of Missouri (including Arkansas).

GAR MARKER

GAR Kansas City, MO Encampment

There is no change since the last report at the Department business meeting in March 2021. The camp has \$5,000 for the purchase and installation of a historical marker to commemorate the GAR's 50th National Encampment and Golden Jubilee held in Kansas City, August 28-September, 2, 1916. While Kansas City's Arts Commission approved locating the marker at Barney Allan Plaza, the city is pursuing a new public parking garage to support the adjacent Bartle Hall Convention Center.

GAR St. Louis, MO Encampment

There is no change since the last report at the Department business meeting in March 2021. The 21st Annual GAR Encampment was held in St. Louis September 27-20, 1887.

One the major challenges that we are facing is finding a location that will allow the placement of a marker.

With the assistance of National Park Rangers Doug Harding and John Pellarin, a newspaper article in the Harpers Weekly showed that there was a camp on the corner of the property of the Old Courthouse in downtown St. Louis. Letters to Mike Ward, Superintendent of the Gateway Arch National Park has been made to receive permission for the placement of a marker. The park rangers have also spoken to their historian Bob Moore about the possibility and asked them to do whatever they could to get support or a decision. Nothing has transpired. In spite of this being an idea location, the support is probably not there. Recently I was informed that Mike Ward has accepted a position with a construction services office of the National Park Service based out of Omaha, Nebraska. Doug said they would probably select a new superintendent.

Another possible location is at the Soldiers Memorial. Correspondence has been sent to the Director of the Missouri History Museum.

Correspondence has also been sent to the Director of the Missouri History Museum. The former Soldiers Museum is now under the authority of the Missouri History Museum has been remodeled and features new military exhibits and displays.

Another possible location is the St. Louis Public library. The US Grant Camp will continue to find an appropriate location.

Applications for grants have been made to the SUVCW Memorial/Monument Grant Fund and SUVCW Charitable Foundation.



Honoring Living Veterans Committee

The chair will remind any brothers who are military veterans of the availability of medals from the National Quartermaster to honor the military service of living veterans, including the War Medal (Form 5) and the Military Service Medal (Form 8).

Also, this committee was tasked with developing a program specifically for our Order which focuses on honoring and caring for living veterans of any war. The *Service to Veterans Medal Guidelines* of the Sons of the American Revolution was suggested as a guide. However, such a program hasn't garnered the interest necessary to make it successful.

ASSISTANT SECRETARY-TREASURER




SIGNALS OFFICER

Draped website several times and have been updating it as needed. Created a few webpages for a few camps, and as I get more time I will continue the process. Finally figured out how to add my email address to that of the JVC so that when people fill out our form for more information on our website, I will also get a copy so I can follow up that the JVC has sent them info.

I think I can proudly say that our website has more information on it regarding monuments, soldiers, genealogy, past commanders and camps that any other SUVCW website. Just finished updating new pictures from the GAR Dept Commander John Hollingsworth archives, plus digitizing two books for the site (the 1936 Missouri GAR Encampment Book and the 1936 Missouri LGAR Encampment Book). One of the books has a name of a MO SUVCW commander and I accidentally found a picture of our 1894 Mo SV Commander in Uniform, so when I get a little time soon have two records to update.

Updated everyone's e-mails as per last per capita report. 7 got rejected as bad e-mails. I have been able to verify 3 with camps so far.





MONUMENTS OFFICER

These are the only known existing monuments that have not been recorded in Missouri. Arkansas still has over 150 monuments that need to have Form 61s created for them.

Civil War in Camden County - It is on the grounds of the Camden County Historical Society in Linn Creek

Stanbury Cannon – Gentry County Courthouse Park Area – Have some information on this, but it appears it has been moved and never replaced.

As of this writing on my computer are files for two Missouri monuments to be added. One to be updated. Two with questions and then did Westport Camp ever post the marker for the 1916 National Encampment? I only have a mock-up of the text in my files.

Almost finally (for this section anyway)—I have had to work through a few monuments that were for both sides or historical markers, particularly in the Platte County area and have had to record that they have been removed due to woke-ism (apparently an American flag crossed with a Confederate flag to represent the conflict is too much). I've kept the files on site as a record of what is now missing.

Recommendation: I would like the department to submit the following petition to National SUVCW to obtain web space similar to a Weebly site that the Civil War Monuments Officer can use to place all files of national monuments on the web like Missouri's website has. Weebly would cost them \$38 monthly if billed annually, so \$456 per year. All monuments could be placed on individual – department pages. Most of the files could be up in less than a year and the main national website could just link to this. [NOTE: Below is the proposal I wrote as of 5/31. I've asked PDC Burd to tweak it so it is more presentable. I hope we will be able to pass out his revised version for consideration at the encampment.]

A Petition to National SUVCW

The Department of Missouri Sons of Union Veterans of the Civil War petitions the Sons of Union Veterans of the Civil War to provide a usable website for the Memorials Officer to create and maintain our monuments records.

Whereas, one of the goals of the Sons of Union Veterans of the Civil War is the protection of Civil War and Grand Army of the Republic monuments; and,

Whereas, to protect those monuments we have created forms, currently Form 61 and Form 62, to record information on monuments; and,

Whereas, the Civil War Memorials Officer has recommended since 2012 the creation of a database to list such monuments on a national basis; and,

Whereas, our grants committees are in need of such information on a regular basis; and,

Whereas, no work has been done on this project; and

Whereas, the department of Missouri has a webpage created that not only lists, but also provides the entirety of the Form 61s and Form 62s submitted by the department of Missouri that any person may access and download; and,

Whereas, a such a site can cost as little as \$500/year; and,

Whereas. the Memorials Officer can create and maintain for each department a webpage of its own listing the Form 61s and 62s, while beginning to train some members to add their own forms; and,

Whereas, this such a site could have this information available to either the public (recommended) or members only; and,

Whereas, such a site could be used by the organization for more than just a listing of monuments; and,

Whereas, one such plan allows for unlimited storage use for items that could be used for this program or other needs of the organization; and,

Whereas, the Memorials Officer assures us that many of these Form 61s and 62s can be online within the next year;

Therefore be it resolved that, the Department of Missouri - Sons of Union Veterans of the Civil War petitions the Sons of Union Veterans of the Civil War to authorize their webmaster to set up an account and to set up the Memorials Officer as an editor of the site so that the work of establishing a file system of our collected Form 61s and 62s can begin.

This recommendation would also provide, if the SUVCW wants, a members only section in which a password is required to enter the site. It could also have an officers' site for Council or other items. I believe for \$456 per year (plus domain costs), this is much cheaper than paying for a database to be developed to handle monuments. There is also no reason why it couldn't be set up where smaller departments could have their own webpage on this, with one of their members responsible for editing the site.

DEPARTMENT ENCAMPMENT CHAIR

Tried to set up meeting in Columbia in 2022. The American Legion post wants way too much for their meeting room despite the fact that I am a SAL member and would hope that would get some type of discount. E-mailed Bryan Bradford about this and asked if there is another place he could recommend. I should have a recommendation by the October business meeting. If there are no suitable places for the price we want, I will probably be recommending Jefferson City for the meeting.

Proposal: Accept the forms on the following pages to use as inventory control and for receiving gifts of property or loans. Eventually, all forms could be similar to one attached that DC Hunnewell created that show a picture of the item and the date of transfer.

Procedures for Acquiring Artifacts and Items

Position: The Sons of Union Veterans of the Civil War are pledged to preserve the memory of the boys in blue and the Grand Army of the Republic. To that end, preserving artifacts of the soldiers is part of our sacred duty. The department of Missouri wants to be clear and honest when dealing with people who wish to donate items to the department or any of its camps. Therefore, any gifts of artifacts or other items (such as a Ipad, etc.), shall have either an article of bailment or an article of gift completed for it.

General Procedure: Artifacts or items can be taken into camp or department possession in two ways.

- Bailment: This is where a person is loaning the department or camp an item for a period of time (an example of this would be someone presenting an original GAR post flag and allowing us to display it at an encampment) but then wanting it returned. The form Articles of Bailment will be filled out.
- Gift: A person wishes to donate an item to the department or camp. This becomes the property of the camp or department to do with as they wish. An Articles of Gift will be filled out.

Each form will be filled out as completely as possible. If a camera, for example, is being donated to a camp, the brand of camera, model and serial number is the minimum information that should be recorded on a form. If an artifact is being donated, more than one picture of the item (different angles, identifying marks) should be taken and attached with the form.

Special Provision for Articles of Gift. A section of the form indicates the intent of the camp/department for the future use of the item. An individual may want to donate a GAR sword, for example, to a camp and want the camp to possess it so that it is preserved for public enjoyment. The camp, on the other hand, may look at it as something they want to sell on E-Bay and make some money. Therefore, the intent must be filled out so that the donor knows upfront what the camp intends to do with it. Example: The department has taken some GAR records recently to be photographed and documented for our website. Both donors were advised that upon completion of the photographing we would donate the artifacts to a museum or library of consequence.

Additionally, especially for gifts, if the donor puts conditions on the gift, those need to be listed on the form. Example: They want it displayed at all meetings with a plaque that says it was donated by them. If those are the restrictions and the camp/department accepts the gift, we must adhere to them.

Forms will be signed by camp commander or department commander depending on who is taking possession of the property. Property taken in by the department may be assigned to a camp's care. ALL COMPLETED FORMS FOR EITHER CAMP OR DEPARTMENT PROPERTY WILL BE SENT TO THE DEPARTMENT SECRETARY SO THAT PROPER FILES CAN BE MAINTAINED. THE DEPARTMENT SECRETARY WILL PROVIDE A COPY OF THE FORM TO THE QUARTERMASTER FOR ALL PROPERTY OWNED BY THE DEPARTMENT!

CAUTIONS:

- We rely on our members to keep many of the items in their houses due to a lack of storage owned by camps/the department. People wanting to donate true artifacts to us should often be encouraged to instead donate them to a museum/library of consequence. By consequence, we mean such as the State Historical Society in Columbia, the Department of Natural Resources Historic Sites and State Museum, Wilson's Creek NHS, US Grant NHS, Missouri Historical Society, etc. Local museums should generally be avoided because many do not have good procedures and security to ensure the preservation of the artifacts.
- 2. Should a camp or department accept an artifact, it is the responsibility of the camp or department to retrieve the item from individuals who leave the organization or pass away. This means that if a member passes, you must retrieve the property! If the family refuses to give it to the camp/department, the camp or department is expected to proceed with court action, such as through a lawsuit or through replevin. The department considers it the camp's and department's fiduciary responsibility to retrieve artifacts that are in our possession.
- Accepting a donation of an artifact may well cost a camp or department money not only to recover it above, but to preserve it. It is for that reason that artifacts are often better in the possession of a museum/library.

It would be hoped that some day in the future, the department will possess its own building. That would be great! At that point we would be in a position to obtain, hold, and display artifacts.

Finally, for all property of a camp or department, yearly accountability should be practiced. Any member that has property of the camp/department should sign a form provided by the department (or similar statement) that acknowledges possession of SUVCW property.



Next time we meet, I expect everyone to know this so we can say the Pledge of Allegiance properly.





The mission of Camp Lillie is to increase public awareness of the Sons of Unions' footprint on the community through education. Membership is slowly increasing in number due to communication and education about Civil War history.

During the October 2020 monthly meeting, Camp Lillie, Sons of Union Veterans, voted to supply a tree and donate \$325.00 in recognition of the Bicentennial of Cole County. The Redbud tree is situated between trees planted by the Daughters of the American Revolution and the Sons of the American Revolution on the west side of the Cole County Courthouse. Members Pete Oetting, Richard Frank, and Sam Buschman represented Camp Lillie at the bicentennial ceremony which took place on May 3, 2021. Camp Lillie received recognition from Cole County on a plaque placed under the tree and by a written proclamation thanking Camp Lillie for its contributions.

This acknowledgement from Cole County is in addition to recognition received from the City of Jefferson upon Camp Lillie's founding.

The last meeting in 2020 was held on November 14. After that time Covid precautions limited face-to-face meetings and meeting space was not available in the area.

Westport Camp #64 Report to the Department Encampment June 1, 2020 – May 31, 2021

While Kansas City's Arts Commission approved locating the marker at Barney Allan Plaza, the city is pursuing a new public parking garage to support the adjacent Bartle Hall Convention Center.
