#### George Henry Palmer 1841-1901 1st Illinois Cavalry

Presented the Medal of Honor in 1896 for heroism at the Siege of Lexington, Missouri. Palmer, a musician in the regimental band, volunteered for duty in the trenches and leda charge to retake the Anderson House which served as a Union hospital? The skirmish resulted in the capture of Missouri State Guard sharpshooters and Union forces occupying the Anderson House for the second time. [SUV Badge] [Crossed US Waving Flags] [Front]
