## GENERAL WILLIAM T. SHERMAN REMEMBRANCE DAY 2022

On Sunday, March 13, 2022, U.S. Grant Camp #68 was proud to sponsor this annual wreath-laying remembrance event at the gravesite of General William T. Sherman—perhaps best known for his 1864 "March to the Sea"— at Calvary Cemetery in St. Louis, Missouri. A color guard from the SVR processed the colors, and piping was provided by Brother Daniel Jackson. The old colors were retired and new ones were hoisted. Past Department Commander Walt Busch led the Pledge of Allegiance and was the master of ceremonies. The prayer was given by Monseigneur Michael Witt, the camp's chaplain. Orations were delivered by Joan Koechig, Missouri Department President, Daughters of Union Veterans of the Civil War, Patricia Baehr, from Julia Dent Grant Tent #16, DUVCW, Greg Wolk, SUVCW Life Member, Heritage Programs Coordinator for Missouri Humanities, and board member of the National U.S. Grant Trail Association. Brother Glennon Alsop had surgery in January and he said that since he did not have anything else to do, and he stated that he enjoyed registering graves so he spent his time registering grave.


Brother Glen registered 356 grave registrations.

## **Battle of Wilson Creek (Oak Hill)**

On 10 August1861, the Union forces under Brig. Gen. Nathaniel Lyon and Col. Franz Sigel met the Confederate forces commanded by Major Gen. Sterling Price and Brig. Gen. Benjamin McCulloch just 10 miles south of Springfield, Mo. in what would become known as the Battle of Wilson's Creek also known as Oak Hill by the south. The first contact of the two armies was at a place called "Bloody Hill". The Confederates were pushed back but rallied and made three assaults to force the Federals to withdraw. In the battle General Lyon was killed. The battle only lasted six hours before the Union army withdrew to


Springfield leaving the field to the Confederates who would claim a victory. The result would be that the rebels would have control of southwest Missouri.

Wilson's Creek would be the largest battle west of the Mississippi River in 1861. While compared to later battles, this battle which pitted 5,400 Federals against 11,000 Confederates was quite costly to both sides.

Federal loses amounted to 1,235 casualties while the rebel forces lost were put at 1,095 for a total of 2,330.

This is the nose of a Hotchkiss artillery bolt. The Hotchkiss was a three-piece shell with a nose and a cup which fitted to the base. The nose and cup were held together by a lead band.







Soon after the war, veterans from both sides began to return to the battlefield. The Union boys began to stack rock at the location

where General Lyon was killed.




Soon, regimental and Grand Army of the Republic reunions were held. Most were held in Springfield but trips to the battlefield were always part of the activities. One of the

largest reunions was held in 1897. This was a joint reunion of the blue and gray. A movement was under way to protect this battlefield, but it would take a century before this would be added to the National Park System. Only one monument was ever erected and that was to mark the location where General Lyon was killed.

The first ribbon was made for the General Lyon's Post #2 of the Grand Army of the Republic located in St. Louis. It was worn at the National



Encampment which was in September 1887. It has the portrait of General Lyons. The red Wilson Creek ribbon was made, like the souvenir badge, for the reunion of the Blue and Gray, Aug. 9-14, 1897. The center disc has boys in blue and gray shaking hands. There is a cross American and Confederate Flag. The final badge was for the First Iowa Infantry reunion, 1898. It has cross American flags. The disc has a portrait of Lyon. On the back is, 37<sup>th</sup> Anniversary, Battle of Wilson's Creek 1861, Aug. 10, 1898. Mt. Pleasant, Iowa.

## **Battle of Cape Girardeau**

The Battle of Cape Girardeau occurred April 26, 1863. It was the final leg of Marmaduke's Missouri Raid to disrupt supply lines and pressure the Union's Army of the Fronter to withdrawal from Arkansas. General John Marmaduke's 5,000 Confederate soldiers positioned themselves to retake Cape Girardeau from General John McNeil's garrisoned 4,000 Union soldiers. Control of Cape Girardeau and its four recently constructed forts meant control of the Mississippi River supply line.



The Union Army evacuated civilians from the city and positioned gun boats along the Mississippi River, allowing artillery and infantry to concentrate along the city's western edge, anticipating the Confederate's attack. General Shelby Brigade did approach from the west and repealed Union Cavalry attacks, but Shelby's efforts to advances were stopped by the Union's fortified artillery fire lines. Neither side could overtake the other after five hours of combat, leading General Marmaduke to withdraw and end the 2nd Missouri Raid.

## Truman's Birthday

President Harry S Truman's birthday is May 8th, a state holiday in Missouri observed on Monday, May 9, 2022. Truman was born in 1884 in Lamar, Missouri and died December 26, 1972, in Kansas City, Missouri. He was the 33rd and only President from Missouri, assuming office during World War II when President Franklin Roosevelt died in office on April 12, 1945.

Harry Truman was a public servant, enlisting in the Missouri National Guard in 1905, serving in the U.S. Army during World War One reaching the rank of Captain, elected a Jackson County Judge in 1922 and Presiding Judge in 1926, and elected a U.S. Senator in 1934 during the Great Depression. Truman was elected Vice President in 1944 for President Roosevelt's fourth term, becoming President three months later and

elected to a second term as President in 1948.

Truman served during times of conflict and controversy: the Pendergrass Machine, Atomic bombing of Imperial Japan, the Korean Conflict, 1952 coal strikes, and McCarthyism; however, he maintained his famous "the buck stops here" stance.

## **Armed Forces Day**

Armed Forces Day is Saturday, May 21, 2022. First observed in 1950 following consolidation of the military branches within the U.S. Department of Defense, Armed Forces Day celebrates service members and their families in the Army, Navy, Marine Corps, Air Forces, Coast Guard, and Space Force. Armed Forces Day is the 3rd Saturday in May and concludes a week of activities. Military bases often invite the public to open and air shows and houses

## James Buchanan Eads (1820-1887)



James Buchanan Eads

May 23rd is James Buchanan Eads' birthday. James was born in 1820 in Lawrenceburg, Indiana but grew up in St. Louis, Missouri. He was the son of Thomas Eads and Ann Buchanan. James was a self-tough innovator and engineer, leaving school at 13 but making use public libraries and experiences while clerking on steamboats. Eads leveraged his knowledge of river currents and steel production to build his fortune salvaging lost cargo from the Mississippi River.

Eads' Civil War contribution was the design and production of 30 ironclads used to patrol river waterways

and the Gulf of Mexico coastline. Although falling short on his promise to produce seven ironclads in sixty-five days, Union Marine Works in Carondelet, Missouri and Marine Railway & Shipyard in Mound City, Illinois delivered the promised gunboats by day 100. These gunboats supported Union victories at Fort Henry, Fort Donelson, Vicksburg, and Mobile Bay.

After the war, James continued his innovative steel work with the design and construction of the first rail bridge across the Mississippi River at St. Louis. Completed in 1887, the bridge is still used for vehicle traffic between Missouri and Illinois.

## **Traditional Memorial Day**



Traditional Memorial Day is Monday, May 30, 2022. First observed in 1868 when General John Logan, Commander-in-Chief of the Grand Army of the Republic (GAR) issued General Order #11 establishing Decoration Day to honor and mourn the soldiers and sailors who died during the American Civil War:

1908 Decoration Day postcard.

Let us, then, at the time appointed gather around their sacred remains and garland the passionless mounds above them with the choicest flowers of spring-time; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us a sacred charge upon a nation's gratitude, the soldier's and sailor's widow and orphan.

Decoration Day expanded to Memorial Day following World War One when veteran gravesites of all wars were honored. Decoration Day and Memorial Day were held on May 30th until the Uniform Monday Holiday Act of 1968 moved Memorial Day to the fourth Monday in May. The SUVCW along with the GAR Allied Orders and veteran groups including the Veterans of Foreign Wars (VFW) advocate returning Memorial Day to May 30th.

## **Observed Memorial Day**

Memorial Day is Monday, May 30, 2022. This national holiday known originally as Decoration Day commemorated deceased Union soldiers from the Civil War. The holiday was extended after World War One to honor and mourn all veterans who have died in all wars. The modern custom is to



place flowers and a U.S. flag at each veteran's gravesite. Traditionally, the U.S. flag is flown at half-staff in the morning and raised to full staff at noon. Many communities, veteran groups, and SUVCW camps participate in Memorial Day parades and services scheduled to coincide with raising the national colors at noon.

## **Army Birthday**



Thursday, June 14, 2022, is the 247th birthday of the U.S. Army, oldest of six branches of our Armed Forces. When the American Revolution started there was no standing army, rather local militia units engaged British troops in the separate Colonies. Although there is no official record of the action, John Adams reported that the 2nd Continental Congress adopted the Connecticut, Massachusetts, New Jersey, and Rhode Island militia troops on June 14, 1775,

which where blockading British troops at Boston following the Battle of Lexington-Concord and authorized the formation of the 1st Continental Regiment with George Washington as commander-in-chief.

At the outbreak of the American Civil War, the United States Army consisted of 16,000 soldiers, with a third defecting to the Confederate Army. President Lincoln called up 75,000 militia for three months and Congress authorized recruitment of an additional 500,000 volunteers. As the war escalated, the Union Army grew with an estimated 2 million serving between 1861 and 1865, including 179,000 African Americans and 100,000 Unionists from Confederate states.

## Flag Day

Flag Day is June 14, 2022, which commemorates adoption of the thirteen stars and stripes flag by the 2nd Continental Congress on June 14, 1777. The U.S. Army was also established on that day. The first National Flag Day was established by Woodrow Wilson's Presidential Proclamation in 1908 and by an Act of Congress in 1949.




A 1942 Congressional Joint Resolution consolidated flag etiquette between the Army and Navy to form the foundation for our current public law: Title 4, United States Code, Chapter 1 The Flag. This United States Flag Code establishes the policy for federal agencies and the national standard for the display and use of our flag.

The United States flag had 33 stars at the start of American Civil War and added a 34th for Kansas in 1861 and 35th in 1863 for West Virginia's succession from Virginia. The Union did not remove any stars when the eleven Confederate States succeeded.

## **Battle of Boonville**

The Battle of Boonville occurred June 17, 1861, with 1,700 Union infantry and militia under Captain Nathaniel Lyon skirmishing with 1,500 from the prosecessionist Missouri State Guard commanded by Colonel John Marmaduke. With few casualties, it was a minor military victory for Union forces but provided an important political and strategic accomplishment.

Missouri like other boarder states was divided between supporting the Union or Confederacy. Captain Lyon's forces were pursuing Governor Claiborne Jackson who was positioning Missouri for the Confederacy. After securing the state capitol in Jefferson City, the Union Army reached Governor Jackson and the Missouri State Guard at Boonville. The better trained and organized Union Army ousted the newly formed Missouri State Guard within a few hours. The strategic significance, was pro-secessionist abandoning central Missouri, regrouping in southern Missouri, and setting up the Battle of Wilson Creek that followed three months later.

## **ROTC Awards Program**



SUVCW's ROTC medal

As colleges and high schools return to some normalcy, it is time to rebuild our ROTC awards program. Missouri and Arkansas have 17 college ROTC and 99 high school JROTC programs. If your camp is resuming or looking to expand its participation, the steps are simple, and the ROTC medals are free:

- 1. Contact your college ROTC or high school JROTC unit that your camp is supporting their ROTC medal award presentation.
- 2. Confirm with the Department's ROTC coordinator at <a href="mailto:rotc@suvcwmo.org">rotc@suvcwmo.org</a> which ROTC-JROTC units your camp is supporting.
- 3. Order the ROTC medal from the Assistant National Quartermaster at <a href="mailto:rotc@suvcw.org">rotc@suvcw.org</a> using <a href="mailto:SUVCW Form 7">SUVCW Form 7">ROTC Award Application</a>. They are provided at no cost.
- 4. Volunteer to present the ROTC medal at the college/school's spring awards program.
- 5. Report each ROTC award with the cadet's name, date, and school to the Department's ROTC coordinator at <a href="rotc@suvcwmo.org">rotc@suvcwmo.org</a>.

## JROTC Outstanding Cadet Competition

The deadline to submit nominations for the annual JROTC Outstanding Cadet competition is 1 July 2022. This competition is open to high school JROTC cadets in Missouri and Arkansas. The Outstanding Cadet receives a ROTC medal-ribbon bar with bronze leaf/star and a \$200 price. The rules and steps to participate in the competition are simple:

- The JROTC cadet must be a 2022 recipient of a SUVCW ROTC medal for his/her high school JROTC unit.
- The JROTC unit must provide a 100- to 300-word summary of the cadet's accomplishments. No form, just a simple write-up or email.
- 3. Each Camp may nominate one cadet for the competition from among the JROTC high school units they sponsor.
- 4. Submit the Camp's nominee with the JROTC unit's 100- to 300-word summary to the Department's ROTC coordinator at <a href="rotc@suvcwmo.org">rotc@suvcwmo.org</a>. Deadline to receive Camp nominations: July 1, 2022.

Camp's may want to consider a local prize for their nominee to encourage participation, such as one-year SUVCW associate membership, invitation to a camp dinner, or a cash prize.



## Installing Officer Reports (Form 22) Due to National Headquarters by 15 March Annually

By the authority vested in me as Commander-in-Chief of the Sons of Union Veterans of the Civil War, the National Constitution and Regulations, and National Policies, it is hereby ordered as follows:

Section 1. Pursuant to a request from the National Executive Director for a review of the Constitution and Regulations regarding the due date for the submission of Certification of Election and Installation of Camp Officers (Form 22), by Department Secretaries to the National Headquarters and following a review of the Constitution and Regulations by the National Counselor, no specific date was identified in either the Constitution and Regulations or the Form 22 as to when the form was to be received at the National Headquarters.

Section 2. Per Chapter I, Article VII, Section 4 (b) of the Constitution and Regulations, a subset of the job description and duties of the Camp Secretary, "The Secretary shall forward to the Department Secretary the Installing Officer's Report (Form 22) on or before February 15th of each calendar year".

Section 3. As the National Counselor found no specific date for the submission of Form 22s to the National Headquarters by Department Secretaries, I hereby rule and Order that Department Secretaries shall forward to the Executive Director Installing Officer Reports (Form 22s) on or before the 15th of March each calendar year.

## General Order #6 Series 2021-2022 13 February 2022

## Department Commanders Authorized to Lobby in Support of H.J. Res. 58 and S.J. Res. 26

Whereas, House Joint Resolution 58 and Senate Joint Resolution 26 of the 117<sup>th</sup> Congress will soon be working their way through the House of Representatives and the Senate to elevate Lt. General Ulysses S. Grant to the Rank of General of the Army, and,

Whereas, the Congressional Charter of the Sons of Union Veterans of the Civil War states that we are to perpetuate the memory of the Grand Army of the Republic and the men who saved the Union in 1861 -1865, and,

Whereas, Lt. General Grant was a key player in the ultimate victory which saved the Union, and,

Whereas, it is only proper that the Sons of Union Veterans of the Civil War support the proposed elevation in rank to General of the Army.

Therefore, the following is Ordered:

- 1. Department Commanders are hereby authorized under the provisions stated withing the SUVCW Lobbying Policy as found in General Order #14 Series 2020-2021, issued by PCinC Brian Pierson, to forward letters of support for the proposed Resolutions to the members of the House of Representatives and Senators from those states within their Departments.
- 2. This authority to Lobby is granted only to the Department Commander, who will speak as the representative of the SUVCW in his Department. Department Commanders are encouraged to consult with their membership on this matter, but the decision to support the Resolutions is solely at his discretion.
- 3. In accordance with GO #14 Series 2020-2021 (Lobbying) Department Commanders will file a report to the Commander-in-Chief in accordance with Paragraph 7 sub-paragraph b.

This Order does not preclude the rights of Brothers acting as private citizens to communicate with their members of the House of Representatives and Senators, however they must not represent themselves as speaking for their SUVCW Camp, Department, or the National Organization. Additionally, in doing so as an individual, Brothers must not express their connection by membership to the SUVCW.

These photos are for SUVCW use and may appear in the Banner, on the SUVCW website, promotional brochures, social media outlets or in other future SUVCW promotional material.
- 3. Individuals attending events hosted by the Sons of Union Veterans of the Civil War, by virtue of their attendance, agree to the usage of their likeness in the Banner, any Camp or Department Newsletter, any SUVCW website and/or on any SUVCW Social Media outlet, promotional brochures, or any other SUVCW material
- 4. It is Ordered that the following statement be noted on the Official Programs for all SUVCW events, ceremonies, and meetings, along with posting on any SUVCW website homepage and photo galleries: "Individuals attending events hosted by the Sons of Union Veterans of the Civil War, by virtue of their attendance, agree to the usage of their likeness in the Banner, any Camp or Department Newsletter, any SUVCW website and/or on any SUVCW Social Media outlet, promotional brochures, or any other SUVCW material".
- 5. It is further Ordered that no one shall post to any Social Media outlet and/or web site, or any other means of communication, any live or video recordings or selected video clips from any business sessions (including committee meetings) of a Camp, Department, or National Encampment, with an explicit exception of the presentation of awards or special recognitions. There shall be no prohibition against the posting of still photography during or after any such meeting. Nothing in this Order shall be considered as any type of prohibition in the use of interactive video technology via Zoom or other such program for Brothers of the Order and invited guests attending meetings by electronic means consistent with National Regulations and/or National Policy.

#### A Brief History of the Grand Army of the Republic and Mountain Grove Connection

The Grand Army of the Republic (GAR) was a fraternal organization composed of veterans of the U.S. Army, Navy, Marine Corps, and Revenue Cutter Service (Coast Guard) who served the Union during the American Civil War, 1861-1865. The GAR was founded on April 6, 1866, in Decatur, Illinois with twelve members and the principles of Fraternity, Charity, and Loyalty. This GAR group was one of several post-Civil War veteran groups but quickly became the dominate organization when the GAR held is first National Encampment in 1866, in Indianapolis with delegates from 10 states.

At its peak in 1890, the GAR had over 7,000 posts and 490,000 members. They met regularly as local posts, held state-level conventions, and an annual National Encampment. At their core, the GAR was a fellowship of veterans: they marched in community parades, brought a military tribute to member funerals, and dedicated countless monuments and memorials. Nationally, they

established our modern

Memorial Day when the GAR issued General Order #11 in 1868 declaring May 30th as Decoration Day. Largely forgotten with our modern Interstate Highway System but the longest highway in its day, U.S. Route 6, from Provincetown, Massachusetts to Bishop, California is designated the Grand Army of the Republic Highway to honor the organization's civic work.

They were the local arm of the Republican Party, honoring their wartime Commander-in-Chief, President Abraham Lincoln, the first Republican President. President Benjamin Harrison's 1888 election over incumbent President Grover Cleveland was credited to Harrison's support for veteran affairs and eventual passage of the Disability Pension Act of 1890, which was an early version of our modern Social Security and Medicare programs. In the era of the GAR, a northern politician needed to be a GAR member or be seen with the GAR at Independence Day parades and Decoration Day memorials.



The GAR's days were numbered, as members aged and passed, so did the GAR's influence. They met annually for 83 years with their last National Encampment in 1949, with 16 living members. The GAR dissolved in 1956 with the death of their last member, Albert Woolson.

There were 594 Missouri GAR posts with 14 in Douglas, Texas, and Wright Counties including Mountain Grove's Major Henry Post #136 and David Porter Post #433, Cabool's Pardee Post #352, and Norwood Post #274.

The GAR's Mountain Grove legacy is the monument on the southeast corner of the square. It was dedicated on Decoration Day (Memorial Day) May 30, 1922. The monument depicts a Union Soldier wearing a kepi, carrying a knapsack, holding a percussion riffle, and appropriately facing south. Unique to the monument is the front-facing text honoring soldiers with reference to the World War and the back-facing text honoring nurses with reference to the Spanish-American War, both wars after the Civil War. The text states the monument is a gift from the GAR to the City of Mountain Grove.

Two National Encampments were held in Missouri: the 21st National Encampment in St. Louis in 1887, and the 50th National Encampment in Kansas City in 1916. The Kansas City National Encampment was special being their Golden Jubilee Reunion. It was also an era when an aging GAR was losing thousands of members each year. The *Kansas City Journal* reported that "ninety older soldiers hear taps each day" referring to the 33,000 Civil War veterans that died in 1915.

The GAR has five auxiliaries making up the Allied Orders: Sons of Union Veterans of the Civil War (SUVCW), Woman's Relief Corps, Daughters of Union Veterans of the Civil War (DUVCW), Ladies of the Grand Army of the Republic (LGAR), and Auxiliary to the Sons of Union Veterans of the Civil War (ASUVCW). Each Allied Order continues the GAR's legacy to preserve the

memory of the soldiers and sailors in blue that saved the Union.



**Francis Blair**, **Jr. Award** is presented annually to an outstanding member of the Department of Missouri, Sons of Union Veterans of the Civil War. It is for the member who has made the greatest collective contribution during a specific year to the Department and his Camp through its programs and activities. The member must have been in good standing and exemplify the virtues of Fraternity, Charity, and Loyalty for the entire year. An award recipient is not eligible for repeat consideration for five years.

**Meritorious Service Award** is presented to a member of the Department of Missouri, Sons of Union Veterans of the Civil War. It is for the member who has made a significant contribution or collective contributions over a period of time to the Department and his Camp through its programs and activities. The member must have been in good standing for five or more years, and exemplify the virtues of Fraternity, Charity, and Loyalty. An award recipient is not eligible for repeat consideration.

**Grand Army of the Republic Award** is presented to an Allied Order member or group. It is for members or groups who have made a significant contribution or collective contributions over a period of time to promote fraternal relationships between the Allied Orders in perpetuating the memory of the Grand Army of the Republic (GAR) and our ancestors who fought to preserve the Union. An award recipient is not eligible for repeat consideration for three years.

**Wayne Sampson Show Me Spirit Award** is presented to an individual who has made a significant contribution or collective contributions over a period of time to promote the SUVCW, Allied Orders, or Civil War history, and who demonstrates a shared interest in the SUVCW mission. An award recipient is not eligible for repeat consideration for three years.

**James Eads Award** is presented annually to all qualifying camps. The award recognizes camps that meet the eligibility criteria published in the nomination application. A qualifying camp receives a ribbon streamer.

**Samuel Curtis Award** is presented to the member who recruits the greatest number of new members within the Department during the period 1 May through 30 April. There is no application with selection based on information provided in the Membership Applications (Form 3) received by the Department Secretary by April 30th.

**Nathaniel Lyons Award** is presented to the Camp with the greatest percentage increase in membership during the period 1 May through 30 April. There is no application with selection based on information provided in the Membership Applications (Form 3) received by the Department Secretary by April 30th.

**Department Under Forty Award** is presented to a Camp with three or more new members under age forty (40) during the period 1 May through 30 April. There is no application with selection based on information provided in the Membership Applications (Form 3) received by the Department Secretary by April 30th.


#### YOU CAN STILL REGISTER AT THE DOOR!!



Membership in the Sons of Union Veterans of the Civil War (SUVCW) is open to all male descendants, whether through lineal or collateral line, and not less than 14 years of age who: (1) are a blood relative of a soldier, sailor, marine or member of the Revenue Cutter Service, who was regularly mustered and served honorably in, was honorably discharged from or died in the service of the Army, Navy, Marine Corps or Revenue Cutter Service of the United States of America or in such state regiments called to active service and was subject to orders of United States general officers between April 12, 1861 and April 9, 1865; (2) have never been convicted of any infamous or heinous crime and (3) have, or whose ancestor through whom membership is claimed, has never voluntarily borne arms against the government of the United States.
