2. If you do not fall into one of those categories, you can vote if you are a delegate of your camp or an alternate recognized by your camp and you do not have the maximum number of delegates allowed for your camp. To be a delegate or alternate, your Camp Secretary or Commander must issue you a copy of Form 2a. If you are at the meeting and not a delegate or in one of the positions noted in 1 above, you can partake in debates (but not vote) in all meetings.
