A native of Affton, MO, he worked as a blood lab technician, meat wholesaler and then at St. Louis Lithographing before becoming disabled from a neck surgery. No funeral services are planned at this time and the only thing the family asks is that David's wife be kept in your prayers as she suffers from severe memory loss and could not even call for help when David passed. She was found malnourished and had to be hospitalized.

He was instrumental in the restoration of Fort D, in Cape Girardeau. This year they had a grand opening and rededication of the stone building at Fort D and he was present for that. He was a reenactor serving with the Turner Brigade in the Engineer Company.

Major General John A. Logan while serving as Commander-in-Chief of the Grand Army of the Republic issued Order #11 on May 5, 1868 establishing May 30th as Decoration Day which we now celebrate as Memorial Day. We have the rare privilege of celebrating Memorial Day on May 30th this year.

While watching on you tube a program link "Civil War Veterans Talking and Telling Stories: Filmed on May 30, Memorial Day, 1930" shared on Department of Missouri – Sons of Union Veterans of the Civil War facebook page. One of the following Civil War veterans said,

"Boys and girls, 62 years ago, my corps commander John A. Logan (1826-1886) issued an order that this 30th of May should be used as a Memorial Day in honor of the soldiers that fought during the Civil War."

As the descendants and lawful heirs of the GAR, each of us pledged during our membership induction to always observe the day set aside as Memorial Day, sacred to the memory of the Union Soldiers and Sailors.

SPECIAL COMMUNIQUÉ NO. 1 SERIES 2021-2022 140th SUVCW National Encampment

Brothers,

As we have recently experienced the successful close of the 140th Anniversary of the SUVCW Encampment in Frontenac, MO, I would like to share with you how important it was.

There were four different organizations of the Allied Orders of the Grand Army of the Republic in attendance. The Allied Orders that were present were the Sons of Union Veterans of the Civil War, Daughters of Union Veterans of the Civil War, Auxiliary of the Sons of Union Veterans of the Civil War and the Woman's Relief Corps. This is the first time that four of the Allied Orders have all had their annual meetings in one location at the same time since 2007. If you do not know, the 2007 meetings were held in St. Louis. Eight of our camps were present. They included members of the Grant Camp, Wilhelmi Camp, Fletcher Camp, Tiger Camp, Phelps Camp, Westport Camp, McPherson Camp and St. James Camp.
