Sigel Camp #614: Rolla Camp Chartered in the SUVCWMO

On 14 June 2011, the 150th anniversary of General Franz Sigel's occupation of Rolla, Missouri, Camp Organizer Randal A. Burd, Jr. applied for authorization to form a new camp of Sons of Union Veterans of the Civil War in Rolla. Combining efforts with charter members Steve Allen (St. James, MO), Brandon Brown (Rolla, MO), Scott Brown (Rolla, MO), and Nick Burchett (Laguey, MO), the name of "Franz" was dropped in order to honor both Franz and his brother, Col. Albert Sigel. Sigel Camp #614 was born. Officers were sworn in on 12 December 2011: Randal Burd as Camp Commander, Nick Burchett as Secretary, Steve Allen as Treasurer, and Scott Brown as Chaplain. The charter was signed by Commander-in-Chief Donald Palmer on 27 December 2011

Why Sigel?

As a Sons of Union Veterans of the Civil War camp in Rolla, Missouri, we are in a unique position to honor a pair of officer brothers who served the Union cause in our immediate area. Major General Franz Sigel occupied Rolla, Missouri with his federal force on 14 Jun 1861. From there, he continued South to fight in engagements including the battle of Wilson's Creek near Springfield. His brother, Colonel Albert Sigel, took his 13th Missouri State Militia and occupied Waynesville, Missouri, on 7 Jun 1862, suppressing Southern sympathizers and bushwhacker activities while keeping the Old Wire Road, a major Union supply route, open from Rolla to Lebanon.

RECRUITING: FROM THE SUVCW RECRUITMENT GUIDE

"Each and every Brother of the Order, whether he is a Member, Junior, or Associate can be a recruiter. It's been said many times that if each of us were to recruit just one new Brother a year, our membership would immediately double and thereafter multiply. As stated in the SUVCW's "Purpose and Objects," there is much to be done and membership growth assures that these efforts will be maintained and improved upon. Essential to recruiting success is public recognition of the SUVCW and the accomplishments of its membership. Public relations can start with any of the physical work that's done at the local level, to honor Union Civil War soldiers and sailors. Leadership officers at the Camp, Department, and National levels can then help publicize these accomplishments. The objective is to create more public recognition of the SUVCW and to provide examples of achievements that will attract new Brothers to the Order.

One such example is the work to restore a GAR Monument or other Civil War Memorial that honors Union soldiers and sailors. Rededication ceremonies should be planned that include participation by other veterans' organizations plus local and state dignitaries who attract attention from the various news media. In addition to coverage of particular functions, newspapers, radio stations, and local access television channels often extend interview opportunities to organizations such as ours. Further interaction with other veterans' groups for Memorial Day, Veterans Day, and other observances will establish and maintain community recognition.

Efforts should also be made to establish an ongoing supportive relationship with Civil War Roundtables, Historical Societies, Genealogical Societies, and other military oriented heritage organizations, including the Military Order of the Loyal Legion of the United States (MOLLUS). These are potential sources of recruits. The same applies to Civil War reenactor groups in your locale.

The memberships of the other Allied Orders of the GAR [Ladies of the Grand Army of the Republic (LGAR), the Woman's Relief Corps (WRC), Daughters of Union Veterans of the Civil War (DUVCW), and the Auxiliary to the Sons of Union Veterans of the Civil War (ASUVCW)] are a potential source of male relatives who qualify for SUVCW membership. A referral of potential membership candidates can be of mutual benefit between the 'Allied Orders.'

History teachers at local schools often welcome speakers to address their classes. This allows an introduction of the SUVCW to a younger generation in many communities. Camp and Department level volunteers are encouraged to actively recruit new Brothers by setting up display booths and greeting the public at community heritage festivals, county & state fairs, Civil War Roundtable expos, Civil War relic & collectable shows, Civil War reenactments (from the local size to the large national scale events), premier exhibitions of Civil War theme motion pictures, and historical & genealogical seminars. Passive recruiting can take place by gaining permission to set up and stock displays of our recruiting brochures at libraries and various government offices. Continuously updated webpages on the Internet can communicate what the SUVCW is all about and attract new Brothers as well. Such efforts should be coordinated between Camp, Department and National level Communication & Technology officers."



12 Dec 2011 – Department of Missouri Commander D. Christopher Warren attends the meeting of Sigel Camp #614 and installs the camp's 1st slate of officers.

27 Dec 2011 – Commander-in-Chief Donald Palmer signs the charter for Sigel Camp #614, making it an official camp of Sons of Union Veterans of the Civil War.

8 Feb 2012 – Randal gives a presentation to the South Central Missouri Civil War Roundtable entitled, "The Case For James H. McMillian, Evidence of Service as 1st Lieutenant, Co. E, Osage County Home Guard."

13 Feb 2012 – Chris Johnson of the South Central Regional Veterans Association gives a presentation to Sigel Camp #614 on the new Veteran's Memorial Park in Rolla, MO.

10 Mar 2012 – Sigel Camp #614 was presented their charter in House Hearing Room #7 of the Missouri State Capital Building at the Department of Missouri Business Meeting. Charter members Randal A. Burd, Jr., Nick Burchett, Steve Allen, and C. Scott Brown were in attendance.

28 May 2012 – Sigel Camp Commander Randal A. Burd, Jr. issues a Camp Order recognizing the event at Rolla Veterans Memorial Park as the Memorial Day observance event for Sigel Camp #614. Randal attends event on behalf of Sigel Camp #614.

2 Jun 2012 - Sigel Camp Commander Randal A. Burd, Jr. attends the Department Encampment in Ste. Genevieve, Missouri, on behalf of Sigel Camp #614. Randal is elected Secretary for the Department of Missouri.

7 Jun 2012 – Observance of the 7 Jun 1862 occupation of Waynesville, Missouri, led by Sigel Camp Chaplain C. Scott Brown. Attendees included pending member Mike Harris and the South Central Missouri Civil War Roundtable.


