## Sigel Camp #614 Turns Two Years Old

On Dec 27, 2011, after a little over six months of organization and the installation of its first slate of Commander-in-Chief officers, Don Palmer signed the charter for Sigel Camp #614, making it officially a camp in Department of Missouri, Sons of Union Veterans of the Civil War.

Scott Brown, both also members of the re-enactor group, Turner Brigade, both have donned the wool while attending numerous events specifically to represent the fledgling camp. #### LETTER TO THE COMMANDER-IN-CHIEF

Brother,

Below is a response I received when telling a camp member his 15-year-old son's application might be deferred on account of General Order #3.

"I am appalled by the possibility that his application might be deferred. If that happens, I am very likely to resign both my offices and my membership within the organization. I am a qualified BSA leader, and I know that the organization can do a better job of responding to this that it has. If it chooses to mishandle the situation in that manner, I will become unwilling to associate myself with it.

I do not intend that this email should come across as hostile, and I do not want to see this happen! But I am obligated to participate in sufficient asinine situations at work and therefore have no need to volunteer to participate in additional ones for my recreation."

While observing multiple like responses to General Order #3 of varying degree, it occurs to me that it may not have been taken into account, in addition to the loss of new membership from those under 18, the loss of current membership from brothers disgusted with the restrictions imposed by this General Order. At the very least, I would expect a General Order which has such a debilitating effect on our organization would be resolved with a special meeting in the immediate future, not left to sow seeds of discontent and inhibit the growth and retention of this organization's membership for almost an entire year.

Might there be some positive message I can convey to those expressing sentiments similar to those in italics above to restore their faith in the Order?
