Rolla was the end of the rail line at the time and was captured by Union forces led by General Franz Sigel on June 14, 1861 and held until the end of the war. Rolla was a staging point for Union forces and a processing point for Confederate soldiers and sympathizers who were arrested or captured and taken to prisons in St. Louis and Illinois.




