

**Sumner Gary Hunnewell, Jr.**, was born in Portland, Maine, on April 9, 1962. His Hunnewell family has very deep roots in the area of southern Maine since the 1650s. His hometown of Scarborough has what is reputed to be the oldest building still standing in the county, the Capt. Richard Hunnewell house. Both of his parents are *Mayflower* descendants.

At eighteen, Sumner met his future wife and (following her) moved to Missouri, where he attended Central Missouri State University, graduating with a Bachelor's Degree in Mathematics / Computer Science in 1984. After graduation, he was employed by Southwestern Bell (now AT&T) where he has held management and supervisory positions for software development. In 1996, he matriculated from Washington University in St. Louis with a 4.0 GPA for this Masters in Telecommunication Management. Later, he became a program / project manager for AT&T and was earned his certification as a Project Management Professional by the Project Management Institute. He retired with 33 years of service at age 55.

He has been married for 38 years to Sylvia Beatrice Richardson. She earned her degree in Fine Arts from Kansas University. They have two children, Sumner Tristan Hunnewell and Rachel Elanor Hunnewell.

In 2003 *The Maine Genealogist* published his two issue article “‘A Doleful Slaughter near Black Point’: The Battle at Moore’s Brook, Scarborough, Maine, June 29, 1677.” The paper took three years to research and write. While historians knew about a handful of men to have taken part in the battle, he made an effort to name every man (about 50) who fought and died there. Also, for his hometown’s 350<sup>th</sup> anniversary, he wrote six articles, mostly covering the colonial period of Maine. These were published in *Scarborough at 350: Linking the Past to the Present*.

Endeavoring to learn something new, he taught himself how to write and prepare indexes for books. Since then, he has indexed an even dozen books mostly baseball autobiographies or on the subject of baseball, which is another of his passions. This, along with this vintage base ball play and his work with the baseball’s independent Frontier League and its Commissioner, garnered him the Fan of the Year Award presented by the St. Louis Sports Hall of Fame in 2016.

He is an expert on the works and fan base of the works of J. R. R. Tolkien. For thirty years, he has worked with Marquette University to microfilm / scan and catalog his vast collection of personal material. He is abstracting the contents of Tolkien publications for use by scholars of popular culture, completing work from the late 1950s to 1968 thus far. He as presented papers on the subject since he was 20, including at the Tolkien Centenary conference



in Oxford. Recently he was hired by Warner Bros. as an expert witness on the matter in a countersuit against the Tolkien Estate.

He is very active in his church, St. John's Lutheran Church (Lutheran Church – Missouri Synod) in Arnold. He has been an elder and selected as lay delegate to both state and national conventions of his church body. He leads two *Bible* studies, heads the English as a Second Language program, and helps with social ministry work. He participated in, organized and/or managed trips of church members to help rebuild homes New Orleans (hurricane), Cedar Rapids (flood), and Joplin (tornado). He is active in service to his neighbor as a Red Cross volunteer, helping with sheltering during recent floods and house fire assistance.

Six years ago, he rekindled his interest in genealogy and joined hereditary societies. Since then he has become a local, state, and national officer in many. His Civil War ancestors are:
