Editor's Comments by Walt Busch, PDC Three Articles - Walt Goes On A Rampage

Recently a man e-mailed about joining the SUVCW, citing his concern against monuments that honored Confederates. He had a very strong opinion on the matter and I honestly thought it might be a ploy to get me to say something in support of Confederate monuments. So, I just e-mailed him back the SUVCW official stance from 2017. He responded that it didn't seem to matched his personal views so he would have to think about joining. I then wrote the following. Since my wife liked what I wrote (and the man wrote back, saying he appreciated having a reasonable discussion without the bickering that seems to go on today), I think it might be something we all need to think about. These are my own personal views! If my opinion offends you (especially about Robert E. Lee) take it up with me. The view is not necessarily that of the Sons of Union Veterans of the Civil War!

I believe you would find that many of us agree with your position. The problem is that there has NEVER been a totally good man to walk the earth in the last 2000 years. Even great men like Martin Luther, Winston Churchill, and Abraham Lincoln all had their foibles. Luther, in later life, had issues with non-Christians (Jews) and Churchill arrogantly was against non-whites. Lincoln was more than willing, initially, to preserve the Union with slavery intact. All sin and fall short...

Today, no good American would say that those fighting the Japanese in WW2 were bad or evil, but there are legitimate stories of some committing cannibalism on dead Japanese because the Japanese were found to be doing the same to our dead (supposedly to consume their fighting spirit) or killing surrendering soldiers. Everything must be judged by the times and circumstances they involved.

Walt Busch – Still On His High Horse, An Editorial Comment! – Part One

Go ahead and google without quote marks "Turkey in the Straw Racist." Read it. I had to roll my eyes. Here is a song written as a fiddle tune in the 1820s. The words of the song at that time were about barnyard animals. Ok, no problem, right?

Well, according to Wikipedia, the song was sung in minstrel shows from about the 1870s to the 1930s(i.e., done in black-face), but that isn't the full issue with the song. After all, what popular song of the 1800s wasn't done in a minstrel show? Apparently in 1916 some moron decided to rewrite the words and use terms like the N-word, watermelon, and so on. Now there are people actually wanting the tune banned! Not just condemn the 1916 song; not destroy all copies of this moron's record! No, they want the tune banned from such things as being played by ice cream trucks.

Symbols like the swastika can be co-opted. The Germans stole it from the Indian culture. Songs can be co-opted. But to co-opt something, that version has to replace the original as the version in the public mind. "Mine eyes have seen the glory of the burning of the school" might be something every school child knows, but it has never replaced the original. So, a tune can be racist if it has been totally co-opted. Now, someone found an obscure version of Turkey in the Straw's that some moron wrote racist words to and suddenly that song is racist. If I wrote racist words to a Beyoncé song, a Beatle song or, God-forbid, Beethoven's Ode to Joy, does that make those tunes or their songs with their words racist? Do we eliminate all copies of Pretty Hurts and Hey, Jude (a song I am personally tired of) or the Ode (something I could listen to every day)?

No one has cared about this *Turkey in the Straw – Remake* since 1916, but you can find it on youtube including one video with the editor complaining about the racism in the *ORIGINAL* 1916 song & tune! Original? In 1916? When the song was written in the 1820s? Someone needs a history lesson along with some common sense! So the tune has not been co-opted. Hence, the song & tune are not racist, except in this person's distorted mind. This kind of nonsense needs to stop!

A rewrite of history to show that there has been racism and that some honored Americans might not be so honorable is not a problem. If Monticello wants to interpret the slavery of Thomas Jefferson in a lot more detail, I'm ok with that. Condemn him as a slave holder who spoke words of freedom for only white Americans? That's kind of what he did, although he did recognize there would be a future when equality would exist! If we need to discuss how Abraham Lincoln was ok with preserving the nation with slavery and his evolving thoughts on slavery, I'm good with that too. But just because someone someday might rewrite the Gettysburg Address creating a racist version and someone finds that obscure version of it years later, does not mean racism is inherent in the original speech.

The Young Americans for Freedom had a song in the 1960s titled *It's a Commie Plot You See to Get Us Orally* sung to *Aura Lea*. You all remember it, right? No? That's because I probably have the only ditto machine copy of it in the world! Well, so don't worry if someone tries to coopt a Beyoncé song. The original will survive. "Save the Turkey (in the Straw)!" But not Turkey for Thanksgiving. I hate turkey meat anyway.

Slavery is wrong in every instance. But, to a person 300 years ago who based their life on the Bible, slavery wasn't necessarily evil. The Bible doesn't clearly condemn slavery. Thus, a man who accepts slavery should be judged only AFTER he realizes that slavery is wrong. Once he realizes it and continues to engage and support it, then that is an evil man! Robert E Lee wrote to his wife in 1858, 'In this enlightened age, there are few I believe, but what will acknowledge, that slavery as an institution, is a moral & political evil in any Country,..." But as late as 1865, he wrote that the best relationship between the white and black races was that of master and servant. So, in my mind, Robert E Lee knew slavery was wrong and had no business defending slavery and was morally bankrupt for doing so. Aside from slavery, Lee also commented that he knew the war was lost after Gettysburg. So, shouldn't he then be personally blamed for all the deaths in northern Virginia from July 1863 to war's end? At one point in his life he designed the levees that saved St Louis from major flooding. A hero to 19th century St. Louisans, an unrepentant slave owner and traitor to America. [Editor – if you don't like the word traitor being used with Robert E. Lee, complain to me personally.] If there are monuments to him, should we attempt to explain them? By tearing down monuments we are attempting to hide our history. When we hide history by tearing down monuments, burning books, etc., we do not learn from history.

Go back to WW2 and to Nuremburg and the postwar trials of the Nazis. Some Nazis who were heading to the gallows for the enslavement and/or execution of Jews and other peoples came in contact with a Lutheran Minister. After long talks with them, some sincerely asked forgiveness. He pronounced God's forgiveness to them. As a Lutheran, I accept that someone who truly seeks forgiveness will go to heaven. I don't have to erect a monument to them, but am I not also to forgive them? According to the Christian concept of forgiveness, I will be seeing some of them in Heaven.

The object of the Sons of Union Veterans of the Civil War is to honor and preserve the memory

of the soldiers who fought to preserve the Union and end slavery. Some were good and some just were not. They still fought to end slavery. We honor their sacrifices; we do as much as possible to correct the ideas of a Lost Cause; and, in my opinion, we expose

the social Darwinism that in the past kept minorities downtrodden by trying to present a patriotic and historically accurate picture of these men.

I hope my opinions here help inform you in any decision that you are considering.

The Flag Code does not prescribe how the salute shall be given in rendering the Pledge to the Flag. However, the following, which is prescribed in the public schools of Washington (D. C.), is the prevailing practice: Standing with the right hand over the heart (Fig. 1), all the pupils repeat together the following Pledge: "I pledge allegiance to the Flag of the United States of America and to the Republic for which it stands, one Nation indivisible, with liberty and justice for all." At the words "to the Flag," the right hand is extended, palm upward, toward the Flag (Fig. 2), and this position is held to the end. After the words, "justice for all," the hand drops to the side.

This is how you co-opt something...The Hitlergruß or Hitler Salute is a perfect example of a simple salute that had been used in many counties, including the United States. Its use has been subverted due to an evil man. In fact, so much so that worldwide it is only recognized as being followed by a "Sieg Heil!"

Having watched several documentaries recently on Franco in Spain and Mussolini in Italy, the greeting was pretty much the same. Hail Caesar! was also pretty similar. But now it is just the Hitler greeting. That is how you co-opt something! Just because someone finds one comment, one time, or one obscure song and wants to claim it is racist is just it trying to force you to indulge in its paranoia and attempting to define political correctness by shouting out its standards rather than allowing for reasonable discussion to define what should be correct.

Note: I used it instead of him or her because it is gender neutral and must be politically correct.

I realize some of you may have issues with some of what I wrote above. That is the time for discussion, not censorship or name-calling. I have never received a letter of critique about this newsletter other than the occasional "good job," without being told what the good job was. 
Leonard was cremated and a memorial service was at a later date.



The badge on the left is a souvenir from Buffalo, New York. The badge on right on the next page is a souvenir from the 37th National







Protecting our Battlefields As sent in by SVC Joseph Rainey, PCC

The Civil War Trust is now the American Battlefield Trust whose primary focus is the preservation of land that our fore fathers fought on during the Civil War, the Revolutionary War, and the War of 1812. It is a charitable organization (501(c)(3)) and has received top rating of 4 stars from the leading charity evaluator.

The way it works is by taking in donations for specific projects and then leveraging that money into more money by matching grants from other sources. The latest project they are working on is 3 revolutionary battlefields, Port Royal Island, Great Bridge, and Parker's Ferry. If they can raise \$30,630 they can turn that into \$2,335,630 thru matching grants.

You join every year for \$35. They then send you letters on the newest battlefields they are working on. I only support those efforts where my great grandfather fought, like Perryville and Bentonville, NC. or battlefields in Missouri or Arkansas. They have helped acquire land for these Battlefields in Missouri and Arkansas.

The New 501-C-3 Tax Status for all Camps & Departments!

Despite the hardships and uncertainties caused by COVID-19, many individuals continue to step up and have increased their giving to support nonprofits working to make a difference during these unprecedented times. As we near the end of the year, please keep in mind some of the new rules and tax laws for charitable giving.

\$300 Charitable Deduction: With the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), individuals can now make charitable deductions of up to \$300 in 2020, even if you do not itemize your taxes. For your contribution to qualify, it must be a minimum of \$300 cash made directly to the nonprofit or charity. In addition, in 2020, you can deduct charitable contributions up to 100% of your adjusted gross income, instead of the previous 60% cap.

The camps and departments are now covered under the National Organization's 501-C-3 status (see General Order on page 16). So donating money straight to your camp, department or the national organization is also tax deductible. Please donate to the SUVCW NOW! If every member donated \$10 a





General Order #6 Series 2020-2021 6 December 2020

IRS Determination of 501(c)3 Status

- 1. Per Internal Revenue Service Letter 4167C, dated 23 Nov 2020, the Internal Revenue Service has determined that the Sons of Union Veterans of the Civil War is a tax exempt organization under Internal Revenue Code (IRC) Section 501(c)3. This recognition also extends to the subordinate organizations on the list we provided in 2017, in other words, Departments, Camps, SVR Military Districts and SVR Units on that list are now recognized as 501(c)3 organizations.
- 2. Per the IRS letter, "for federal income tax purposes, donors can deduct contributions they make to you as provided in IRC Section 170. You're also qualified to receive tax deductible bequests, legacies, devises, transfers or gifts under IRC Sections 2055, 2106, and 2522. Because IRC Section 170(c) describes your subordinate organizations, donors can deduct contributions they make to them."
- 3. For Departments, Camps and SVR units that were organized after 2017, and for new organizations, they will be added to the SUVCW group exemption. The National Treasurer must annually submit information to the IRS, removing units that no longer meet the definition and add new units. This report is due each year 30 days before the end of the Order's accounting year.
- 4. Please note that The IRS website that lists charitable organizations is not current and does not yet include the SUVCW. The IRS is behind updating the site due to COVID-19. This may impact such things as matching grants from employers. It is not known when the IRS will get the website updated, but it is being monitored, and we have made inquiries.
- 5. The SUVCW National Organization and all subordinate SUVCW organizations are to follow the direction regarding lobbying and political advocacy for 501(c)3 organizations provided in General Order #35, Series 2019-2020; paragraphs 2, 3, 5, and 6 remain in full effect. The guidance in GO #35 regarding 501(c)4 organizations is no longer applicable, specifically that in paragraphs 1 and 4.
- 6. This is the successful culmination of a rigorous, years-long process with the IRS that began with a vote of the National Encampment in 2015. Thanks are owed to our previous Commanders-in-Chief and to our National Treasurer and his predecessor for perseverance in a rigorous process with the IRS, to the Council of Administration for advice, expertise, and hard work throughout this process, and to the Departments and Camps that updated their bylaws to be in accordance with IRS regulatory guidance, thus enabling them to be granted 501(c)3 status under the National Organization's umbrella.

This determination opens a new chapter in our illustrious Order's history. As we mutually work to implement it, more guidance will be forthcoming.

National Policy on Monument Protection and Preservation

- 1. Whereas the 2020 National Encampment voted to abolish the existing Battlefield Flag and Monument Policy (August 2017) in order to be able to develop a policy regarding the protection of war memorials and monuments that is appropriate for the current conditions in the United States; and,
- 2. Whereas the Special Committee for Monument Protection Policy diligently and thoughtfully developed a draft policy and presented it to the Council of Administration for review and approval; and,
- 3. Whereas the Council of Administration carefully reviewed the draft policy and subsequently voted to approve it;
- 4. Therefore the National Policy on Monument Protection and Preservation attached to this General Order has been adopted as the official policy of the Sons of Union Veterans of the Civil War regarding war monument protection. It will be published on the SUVCW National Policy web page.
- 5. This policy builds upon the solid foundation of earlier General Orders, policies and resolutions on this critical topic. It clearly articulates the Order's position, provides a basis for engaging the public with a unified message, and allows the ability for a flexible response for different conditions and situations.
- 6. The new monument protection policy intentionally does not take a position on the status of the Confederate battle flag; therefore, the SUVCW is officially silent on this issue.
- 7. All Brothers, Camps and Departments, Camps shall follow and refer to this policy, especially when communicating with members of the public, government, or press.

SONS OF UNION VETERANS OF THE CIVIL WAR

NATIONAL POLICY

ON MONUMENT PROTECTION AND PRESERVATION

The Sons of Union Veterans condemns the criminal vandalism or unlawful destruction of monuments dedicated to the memory of American Soldiers from all wars as a breach of faith and duty to our ancestors, and to the principles of freedom they fought to preserve and pass on to their descendants.

- I. The primary purpose of the Sons of Union Veterans of the Civil War is to perpetuate the memory of the soldiers and sailors who fought and sacrificed for the Union from 1861 to 1865 and in many cases were wounded or died to save the United States of America.
 - a. It is our solemn duty to honor the soldiers belonging to the Union, "Boys in Blue" who fought that terrible war and to oversee the process of preserving the memories of those soldiers and sailors, and their courage, tenacity and strength, by raising monuments commemorating their service and deeds. The erection of such monuments has continued down through the years, extending even unto the present day. These monuments can be found in cities, towns, and villages across the entire country, and indeed, beyond our shores.
 - b. Furthermore, we seek to honor the men and women, both public and private, who provided the inspiration and leadership, which lead to the salvation of the Union and the liberation of a people from bondage.
 - c. One of the ways we perpetuate the memory of the "Boys in Blue" is to care for and work to repair those monuments dedicated to their sacrifice when the need arises. To this end, we have established ways by which we may assist in the erection and repair of monuments and memorials. This work is ongoing.
 - d. Recent, criminal acts of vandalism and outright destruction of monuments dedicated to our Union heroes by groups or individuals demanding their elimination or removal have increased. With regard to the vandalism or destruction of such monuments it is the policy of the Sons of Union Veterans of the Civil War, that there should be criminal prosecution of perpetrators of such crimes by legal authority.
 - e. In cases of organized attempts to remove monuments, those efforts to remove them are to be actively opposed in all ways that are both practical and legal. The methods by which this active opposition would happen will differ from case to case, given the unique situation involved in each event. However, in all cases, the Commander-in-Chief, or his designee, acting with his instructions and under his authority, should set the course of action to be followed in addressing the problem.
- II. Monuments serve the necessary purpose of inspiring and educating future generations of Americans on the sacrifices made by their forefathers. Further, monuments are visible signs of the patriotism and selflessness shown by American soldiers and sailors, who placed the country before their own lives and fortunes, to ensure the preservation of the Nation. By this policy, we state our intent and reaffirm our commitment to our honored dead and dedicate ourselves to do all in our power as an organization, to ensure that the memorials to them will be preserved for the inspiration and education of future generations.

Monument Protection Policy

Dear Brothers,

Having received some questions and comments from our fellow Brothers on the SUVCW's National Policy on Monument Protection, as well as having heard of some posts on social media that misunderstand what the policy says and means, I would like to take a few minutes to offer some thoughts for your consideration.

Today, our great nation is faced with anti-patriots who have been and are illegally destroying private and public property. They have pulled down statues of Union Civil War heroes and even of President Lincoln. They have attacked monuments and memorials to great Americans from every period in our history.

In this context, the 2020 National Encampment directed that our National Policy on Monument Protection be updated in order to be relevant to what has been going on today. Our National Policy on Monument Protection was carefully written with this goal in mind. The introductory paragraph is the keystone for the rest of the policy.

"The Sons of Union Veterans condemns the criminal vandalism or unlawful destruction of monuments dedicated to the memory of American Soldiers from all wars as a breach of faith and duty to our ancestors, and to the principles of freedom they fought to preserve and pass on to their descendants."

I want to emphasize that it is the policy of the SUVCW to honor American veterans, as defined by Federal (Public) Law, from ALL wars. Anyone who says otherwise is flat wrong.

Some Brothers have asked, "because the policy doesn't specifically mention Civil War monuments, are we are no longer defending our Civil War heritage?" I assure you that our great Order remains as fully dedicated as ever to preserving and teaching the true history of the Civil War. We aren't retreating on any front. We aren't bowing to political correctness. We have chosen the best strategy to fight to preserve our nation's history.

Far from abandoning support for monument preservation for any one era or side, we have expanded our reach to all American Veterans of all wars. That is clearly in line with our charge given to us in our Congressional Charter. Thus, the policy has more of a desired goal of helping to keep green the memories of all our veterans, the things they did, qualities they possessed, and what they stood for. It also combats "cancel-culture" right across the board, better than did the former policy.

If we decide to support legislation to protect monuments, <u>any monuments</u>, we are encouraged to do so by this policy! If we want to oppose the lawful attempts to remove monuments, <u>any monuments</u>, we are encouraged to do so by this policy! If we want to call for prosecution of criminals who maliciously destroy monuments, <u>any monuments</u>, we are encouraged to do so by this policy!

On a related topic, a number of Brothers have expressed their concern regarding the outside commentary in social media and other venues regarding this policy. To this, I would encourage you all to read the policy itself; you will see that such comments are uninformed and baseless.

Brothers, I hope you found this special message helpful in explaining the real background, intent, and impact of the National Policy on Monument Protection.

Thank you for all the great work you do to keep green the memory of the Boys in Blue! Every day you make me more and more proud to be a member of our great Order!

How to record monuments

Use a <u>form 61</u>. Don't let the five-page length confuse you! Only 2 ½ pages really need be filled out. Page two consists of sections depending on the type of monument. So, you don't need to fill out the cannon section unless it is a cannon. Also on that page is a box to record text in. If you have taken a bunch of photos of the monument or cannon and got some close ups of text, you can simply say *see photo* instead of writing a lot of text.

THE MAIN THING is to take a lot of photos of all sides and some close ups of the monument or cannon. Get a good location too, please. GPS is fantastic, cross streets are good. If in the middle of a cemetery and you don't know how to do GPS, can you find section and row numbers. All the information can be sent to wbusch@suvcwmo.org by e-mail, or Walt's google drive has been set up and all members have been sent a link that they can upload pictures or other files to it and not use e-mail. All photos and files can be separate. Walt compiles them into pdf documents.

ON THE SUBJECT OF CANNONS

There are markings all over them. Don't just take a general picture of it. We would like to identify the cannon and compare it to the national database of Civil War cannons. Markings are usually on the muzzle face, the left and right trunnions and the back

We had a lot of people come through as we discussed the Civil War and talked about our display, Ed had to leave before a photograph was taken



← On October 24th, Gary participated in the annual De je Vue also known as the Spirit Reunion. He portrayed Lt. Col. J. Felix St. James, our camp's namesake. It ran from 5 p.m. to 8 p.m. and there were lots of people who came by to hear Colonel St. James tell his story. He never sat

down during the whole time. There were over twenty different spirits present for the people walking around. The wool uniform felt really good.

Scott Reed, Bob Mueller, and Gary Scheel continue to work on researching Civil War veterans from Ste. Genevieve. An example is Corporal Theodule Lalumindier of Co. K, 10^{th} Missouri Cavalry Regiment. He was not on our list. Gary found him in his research; Bob found his obituary and his real name, Joseph Eusubie Theodule Lalumondiere, along with his short obituary in the Fair Play newspaper, where it states he died in Head of

Island, LA. Scott is trying to find his burial place. It is a team effort sometimes to learn what we can about Ste. Genevieve County men who served in the Civil War.

General James McPherson Camp #1 & Captain G.N. Spradling Camp #72

Camps Receive \$600 Grant from National SUVCW to Clean the GAR Monument in Judsonia, AR.



Our Arkansas Camps were approved for a grant from the National SUVCW Monuments Committee for cleaning and repairs to the GAR monument in a cemetery just outside Judsonia. As with many such monuments, it is surrounded by the graves of Civil War soldiers.

The camp needed to raise \$950 for the project and came up with \$250 of their own funds. The Department of Missouri kicked in \$100 from the Past Commander's Project Fund and National SUVCW provided the rest. Department SVC Joseph Rainey submitted the paperwork on this and gave it to our department monuments officer for review. Since our monuments officer is the national monuments officer (but not on the committee to approve funding), he is in a position to help our camps prepare the paperwork necessary for a successful grant from national.

The GAR Monument in Judsonia, Arkansas was erected in 1894 by the W.T. Sherman post no. 84. It is the oldest of the 3 GAR Monuments in Arkansas. Judsonia is 56 miles north east of Little Rock. At the dedication of the Monument the sheet covering the Monument was removed by Ethel Newman and Carly Kinney, daughters of Union Veterans, and Nell Young and Laura Hanson, daughters of Confederate Veterans. This seemed to indicate that the people of Judsonia had come to terms with the outcome of the war. The thirteen-foot-tall obelisk is topped by a stone cannonball. There are 16 post war graves of Union veterans around it.

On its east side is inscribed G.A.R. and a carved eagle resting on a sword and nine cannonballs on top of a five-pointed star. The east side faces the road and the town. The west side has a relief of two crossed flags and the inscription "IN MEMORY OF THE / DEFENDERS OF THE / UNION / 1861-1865". The south side is inscribed "ERECTED / BY / W.T. SHERMAN, / POST '70. 84. / 1894". The north side has a relief carving of two crossed swords and at the bottom the manufacturer's name, "MORRISS BROS. / MEMPHIS".

Brother Wesley Harris sent a picture of the monument to the Capt. G.N. Spradling camp and the General McPherson camp. The picture showed the monument in need of repair and cleaning. The General McPherson camp contracted with Brother Bruce Wright of the Livingston Hollow Corp. to do a survey of the monument. Brother Wright had worked many years with the National Park Service cleaning and repairing monuments all over the nation. He now lives in Eureka Springs, AR. and is working on a master's degree at the University of Arkansas. When Brother Wright did the survey, he had to clean off about ½ inch of biologicals to be able to do a proper survey. The cost of cleaning and repairing the monument came to \$950.

The McPherson and Spradling camps where able to raise \$250. The Dept. of Missouri donated \$100. A request of \$600 from the Civil War Memorial Fund was submitted to National and approved. Since the Monument was listed on the National Register of Historic Places, they were notified that we were cleaning the Monument according to National Park standards. We also notified the Dept. of Arkansas Heritage. Both were very supportive.

One Saturday Brothers Joe Rainey and Bruce Wright drove the 4 hours to Judsonia. We were joined there by Brothers Wesley Harris and Gary Glisson from the Spradling Camp. Saturday was spent cleaning the monument and the adjacent 16 post-war Union veteran grave stones. The next day was spent repairing the base of the monument, work that could not be done the same day as cleaning. After we cleaned the monument, we found very fine detail work not usually done. Brother Wright was very impressed with it. It was very unique. We were very glad that we cleaned off the biologicals as they would have eaten away, in time, the fine detail work.



Brother Bob Underdown Speaks at Bella Vista (AR) Civil War Roundtable

The December 3rd meeting was held in the American Legion Hall. This was their last meeting in the hall and now they have to find another venue. Masks were required and social distancing was enforced with a maximum of 40 attendees. Guest speaker, Bob Underdown, covered a very timely topic, *Christmas during the Civil War*. In addition to his talk, Bob had a display of Christmas-related memorabilia for American wars through the years, in addition to being dressed in period civilian attire.

Wreaths Across America

Each year the General McPherson Camp helps out with Wreaths Across America at the Fayetteville National Cemetery. The Camp then takes the wreaths that are left over and not used to the GAR cemetery in Sulphur Springs. This little cemetery has the graves of Civil War, WWI, WWII, Korea, Vietnam, and the First Gulf War. It also has the grave of Medal of Honor recipient Waldo Hatler. This year someone set aside 244 wreaths for us. We only needed 52 for the GAR Cemetery. Camp Commander Joe Rainey placed 92 wreaths at the Rogers Cemetery. Brothers Jim Spillers and Larry Nelson placed 99 wreaths in Washington and Benton Counties. Wreaths were placed on veterans' graves from the Revolutionary War, The War of 1812, The Black Hawk War of 1832 (which Lincoln was in), Civil War, Mexican War, WWI, WWII, Korea, Vietnam and the first Gulf War. We were also able to place a Wreath on Civil War Medal of Honor Recipient Samuel Johnsons grave in the little Baker Cemetery 16 miles Southwest of Fayetteville. Jim Spillers said "It is really humbling to see how many veterans buried out in these small rural cemeteries." To me it was a pleasant afternoon, placing the Wreath,







Pete Oetting got this request for identifying the pictured flag from the Missouri State Museum.



The following is a what the state museum housed in the state capitol told Pete about the flag "... one of the flags that is a potential candidate for conservation is a U.S. National guidon identified as the 1st Regiment Company B. Unfortunately, what type of regiment that was is a mystery to our staff. Therefore, we would appreciate it if someone from your group was willing to help us research it so that we can hopefully positively identify it. Here is what we know for sure:

The flag was presented to the Maj. Wm. McKinley Circle No. 18 (of St. Louis) by Mrs. Mary Mohrmann (of St. Louis) in April 1921. Mrs. Mohrmann was noted as the daughter of Captain Philip Frank of Company G 4th Missouri Cavalry. The flag had been in two fires since it became the property of the Maj. Wm. McKinley Circle No. 18 and before it was sent to the Missouri State Museum in 1935."

The Unionist editor had a suspicion, but wasn't sure of what it meant, but researched the several possibilities. Here is what followed. Suspicion #1: The flag is that of the 1st Missouri Infantry and that Mary Frank Mohrmann is somehow related to Francis or Henry Frank (see picture left). According to the records both of them served in the 1st Missouri Infantry. If there are not transcription errors, Francis served in Co. E and Henry served in Co. F.

Brigade Co, B. That could be her father and if so, the term "Captain" could be affectionate term as he was a naval man. This person was twenty -three, but since I can't find a reference to Mary Mohrmann's age, this could or couldn't be her father.

I then found this a reference to a 1st Lieutenant Phillip Frank who was in the 4th MO Cav Volunteers. So the information at the Museum is most likely correct that Mary was the daughter of a soldier in the 4th Mo Cavalry (and later 5th Mo Cav Co. B). But that still doesn't explain a flag from

the 1st Regiment Co. B, unless we go back to the theory of the likely relatives listed in the GAR search above.

While researching this, I finally went to ancestry.com and did a little research. I still couldn't definitely find a Mary Mohrman in Missouri with a father named Philipp Frank (I'm going with the German spelling). But I suddenly found this reference:

Here is the smoking gun! There was a Philipp Frank in the 1st Battalion USRC Missouri Cavalry and he was in Company B! While Dyer's Compendium of Civil War Units doesn't record any records for such a cavalry unit, the State Historical Society in Columbia, MO does have some documents from it. They apparently merged later with the 5th Missouri Cavalry. Henry Frank from the records of the GAR shown on the previous page was also in the 1st Regiment, but in a different company, so I suspect he was also a brother/relative of Philipp. Since all this is guessing right now as I can't find Mary Mohrmann or Philipp Frank in other records to verify it, if you can find out some information we will publish it and send it along to the State Museum. The Missouri State Museum is responsible for the stands of colors taken in various wars and turned in by Missouri troops. Repairing them can run into the 10s of thousands of dollars, due to the old method of storing them rolled up and sometimes in damp conditions. Efforts continue to preserve all of them and many are on display at the capitol compound.


