

Editor's Comments by Walt Busch, PDC

I just finished reading *Slavemaster President:The Double Career of James Polk* by William Dusinberre. Mostly the book concerned Polk's dealings before and during his Presidency as a slave master. Apparently, since he died shortly after leaving office, he didn't have time to sanitize his papers concerning his slave dealings (purchasing young slaves taken from mothers, separating families, punishing, etc.). The book is interesting detailed reading, similar to reading *The Peculiar Institution* by Kenneth M. Stampp, but on family level. This leads me to the point that I always admired Polk as President because he said he would do 4 things prior to leaving office and did them. He promised to place the US-Canada Boundary above the Columbia River, gain California (and Texas) from Mexico, reduce tariffs, and institute an independent treasury. Unfortunately, the book very definitely and strongly taints my image of him as at least three of these are tied to slavery.

If you ask anyone what is the first war Americans fought over slavery, most Americans would answer "the Civil War." Wrong answer. Americans (Texans and Davy Crocket) fought Mexico to be free of Mexico's law against slavery. Slavery increased five-fold in Texas after that war. In 1846, Polk wanted to extend slavery to all of the southwest and also planned to take more land in what is now northern Mexico. He didn't get everything that he wanted because his ambassador went against his orders and made peace with Mexico. Polk then refused to pay the ambassador's salary. Polk hoped to extend slavery across the southwest including southern California. The Oregon question was a plan to divert attention to all the slave lands under the Missouri Compromise that were being acquired and the tariff was increasing the price of British imports (the South's trading partner), and forcing them to buy northern goods.

Polk succeeded in all keeping all his promises in 4 years and left office, dying in 1849 of cholera. His vision of Manifest Destiny for America was a vision of Manifest Slavery. The book has clearly changed the image of this President that I previously had. It was also during Polk's presidency that talk of seceding started if slavery was not allowed to extend to the Pacific. While the book probably would be boring to most readers, those interested in a President's handling of slaves during his life time and slavery on a personal level should find it most interesting.

By the way, Polk had no intention of freeing his slaves after his death. He bought them to provide a good income in retirement for his wife and him. If the Civil War didn't happen, many of his slaves would never have seen freedom as his wife lived into the 1890s.

James Sylvester Cunningham May 4, 1925 — May 14, 2020

James Sylvester Cunningham, 95, of Columbia passed away May 14, 2020, at Columbia Post Acute. James was born May 4, 1925 near Ashland, the son of James W. and Cordelia Taylor Cunningham. He graduated from Ashland High School in 1943.

He served in the U.S. Navy during World War II serving on the USS Uvalde in the Pacific Theater and being awarded the Combat Action Ribbon, Philippine Liberation Medal and two Battle Stars. He was called back to service during the Korean War and was assigned to the Seabees (MCB-6). He was discharged at Brooklyn Navy Yard in August 1952 as a Chief Petty Officer.

He married Alva Jane Sappington in Ashland on Aug. 9, 1947. He was survived by his wife, Alva, of the home; granddaughter, Vivaca, and her husband, Chet Crowser, and three great-grandchildren, Arden, Nora and Holden Crowser, all of Missoula, Montana; and many nieces and nephews. He was preceded in death by his daughter, Laurel Jane Cunningham Fuemmeler, and five brothers, Robert, Harold, Hartley, Lewis and twin John.

James retired from MFA Oil Company in 1990 as Secretary-Treasurer after 43 years of service. He was a member of various Masonic organizations, Twilight Lodge #114, York Rite, Tiger Shrine, Moolah Shrine, Eastern Star, KYCH and others. He was also a Life Member of the American Legion, VFW, Seabees of America, AMVETS and 40 & 8.

Other memberships include IOOF, Knights of Pythias, Sons of Confederate Veterans, Sons of Union Veterans -

Alan Wayne Heidbreder (1946-2020)

Alan Wayne Heidbreder, age 73, of Columbia, passed away on May 16, 2020 at Boone Hospital in Columbia.

Alan was born near Russellville, the son of Guilford Heidbreder and Edna (Rockelman) Heidbreder, both of whom preceded him in death. On June 14, 1969, Alan was united in marriage to Rosalyn Duvall, who survives. Along with his wife, Alan is survived by numerous nieces, nephews, cousins, and a special Godchild.

He graduated from Russellville High School in 1964. After high school, Alan went to Lincoln University and graduated in 1969. He was also

preceded in death by one brother, Carl Heidbreder. He served in the U.S. Army from September 1969 to August 1971. He was an accountant at MFA Inc, Columbia Office Supply, Woodhaven and OATS.

Alan was a member of St. Andrew's Lutheran Church in Columbia and served as the church treasurer for many years. He was a member of the American Legion Post 202 in Columbia and was a member and officer with the Columbia Tiger Camp, Sons of the Union Veterans of the Civil War. Alan volunteered and took his flight with the Central Missouri Honor Flight. He was an active member of Central Missouri Wood Carvers and volunteered at the Columbia Senior Activity Center. He loved to travel and collect Native American artifacts. His family fondly remembers his love of antiquing.

Per the CDC recommendations, social distancing recommendations were observed. The visitation was held from noon to 3 p.m. on Wednesday, May 20 at Windmill Ridge Funeral Service, with the service following at 3 p.m. with Rev. Earl Fuller officiating. Interment was at the Sappington Community Chapel Cemetery with full military honors.

NO FLAG IN CHURCH? -- The below 1925 report from a member of GAR Ransom Post 131 indicates that they had an issue with Holy Cross Lutheran Church allowing a flag draped coffin inside the church. The German congregation, a founding member of the Lutheran Church – Missouri Synod, would never have allowed any flag (including the Christian flag) in their church prior to World War I. During WWI, the concern that they weren't patriotic enough changed some congregations' opinions of having a flag up front, but apparently not Holy Cross. It was clearly a case of "render unto Caesar the things that are Caesar's, and God the things that are God's." The soul belongs to God and the body, rising on Judgement Day, belongs to him too. Hence, no flag!

There is no comment about whether they were successful in bringing in the flag draped coffin. But reading between the lines, it seems the pastor protested, but in the end allowed it. Now just wait until the *Unionist* editor has a chance to explain corporate (public) prayer and why true Christians shouldn't participate in it!

Born 11 October, 1943 in Hermann, Gasconade County, Missouri, passed18 June 2020 St. Louis County, Missouri (age 76). His parents were Leslie Michael and Stella Selma (Schaumburg) Von Behren. Larry had one sister Shirley Emma (Von Behren) Oberg (Curtis Wayne). Larry was christened at Swiss Evangelical Reform Church in Swiss, Gasconade County, Missouri, attended church in Hermann, at the St. Paul Evangelical Church, was confirmed there.

Larry's grade school is now a museum, "Historic Hermann Museum". He began his freshman year at Hermann High School. In 1958 his family relocated to St. Louis City, Missouri. Larry finished high school at Cleveland High School. While in high school he was on the tract team as a pole vaulter and was a coach to several ladies soccer teams. Larry then went on to attend

St. Louis Community College and Washington University.

Attending Trinity Evangelical & Reform Church, which became a United Church of Christ, he attended Sunday School and sang in the choir, where he met and married Nancy Carolyn Terry on 14 October 1961 years. They later belonged to St. Lucas United Church of Christ.

During high school he worked at Calamon Shoe Company and worked for a neighbor manufacturing parts. After high school he started work at Anheuser-Busch; first in Traffic Department, then to Bakery Products, and to the Computer Area where he was a Burster Boy, main frame operator, shift supervisor, supervisor, and manager, retiring after 40 years in 2000. Through the years Larry played softball at Anheuser Busch and on several other teams, played golf, love to hunt and fish, and took many vacations with family camping, hiking enjoying the outdoors, scuba diving. Loving to photograph his travels and especially nature close ups.

Larry and Nancy have a son, David Edmund Von Behren, wife Linda Marie (Rohan) David's children are, KaDee Marie Rosner (Elmer William (Billy) Rosner III), Kourtney Ellen Von Behren, KC Mitchell Von Behren, and Madison Rae Holliday, and a great grandson Elmer William (Will) Rosner IV.

Larry farmed on both his parent's farm and after Nancy's father passed, managed and farmed their farm. When his dad, Leslie, passed they purchased the farm from his stepmother, Margie. When Nancy's mother, Garnett passed, they became owners of two farms, one in Danby, MO and one in Rhineland, MO. In 1999 they sold the farm in Jefferson and Ste. Genevieve County.

Larry traced his Von Behren family line back to 1590, to his 8th Great Grandfather, living at Nordhemmern, Westphalen, Prussia, Germany. His Schaumburg family line traces to his 5th Great Grandfather in Vollmarshausen, Kassel, Hesse, Germany. His 2nd Great Grandfather was sent to America in the Hessian Army under General Ralls in the American Revolution and was at the Battle of Trenton. He returned to Hesse, but most of his children came to America. Larry thought himself to be 100% German until he found Great Grandfather Michael Wettling was born in Soultz-sous-Forets, Alsace, Bias-Rhine, France. Great Grandmother Mary Jane (Fenton) Hale/ Wettling was born in Tremont, Clark County, Ohio, her family goes back to his 3rd Great Grandfather William Fenton born in Ireland and her maternal side goes back to a 6th Great Grandfather, Johann Georg Pence or Bentz from Virginia. Also there is a 2nd Great Grandfather Heinrich Ulrich Hoffer (Hofer) born in Canton Aargau, Switzerland.

Larry took up playing the harmonica, guitar, banjo, and ukulele, joining the St. Louis Banjo Club at the Turners Hall and the belonging to the SLUG as a lifetime member. He was a member of the St. Louis Camera Club, giving many programs and heading the Mississippi Valley Salon for 2 years. Larry was able to hang a photo at the Sheldon for the St. Louis Camera Club 100 Years exhibition. Larry was a member of Missouri Nature and Environmental Photographers and gave programs for them. Larry was a member of the German- St. Louis Research Group; St. Louis Genealogical Society; the old German Genealogy Special Interest Group; Civil War Museum; Bosque de Apache Wildlife Refuge; Gateway Metal Detecting Club; Gasconade Historical Society; and, US Grant #68 Sons of Union Veterans of the CivilWar, though his Great Grandfather Michael Wettling.

Larry was buried at Swiss Evangelical Cemetery, Swiss, Gasconade County, MO. Memorials may be made to Swiss Evangelical Reformed Cemetery, American Cancer Socity. C/O Toedtmann & Grosse Funeral Home.

Collector's Corner

Several years ago, while at a Civil War show, I ran into this unusual relic of the Civil War. It is a Union officer's sword which was mounted on a rubberized canvas. It had at one time adorned the wall of a G.A.R. post. This is that story.

<u>**The Post Relic Sword:</u>** Andrew William Drips was born in 1826, in Pennsylvania. At an early age he was apprenticed and learned the skill of printing. Andrew Drips married Margaret Ann Jacobs March 21, 1850. They soon moved west and by 1853, had settled in Garnaville, Iowa. He became a copyist in the county records office. He soon after became a postmaster and worked as publisher for the Clayton County Herold. He sold the paper and moved to Maquoketa, Iowa, where he purchased an interest in the local paper, Maquoketa Excelsior.</u>

Upon Lincoln's call for 300,000 volunteers to protect Washington, in 1861, Andrew Drips organized a company of infantry at Dubuque, Iowa. He was elected Captain and the company was accepted into federal service, September 24, 1861, as Company A, 9th Iowa Infantry. The company was sent to St. Louis, Mo., in October and performed picket duty at Pacific, Mo. February 1862, the 9th Iowa was sent to Southwest Missouri. On March 6-8, 1862, the 9th participated in the Battle of Pea Ridge. It was here on 7 March 1862, while leading his men, that Captain Andrew Drips was shot on his right side and killed. His effects were sent to his wife. Margaret Drips would later remarry and became Margaret Ann Knight.



On the 25th anniversary of his death, his wife presented his officer's sword in a public ceremony to A. W. Drips, Grand Army Post No. 74. This post had been chartered April 21, 1882, in Maquoketa, Iowa. There were 68 charter members. The post survived until February 19, 1930, when it was dissolved and its contents dispersed. On the day Captain Drips sword was presented to Post 74, another sword was also presented. It belonged to Captain Kelsey. What became of this sword is a mystery.


Commander Hunnewell's Initial Message

When I joined the Sons of Union Veterans, I wasn't sure what to expect. I came home after my first Fletcher Camp meeting and I told Die Frau [the wife], "They want me in a uniform." I had no great desire to wear a Civil War soldier's uniform, but I am happy as a member of the SVR to do so now.

I went to my first department meeting soon after. I understand that there are a lot of people who don't feel it's important to be involved at the department level, but many of us come from different backgrounds and experiences. Adding new people can bring new perspectives and ideas. Encourage people to attend. Carpool. As we come up to our 2021 National Encampment, it will be even more important to connect our Department with Camps.

Making a lot of pies can get you thinking, and I was thinking of how Fraternity, Charity, and Loyalty play out in our organization.

What makes a successful work team and a successful camp is a level of Fraternity. We call each other brothers and we need to act like it. PCC Mark Coplin has started a process in his camp to match members who are active and attend camp meetings with those who cannot for various reasons. We find that some members have been dead for many months before we know of it. Consider doing this at your own camp. The more we stay connected, the more we learn about each other, the more we treat people like family (brothers) and less like "members." And by connecting with people personally, I think we have the opportunity to retain brothers in our camps.



As for Charity, I will ask that you give me a good dose of that. I am

still learning the ropes. When I became JVC, I didn't know "how things worked" – that this was a step up to leadership. If you find that I've forgotten something or missed something, approach me. I'd rather hear from you then second-hand from someone else. Some of you will be better at pointing out my mistakes than others. That's OK. Also, cut some slack to your brothers. Martin Luther in his explanation to the eighth commandment says, "We should fear and love God so that we do not tell lies about our neighbor, betray him, slander him, or hurt his reputation, but defend him, speak well of him, and explain everything in the kindest way." Easier said than done, even for Luther, even for us.

Every generation questions authority and the same happens today. Our ancestors fought for an ideal: to uphold the Constitution and maintain the Union. Our loyalty should continue in that vein. Loyalty to county and loyalty to each other.

In a year's time, we'll be meeting just before our National Encampment. This isn't a **St. Louis** Encampment, it's a **Missouri and Arkansas** encampment. I am always impressed (but not surprised) that when the encampment is held in some department's state and 40 guys stand-up for that department. I would like to see that next year for Missouri and Arkansas. We have enjoyable events planned but they won't come off without help. We will need volunteers to man various positions but, even if you cannot volunteer your time, you can attend. At the National Encampment, you are a part of a chain of tradition that goes back to the late 1800s, using many of the same rituals that harken back to the Grand Army of the Republic. It is a good feeling to know that you are keeping a worthwhile tradition alive.

I want to strengthen our ties with the Daughters of the Civil War 1861-1865. I would like to see a day where no Camp or Tent decides to take part in a public even without involving the other side. We have the same purpose. We are a part of the Allied Orders. We should act like it.

My plans are to visit Camps this year. My calendar fills up pretty quickly due to commitments that I have with other organizations. I will try to make things work.

Our JROTC/ROTC program was curtailed this year. I am hoping that we reach some normalcy next year, so we can present awards statewide.

I think it's important to continue the work of PDC Crandell with the placarding of the GARs encampments in Kansas City and St. Louis, as well the work of honoring Medal of Honor recipients, who are interred in Missouri.

I applaud all camps that are taking an active role in their communities either by grave markings, grave registrations, parades, encampments, public speaking, school visits, among other things. It is important that we let people (especially the press) know that the Sons of Union Veterans of the Civil War is **not** a re-enacting group but a fraternal organization.

I want to thank everyone that has helped me on this journey. It is good to be among brothers who share the same passion to honor not just our ancestors but what they fought for.

Scenes from the Northfield MN bank, scene of the James Gang Bank Robbery, in which 3/4ths of the gang were either captured or killed by townfolk and farmers.



The inside of the bank with the exterior safe door shown open. It was unlocked and so was the safe door inside it, but a bank employee bravely made the robbers believe that the safe was locked and he didn't have a key. The employee later lost his life in the robbery.

All the Younger brothers were captured and/or injured in this robbery and all ended up in prison in Minnesota. Three other bank members were killed either during the robbery or later by a 1000 man posse. The only two people to get away from this robbery were Frank and Jesse James. The gunbelt of Cole Younger. With so many gang members captured in town, their artifacts were stripped from them as souvenirs and many have ended up in the bank in care of the Northfield Historical Society.

This U.S. Army button was worn on General Ulysses S. Grant's uniform during the Civil War and was later donated to the park by Grant family descendants. A federal eagle on the front grasps arrows and an olive branch symbolizing war and peace. The reverse is stamped "SUPERFINE GOLD PLATE - W.B. CO". W.B. Co. stands for Waterbury Button Company, which produced the most widely used officer's buttons in the Union, and is the only Civil War button producer still operating today.

CAMP PURCHASES CIVIL WAR LETTER FOR DONATION TO WIL-SON'S CREEK

Camp members voted to purchase an original Civil War letter with a unique story.

The museum collection at Wilson's Creek National Battlefield contains a number of artifacts associated with Benjamin Fullagar, a member of Companies A and K, 3rd Wisconsin Cavalry. Fullagar was born in London, England in 1835 and died in Penn Yan, New York in 1919. The Fullagar Collection includes a number of documents, his campaign desk, and other artifacts.

The 3rd Wisconsin saw extensive service in the Trans-Mississippi Theater during the Civil War. The regiment left Wisconsin in March 1862 and moved to St. Louis. From there, the Badgers traveled to Fort Leavenworth, where they were mounted. The regiment's Second Battalion arrived at Fort Scott that June. The 3rd took part in the battles of Cane Hill and Prairie Grove. Arkansas in 1862, and Honey Springs, Indian Territory and the Baxter Springs (KS) Massacre in 1863. The regiment is probably best known for its actions against Confederate guerrillas in Missouri, as it fought a vicious hit-and-run war against those wily opponents.

When a well-known Civil War collectibles dealer announced that he had a letter written by Fullagar for sale, camp members quickly voted to purchase it and donate it to Wilson's Creek to help add yet another piece to this special collection.

A formal presentation of the letter to the NPS will take place this fall after the Visitor Center renovations are completed and the museum collection returns from storage in Kansas City.

Fullagar, in Milo. Those present were Miss Mabel I. Fullagar, their daughter; Howard S. Fullagar and wife and four children; the son, Edwin G. Fullagar, and wife and four children; the son, Lloyd B. Fullagar and wife and three children; Rev. Nevin D. and Mrs. Bartholomew, of Penn Yan, and Miss Sarah Scott, of Penn Yan, a friend of the family.

Mr. and Mrs. Fullagar were married near Emerald Grove, Wis., on March 20, 1867, and immediately thereafter came to the farm in Milo now occupied by Ed-win'G. Fullagar. They lived there near-ly forty years and then moved to their present home nearer the village. The husband was born in London, Eng., on August 12, 1835, the son of Samuel and Sarah Fullagar. He came to this country with his parents, who set-tled in the town of Benton in 1841. In 1861, he enlisted in the Third Wisconsin Cavalry, served with distinction through-

Cavalry, served with distinction through out the war and was mustered out a cap tain

He, with Captain Morris F. Sheppard and Captain Reuben A. Scofield are the only surviving commissioned officers of the Civil war living in this neighborhood. For many years Captain Fullagar has been regarded as one of the county's lead-ing altimate of the county's lead-

been regarded as one of the county's lead-ing citizens and most successful farmers. The farms owned by him and his sons are among the largest and most produc-tive in the county. Samuel Fullagar, the father, lived here for more than sixty years and died in 1903 at the advanced age of 01 years. Mrs. Fullagar, also was born in Lon-don, England, on March 20, 1844, coming to America with her father, S. J. Cuch-ow, in 1850, and settling in Wisconsin. She has long been noted for her woman-ly efficiency and for the steadfastness and sympathy of her character. Besides being a wedding anniversary the gathering celebrated the birthday of Mrs. Fullagar, and her daughter, Mabel.

Since today is Decoration Day, I composed a biography of Captain John Matthews and his company's participation in the Battle of Springfield. I placed a printout in a plastic sleeve and attached it to a synthetic flower arrangement and then put it alongside Captain Matthews's tombstone in the Springfield National Cemetery.

"JOHN MATTHEWS, an antebellum Springfield resident, was a steadying influence during the BATTLE OF SPRINGFIELD, January 8, 1863. About 1 p.m., he and his company of 20 convalescing soldiers and 20 Springfield citizens obtained muskets and

ammunition at the Methodist Church arsenal (modern-day Walnut and South Street) and minutes later were on their way to an assigned position (modern-day National at Cherry) where they bluffed 300 Confederate cavalrymen into inactivity for most of the afternoon. Matthews and his company hurried to reinforce 20 Union cavalrymen defending Fort Number 5 (modern-day Sherman at St. Louis), repulsed an attack there and saved the Union east flank until the close of the battle. Thank you for your service."

This is a relatively inexpensive way to honor a Civil War veteran and it gives readers a chance to take a mini tour of the Battle of Springfield's east flank. I hope this inspires future biographies on Decoration Day. ------ John Rutherford, PDC – Phelps Camp.






