The Thomas M. Goodman Grave Marker at Jefferson Barracks National Cemetery, Jefferson City, MO: A Necessary Name Correction

The date of death corresponds to that of the American Civil War event known as the Centralia Massacre. The soldiers who died there and who could be identified are all buried closely adjacent to the Goodman Site.

Sgt. Thomas M. Goodman who was serving with

the 1st Missouri Engineers at the time was in fact a notable survivor of the Centralia Massacre and described his experience immediately afterwards in a newspaper interview and also in his memoir published in 1868. In about 1873 Goodman and his family removed from their home in Hawleyville, IA to Santa Rosa, CA. He died there in 1886 and is buried in the Santa Rosa Rural Cemetery.

Incontrovertibly the grave at Section 45, Site 1642 at Jefferson Barracks National Cemetery, Missouri does not bear the remains of Sgt. Thomas M. Goodman, 1st Missouri Engineers who bore witness to the Centralia Massacre on September 27, 1864; the marker is erroneously inscribed with his name.

This narrative describes and analyses the evidence that has been accumulated to show, essentially beyond doubt, that the grave marker at Section 45, Site 1642 at Jefferson Barracks National Cemetery, Missouri should instead bear the name of Valentine T. Peters, SGT 1st Missouri Engineers who was killed at the Centralia Massacre on September 27, 1864.

1. Background

The Centralia Massacre ("the Massacre") was an incident during the American Civil War in which unarmed Union soldiers were captured and executed at Centralia, Missouri on the morning of September 27, 1864 by the pro-Confederate guerrilla leader William T. Anderson.

To distinguish the events in Centralia itself from those during the same afternoon outside the town, the guerrilla actions that occurred in town that morning are usually referred to as "the Massacre," while the contest between the guerrillas and Major Johnston's command southeast of Centralia during the afternoon is called the "Battle". The Centralia Monument at Jefferson City National Cemetery commemorates only the members of Companies A, G and H of the 39th Regiment of the Missouri Volunteer Infantry commanded by Major Johnston who were killed in action near Centralia on Sept. 27, 1864, i.e. the Battle in the afternoon. Since a large majority of the infantry regiment died that day it is often confusingly referred to as the "Centralia Massacre".

Historical accounts of the Massacre - including those written in the days following September 27, 1864, as well as those written years later - contain many inconsistencies and contradictions. Many details of what happened that day can be disputed from the myriad of historical evidence available (1).

Contemporary military reports stated that the soldiers murdered at the Massacre were 20 (2) to 21 (3, 4) in number. A recently compiled list of those killed provides the names and some biographical detail of 19 of the 21 soldiers killed (5).

2. Sgt. Thomas M. Goodman, 1st Missouri Engineers The Thomas M. Goodman Marker at Jefferson Barracks National Cemetery

The grave marker at Section 45, Site 1642, Jefferson Barracks National Cemetery, Missouri bears the inscription "*Goodman, Thomas M, d. 09/27/1864, US Army, SGT*"; the date of death corresponds to the date of the Massacre. Nine soldiers who died on that occasion are buried near the Goodman plot; e.g. ARNOLD, J. K. is buried at Section 45 Site 1664, BROWN, William R. is buried at Section 45 Site 1621 and CARPENTER, C. G. is buried at Section 45 Site 1666. Therefore it is inarguable that this is the apparent gravesite of Sgt. Thomas M. Goodman who served in Company C of the 1st Missouri Engineers at the time of his apparent death at the Massacre.

Thomas M. Goodman Misidentified as Victim of the Massacre

Thomas M. Goodman was incorrectly reported killed at the Massacre as mentioned in his own account to a newspaper shortly after the event when in transit to his place of residence in Hawleyville, IA (6). Mention of that fact is also made in his memoir published in 1868 (7).

The misinformation seems to have originated from another newspaper story five days after the Massacre, which reported that one Thomas Goodwin was one of the murdered soldiers (8). No record of a Thomas Goodwin is found on the 1st Missouri Engineers Regimental roster (9). It is therefore reasonable to infer that a soldier's body was misidentified as that of Thomas M. Goodman and that the aforementioned newspaper account either misreported his name or the identifier of the body provided the misspelled last name. The same newspaper story also reported that "Serg't Claib Thompson" was one of the victims and this is similar misinformation because

Claiborne Thompson of the 1st Missouri Engineers was a Private in that Regiment and mustered out on March 26, 1865 (10).

It is also reasonable to infer that the misidentification of a body as that of Goodman occurred at least partly because he was missing immediately after the Massacre; as described by Goodman he was taken hostage by Anderson (6, 7). The report by Chas. H. Lathrop, Surgeon 1st Iowa Cavalry the day after the Massacre (11) documents the body of an unnamed Sergeant and, based on the newspaper account (8), it can be concluded that it was subsequently identified as that of Thomas Goodwin i.e. Thomas M. Goodman.

It is probable that it is the newspaper's error in reporting Goodman's name as Goodwin because the further newspaper item 12 days later **(6)** that tells of Goodman's experience as a hostage of Anderson's guerillas makes it clear that Goodman had been reported murdered at the massacre. Corroboratively, Goodman's correct name and rank were ultimately inscribed on the marker on the grave at Section 45, Site 1642 at Jefferson Barracks National Cemetery, Missouri.

Since there was only one soldier (Sgt. Valentine T. Peters) among the victims with the rank of Sergeant (5) it therefore appears likely that Goodman's name was ascribed, by a person unknown, to the body of the Sergeant, 1st Missouri Engineers documented in Lathrop's report with no name identification at all or at least one that was not verifiable.

Thomas M. Goodman a Survivor of the Massacre is buried in Santa Rosa, CA

It is certain that Sgt. Thomas M. Goodman, 1st Missouri Engineers survived the Centralia Massacre. In about 1873 he and his family removed from their home in Hawleyville, IA to Santa Rosa, CA. He died there on February 5, 1886 and was buried in Plot 52 of the Eastern Half Circle of the Santa Rosa, CA Rural Cemetery. His is a notable grave in that cemetery (12, 13) and has a Standard Government Headstone. That the Thomas M. Goodman buried in that grave in Santa Rosa, CA is the same Thomas M. Goodman who survived the Massacre is confirmed by a) observing the continuity of vital information relevant to him and his family in the 1860, 1870 and 1880 U.S. Federal Census records (14, 15, 16) b) The mention in 1882 of his then residency in California made by Switzler in his account of the Massacre and Battle (17) and c) the history of his regiment published in 1889 records Goodman's survival of the Massacre although it erroneously states the date of the Massacre (Oct 1864) and the date (1887) and place of his death as Santa Barbara, CA (18).

3. Sgt Valentine T. Peters, 1st Missouri Engineers

Short Account of his Life and Military Service

Valentine T. Peters was born in Indiana about 1840 (19, 20). His father died when he was 2 years old. On July 05, 1857 Valentine Peters married Evaretta (later known as Avarilla) Schooler in Holt County, MO. On August 21, 1861 when mustered into Company H of the 25th Regiment of

Volunteers (which later became the 1st Missouri Engineers) he resided in Whig Valley, Holt Co. MO (22).

On September 14, 1864 he was discharged at the expiration of his service as shown on his regimental service record card (21). His rank/unit was Sergeant, Company M, 1st Missouri Engineers. He was returning home to his wife and two young daughters at the time of his death at the Massacre on September 27, 1864.

No burial record could be found for Sgt Valentine T. Peters using the National Cemetery Association grave locator website http://gravelocator.cem.va.gov/index.html and additional searches of genealogical data available at www.Ancestry.com did not produce any burial record for him.

Peters' death at the Massacre is documented in the Regimental Roster (22) and in Goodman's memoir (23) where his heroic struggle is described; "One brave man, Sergeant Peters, made a desperate struggle for his life, and succeeded in felling a number of his assailants, and obtaining a temporary respite beneath the station-office. It was fired at once, and finally by force of circumstances alone the fiends succeeded in killing their victim" Contemporary and latter day accounts of the Massacre also document his demise in even more graphic detail (24).

Peters' death is also documented in the recently compiled list of 21 victims (5). It includes two soldiers described as "unknown". The finite possibility that one of these could be a Sergeant and/or possibly buried in the "Goodman grave" at Jefferson Barracks National Cemetery was eliminated by identifying those two soldiers. They are;

a) **Lewis Thompson,** Artificer, Company L, 1st Missouri Engineers who was mustered in on July 15, 1863 **(25)**. He died 9/27/1864 and is buried at Jefferson Barracks National Cemetery at Section 45, Site 1641. Interestingly this is next to the "Goodman" Site in the "Centralia" Section. His is assuredly the body identified by Surgeon Lathrop as "--- *Thomson, 1st Engineers, on furlough*" **(11)**. It seems possible that his body could have been confused initially with that of *Claiborne Thompson* who had been reported killed at the Massacre **(8)**.

Lewis Thompson is *not* listed on the regimental roster (9) which probably has contributed to his "*unknown*" status on the compilation of soldiers killed at the Massacre (5).


b) William R. Brown, Rank unknown, Unit unknown. He, as mentioned in Section 2 of this narrative, is buried at Jefferson Barracks National Cemetery at Section 45, Site 1621. His body was identified in Lathrop's documentation of soldiers killed at the Massacre (11). There can be little doubt that it is his killing that was described by an eyewitness;

"There was a sick soldier on the train who had been in a St. Louis hospital and his father was bringing him home. He was taken from his father, put in line and shot down." (26).

Why was the body of Sgt. Valentine T. Peters not identified after the Massacre?

It cannot be known with certainty why Peters' body was not identified. However the historical record offers some clues;

- i. Lathrop reported that "Many of them were horribly mutilated; in some instances the clothing and skin were "powder burned," showing that the weapons of the murderers when discharged were but a short distance from their unhappy victims. There is scarcely a body that did not receive more than one wound, and some four or five." (11). In light of the especially brutal manner in which Peters died (22 & 23) it is not unexpected that identification of his body the day after the Massacre would have been a forensic challenge.
- ii. It appears that at least some of the soldiers killed at the Massacre were not dressed in their uniforms because "The rebels confiscated all of their clothes that they wanted and then lined them up outside to be shot." (27).
- Peters apparently had removed at least some of his uniform in order to avoid detection by Anderson's guerillas because the following excerpt from an eyewitness report closely matches the description of the manner in which he is known to have died (22 & 23); "One fine looking young man, a surgeon [i.e., a sergeant] in some company, stripped off his uniform to put on citizens clothes, but he did not have time to make the change and



was marshaled out with the rest. He did not fall in the first fire but broke and ran towards the engine where I was standing at the time looking on and it was hard telling which they were shooting at, the soldier or me, for a second the bullets were plowing the ground up all round me. He turned and went between the engine and the baggage car and crawled under the depot, but the depot was all on fire so he could not stay under there. He came out on the other side of the depot and they caught him again and brought him around and shot him down where he started from with the rest. "(26)

That this indeed occurred is corroborated by another account by eyewitness Reuben Russell who "...said that two soldiers stripped off their uniforms while still on the train, but were caught before they could don civilian clothes." (28).

In summary it is apparent that the body identified by Lathrop as that of a

Sergeant, 1st Missouri Engineers had nothing associated with it such as documentation or clothing initials/name to enable identification. In regard to Sergeant Peters this is not surprising.

Conclusion

The grave marker at Section 45, Site 1642 at Jefferson Barracks National Cemetery bears the inscription "*Goodman, Thomas M, d. 09/27/1864, US Army, SGT*". In this section of the cemetery are buried those victims of the Centralia Massacre on 9/27/1864 who could be identified at the time.

The historical facts presented in this narrative preclude any possibility that Thomas M. Goodman, Sgt., 1st Missouri Engineers, who was a witness to the Massacre, is buried there and the marker is therefore incorrect.

Twenty-one unarmed soldiers, taken as a group from a train by William T. Anderson's guerillas, were killed at the Massacre and the identities of all have now been ascertained. Sgt. Peters was one of them and was the only Sergeant in the unfortunate group. The U.S. Army Surgeon who examined and identified some of their bodies on the day after the Massacre recorded that one of them was that of a Sergeant, 1st Missouri Engineers but was unable to ascribe a name. Shortly after the Massacre Sgt. Goodman was reported by a newspaper to have been one of those murdered at the Massacre.

It is abundantly evident that the body of the Sergeant of the 1st Missouri Engineers, of identity unknown to the Surgeon who examined it, was mistakenly identified as that of Sgt. Thomas M. Goodman, 1st Missouri Engineers by a person unknown; it was in fact that of Sgt. Valentine T. Peters of the same regimental unit.

There can be no doubt that the plot at Section 45, Site 1642 is the grave of Sgt. Valentine T. Peters, Sgt., 1st Missouri Engineers and the marker should be amended accordingly.

Collector's Corner

Grave Markers/Flag Holders part 2

The Grand Army of the Republic, for many years decorated the graves of deceased comrades with iron, brass and bronze flag holders/grave markers. When a Post went out of existence, the items of that post were sometimes divided among the remaining veterans or were sold. The grave markers were sometimes recycled into an assortment of items including plaques. This was done by removing the knobs in the back and then drilling holes through the marker. Below are four markers which were at one time attached to a board. They were cleaned of rust and painted. Included is a grave/flag holder for the Ladies of the GAR Circle 120.





These star shaped markers were recovered many years ago by a collector who painstakingly removed the rust and painted them black. The raised areas were painted gold and silver. A close examination still reveals how pitted and rusted they once were. A small hole was drilled at the top point of the star for attachment to a board.

Companies used the "star" pattern in a variety of ways and marketed them to individuals within the Post. Many of these grave marker/flag holders have survived as desk ornaments. Some were purchased by the Post and displayed in their halls. Many individual members purchased these items as desk ornaments or for display in the parlor of

their homes. Below are two examples of desk ornaments.



The desk ornament on the left is almost 9 inches tall. It is a generic piece with GAR and 1861-1865 in the middle of two circles. The arms of the star have the branches of service and the trefoils have a raised star. The star is held to a thin tin base by a brass rod. The base rest on small cannon balls. These cannon balls are used as the legs. On the back of the star is the maker's name, Trenton Emblem Co., Trenton, N. J.

The last desk ornament is 10 inches tall and was also

made by the Trenton Emblem Co. of Trenton, N. J. The star has the GAR letters with an addition of Post 19. The star is attached to a polished

granite base. This desk display came out of Missouri Post 19. This post was the Phil Kearney Post and was located in Laclede, Missouri.






William Anderson Pile (February 11, 1829 – July 7, 1889) was a nineteenth-century politician and Methodist Episcopal minister from Missouri. After the war he was Governor of New Mexico Territory and a Missouri Representative in Congress. He was one half Native American (from his mother), most likely Choctaw.

He was the general in Missouri responsible for the recruiting of U.S. Colored Troops. Like many Union officers in Missouri by that time in the war, he was not particularly concerned with the politics of the owners of slaves as long as the slaves wanted to enlist. He ended his duty with the brevet major general rank.





THE INSTRUCE GUITTON.



The Old Soldier's Home

With the ending of the Civil War, Union veterans returned home to their farms, shops, or other vocations. Many returned to their families and began to rebuild their lives. For others, it was time to start a family. All were not so fortunate. Many of America's soldiers went home having lost one or more limbs, been blinded, or had their mental and physical health wrecked by war, disease and exposure. They would need long term health care. The war would have a profound effect on health care for veterans.

The concept of veteran's care was not new. In 1811, the United States Naval Home was approved but did not open until 1834 in Philadelphia. Later it was opened to veterans of the other branches of the military. The first Army national old soldier's home was opened in 1851. Gen Winfield Scott founded the Soldier's Home in Washington, D.C. and, another in Harrodsburg, KY. They were partially funded by the sale of tobacco captured in the Mexican war. When the Civil War broke out, it was estimated that America had 80,000 veterans from previous conflicts scattered around at a handful of veterans homes around the nation.

The Civil War added over 1.9 million soldiers and sailors to the roles. Benefits were restricted to those who fought on the Union side. Confederates were not legally recognized as veterans until 1958 when Congress pardoned them.

Lincoln made frequent visits to the hospitals and was shocked by the overcrowded conditions and number of casualties. He saw

the growing need for long term care that many veterans would require. He addressed this problem to the nation in his second inaugural address, "to care for him who shall have borne the battle, and for his widow, and his orphan." His words are today the motto of the current Department of Veterans Affairs.

Lincoln's efforts resulted in the creation of the National Asylum for Disabled Volunteer Soldiers. In 1873, it was renamed the National Home for Disabled Volunteer Soldiers. The term asylum had negative connotations. His actions helped create 11 national homes. These were set up between 1865 and 1930.

Originally these homes addressed the health needs of

The original home also played host to G.A.R. - Col. Amos W. Maupin Post 586. For a small town St. James had more than its share of G.A.R. posts, most likely due to the soldier's home being here. The other two posts in the small town were the John S. Phelps Post 297 and John W. Noble Post 593.

the vets. In time their functions were expanded to include recreation and entertainment through theaters, libraries, and billiard halls. Some homes offered games such as dominoes, checkers, chess, cards, boating and croquet. Four of the original homes are under consideration as national landmarks; they include Milwaukee, WI; Leavenworth, KS; Johnson City, TN; and Hot Springs, S.D.

The needs of veterans were also being supported state homes, city homes, and the U.S. Sanitary Commission's homes and lodges. By 1865, the Sanitary Commission operated 18 soldier's homes, 11 lodges, and 1 "rest" facility. Their function was to provide temporary aid and protection, food, lodging, care, etc. for soldiers in transition, receiving discharges, furloughed, and disabled. Most of these were closed at war's end.

There were some soldier homes in cities that started out as hotels for men passing through but expanded to take on disabled servicemen. These were run as a paying business and were not fully funded by the government. Women activists also helped to establish disabled soldier's homes in Boston, Chicago, Milwaukee, and also worked with the Sanitary Commission in 25 other cities. Most of these had closed by 1877.

State homes were established as early as 1864. Fitches Home for Soldiers and Their Orphans was opened in Connecticut with private donations. Several ladies benevolent societies pushed for the creation of long term care. Veteran organizations like the GAR and United Confederate Veterans also worked for the creation of federal and state homes to care for disabled and elderly veterans.

A few states had separate Union and Confederate old folks homes. The first of 16 Confederate homes was opened in 1881 in Georgetown, Kentucky. These homes were entirely supported by subscribers or their states. They received no money from the federal government. A few of the state run homes were merged into the federal veterans system. As the last of our Civil War veterans were dying by the 1930's, many states chose to close their homes and some began admit veterans from other wars.

Here in our home state, the Federal Soldiers Home Association was incorporated in 1894 with the purpose of establishing a home for Union veterans. The Women's Relief Corps, GAR, and citizens of St. James raised \$77,000.00 to purchase and improve the Dunmoor Mansion and 60 acres. It was dedicated in October of 1896 and had 18 residents. The property was later transferred to the state of Missouri and by 1920 boasted the mansion, two dormitories, two barracks, a hospital building, commissary, power plant, laundry, chapel, and administration building. Sadly, 100 years after its construction, the Dunmoor Mansion was torn down.

Many veterans lived out their remaining years in these homes. Many have never left. They lie in neat orderly rows beneath military tombstones in well-manicured cemeteries. Their names, rank, and other information is carved into the weathered stone slabs. As SUV members, we honor and preserve their memories. May their legacy always be part of our present and future. It is our responsibility and an honor.





Memorial Day Services







Annual Report to the Department Encampment, 6 Jun 2015

With the blessing of the Department Commander, I have been working to coordinate the reorganization/revitalization of two suspended camps, McPherson Camp #1 and Sigel Camp #614.

McPherson Camp – Much recognition should go to Brother Joe Rainey for coordinating a combination of Spradling Camp brothers and new brothers to revitalize this camp with the eventual goal of changing its location to a place more convenient for the camp's new brothers. Joe has submitted Form 4 transfer forms for members of Spradling Camp joining McPherson. Joe has also submitted a Form 30 for all brothers joining McPherson Camp to update their status. Glen is seeking permission from the National Council of Administration to submit a late Form 22 for this camp. They will be holding officer elections on June 9, 2015, and after said officers are installed and National accepts their Form 22, the suspension on this camp will be lifted.

Sigel Camp – A fortuitous inquiry into the SUVCW after Sigel Camp's suspension opened up the opportunity to save this camp as well. Matt Cordoves, a police officer and re-enactor from Lebanon, Missouri, is working with me to rebuild this camp and move it to the Lebanon, Missouri area, about an hour west down I-44 from its current location in Rolla. We have set a goal of 1 Jul 2015 to have a membership of all new SUVCW brothers ready to elect officers and submit late paperwork. We have enough individuals committed to joining the SUVCW via Sigel Camp #614 to have a strong reboot for this camp.

Awards Committee - I convened the Awards Committee and we successfully discharged the duties put before us.

Walt Busch and I agreed to submit the following motion to further improve our Awards Program:

Any nomination of a Brother, individual, group, or entity for an award issued by the Department of Missouri after the 2015 Department Encampment must include a description in the recommendation which states how the nominee's action(s) have furthered the Purpose and Objects of the Sons of Union Veterans of the Civil War as set forth in Article II of its Constitution. Each recommendation should further state why the Department of Missouri, and not a lower or higher governing body, should be presenting this award. No award will be considered without such a description.

AND

The Awards Committee in making its recommendations should strive to choose only one nomination for each award when possible. If more than one recommendation is made, the committee must state specifically in writing why more than one of an award was recommended. This does not include issuing several certificates to individual members of an awarded group, nor does this pertain to Department Certificates of Appreciation, which the Awards Committee may recommend as needed.

AND

Awards which require plaques to be issued should be limited to one recommendation per award. If more than one recommendation is made, the committee must state specifically in writing why it determined more than one of said award was recommended.

A standing committee on awards will be formed for the 2015-2016 year, chaired by the Senior Vice Commander and consisting of the most recent three Past Department Commanders and any additional Brothers in good standing appointed by the Department Commander. This committee will review the awards program of the Department of Missouri, develop a Purpose and Objects statement for the same, compile a list of past award recipients, review the award programs of other departments within the Sons of Union Veterans of the Civil War, produce a list of actionable proposals for adjustments to the criteria of current awards, and develop new applications and instructions for all awards which will provide clarity as to what types of service qualify a nominee for any given award. The committee will also develop detailed criteria for any new awards which may help the Department of Missouri further the Purpose and Objects of the Order as set forth in Article II of its Constitution and will submit proposals for any bylaws changes necessary to complete all above stated objectives at the March 2016 business meeting. This committee will provide preliminary reports at the October 2015 and March 2016 business meetings and solicit input from the attendees of these meetings, with a final vote on any proposals and resulting bylaws revisions to take place at the 2016 Department Encampment.

ROTC Award Coordinator — In temporarily discharging the duties of this appointed officer position, I contacted camps via email on 15 March 2015, again on 28 April 2015, and finally on 2 Jun 2015 for reports on their programs this year. I am still working on a job description for this appointed position, which I put on the back burner while dealing with camp reorganizations and the awards committee. I will forward a job description for this position to the bylaws committee once completed.

I made sure the three ROTC programs usually sponsored by Sigel Camp received their awards this year (through the sponsorship of McCormick Camp) and personally presented an award to Air Force ROTC Cadet Grant Watkins Davis of Detachment 442 at Missouri S&T. Camps reporting awards sponsored/presented include:

DEPARTMENT OF MISSOURI SONS OF UNION VETERANS OF THE CIVIL WAR

PURPOSE OF REQUESTED REGULATIONS CHANGE:

Past Commanders-in-Chiefs are a treasure to the organization and they may move to other states due to family, business issues or just age. To require them to move up the ladder of an organization to, at minimum, that of a past camp commander so that they may have a vote in department encampments is not properly using the abilities of a man who once ran the entire organization. To rectify this, the Department of Missouri proposes the following amendment to the regulations.

WHEREAS, the Regulations of the Sons of Union Veterans of the Civil War Chapter II (Departments), Article II (Membership), Section 1 outlines the membership of a department encampment; and,

WHEREAS, paragraph 2 states appropriate credentials for all Past Commanders-in-Chief...shall be issued by the office of the Department Secretary; and,

WHEREAS, Past Commanders-in-Chief moving to another state without transferring his credentials or having dual membership in a state through which his credentials have not been earned currently is not entitled to such credentials; and,

WHEREAS, Past Commanders-in-Chief are a treasure to our organization and have non-voting status on the Council of Administration; now,

THEREFORE, the Department of Missouri, Sons of Union Veterans of the Civil War, duly meeting in encampment on June 6, 2015 in Jefferson City, Missouri, proposes a change to the National Regulations to add a third paragraph to Chapter II, Article II, Section 1 which states:

"Any Past Commander-in-Chief in good standing who joins or transfers into a Department as a brother or dual brother from another state shall have voting rights in Department encampments and his credentials shall be issued by the department secretary."

Subject: Missouri Monument @ Vicksburg Committee Annual Report

To: 20th Missouri Department Encampment

In 2014, the Department of Missouri established a project to restore and ultimately re-dedicate the Missouri state monument at Vicksburg National Military Park. The Missouri monument, purchased by the state of Missouri, was originally dedicated in October 1917. Department Commander Glen Alsop appointed the committee, which consists of PCinC Don Palmer, serving as chairman, PDC Larry Dietzel and PCC Mark Coplin. PCC Gary Scheel joined the committee earlier in 2015.

A survey of the monument conducted by the National Park Service in 2013 revealed that approximately \$375,000 would be needed for the stone and metal work necessary to restore the monument to good condition. The Department of Missouri, inspired by the success of the Department of Iowa in their monument restoration and re-dedication project, developed a plan to obtain state funding to cover restoration costs. But this proved to be easier said than done. Initial attempts by PCC Coplin and fellow committee member PDC Larry Dietzel to contact state legislators proved to be fruitless and frustrating. In addition, Missouri Governor Jay Nixon claimed that there were higher funding priorities, including a \$75 million renovation package for the State Capitol building in Jefferson City.

Since the Missouri state monument at Vicksburg honors Missourians who fought in both Union and Confederate forces, the Missouri Division of the Sons of Confederate Veterans was contacted to enlist their support. Feedback has generally been positive, but support to date has been limited.

But the tide began to turn in 2014. PDC Dietzel made contact with Sen. Kurt Schaefer (R-Columbia), who serves on the Appropriations Committee. Sen. Schaefer appeared interested in our project and was willing to carry it forward to the budgeting process. He also contacted Rudy Keller, a reporter for the Columbia Tribune, who focuses on political matters, but has also published articles on the Civil War history. In February 2015, Keller published an article in the Columbia Tribune describing the project and the plight of the Department of Missouri to obtain the necessary funds from the state. Keller's article definitely brought about widespread awareness of the project. Thanks to Sen. Schaefer, the proposed 2016 state budget contains a \$375,000 earmark in the Department of Natural Resources budget for the monument restoration project. The budget passed both the House and Senate and was sent to Gov. Nixon on April 23.

Assuming Gov. Nixon approves the budget, the next phase of the project will likely begin later this summer. This next phase focuses on stone and metalwork restoration. The 2016 state fiscal year begins on July 1, so a decision is expected soon.

Westport Camp Report to the Department of Missouri Encampment May 1, 2014 – April 30, 2015

Westport Camp #64 had a productive and successful year. Membership stands at 24 with the addition of one member and loss of seven members. Monthly camp meetings were held on the first Wednesday of the month at the Bass Pro Shop's Conservation Room in Independence, Missouri. Eight camp members are also enrolled with the Sons of Veterans Reserve.

Eagle Scout. Under Brother Michael Lundeen's guidance, the camp recognized three new Eagle Scouts with presentation of certificates and coins at their Court of Honor. Each presentation has been the result of a camp member's connection to the Eagle Scout's family. Our efforts to coordinate Civil War related Eagle Scout projects with the BSA Heart of America Council is on ongoing discussion.

Grave Registration. Under Brother Ron Guthrie's guidance, the camp registered 26 new Civil War veteran gravesites to the SUVCW database. With the completion of Brother Ron's tenure as Grave Registration Officer, he was nominated for recognition by the Department. Brother David Short is our new Grave Registration Officer.

ROTC/JROTC. Under Brother Dale Crandell's guidance, the camp presented eighteen ROTC awards: two college ROTC and sixteen high school JROTC. This is an increase of four from last year. There is only one ROTC/JROTC program in northwest Missouri not currently supported: Excelsior Springs Career Center.

Memorial Day. The camp continued its active support of Memorial Day observances.

- Brookings Cemetery. Camp members placed flags at an estimated 200 Civil War veteran gravesites.
- Union Cemetery. Uniformed SVR members were part of the timeline color guard for services at this historic cemetery.
- Liberty Memorial. Uniformed SVR members participated in the parade of colors for Kansas City's largest Memorial Day service.
- Vietnam Veterans Memorial. Uniformed SVR members participated in the parade of colors for the Memorial Day service at this Kansas City memorial fountain-park.

Battle of Lone Jack Commemoration. Uniformed SVR members provided a color guard for the city parade on 16 August 2014. Camp members also manned an information-recruiting booth during the day long festival. The parade and festival commemorated the Battle of Lone Jack on 15-16 August 1862.

Battle of Westport Commemoration. The camp hosted a Battle of Westport Commemoration to coincide with the battle's sesquicentennial on 23 October 2014. Held at Kansas City's Loose Park the location of much of the battlefield, an estimated 75 people attended. Brother James Beckner was the keynote speaker, outlining the battle history, points of interest, and corrections to several historical markers. Missouri Governor Jay Nixon and Kansas City Mayor James Sly both provided proclamations declaring October 23rd as Battle of Westport day. This was a first

ever joint event with Kansas City's SUVCW, SCV, DUVCW, and UDC. The commemoration included camps/tents from Kansas and Missouri.

Battle of Westport Exhibition-Reenactment. The Battle of Westport Exhibition and Reenactment was held on 24-26 October 2014 at Kansas City's Swope Park. An estimated 500 school children, 800 spectators, and 200 re-enactors-exhibitors participated in the three day event for the 150th anniversary of the Battle of Westport. Westport Camp #64 and Franklin Camp #5 participated in the opening ceremony color guard as well as providing information-recruiting booths during the reenactments.

Veterans Day. Uniformed SVR members participated in the parade of colors at Kansas City's Vietnam Veterans service. The 2014 service was held at the Vietnam Veteran's Hall due to inclement weather. Key note speaker was U.S. Senator Claire McCaskill.

Christmas Dinner. The camp closed 2014 with its traditional Christmas Dinner with the DUVCW Macklind Tent #24. Key note speaker was Peggy Buhr with the Bates County Museum and Historical Society speaking on the Battle Island Mound. The camp presented its 2014 annual awards:

- Distinguished Service Award Brother David McCann.
- Outstanding Member of the Year Brother James Beckner

Medal of Honor. The camp continued its practice to recognize a local Medal of Honor recipient with a gravesite service for National Medal of Honor Day. An estimated 50 attended the commemoration for Private Wilbur Fiske Moore (1840-1924) on 22 March 2015 at Forest Hill Cemetery. Private Moore is a veteran of the Civil War and received his Medal of Honor for heroism at the Battle of Nashville on 16 December 1864. This was a joint service with SAR, DAR, CAR, 1812 Society, USD 1812, SUVCW KS, DUVCW, and Burgles Across America.

Any nomination of a Brother, individual, group, or entity for an award issued by the Department of Missouri after the 2015 Department Encampment must include a description in the recommendation which states how the nominees action(s) have furthered the Purpose and Objects of the Sons of Union Veterans of the Civil War as set forth in Article II of its Constitution. Each recommendation should further state why the Department of Missouri, and not a lower or higher governing body, should be presenting this award. No award will be considered without such a description.

AND

The Awards Committee in making its recommendations should strive to choose only one nomination for each award when possible. If more than one recommendation is made, the committee must state specifically in writing why it determined more than one of an award was recommended. This does not include issuing several certificates to individual members of an awarded group, nor does this pertain to Department Certificates of Appreciation, which the Awards Committee may recommend as needed.

AND

Awards which require plaques to be issued should be limited to one recommendation per award. If more than one recommendation is made, the committee must state specifically in writing why it determined more than one of said award was recommended.

AND

A standing committee on awards will be formed for the 2015-2016 year, chaired by the Senior Vice Commander and consisting of the most recent three Past Department Commanders and any additional Brothers in good standing appointed by the Department Commander. This committee will review the awards program of the Department of Missouri, develop a Purpose and Objects statement for the same, review the programs of other departments within the Sons of Union Veterans of the Civil War, produce a list of actionable proposals for adjustments to the criteria of current awards, and develop new applications and instructions for all awards which will provide clarity as to what types of service qualify a nominee for any given award. The committee will also develop detailed criteria for any new awards which may help the Department of Missouri further the Purpose and Objects of the Order as set forth in Article II of its Constitution and will submit proposals for any bylaws changes necessary to complete all above stated objectives at the March 2016 business meeting. This committee will provide preliminary reports at the October 2015 and March 2016 business meetings and solicit input from the attendees of these meetings, with a final vote on any proposals and resulting bylaws revisions to take place at the 2016 Department Encampment.
