# Collector's Corner by Douglas Roussin (2019)

# "Leftover junk"

After the Civil War, the federal government had large quantities of surplus military goods and held large auctions to dispose of this surplus. Business's like Bannermann's, purchased these goods at greatly discounted prices and had warehouses full of everything from rifles and swords to cannon, uniforms and saddles. Among the items stored in their warehouses were thousands of bayonets. The Bannermann company needed innovative ways to deposed of this "leftover junk".




This matched pair of candelabra is from the Ransom G.A.R. post located in St. Louis, Missouri. The candelabra is made from three Austrian bayonets. The blades have been curved outward and are held together with a brass throat. They measure 15 inches tall. Both are made of socket bayonets, which were bought as military surplus, then fashioned into these relics. Bannermann sold many items like this to G.A.R. posts. Many veterans also purchased these relics for display above fireplaces or as a decoration on their dining room table.

Since, this pair of candelabra have no maker's mark, it is not known whether Bannermann or one of his competitors fashioned this piece.

This candelabra is one of a matched set and measures

14 inches tall. The set was made of surplus Civil War bayonets. The curved bayonets are screwed to a center section which is made of iron. This makes these candelabra quite heavy. At the top is a cup, designed to hold a candle. Many times these were designed with a special brass insert which fit in the bayonet socket. They could then hold a candle. Many of these inserts have been lost over the years. The candelabra, being iron, had a lot of rust. They had to be taken apart and carefully cleaned then restored to their original condition. This pair of candelabra now sit on my fireplace.





candelabra was found at an estate sale in St. Louis, Missouri, and was used by a veteran in his home.

The candelabra on the left is said to have come from a Grand Army post in Pennsylvania. It is made of socket bayonets and the tips have been turned inward thus, forming the base. They are carefully held together by small screws. Traces of candle wax is still visible. The bayonets were originally made for the .58 Springfield musket.

painted gold.

The sconce on the right has a bayonet which fit on a .58 cal, Springfield musket and probably saw action during the Civil War. It is now a wall decoration. The bayonet goes through a brass ball. The base is attached to a black board and can, therefore, be applied to the wall. This sconce is one of a matched set and is hanging on the author's den wall on either side of the door.

This bayonet display focused on veterans from another war, World War 1. The brass top has the standard insignia from the Civil War. This includes an eagle plate, U. S. buckle and artillery, infantry and cavalry hat pins. But, the bayonets which hold the stand together are French in origin. This would date the stand to post World War 1. The sconce above is made from three bayonets. These have been carefully bent and are attached to a block with brass bolts. At the top is a small piece of brass with a hole for attachment to the wall. The bayonets are





## **Department Purchases St. Joseph MO GAR Post Records**

Brother James Dixon of Tiger Camp found one of the Minute books of the General Custer Post in St Joseph, MO for sale on E-Bay and Historic Records Officer Walt Busch brought this information before the last Department Encampment to try to purchase the item. The book was described as:

65 OFFICERS FOR 1892. TRUSTEES WM. HAND COL. HASSENDEUBEL POST, No. 13, S Department of Missouri, G. A. R. S SOUTH ST. LOUIS TURNER HA St. (ouis, August 18th, 1892. At the last regular meeting of this Post, held August 16th, 1892, the following Preamble and Resolutions were unanimously adopted: WHEREAS, Maj. CHAS. F. ERNST, a Comrade of Custer Post, No. 7, St. Joseph, Mo., has departed this life, we, in view of the relations he maintained with this Post, deem it proper to give formal expression to our sympathy and sorrow; therefore, be it RESOLVED, That his high reputation as a soldier, and his record as a valued citizen, commands our sincere regard. RESOLVED, That he was endeared to us by his many genial, social qualities, and that we gratefully remember the attentions which he has on many occasions extended to us. RESOLVED, That we proffer his family our heartfelt sympathy in their bereavement. J. J. Jimmerer, Post Commander. Martin Scherer Adjutant.

"Original General Custer Headquarters of G.A.R. 1892 Book of Meeting minutes . This wonderful historical book contains 201 pages of handwritten notes taken at the G.A.R. meetings in St. Joseph, MO from the headquarters of the Custer Post No. 7. All pages are handwritten by Thomas R. Dumont, Adjutant, at that time. There are also some pages of congratulatory order from Gen. Custer dated 1864, and Custer's Farewell Order from April 9, 1865. The binding on this book is coming loose, as shown in photos. It measures 11 1/2" x 14".

The department approved the purchase on a motion that after we photograph it for our records, we gift it to the Missouri Historical Society in Columbia.

We were able to purchase it for just under the amount authorized by the encampment for us to bid.

The Custer post was a very active post and has a GAR monument in a local cemetery. The camp was also responsible for incorporating to buy and develop a "Grand Army of the Republic Park" in St. Joseph.

Several years ago, Walt found the incorporation papers for this on the Secretary of State website and tried to find out more about the park. Did they accomplish their goal? Is the park renamed as something else now? The results of the incorporation are still a mystery.

The altar was cov-ered with the stars and stripes, draped with black and white crepe, and sur-mounted with a beautiful floral design bearing the single inscription, "Our Dead." Six vacant chairs, covered with the national colors and suitably draped, were placed between the com-mander's chair and the altar. The exercises began with music-beautiful and appropriate selection beautiful and appropriate selection Relief Corps were also present in large

young ladies and gentlemen, under the direction of Prof. Phil W. Kost. The post commander then called upon the adjutant to read the record of each of the deceased comrades in the cause of our country and in the Grand Army of the Republic. The reading of each record was followed by three rolls on a muffled drum. The exercises were then continued with a beautiful re-sponsive service by the post chaplain and comrades. Rev. W. H. Welton read a selection from the nineteenth y psalm and offered a prayer, closing with the Lord's Prayer in concert. #### The Hero from Jefferson County, Missouri: Thomas Clement Fletcher Part 2 by Oliver R. Pechmann

With the outbreak of the Civil War, Fletcher was appointed assistant provost marshal general at St. Louis by Gen. Nathaniel Lyon and continued in that post for the next year. During the summer of 1862 he recruited the Thirty-first Missouri Volunteers as part of a larger recruitment effort headed by his friend Frank Blair. Most of those volunteering for the Thirty-first were from Jefferson County and included his brothers, John William and Charles Carroll. Thomas became their colonel, receiving his commission in October 1862.

Fletcher and his 31st Missouri Volunteer Regiment would soon see action with Francis Blair's brigade at Chickasaw Bayou, north of Vicksburg, in December 1862.

The Battle of Chickasaw Bayou, also called the Battle of Walnut Hills, fought December 26-29, 1862, was the opening engagement of Vicksburg Campaign during the American Civil War. Confederate forces under Lt. Gen. John C. Pemberton repulsed an advance by Union Maj. Gen. William T. Sherman that was intended to lead to the capture of Vicksburg, Mississippi.

On December 26, three Union divisions under Sherman disembarked at John's Plantation on the Yazoo


River to approach the Vicksburg defenses from the northeast while a fourth landed farther upstream on December 27. On December 27, the Federals pushed their lines forward through the swamps toward the Walnut Hills, which were strongly defended. On December 28, several futile attempts were made to get around these defenses. On December 29, Sherman ordered a frontal assault. At noon, Union troops advanced with a cheer. Blair's brigade, including Fletcher's 31st Missouri, moved on the left, DeCourcy's in the center, followed by Brig. Gen. John M. Thaver's brigade on the right; Thaver's brigade lost its way and only one regiment, the 4th Iowa Infantry, was engaged. The Federals crossed the water barriers and advanced on the weight of their sheer numbers, but met stiff resistance and were repulsed with heavy casualties when they came against the main Confederate line.

A field correspondent from the Missouri Democrat reported: "The enemy commenced retreating up the hill, General Blair's brigade pursuing them, when all of a sudden the enemy, from a masked battery, opened a most deadly and destructive fire upon them with grape and canister. In a few minutes the ground was covered with the dead and dying. This ended the assault on the hill at this point, and the survivors of General Blair's brigade fell back across the bayou on a log bridge."

Confederate General S. D. Lee ordered his men to make a counterattack, during which they captured 332 Federals and four battle flags. Colonel Fletcher was wounded and captured. He spent the next five months in Libby Prison in Richmond. Exchanged in May 1863 he rejoined his regiment in time to be present at the surrender of Vicksburg on July 4.

He later participated with his regiment in the struggle for Lookout Mountain at the battle of Chattanooga in

December and commanded a brigade in the Atlanta campaign the following spring. While engaged in the latter, he contracted a severe cold, which settled in his back, making it impossible for him to mount his horse. He would later say that his health problems were caused by spending part of the winter on a covered bridge near Jackson, Mississippi, over the Pearl River, which had been converted into a prison. On the recommendation of the regimental surgeon, he returned home to recuperate. During his convalescence he painted a pen and watercolor rendering of that very same covered bridge. It is on display at the Museum of Fine Arts, Boston.

## Buried in Arkansas: Three Civil War Medal of Honor Profiles

In addition to the Union soldiers and sailors of the Civil War who received the Medal of Honor and are buried in Missouri, the Department of Missouri is currently aware of three such Medal of Honor recipients who are buried in the State of Arkansas. Acting Master's Mate William J. Franks of the U.S.S. Marmora, Armorer George Taylor of the U.S.S. Lackawanna, and Private John Kennedy of Company M, 2nd U.S. Artillery were each awarded the Medal of Honor for their conspicuous service during the Civil War and subsequently buried



in Maple Springs Cemetery, Batesville, Arkansas. The U.S.S. Franks (DD-554), a Fletcher-class destroyer, was named in his honor and launched on December 7, 1942.

George Taylor was born in Watertown, Jefferson County, New York, on November 15, 1830. His Medal of Honor citation states the he was "on board the U.S.S. Lackawanna during successful attacks against Fort Morgan, rebel gunboats and the ram Tennessee in Mobile Bay, on 5 August 1864. When an enemy shell exploded in the shell room, Taylor although wounded went into the within the geographical boundaries of this department. These are their stories.

William J. Franks was born in Pittsboro, Chatham County, North Carolina, in 1830. He entered the Union Navy on September 16, 1863, in Duvall's Bluff, Arkansas. Arriving in Yazoo City, Mississippi, on March 5, 1864, Franks disembarked from the U.S.S. Marmora with other members of the crew "in the midst of a heated battle and, bravely standing by his gun despite enemy rifle fire which cut the gun carriage and rammer, contributed to the turning back of the enemy during the fierce engagement." Franks, who held the rank of Seaman at the time, received the Medal of Honor along with two of his crewmates and was promoted to Acting Master's Mate for his actions during this battle.

After leaving the Navy in 1865, Franks settled in Arkansas and married Mary Francis, with whom he had five children. He died in April 1880 and is buried



room and, with his hand, extinguished the fire from the explosion. He then carried out his duties during the remainder of the prolonged action which resulted in the capture of the prize rebel ram Tennessee and in the damaging and destruction of Fort Morgan." His award was issued through General Order 45 on December 31,

1864. His Medal of Honor grave marker states his name as George Taylor F. Johnson; however, his citation is listed simply under "George Taylor," and his name is given as George Taylor in A History of the United States Navy from 1755 to 1894 by Edgar Stanton McClay, which was published by D. Appleton and Company in 1894.

John Kennedy was born in County Cavan, Ireland, on May 14, 1834. He enlisted at Philadelphia, Pennsylvania, for a five-year term in Battery M, Second U.S. Artillery, on December 16, 1857. It was on June 11, 1864, when Kennedy and four other artillerymen also serving in Brigadier General George Armstrong Custer's cavalry division stood their ground at the Battle of Trevilian Station and defended their 12-pounder brass artillery piece against a Confederate cavalry charge.



According to a quote in the Encyclopedia of Arkansas, Kennedy later recounted the event: "With the ammunition gone, in the tussle, we used our pistols. When we emptied them, we took the sponge staves and handspikes and used them freely until overpowered, by them actually riding us down. I was fencing with the handspike with a calvaryman when another came in rear [sic] and knocked me down."

General Custer led a charge which recaptured the gun, but not before Kennedy and Private Charles O'Neil were captured and taken to Andersonville Prison. Forty-four men in Battery M were killed or wounded in the battle. O'Neil would die at Andersonville; Kennedy would survive to continue his service in the 2nd Artillery until 1891, when as an ordinance sergeant, he would retire to Little Rock, Arkansas, with wife Margaret Kirker Woodlock, who he married in 1878, and their five children, including a son from Margaret's first marriage.

Kennedy was nominated for a Medal of Honor twenty-eight years after the action at Trevilian Station, and was presented the medal on August 19, 1892. The simple citation reads that he: "remained at his gun, resisting with its implements

the advancing cavalry, and thus secured the retreat of his detachment." He died in Little Rock on September 28, 1910, and is buried in Willow Lot 298 of Oakland and Fraternal Cemetery in Little Rock, Arkansas. The USCIS Fort Smith Field Office is named in his honor.



She reported on their fund raising efforts to place an historical marker to commemorate the 1916 GAR National Encampment held in Kansas City and as well as the efforts to publish a compendium about the GAR's Missouri history.

A week later, I reciprocated by attending the DUVCW Missouri Department Conference in Kansas City on June 8th. The SUVCW was one of three groups to bring greetings but we were the only Allied Order. As we do the Department and Camp's work this year, I'm asking that we look for opportunities to partner with the Allied Orders: DUVCW, ASUVCW, LGAR, and WRC. Some, like the DUVCW have a presence throughout Missouri; and others, like the LGAR only have local members-at-large.





#### DEPARTMENT ORDER NO. 13 Series 2018-2019 2 May 2019

#### **Proposed Amendment to the Constitution and Regulations**

General Order #7 dated 5 December 2018 reported that the 137th National Encampment of the Sons of Union Veterans of the Civil War (SUVCW) approved an amendment to the Constitution and Regulations (C&R), Article V, Section 2(b) by removing "the last proceeding" from the first sentence:

Article V, Section 2b. If the Commander-in-Chief is of the opinion that an action of the last proceeding any National Encampment is in violation of or in conflict with our Congressional Charter, and/or the

Constitution, and/or National Regulations, and/or United States Law, and/or any State's Law, he may propose such General Order(s) to delay implementation of such action or suspend such action if previously implemented, until such time as the violation or conflict can be corrected. A two-thirds majority vote of the Council of Administration is required to support the proposed General Order authorizing the Commander-in-Chief to proceed, the Commander-in-Chief abstaining from participating in such vote and the Senior Vice Commander-in-Chief may only vote to break a tie. Such presentation and vote may be taken by electronic means of communication. The Commander-in-Chief must propose a resolution to the conflict by the next National Encampment.

For compliance with the C&R, Article IX, ratification of an amendment to the Constitution requires approval by 50% of the Departments. Accordingly, General Order #7 directs all Departments to vote to approve or reject the amendment at their 2019 Departments Encampments.

A vote by the Department of Missouri to approve or reject this proposed amendment is on the agenda for the 24th Encampment of the Department of Missouri on 1 June 2019 at St. Clair, Missouri. Members and Camps are encouraged to review the proposed amendment and provide guidance to their delegates.

General John Logan, while serving as Commander-in-Chief of the Grand Army of the Republic (GAR) issued General Order #11 on May 5, 1868 establishing Decoration Day, which we now call Memorial Day. His charge was that we commemorate at the gravesite of fallen soldiers, sailors, and marines:

Let us, then, at the time appointed gather around their sacred remains and garland the passionless mounds above them with the choicest flowers of spring-time; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us a sacred charge upon a nation's gratitude, the soldier's and sailor's widow and orphan.

As the descendants and lawful heirs of the GAR, each of us pledged during our membership induction to always observe the day set aside as Memorial Day, sacred to the memory of the Union Soldiers and Sailors. Whether commemorating the observed Memorial Day on Monday, May 27<sup>th</sup> or traditional Memorial Day on Thursday, May 30<sup>th</sup>, or both, Camps and members of the Sons of Union Veterans of the Civil War throughout Missouri and Arkansas are asked to take time to participate in Memorial Day services honoring our fallen veterans of all eras but especially those Civil War veterans.

#### The King Of Siam Offered War Elephants To Lincoln

Before the war, King Rama IV of Siam found out that the US did not have elephants. This, King Rama IV felt, was a tragedy and one that needed to be righted as soon as possible. When the Civil War began, Rama IV jumped on the opportunity. He wrote to Abraham Lincoln, offering to send him as many war elephants as he required. These, King Rama IV explained, would not only help him crush the Confederates but could also be put to work on construction projects or just set loose in the forests. Lincoln did his best to be polite. "I appreciate most highly Your Majesty's tender of good offices," he wrote back. "Our political jurisdiction, however, does not reach a latitude so low as to favor the multiplication of the elephant." It's easy to imagine, though, that a few years further in, Lincoln was probably regretting not putting a few war elephants on the front lines.


surrounding the battle. Many guests attended the presentation.


