




In Memory of James (Jim) Harrison Chilcutt, age 83, died Wednesday, February 14, 2018, at home in Jefferson City. He had battled cancer and heart disease. He was born on November 19, 1934, in Diamond, Missouri, a son of James Ramey and Mary Frances (Rodgers) Chilcutt. He was married on August 12, 1962, in Springfield, Missouri, to Barbara Frances Woods, who survives at the home. They raised three sons and enjoyed 55 years of married life together. He was a 1953 graduate of Joplin High School in Joplin, Missouri, and he attended Missouri Southern. He served three years in the U. S. Army (16 months in Korea.) He worked for 38 years at the Missouri Division of Employment Security, serving as Manager of the Job Service offices in Hannibal, Jefferson City, and Springfield. He retired in December 1996, as Manager of Administrative Services for the Missouri Department of Labor in Jefferson City. He was a member, Deacon, and Elder at First Presbyterian Church in Jefferson City; a former member of the Evening Rotary Club, a Rotary Foundation Sustaining Member, and was a Paul Harris Fellow; a past member of the Board of the Employment Security Credit Union; the American Legion Roscoe Enloe Post 5; the VFW Post 1003; the World's Fair Preservation Society; the Jefferson City Park Department Resources Committee; the Historic Preservation Commission for the City of

Jefferson; the Missouri Society of Military History, the Sons of Union Veterans Lillie Camp 6; a lifetime member of the Sons of Confederate Veterans and a member of the Mosby Monroe Parsons Camp #718. He was also past President of the River City Collectors' Guild and past Co-Director of the Friar Tuck Collectors' Club; a past Chairman of the Capitol Area Chapter of the American Red Cross and a long-time blood donor; a past President of the Jefferson City Men's Garden Club and a long-time member of the Missouri Botanical Gardens; and he was a board member of the Riverview Cemetery Association. After retirement, he and Barbara were in the antique business. He was a gardener, enjoyed raising orchids, and was a Master Gardener. Jim was interested in all things old and historical. He wanted to know how and why things happened and the results. He had a great interest in archaeology, particularly, in Biblical archaeology. Survivors include his wife, Barbara Chilcutt; two sons, Bryan Rodgers Chilcutt (wife, Susan) of Columbia, Missouri and Darin Foster Chilcutt (wife, Jennifer) of Jefferson City, Missouri; two grandsons, Cameron Daniel Chilcutt of Jefferson City and Carson James Chilcutt of Columbia; one sister, Jo Helen Beauchamp of Springfield, Missouri, one brother, Don R. Chilcutt (wife, Charlotte) of Edmond, Oklahoma; one niece; and four nephews. He was preceded in death by his parents and a son, Kevin Woods Chilcutt. Visitation will be held from 9:30 until 11:00 a.m. Saturday, February 24, 2018, at First Presbyterian Church with a memorial service following at 11:00 a.m. with the Reverend Dr. David Henry officiating. Graveside services will be held at 1:30 p.m. at Riverview Cemetery. REMINISCING ABOUT THE FORMATION OF THE RANSOM POST IN ST LOUIS AND GENERAL WILLIAM T. SHERMAN.

Henry Fairback, who became department commander of the Missouri GAR in 1905, was a member of Ransom Post 131.

His booklet, A Wanderer: Being A
Brief Sketch of the Civil and
Military Experiences of Henry
Fairback, not only describes this
story of General Sherman, but also
his career as an artificer with Co. E,
1st Missouri Engineers, his time as a
POW, and his escapades as he
escaped.

"I looked at the Confederate time and again; he held his carbine in both hands partly resting on his knees; my heart was beating with anxiety; the despite deed had to be done; it was man to man. With one quick jump, I snatched his carbine from him; he hallooed and ran. I cocked the carbine and told him to stand or I would shoot him. He did so, and slowly got down the slide on which we went up. When on the ground he begged us not to kill him; he told his partner his suspicion was that we were "Yanks," now he was sure of it...I took all his ammunition, threw it in the river, took the load out of his carbine, and told him I would give it back to him, that he should tell the officers who came with him that he had found our furloughs, then let us go. Off we started and paddled as hard as our physical strength would allow. When we rounded a river bank, out of sight, we remained in the cane-brake till midnight."

Note: Some war records name him as Henry Feuerbach.

On December 7th, 1883, some eighteen comrades who served in the Civil War of the Union to defeat all of its enemies, whose object was to divide our Republic and establish a separate Government based on inhuman slavery for its pedestal. We assembled at the hall, S. W. Corner Garrison and Easton Avenues, where we were mustered in the Grand Army of the Republic by Department Commander Major Wm. Warner of Kansas City. The great Gen. Wm. T. Sherman was the center of attraction. He became the first Commander of Ransom Post G. A. R. 131, Department of Missouri. It was indeed a great pleasure to have the honor of being in such company. While my regiment and company served under Gen. Grant in his campaigns in the Mississippi Valley. We observed Gen. Sherman often as the companion of Gen. Grant. Yet I had never come at any time (a soldier in the ranks) near him enough to judge his value and his character. The following year I was elected as Quartermaster, 1884. Then many times



my business brought me in close contact with him. Gen. Wm. T. Sherman was one of the most remarkable world-wide man of knowledge and as a soldier the world ever produced. I used to consult him, call on him at his residence, Garrison and Bell avenues, for information on national subjects. There was not a scientific subject on which he was not informed—astronomy, geology, weatherology, music and the drama. He had a refined sense and excellent judgment as a thorough lover of classical operas. His memoirs are by all odds the most brilliant and interesting of all the Generals who commanded armies in the war of 1861 and 1865. On one occasion he went with Ransom Post to the National Cemetery at Jefferson Barracks on Memorial day. We were walking around in the cemetery when a large fat Irish woman approached him, spoke to him saying: "General, won't you come and see where my husband lies buried-Michael McGinnis of the Regulars, who served under you, his grave is right here?" He walked over to the place, the General looked at the woman, and said, "Well," said he, "he seems to rest well, have you selected a place for yourself?" "No, General, I married the second time." "Well you should select a place, for I have a resting place engaged in Calvary Cemetery."

If you are a veteran you are eligible for the SUVCW WAR MEDAL. How to receive one is listed in the information below with a link to Form 5 which is the application form for the medal.

The SUVCW WAR MEDAL is authorized for any Brother who has served honorably in any branch of the Armed Forces of the United States during a period of war or military conflict as defined by the Council of Administration. 1. A DD214, DD4, or DD215 must accompany the application and reflect the qualifying medal/ribbon. 2. Entitlement is determined by the Brother's Camp at a regular meeting of that Camp. 3. A gold bar naming the war or conflict in which the Brother served may be attached to the ribbon of the medal. This bar may not be attached to any other badge of the Order. 4. The WAR MEDAL shall NOT be worn at the same time with the MILITARY SERVICE MEDAL. [Ref. REGULATIONS, Chapter V, Article III, Section 3, sub-sections F, G – C&R.] I have the honor to apply for the WAR MEDAL of the Sons of Union Veterans of the Civil War, having received

If you have ever been a member of the Military of any branch of the Armed Forces and did not serve during a time of war there is a SUVCW Military Service Medal you are eligible for this medal. How to receive one is listed in the information below with a link to Form 8 which is the application form for this medal

The SUVCW MILITARY SERVICE MEDAL is authorized for any Brother who has served honorably in any branch of the Armed Forces of the United States. If a Brother is qualified for this medal and the SUVCW WAR MEDAL, the Brother may purchase both, but may only wear one medal or the other at any one time. [Reference = REGULATIONS, Chapter V, Article III, Section 3, sub-section G of the C&R.]

# A Long Journey into Night: Abraham Lincoln's Corpse at Rest

Although Abraham Lincoln was assassinated in 1865, his final burial didn't occur until 1901, and only after his coffin had been moved and opened several times.

April of 1865 was a month of triumph and tragedy in Washington D.C. The surrender of Confederate General Robert E. Lee at Appomattox Court House in Virginia on the 9th of April marked a formal end to the bloodiest conflict ever fought on American soil. Ulysses S. Grant, the victorious general once ridiculed as an abject failure at life and a perpetual drunk, was a national hero held in such high regard that he would go on to serve two terms as President of the United States. But it was another man of humble origins who would, as Secretary of War Edwin M. Stanton so eloquently stated, "belong to the ages": a modest yet brilliant lawyer and politician from Springfield, Illinois. Abraham Lincoln, whose likeness is etched into the national consciousness on coin and currency, in marble and in stone, was the 16th President of the United States, the great emancipator, and savior of the Union. On the 15th of April 1865, he died a martyr's death.

Justice was swift. The assassin, an actor and Confederate sympathizer named John Wilkes Booth, was tracked, cornered, and shot by the 26th of April. The larger failed conspiracy was investigated, arrests were made, and four conspirators were executed by hanging on the 7th of July. But the mourning endured. From verses of Shakespeare's "King Henry VIII" published in a letter proclaiming Lincoln a martyr to the New York Times on the 26th of April 1865, to the classical poem, "O Captain! My Captain!" written by Walt Whitman in 1865 to eulogize Lincoln and learned in schools across the nation to this day, the nation grieved for the greatest and most beloved president since General George Washington. So it is no wonder that unscrupulous citizens would believe a successful kidnapping plot involving the post-mortem Lincoln might be a lucrative endeavor.

A failed attempt to steal Lincoln's corpse for ransom occurred on the 7th of November in 1876. A band of counterfeiters broke into Lincoln's tomb, removed the marble lid from his sarcophagus, and arduously attempted to make off with the coffin before police were alerted and the plot quickly thwarted. The coffin was moved and stored in various discreet locations in the cemetery over the following years. The unsecured and deteriorating tomb at Oak Hill Cemetery was replaced with a new tomb in 1901. Robert Todd Lincoln, the president's son, decided to encase the president's coffin in steel and concrete to prevent future disturbance.

Before the final interment, and unbeknownst to Robert Lincoln, workers re-interring the president decided it was necessary to once again view Abraham Lincoln's remains to prevent future rumors that the body was not resting in the soon to be permanent grave. A portion of the lead-lined coffin was removed from above Lincoln's face and shoulders to reveal the intact features of the 16th president, minus eyebrows and with the addition of some mold and mildew. The frequent embalming required for the deceased president's seven-state funeral procession probably accounted for the impressive extent of the corpse's preservation. Witnesses unanimously agreed that the coffin contained Lincoln's remains.

The coffin was placed in a steel cage, buried 10 feet below the ground, and encased in concrete—permanently interred in a monument befitting Lincoln's status. There Abraham Lincoln remains, at rest only after his coffin was moved 17 times and opened five. His final resting place, located in Oak Hill Cemetery, Springfield, Illinois, is and will continue to be one of the most sacred of historical landmarks in the United States.

#### Unlikely a Lincoln: The Improbable Progeny of Honest Abe

October 14, 1968, was a day like any other in Williamsburg, Virginia. It was a rough year nationally for the Civil Rights Movement as the country still reeled from the assassinations of Martin Luther King, Jr. in April and Robert Francis Kennedy in June. The Civil Rights Movement, arguably set in motion by the emancipation of slaves, and achieved due to the political genius of the 16th president a little over 100 years previous, would survive these losses and continue thriving into the 21st century. But while

the legacy of Abraham Lincoln has thrived up to the present day, his progeny has not fared equally well. Robert Todd Lincoln Beckwith would widely be considered the last direct descendant of Honest Abe when he died, presumably childless, in 1985. But on October 14, 1968, the eventually thrice-married, 63-year-old playboy's 27-year-old second wife gave birth to a son and named him Timothy Lincoln Beckwith.

#### SETTLED ESTATE, UNSETTLED QUESTIONS

The problem with lineage of this son, born to Annemarie Hoffman Beckwith, is that Robert Beckwith had undergone a vasectomy six years prior and was supposedly confirmed by a doctor to be completely sterile. Robert Beckwith divorced Annemarie, whom he accused of adultery, and the divorce court ordered blood tests to confirm the paternity of the child. Annemarie, who was raised in Hanover, Germany, fled with her son to Europe to avoid complying with the court's wishes. The divorce court ruled that Timothy Lincoln Beckwith was the product of an adulterous relationship; however, he retained the right to pursue a future claim of being heir to the Lincoln estate.

The Mary Harlan Lincoln Trust, established by the wife of Abraham Lincoln's son Robert, consisted of a significant amount of money to be distributed to three beneficiaries in the absence of a bloodline heir: the American Red Cross, First Church of Christ Scientist, and Iowa Wesleyan College. These beneficiaries agreed to provide Timothy Beckwith a considerable settlement<sub>2</sub> from this Trust at the time of Robert Beckwith's death in exchange for his relinquishing any future claims as heir to the Lincoln Estate.

#### **SCHOLARS' CONSENSUS**

Most articles, museums, and other sources espouse the belief that Robert Todd Lincoln Beckwith, who died in 1985, was the last living descendant of President Abraham Lincoln. The circumstantial evidence, such as Annemarie Hoffman Beckwith's defiance of the court's request for a blood sample from her son, Timothy Beckwith's acceptance of a settlement from the three beneficiaries of the

Lincoln Estate, and Timothy's reluctance to speak on the subject, as highlighted in a USA Today article<sub>3</sub> from 6 February 2013, also seems to indicate that Abraham Lincoln's direct line of descendants ended with the death of Robert Todd Lincoln Beckwith in 1985.

#### **BOTTOM LINE**

The stories and events surrounding the Lincoln family after the president's death offer a shadowy aura of mystery and mystique to contrast the often whitewashed veneration of his life. From the unusually long span of time it took Abraham Lincoln to reach his <u>final resting place</u><sub>4</sub> to the relatively short span of years until his progeny were no more, there is seemingly no part of the Lincoln story which lacks the interesting details necessary to captivate students of American History.



# "Gerry Owen" or should that be "Roll Out the Barrel"

The Song Custer's Soldiers should have been playing?

From an 1890 book: The German Soldier in the Wars of the United States



General George A. Custer, one of the most picturesque characters of the war and an exceptional soldier in his Indian campaigns, was the great-grandson of an officer of the Hessian soldiers sent here to serve in the British army during the Revolution. His ancestor, paroled in 1778, after Burgoyne's surrender, settled in Pennsylvania, married there, changed his German name, "Küster," to one easier to pronounce in English, and moved to Maryland, where the father of General Custer was born in 1806. His famous son was born in Ohio, in

1839,

#### Camp Bylaws Updates Needed

2018 is the Chinese Year of the Dog, but in the SUVCW it is the year of the bylaws. General Order 18 and Department Order 10 calls for camps to update their bylaws for signature at the Department Encampment on June 2, 2018. It is all for a good cause, to extend National's 501(c)(3) tax exemption to Departments and Camps.

First, confirm if your camp is incorporated at the Missouri Secretary of State website:

https://bsd.sos.mo.gov/BusinessEntity/BESearch.aspx?SearchType=0. Most camps are not incorporated and would use the National Treasurer's recommended wording. Lincoln and Westport are incorporated, while Grant and Phelps are incorporated and have fictitious names so they may want to alter the wording to reflect their legal status.

#### Article \_\_\_\_ - Organization

The Camp shall be constituted and remain constituted as provided by the Constitution and Regulations (C&R) governing the National Organization, Sons of Union Veterans of the Civil War, and shall be known as the <u>CAMP NAME</u> #99, SONS OF UNION VETERANS OF THE CIVIL WAR, hereafter referred to as the Camp. The Camp is organized as an <u>unincorporated (or incorporated as in the cases mentioned above)</u> association under the laws of the State of Missouri. The Camp is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)3 of the Internal Revenue Code, or corresponding section of any future tax code.

#### Article \_\_\_\_\_ - Exemption Purpose

No part of the net earnings, if any, of this Camp, shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the unincorporated association shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)3.

No substantial part of the activities of the Camp shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Camp shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these by-laws, the Camp shall not carry on any other activities not permitted to be carried on (a) by a nonprofit corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or

(b) by nonprofit corporation, contributions to which are deductible under section 170(c)2 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### Article \_\_\_\_\_\_ - Separation, Dissolution and Disposition of Assets

In the case of surrender or forfeiture of the Camp Charter, all Camp property and assets shall be turned over to the National Commander-in-Chief of the Sons of Union Veterans of the Civil War or his duly authorized representative and such become the property of the National Organization, Sons of Union Veterans of the Civil War, an organization exempt from taxes under section 501(c)3 of the Internal Revenue Code. The receipts for property and assets shall be added to the surrendered Department records.

All property of the Camp shall be held by the National Organization, Sons of Union Veterans of the Civil War, as a charitable trust and used for the purpose for which the Order exists. Any such transfer or disposal within six (6) months of disbandment or

surrender of the Camp Charter without the written consent of the National Commander-in-Chief of the Sons of Union Veterans of the Civil War is prohibited. The property and funds of the Camp shall not be divided among its members.

In the event the National Organization, Sons of Union Veterans of the Civil War, no longer exists, said property and funds shall revert to the benefit of the first and any remaining organization of the Allied Orders of the Grand Army of the Republic or in their absence, to the holdings of the Missouri Historical Society (or State Historical Society of Missouri, or St. Louis Mercantile Library).

Notwithstanding the above language, upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

If your Camp has not updated their bylaws in several years, you're not done. General Order 11 in 2017 and General Order 22 in 2014 requires you to add a Youth Protection Policy. Feel free to borrow the Department's wording.

#### Article \_\_\_\_\_ - Youth Protection

All Brothers and guests under the age of 18 years of age shall be accompanied by a parent, legal guardian, or chaperon when participating at any SUVCW Camp event. A chaperon must be 18 years of age or older, and have written authorization from a parent or legal guardian.

All Brothers must comply with all applicable laws pertaining to child protection. Any Brother who witnesses or suspects any type of physical, mental, or sexual abuse of any other Brother or guest under the age of 18 is obligated to report such activities to local authorities and the Camp Commander.

Every Brother who may have direct contact with or oversight of another Brother or guest under the age of 18 (other than their child) at a SUVCW Camp event must complete a child protection course offered by a government agency or other reputable source. Evidence of course completion must be provided to the Camp Commander.

The **Francis P. Blair, Jr. Award** is presented annually to the most outstanding member of the Department of Missouri, Sons of Union Veterans of the Civil War. It is for the member who has made the greatest collective contribution during a specific year to the Department and his Camp through its programs and activities. The member must have been in good standing and exemplify the virtues of Fraternity, Charity, and Loyalty for the entire year. An award recipient is not eligible for repeat consideration for three years.

The **Meritorious Service Award** is presented to a member of the Department of Missouri, Sons of Union Veterans of the Civil War. It is for the member who has made a significant contribution or collective contributions over a period of time to the Department and his Camp through its programs and activities. The member must have been in good standing for five or more years, and exemplify the virtues of Fraternity, Charity, and Loyalty. An award recipient is not eligible for repeat consideration for three years.

The **Grand Army of the Republic Award** is presented to an Allied Order member or group. It is for members or groups who have made a significant contribution or collective contributions over a period of time to promote fraternal relationships between the Allied Orders in perpetuating the memory of the Grand Army of the Republic (GAR) and our ancestors who fought to preserve the Union. An award recipient is not eligible for repeat consideration for three years.

The **Wayne Sampson Show Me Spirit Award** is presented to an individual who has made a significant contribution or collective contributions over a period of time to promote the SUVCW, Allied Orders, or Civil War history, and who demonstrates a shared interest in the SUVCW mission. An award recipient is not eligible for repeat consideration for three years.

The 2017-18 Annual Awards Committee members are: SVC Dale Crandell (chair), PDC Martin Aubuchon, PDC Glen Alsop, and PDC Larry Dietzel.

# Eads Award Application Deadline: April 15th

The Department's **James B. Eads Award** is presented annually to honor Camps who demonstrate exceptional service to the order's ideals through their work at the local, department, and national levels. Since its revision in 2013, the Eads award is not a competition for a single outstanding camp but a distinguished service citation for all camp meeting the checklist criteria.

To encourage greater participation, the Department's 2017 Annual Encampment revised the award criteria to provide flexibility to recognize a Camp's many activities. Every camp is encouraged to apply using the application form posted at: <a href="http://www.suvcwmo.org/awards.html">http://www.suvcwmo.org/awards.html</a>. #### **ROTC Awards Program**

#### **JROTC Outstanding Cadet Competition**

The Department of Missouri authorized the Outstanding JROTC Cadet program for a third year and extended the submission deadline to July 1st. This competition is open to high school JROTC cadets in Missouri and Arkansas. - 3. Each Camp may nominate one cadet for the competition from among the JROTC high school units they sponsor.
- 4. Submit the Camp's nominee with the JROTC unit's 100- to 300-word summary to the Department's ROTC coordinator <a href="decrandell@suvcwmo.org">dcrandell@suvcwmo.org</a>. Deadline to receive Camp nominations: July 1, 2018.

#### Appropriate Display of SUVCW Insignia, Etc.

The Department of Missouri, Sons of Union Veterans of the Civil War, has been informed of an impending ethics committee hearing involving a state representative who is also a member of this organization. The hearing is on January 4, 2018, and will include no public testimony.

The issue involves comments made by the representative after vandalism of a Civil War monument in Springfield National Cemetery. As citizens of the state of Missouri, you are free and encouraged to submit letters to the members of this committee stating your personal position as well as to attend the hearing if you so desire.

Article IV of our Order's Constitution states "The Order being strictly non-sectarian and non-partisan, the introduction or discussion of sectarian or partisan topics is strictly prohibited."

Commander-in-Chief Mark Day's General Order #2 forbids members from "making statements written or oral using the organizations name, symbols, letterhead, or while in the branded attire of the organization to include SVR uniforms and symbols," in regards to the veterans' monument issue.

It is very easy to get "tricked" by the media into making statements for our organization on the monuments issue, and it is not hard to imagine how these statements can be twisted in the most negative manner possible to suit the political ends of others.

In regards to the House Ethics Committee Meeting of January 4, 2018, and any similar future event, it is imperative that brothers of this department refrain from indicating in any manner that their personal positions on the issue are those of the Department of Missouri or the Sons of Union Veterans of the Civil War. Specifically, members will not mention membership in this organization in letters of support or wear the SUVCW insignia should one decide to attend the hearing.

- 1. Camps are hereby directed to review their bylaws, include the necessary additions, vote on the changes, and strive to have their camp's bylaws ready for the Department Commander's signature by the Department Encampment on 2 Jun 2018.
- 2. The Department of Missouri will be voting on the necessary changes to its bylaws in regards to CinC Mark Day's General Order #18 at the June 2, 2018 Department Encampment. The Bylaws Committee is hereby instructed to create a draft of the Bylaws with the necessary language included. This draft should be sent to the Department Secretary, who will then follow the notification procedure detailed in Article XIII, Section 2, of the Department of Missouri's Bylaws.

## Department Communiqué No.6,

Brothers of the Department of Missouri,

This has been a busy year, and thus I will take this opportunity to keep you abreast of things as we approach our next Department business meeting on Saturday, March 10, 2018. This is not an exhaustive approach to everything currently happening in the Department of Missouri, but hopefully it is an effective reminder of some actionable items which deserve your immediate attention.

1.) Regarding Department Order #10: I have contacted the National Treasurer regarding the bylaw language as it relates to the incorporation status of our department and its camps. We must change the wording provided to reflect our incorporation status; however, we must keep the 501(c)3 language even though we currently have 501(c)4 determination. The National Treasurer explains as follows:

"You may substitute however your entity is constituted in your state (or states since some Departments are in more than one state). If the Department and Camps have articles of incorporation and you are corporations, then substitute that language. And it says 501(c)3 so that all bylaws in the Order comply with the requirements set forth by the IRS to request a change in the Group Exemption to 501(c)3. We cannot move forward with the change in Group Exemption until these bylaw changes are made."

Keep in mind the time needed to notify members of a bylaws vote as you strive to have camp bylaws ready for a signature by the Department Encampment on 2 Jun 2018. The bylaw wording which you must customize for your camp is included in CinC Mark Day's <u>General Order #18</u>. We will be discussing this topic further at the March business meeting.

- 2.) Speaking of bylaws, do your bylaws (or policies) include minimum protections for juniors and junior associates? PCinC Kenneth Freshley's <u>General Order #22</u>, <u>Series 2013-2014</u>, provides suggestions.
- 3.) Have you paid your annual dues? For an extra few dollars you can join an SVR unit. Lifetime memberships for the SUVCW are also available; contact JVC Hunnewell.

- 4.) Past Camp Commanders who have left the camp they commanded need to apply for rank reinstatement in their current camp. These are voted on at the camp level and then forwarded to the Department for a vote at the next Encampment.
- 5.) Department Order #7 directs all camps and (current and former) department officers to submit a complete list of items in their possession which are owned by the Department of Missouri to commander@suvcwmo.org. These lists should be submitted by March 3, 2018, in time for review at the March 10, 2018, Department business meeting. We are compiling a comprehensive inventory of Department property.
- 6.) Check in with your committee chairs!
- 7.) The time of year is approaching for presenting ROTC awards to your local ROTC units and for submitting nominations for Department awards to the SVC. Don't forget to also review the Eads Award checklist for your camp there is still time to get things done!
- 8.) Submissions for the March 31<sup>st</sup> *Missouri Unionist* are due March 28<sup>th</sup>. Submissions for the Spring Issue of *The Banner* are due March 15<sup>th</sup>.
- 9.) Camps do not forget the **Department Secretary** needs your signed Form 22 by Feb 15<sup>th</sup>. I will forward those which have been sent to me for a signature (or for any other reason).
- 10.) The next business meeting for the Department of Missouri is **Saturday**, **March 10**, **2018**, **at 10:00 a.m.**, **House Hearing Room #7**, **State Capitol Building**, **Jefferson City**, **Missouri**. All camps are encouraged to send representatives to the meeting. All officers and committee chairs should submit written reports to the Commander and to Department Secretary Ed Krieser at least one week prior to the date of the business meeting (March 3, 2018).

As stated previously, there have been a lot of things going on this year, so look back over the department orders, communiqués, and issues of the *Unionist* for things you may have overlooked. Stay warm and drive safely. I'll see you at the March business meeting!


The construction period of Phase II of the Missouri State Capitol Construction Project will begin on Friday, March 2nd, 2018.

During this incredibly complex and long-term project, the south lawn of the Capitol building will be converted into a construction staging area in order to allow for heavy equipment & materials to be stored on-location. As such, the south circle drive will CLOSE to public traffic from Friday, March 2nd until late 2020. Eastbound traffic approaching the Capitol Building from West Main will be diverted right onto Broadway Street. Westbound traffic approaching the Capitol Building from Capitol Avenue will make a slight diversion on Senate Garage Drive and then proceed around the north side of the Capitol. As a precaution, please note the speed limit on the north drive is 20 mph and traffic will be limited to one lane only. Visitors will continue to enter the Capitol through the south carriage & west public entrances.


#### Commander's Letter

God bless this Union, our ancestors who fought for it, and you my brothers, who are preserving its history even in the midst of occasional indifference.



Westport Camp #64 and DUVCW Macklind Tent #24 held a joint-commemoration for President Abraham Lincoln's birthday on Sunday, 11 Feb 2018. Unplanned but to everyone's enjoyment was an unknown school age boy from the audience that stepped forward and recited Lincoln's Gettysburg address from memory.

This second-time event was appropriately held at the *Abraham Lincoln and His Son Tad* memorial statue that sits at Kansas City's south entrance to City Hall. A well-known downtown Kansas City landmark, the Abraham and Tad statue was provided from a community-wide campaign that raised \$140,000. Artist Lorenzo Ghiglieri was commissioned in 1983 to create the 10' tall, 2,500 bronze statue that was installed and dedicated in 1986.

#### Medal of Honor Commemoration

For the eighth year, Westport Camp #64 joined with the Sons of the American Revolution and Society of the War of 1812 for National Medal of Honor Day. This year's event honored Second

Lieutenant Paul Riordan (1920-1944) with a gravesite service on 25 Mar 2018. He was a veteran of World War II and posthumously received the Medal of Honor for heroism during an advancement on the City of Casino, Italy on 3 Feb 1944. The family was presented the Medal in his name on 11 Sep 1944, at the home in Kansas City.

Paul Riordan was born 8 Nov 1920 in Charles City, Iowa to Herbert Riordan and Orpha Josephine Riordan. Like others of his age, Paul entered military service in 1940. He trained with the Iowa National Guard and was assigned to Company L, 133rd Infantry Regiment, 34th Infantry Division, U.S. Army.

Among Second Lieutenant Riordan's many awards: United States Medal of Honor, Purple Heart, American Defense Service Medal, American Campaign Medal, Europe/African/Middle Eastern Campaign, and World War II Victory Medal as well as France's Croix De Guerre.



Riordan was originally buried at the American Battlefield Memorial Cemetery in Italy. His remains were returned to Kansas City in late September of 1948 and he was interned in the family plot at Mt. Olivet on 2 Oct 1948.

#### National Medal of Honor Day

Often called the Congressional Medal of Honor, the United States Congress designated March 25th of each year as National Medal of Honor Day, a day dedicated to honoring the over 3,400 men and women whose service and sacrifices were recognized with the nation's highest medal for valor, the Medal of Honor. Westport Camp #64 dressed each of the five Civil War Medal of Honor recipients buried in the Kansas City area for National Medal of Honor Day.

Private Nathanial McLean Gwynne (1849-1883) for action at the Battle of Crater while serving with Company H, 13th Ohio Cavalry.



Major M.R. William Grebe (1838-1916) for action at the Battle of Jonesboro and Atlanta Campaign, while serving with Company F, 4<sup>th</sup> Missouri Cavalry.

Sergeant Thomas Toohey (1835-1918) for action at the Battle of Franklin, while serving with Company F, 24th Wisconsin Infantry.

Private John Henry Ricksecker (1843-1929) for action at the Battle of Franklin, while serving with Company D, 104<sup>th</sup> Ohio Volunteer Infantry Regiment.

Private Wilbur Moore (1840-1924) for action at the Battle of Nashville, while serving with Company C, 117<sup>th</sup> Illinois Infantry.



# Headquarters Department of Arkanzas Brand Army of the Republic.

General Order No. 5.

Springdale, Ark., September 24, 1900.

- I. The proceedings and findings of the general court martial in the case of Silas K. Robinson, of Post No. 2. Department of Arkansas Grand Army of the Republic, having been approved by the Communder-in-Chief on the 27th day of August, 1900, the said Silas K. Robinson is dishonorably discharged from the Grand Army of the Republic. All Posts and Comrades will take due notice and govern themselves accordingly.
- II. There will be an inspection of all the Posts in this Department between the 1st of September and the 31st of December. See Rules and Regulations, Art. 5, Chap. 5. In the absence of Assistant Inspectors, Post Adjatants will act and make their reports to Department Inspector, Comrade A. K. Sawyer, West Fork, Ark.
- III. Posts not having sent in their Adjutant and Quartermaster reports for the term ending June 30, 1900, will please do so at their earliest convenience, with per capita tax. Delinquent Posts will please reinstate in accordance with General Order No. 3, from these headquarters. Comrades, our ranks are thinning fast. Please fall in and fill the vacant ranks. Our Department made a very satisfactory showing at Chicago, but we could have done better. Comrades, let us go to work in real earnest as we did in the sixties, and not rest content until we have every man who were the blue in the warm embrace of a true comradeship in the Grand Army of the Republic.
- IV. The Posts of this department will elect officers at the first meeting in December. They will also elect delegates and alternates to the next state encampment. The new officers will be installed at the first meeting in January, unless otherwise arranged by the post.
